THE following is a copy of an Order of Her Majesty in Council, assigning a district chapelry to St. John's Chapel, in Clapham-road, in the parish of Clapham, in the county of Surrey, under the 16th section of the 59th Geo 3., cap. 134:

the Court at Windsor, the 2d of At November 1842, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fiftyeighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal ; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments which will by such division arise and accrue, and remain and be, within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division ; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided ;" and it is by the 21st section of the said Act further enacted, "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the bishop, signified under his hand and seal, may deem necessary for the purpose of afford-ing accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein,

livings, any thing in such Act or Acts of Parliament, or law or laws, to the contrary notwithstanding :"

And whereas the said Commissioners have made a representation to Her Majesty in Council, bearing date the twenty-seventh day of September one thousand eight hundred and forty-two, in the words following, viz.

"That, besides the parish church, which affords accommodation to one thousand one hun dred and seventy-nine persons, there are three consecrated chapels in the said parish, namely, St. Paul's, St. James's, and St. John's; and divine service is regularly performed therein; and that the said last-mentioned chapel, called St. John's, will accommodate one thousand one hundred and twenty-five persons, including four hundred and fifty free seats appropriated to the use of the poor:

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances

attending this parish, it appears to them to be expedient, that a particular district should be assigned to the said chapel, called St. John's Chapel, under the provisions of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and that such district should be named "The Chapelry District of St. John, Clapham," with boundaries as follow :

" The boundary of this district commences in the centre of the high road leading from London to Clapham, opposite to Manor-street, and proceeds in a northerly direction up the centre of that street to a point on the east side of Manor-street, indicated by a stone there placed; it then proceeds east along the boundary that divides the properties of Messrs. Loat and Fairbairn, and also the respective properties of Dr. Burrows, Mr. Capper, and Mr. Thornton, to a stone placed in the north east corner of Mr. Thornton's grounds; when it proceeds north by an imaginary straight line to the south west corner of the Union-road, in Lark-halllane; it then crosses that lane, and continues down the centre of Union-grove for fifty yards; whence it proceeds in a north easterly direction, by an imaginary line drawn at the backs of the houses on the north side of Lark-hall-lane, as far as the boundary line between the parishes of Clapham and Lambeth; which boundary it then follows in a southerly and south westerly direction as far as the Bedford New-road; then up the centre of that road one hundred yards; and thence in a south westerly direction, by an imaginary line drawn at the backs of the houses on the south side of the high road from London to Clapham, to the south western extremity of the premises known as the Grammar School; and thence in a north westerly direction along the enclosure fence of the said premises, to the point in the high road aforesaid where the boundary commenced, as is more particularly delineated on the map hereunto annexed, and thereon tinted blue:

"That marriages, baptisms, and churchings should be solemnized and performed in the said chapel; and that the fees arising therefrom should be received by and belong to the Minister of the said chapel:

"That the consent of the Lord Bishop of Winchester has been obtained thereto, as required by the above-mentioned section of the said Act, passed in the fifty-ninth year of His Majesty King George the Third; in testimony whercof the said Lord Bishop has signed and sealed this present instrument:

"Your Majesty's Commissioners, therefore, beg leave to lay before your Majesty the before-mentioned circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the recommendation of the said Commissioners in respect of the solemnization of marriages, bap-

tisms, and churchings, and the fees arising there-

sist of all that part of the parish of Rotherhithe which is bounded on the north and east by the River Thames; on the south by a ditch which is also the boundary of the counties of Kent and Surrey; on the west by a line drawn from the River Thames, at Globe-stairs, along the middle of Globe-street, on the east side of Mr. Sedger's house, to the Commercial Docks; then crossing to the Surrey Canalbank, and so along the banks of the canal to meet the said ditch, the boundary of the said counties, as the same is more particularly delineated on the map hereunto annexed, and therein coloured pink :

" The district of All Saints, Rotherhithe, is to consist of all that part of the parish of Rotherhithe which is bounded on the north by a line starting from the point of the ditch or drain which is the extreme south west point of the district of Christ Church, and which ditch or drain forms a part of the Mill-pond separating that part of the glebe land lately occupied by Mr. Jeffery from Sir William Gomm's land, and which ditch or drain forms the boundary of the district of Christ Church, and turns to the east of the Seven Islands; and which said boundary line then follows the course to represent to your Majesty, that, when the of the said drain to the point of land between the last census was taken, the parish of Rother- gardens of Prospect-place and of Mr. Branden's of the said drain to the point of land between the

gardens, to the gateway and ancient wall at the back of the gardens now occupied by the inhabitants of the houses in Paradise-row, and so along the footpath in Callender's-garden, till the said footpath comes to the fence on the west of Mr. Hay's garden; and then along the fences at the west of the gardens of the houses in Walker'splace, to the west end of the National School-rooms; and from thence along the fences at the west of the gardens of Mrs. Cawthorne's and Mr. Hawk's houses, and so between Mr. Hawk's premises and Claremont-place, to the centre of the Deptford Lower-road; and proceeds along the centre of the Deptford Lower-road till the same comes to Albion-street; and from thence goes thirty feet on the north of Albion-street to Swan-lane; and then proceeds thirty feet to the east of Swan-lane, to the King's Mill-stream; and from thence along the centre of the Mill-stream to the Half-penny Hatch footpath; and from thence along the east fences of Mr. Dunn's garden to his large gates on the Deptford-road, near the turnpike-gate; and from thence along the centre of the Deptford-road to the boundary line between the counties of Kent and Surrey, and so along the south and west boundary of the parish of Rotherhithe till the same comes to the starting point, namely, the south west corner of the premises lately occupied by Mr. Jeffery, on the glebe land, and adjoining the Blue Anchorroad, as the same is more particularly delineated on the map hereunto annexed, and therein coloured green:

"That baptisms, churchings, and burials should be solemnized and performed in the said chapels of the Holy Trinity and All Saints; and that the fees arising therefrom should belong and be paid to the respective Ministers thereof:

"That the consent of the Lord Bishop of Winchester has been obtained thereto, as required by the above-mentioned section of the said Act, passed in the fifty-ninth year of the reign of His MajestyKingGeorge the Third; in testimony whereof the said Lord Bishop has signed and sealed this present instrument:

"Your Majesty's Commissioners, therefore, beg leave to lay before your Majesty the beforementioned circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."
