OTICE is hereby given, that His Royal Highness Prince Albert will, by the desire of Her Majesty, hold Levees, at St. James's-Palace, on behalf of Her Majesty, on Wednesday the 29th instant, and on Wednesday the 26th of April next, both days at two o'clock.

The Noblemen and Gentlemen, who propose to attend the Levees at Saint James's-Palace, are requested to bring with them two cards, with their names thereon written, one to be left with the Queen's Page in Attendance in the Presence-chamber, and the other to be delivered to the Lord in Waiting, who will announce the name.

Those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them (not the Lord in Waiting), should be sent to the Lord Chamberlain's-Office, before twelve o'clock, on the day but one previous to each Levee, in order that they may be submitted for approbation; it being Her Majesty's command, that no presentation shall hereafter be made at the Levees, but in conformity with the above regulations; and further, that no person shall be admitted, on any pretence whatever, who has not been so presented.

It is particularly requested, that Gentlemen, who are to be presented at the Levees, will have their names distinctly written upon the card to be delivered to the Lord in Waiting, in order that there may be no mistake in announcing them.

The state apartments will not be open for the reception of Company coming to Court, until half past one o'clock.
