WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act for carrying into effect, with "certain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues;" and of another Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An Act "to explain and amend two several Acts re-"lating to the Ecclesiastical Commissioners for "England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-first day of March in the year one thousand eight hundred and forty-three, in the words followine, that is to say:

lowing, that is to say: "We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act for

" carrying into effect, with certain modifications, " the fourth report of the Commissioners of Eccle-" siastical Duties and Revenues;" and of another Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled " An Act to explain and amend two " several Acts relating to the Ecclesiastical Com-" missioners for England," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for regulating the average annual incomes of the Dean and Canons of the collegiate church of Westminster, appointed, or to be appointed, after the passing of the said first recited Act.

"Whereas it is, by the first recited Act, enacted, that, so soon as conveniently may be, and by the authority therein provided, and subject to the provisions therein contained respecting the canonries in the collegiate church of Westminster annexed to the rectories of St. Margaret and St. John, such flxed annual sums shall be determined on to be paid, and shall accordingly be paid to us, by the Dean and Canons of the said collegiate church of Westminster as, after due inquiry and a calculation of the present average annual revenues of the Chapter of such church, shall leave to the said Dean an average annual income of two thousand pounds, and to each of the Canons of the same church an average annual income of one thousand pounds; but such provision was not to affect any Dean or Canon in possession at the passing of the same Act:

"And whereas, by the said secondly recited Act, it is declared and enacted, that, notwithstanding such last recited provision, it shall be lawful to carry such purpose into effect by any mode of payment or contribution which may be deemed fit, as well as by the mode in the said first recited Act specified : "And whereas the present Dean of the said collegiate church of Westminster has been appointed since the passing of the said recited Acts :

"We, therefore, having made the inquiry and calculation required by the said first-recited Act, humbly recommend and propose, that, in order to leave to the Dean and Canons of Westminster, respectively, appointed or to be appointed after the passing thereof, the average annual incomes in the said Act specified, there shall be paid to us, in the manner and at the times hereinafter mentioned, and for the purposes of the said recited Acts, one equal fifth part of all monies at any time accruing and payable to such Dean, and one equal sixth part of all monies at any time accruing and payable to any such Canon; and to this end we recommend and propose, that the Treasurer, or other proper officer or officers of the said collegiate church, shall, from time to time, divide each and every sum of money, from whatsoever source arising, which, according to the statutes or usage of the said Chapter, would be payable to the Dean, or, in case of the vacancy of the deanry, would, if such vacancy had not occurred, have been payable to the Dean making such vacancy, in respect of the deanry of the said church, into five equal parts, and that four of such parts shall be paid to the Dean for the time being, or, in the case of such vacancy, to such uses as shall be in accordance with the statutes or usage of the said Chapter, and the remaining part shall be paid to us or to our order; and that the said present Dean shall pay to us, or to our order, one fifth part of all monies already received by him in respect of his said deanry since the date of his appointment thereto; and that the said Treasurer, or other officer or officers, shall, from time to time, divide cach and every sum of money, from whatever source arising, which, according to the statutes or usage aforesaid, would be payable to any Canon appointed after the passing of the said first-recited Act, or, in case of the vacancy. of a canonry (not being a suspended canonry, nor either of the canonries whereto the rectories of Saint Margaret and Saint John are, by the said first-recited Act, annexed), would, if such vacancy had not occurred, have been payable to the Canon making such vacancy, into six equal parts, and that five of such parts shall be paid to the Canon for the time being, or, in the case of such vacancy, to such uses as shall be in accordance with the statutes or usage of the said Chapter, and the remaining part shall be paid to us or to our order :

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the Dean and Canons of the said collegiate church of Westminster, in conformity with the provisions of the said recited Acts, or either of them."

And whereas notice of the said scheme has been duly given to the Dean and Chapter of the collegiate church of St. Peter, Westminster, and no objection has been made thereto:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of London. *Wm. # PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act, made in the session of Parliament holds of Parliament holden in the third and fourth years of Her present Majesty's reign, intituled "An Act to enable Her Majesty to carry into " effect certain stipulations contained in a Treaty " of Commerce and Navigation between Her " Majesty and the Emperor of Austria; and to "enable Her Majesty to declare, by Order in." Council, that ports, which are the most natural and convenient shipping ports of States within " whose dominions they are not situated, may, in " certain cases, be considered, for all purposes of: " trade with Her Majesty's dominions, as the " national ports of such States," it was, among other things, enacted, that, from and after the passing of the said Act, notwithstanding any thing contained in an Act, passed in the session of Parliament of the third and fourth years of His late Majesty King William the Fourth, intituled "An Act for the encouragement of British "shipping and navigation," it should be lawful for Her Majesty, from time to time, to declare by Her Order in Council, to be published in the London Gazette, "that any port or ports to be named in such Order, being the most convenient port or ports for shipping the produce of any State, to be also named in such Order, shall, although not situated within the dominions of such State, be port or ports for the use of the ships of such State in the trade of such ships with all parts of the British dominions, or with any part or parts of the same named and limited in such Order, in as full and ample manner as if such port or ports were within the dominions; of such State; and, thereupon, and for so long a time as such Order shall be declared to be in force, or shall remain unrevoked, it shall be. lawful to import into the British dominions, or into such parts of the same as shall be named and limited in such Order, from such port or ports in the ships of such State, any goods which, by the laws in force at the time of such importation, might then be imported in such ships from a port of the country to which they belonged, and so to import such goods upon the like terms as the same could there be imported from the national ports of such ships:"

And whereas a Treaty of Commerce and Navigation has been concluded between Her Majesty and His Majesty the Emperor of All the Russias, and the same was signed on the eleventh day of January of the present year, and the ratifications thereof were exchanged on the thirty-first day of the same month; and by the said Treaty, in consideration that British ships, arriving directly from other countries than those belonging to the High Contracting Parties, are admitted, with their cargoes, into the ports of the Russian empire without paying any other duties whatsoever than those payable by Russian vessels; and in consideration of the advantages which in this respect the said Treaty specifically grants to British commerce in the Grand Duchy of Finland; it is agreed that, from the date of the exchange of the ratifications of the said Treaty, Russian vessels, arriving from the mouth of the Vistula, the Niemen, or any other river which forms the outlet of a navigable stream having its source in the dominions of His Majesty the Emperor of All the Russias, or passing through the said dominions, shall be admitted, with their cargoes, into the ports of the United Kingdom of Great Britain and Ireland, and of all the possessions of Her Britannic Majesty, exactly in the same manner as if these vessels arrived directly from Russian or Finnish ports, with all the privileges or immunities agreed upon by the said Treaty of Navigation and Commerce; and that, in like manner, Russian vessels, proceeding from any port of Great Britain, or of the British possessions, for the mouth of any of the above-mentioned rivers, shall be treated as if they were returning to a port of the empire of Russia, or of the Grand Duchy of Finland; it is, however, by the said Treaty declared to be understood, that these privileges shall apply to Russian vessels only so long as British vessels and their cargoes shall be treated at those places, on their arrival and departure, on the same footing with Russian vessels:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased, in pursuance of the power and authority in Her vested by the hereinbefore-recited Act, and of every other power and authority in anywise enabling Her in that behalf, to order and declare, that Russian vessels, arriving from the ports or mouths of the Vistula, the Niemen, or any other river which forms the outlet of a navigable stream having its source in the dominions of His Majesty the Emperor of All the Russias, or passing through the said dominions, shall be admitted, with their cargoes, into the ports of the United Kingdom of Great Britain and Ireland, and of all the possessions of Her Majesty, exactly in the same manner, and with the same privileges and immunities, as if such vessels arrived directly from Russian ports, or from ports in the Grand Duchy of Finland; and that, in

like manner, Russian vessels, proceeding from any part of the United Kingdom, or of the British possessions, to the ports or mouths of any of the rivers above-mentioned or described, shall be treated as if they were returning to a port of the empire of Russia, or of the Grand Duchy of Finland; provided, nevertheless, that these privileges shall apply to Russian vessels only so long as British vessels, and their cargoes, shall be treated at those places, on their arrival and departure, on the same footing with Russian vessels:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions therein accordingly.
