THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to make better provision for the spiritual care of populous parishes.

An Act for the better apprehension of certain offenders.

An Act to make further regulations for facilitating the hearing appeals and other matters by the Judicial Committee of the Privy Council.

An Act for confirmation of certain marriages in Ireland.

An Act to repeal so much of an Act, of the first year of King George the First, as limits the time for taking, and being restrained from taking, salmon in certain rivers; and to amend and extend the provisions of an Act, of the fifty-eighth year of King George the Third, to the rivers therein mentioned.

An Act to exempt from county, borough, parochial, and other local rates, land and buildings occupied by scientific or literary societies.

An Act to amend so much of an Act, of the last session, for the government of New South Wales and Van Diemen's Land, as relates to Norfolk island.

An Act to render valid an Act, for better raissing and securing the fund for the relief of widows and children of burgh and parochial schoolmasters in Scotland.

An Act to make, complete, maintain, and incorporate with the Monkland and Kirkintilloch Railway, two improved or additional lines of railway, and to alter, amend, enlarge, and repeal the Acts relating to the said undertaking.

THE following is a copy of an Order of Her Majesty in Council, assigning a chapelry district to Trinity Chapel, in the parish of Darlington, in the county of Durham, under the 16th section of the 59th Geo. 3., cap. 134:

At the Court at Buckingham-Palace, the 3d of April 1843, present, the Queen's Most Excellent Majesty in Council.

WHEREAS, by an Act, passed in the fifty-eighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to

respective proportions of glebe land, tithes, moduses, or other endowments which will by such division arise and accrue, and remain and be, within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such divsion; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and it is by the 21st section of the said Act further enacted, "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete, separate, and distinct parishes as afore-said, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the bishop, signified under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:"

And whereas by an Act, passed in the fifty-ninth year of His late Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, that it shall be lawful for the Commissioners, in the same manner and with the like consents as are required in case of division into ecclesiastical districts under the said recited Act, or this Act, to assign a particular district to any chapel of ease or parochial chapel already existing, or to any chapel built, or which may hereafter be built or acquired under the powers of the said Act, or this Act; and such district shall be under the immediate care of the curate appointed to serve such chapel, but subject. nevertheless, to the superintendence and con-

troul of the incumbent of the parish church; and all such curates shall be nominated by the incumbent of the parish to the bishop for his licence, except where the right of nomination shall already be legally vested in any other person or persons, and in every such case by the person or persons possessing such right of nomination, subject to all the laws in force relating to stipendiary curates, except as to the assigning of salaries to such curates; provided always, that it shall be lawful for the Commissioners, with the consent of the bishop of the diocese, to determine whether any and what part or proportion of the fees or dues for marriages, baptisms, churchings, and burials shall be assigned to any such curate; and whether banns of marriage shall be published, and marriages or baptisms, churchings or burials, shall be solemnized or performed in any such chapel or not; and in any case in which marriages shall be allowed in any such chapel, the Commissioners shall cause the boundaries of the district assigned to such chapel to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese, any thing in the said recited Act to the contrary notwithstanding; and no such chapelry shall become a benefice by reason of any augmentation of the maintenance of the curate, by any grant or bounty under the provision of any Act or Acts of Parliament, or law or laws, for augmenting small livings, any thing in such Act or Acts of Parliament, or law or laws, to the contrary notwithstand-

"That, besides the parish church, which affords accommodation to one thousand two hundred and thirty-nine persons, there is only one consecrated chapel, called Trinity Chapel, in the said parish, and divine service is regularly performed therein, and that the said chapel will accommodate one thousand and ten persons, including six hundred free seats appropriated to the use of the poor:

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances attending this parish, it appears to them to be expedient, that a chapelry district should be assigned to the said chapel of the Holy Trinity, under the provisions of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and that such district should be named, "The District of Holy Trinity, Darlington," with boundaries as follow:

"The district is to be formed out of the north-

ernmost part of the parish, and to consist of the townships of Archdeacon Newton and Cockerton, and part of the township of Darlington. The boundary thereof to commence opposite the house at the south west corner of Skinner-gate, and then proceed up the centre of Skinner-gate, including all the houses on the west side thereof, as far as Bond-gate; then east along the centre of Bond-gate, including all the houses on the north side thereof, as far as Commercial-street; then north up the centre of Commercial-street, including all the houses on the west side thereof, as far as Albion-street; when it again proceeds east along the centre of Albion-street, including all the houses on the north side thereof, as far as Northgate; when it proceeds north along the centre of North-gate and the High-road from Darlington to Durham, including all the houses on the west sides thereof, as far as the point where the parishes of Darlington and Haughton le Skerne join, at a field called Lawson's Slack; the boundary then leaves the high road, and proceeds in an easterly, north easterly, and north westerly direction along the line that divides the said parishes of Darlington and Haughton le Skerne to where the said parishes join the parish of Heighington; thence in a divides the said parishes of Darlington and Heighington to where they join the parish of High Coniscliffe; and then along the boundary line that divides the said parishes of Darlington and High Coniscliffe as far as the road leading from Barnard Castle to Darlington; and then east along the centre of that road, including all the houses on the north side thereof, to the point where the boundary commenced in the centre of Skinner-gate, as is more particularly shewn by the map, and thereon tinted yellow, pink, and green.

"That marriages, baptisms, churchings, and burials should be solemnized and performed in the said chapel; and that the fees arising therefrom should be received by and belong to the Minister

of the said chapel:

"That the consent of the Lord Bishop of Durham has been obtained thereto, as required by the above-mentioned section of the said Act, passed in the fifty-ninth year of His Majesty King George the Third; in testimony whereof the said Lord Bishop has signed and sealed this present instrument:

"Your Majesty's Commissioners, therefore, beg leave to lay before your Majesty the beforementioned circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the recommendations of the said Commissioners, in respect of the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts.

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances attending this parish, it appears to them to be expedient, that particular districts should be assigned to the said three last-mentioned chapels, respectively, under the provisions of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and that such districts should be named, respectively, "The Chapelry District, Saint George," "The Chapelry District of Saint Catherine," and "The Chapelry District of Saint John the Evangelist, Abram," with boundaries as follow:
