A T the Court at Buckingham-Palace, the 23d day of August 1843,

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with "certain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues," duly prepared and laid before Her Majesty in Council a scheme, bearing date the first day of August one thousand eight hundred and forty-three, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into effect, with cer"tain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for fixing the number and emoluments of the Minor Canons in the collegiate church of Saint Peter, Westminster.

- " Whereas it is by the said recited Act enacted, that so soon as conveniently may be, and by the authority therein provided, regulations shall be made for fixing the number and emoluments of the minor canons in each cathedral and collegiate church, provided that there shall not in any case be more than six nor less than two, and that the stipend of each such minor canon, thereafter to be appointed, shall not be less than one hundred and fifty pounds per annum; and that arrangements may, from time to time, be made by the like authority, for securing to any minor canon, not otherwise competently provided for, such annual sum as shall make up to him an income, as minor canon, not exceeding in any case the said sum of one hundred and fifty pounds:
- "And whereas application has been made to us by the Dean and Chapter of the collegiate church of Saint Peter, Westminster to fix the number and emoluments of the Minor Canons in the said church as hereinafter mentioned:
- "And whereas it has been represented to us by the said Dean and Chapter, that the number of Minor Canons in the said church has hitherto been six, and that the stipend of each Minor Canon, payable out of the revenues of the said church, amounts, as last fixed, to the annual sum of one hundred and seventeen pounds, and no more; and that it is expedient that the same number of six Minor Canons should be continued

in the said church; and it has been further represented to us by the said Dean and Chapter, that they have assigned to the two junior Minor Canons, who have been appointed since the passing of the said recited Act, fixed annual stipends, as such Minor Canons, of one hundred and fifty pounds each, and that the three senior Minor Canons, although receiving, as Minor Canons, the smaller stipends aforesaid, are otherwise competently provided for; but that the Reverend Randle Jackson Waters, the fourth Minor Canon, who also receives the smaller annual stipend aforesaid, is not otherwise competently provided for;

"And whereas by and under an Order of your Majesty in Council, bearing date the third day of April last, the Deans and future Canons of the said church are charged with the payment to us of a certain portion of their respective incomes, so as to reduce the same to the average annual amounts respectively named in the same Act; and, in making such reduction, their existing incomes respectively have been estimated without accounting for any increase in the stipends of the Minor Canons of the said church:

"Now, therefore, we humbly recommend and propose, that the number of Minor Canons in the said collegiate church of Westminster shall from henceforth be and continue to be six; and that there shall be paid to each Minor Canon in the said church, appointed after the passing of the said recited Act, a fixed annual stipend, as such Minor Canon, of one hundred and fifty pounds:

... And we further and recommend and propose, that, so long as the said Randle Jackson Waters shall continue to be a Minor Canon in the same church, and shall not hold any other office therein, or any benefice, there shall be paid to him, by the Treasurer or other proper officer of the said church, in addition to his aforesaid stipend of one hundred and seventeen pounds, the annual sum of thirty-three pounds by equal half-yearly payments, and that two of such payments shall be considered to have been due and payable to him at the expiration of six calendar months from the day of the general audit of the said Dean and Chapter now last past; and that the said Treasurer or other officer shall and may, from time to time, retain, out of any monies payable to us in respect of any canonry or canonries now or hereafter suspended in the said church, such sum or sums of money as may have been so paid to the said Randle Jackson Waters, and also every such sum of money as, according to the same rate of increase of stipend, shall have been paid to each and every Minor Canon appointed after the passing of the said recited Act:

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing other measures relating to the matters to which this our scheme applies, or any of them, in conformity with the provisions of the said recited Act."

And whereas notice of the said scheme has been duly given to the Dean and Chapter of the collegiate church of Saint Peter, Westminster, pursuant to the provisions of the said Act, and no objection has been made thereto.

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of London.

*f and sole, to grant leases for long terms of "years," duly prepared and laid before Her Majesty in Council a scheme, bearing date the eighteenth day of July one thousand eight hundred and forty-three, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act " to carry into effect, with certain modifications, "the fourth report of the Commissioners of " Ecclesiastical Duties and Revenues;" and of another Act, passed in the last session of Parliament, intituled "An Act for enabling ecclesiastical " corporations, aggregate and sole, to grant leases " for long terms of years," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for determining the portion of the improved value to be made payable to us, in a mining lease about to be granted, with our consent, by the Bishop of Saint David's.

"Whereas by the said last-recited Act it is enacted, that it shall be lawful for any bishop, from time to time, with the consent in that behalf thereby required, and subject to the several provisions in the same Act contained, to grant or demise, by lease for any term, not exceeding sixty years, any mines, minerals, quarries, or beds belonging to such bishop in right of his see:

And whereas, in pursuance of the powers contained in the said recited enactment, it is proposed by the Right Reverend Counop, Bishop of Saint David's, with our consent as required by the same Act, to grant and demise by lease certain mines, with the produce thereof, belonging to the said see of Saint David's, situate within the manor, lordship, or parish of Llandewi Brefi, and the hamlets thereof, in the county of Cardigan:

"And whereas by the same Act it is further enacted, that in case of any lease of mines, minerals, quarries, or beds granted thereunder, such portion of the improved value accruing under such lease, as by the authority provided in the first recited Act shall be determined, not being more than three fourth parts, nor less than one moiety of such improved value, shall forthwith, and from time to time as the same shall accrue, be paid to us, and shall be subject to the provisions relating to monies payable to us:

"And whereas the improved value to accrue under such proposed lease, within the meaning of the same Act, will be the whole net amount of the reservation or reservations to be made in such lease, inasmuch as the same mines have not been worked for a long series of years previously to the incumbency of the said Connop, Bishop of Saint David's:

"Now, therefore, we humbly recommend andpropose, that five eighth parts of the whole netamount of the reservation or reservations to bemade in the lease so to be granted, whether consisting of rent, royalty, or otherwise, shall by such lease be made directly payable to us, and that we shall have all the like remedies of distress, and other rights and remedies in respect of such five eighth parts of any such reservation as aforesaid, as if the same were a separate rent reserved to us as lessors or grantors, and reversioners of the premises comprised in such lease, independently of the rights and remedies of the said bishop and his successors in respect of the remaining three eighth parts thereof, and without any priority preference between us and the Bishop of Saint David's for the time being; and further, that we shall have the full benefit and advantage. either jointly with or separately from the said bishop, of all or any of the covenants, conditions, . and agreements in every such lease to be contained on the lessees part, in like manner as if we had been such grantors or lessors and reversioners as aforesaid, and as in such lease shall be expressed; and that, for effectuating such objects such lease sháll and may be framed in such manner, and contain all such clauses and provisions as we shall approve, and shall have full force accordingly, any rule of law, statute, or custom to the contrary notwithstanding.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters of this scheme, or any of them, in conformity with the provisions of the said recited Acts."

And whereas notice of the said scheme has been duly given to the Right Reverend Connop, Bishop of Saint David's, pursuant to the provisions of the said Act herein first recited, and no objection like been made thereto:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Saint David's.

HEREAS the Lords of the Committee of Her Majesty's Privy Council appointed for Trade and Foreign Plantations have, in pursuance of an Act, passed in the session of Parliament held in the second and third years of the reign of Her present Majesty, intituled "An Act to carry into "effect a Convention between Her Majesty and "the King of the French, concerning the fisheries "in the seas between the British islands and "France," duly prepared and laid before Her Majesty in Council a rule, bearing date the twenty-second day of August one thousand eight hundred and forty-three, in the words and figures following, that is to say:

"We, the Lords of the Committee of Her Majesty's Privy Council, appointed for the consideration of matters relating to Trade and Foreign Plantations, humbly lay before your Majesty in Council the following rule for suspending the operation of the therein-mentioned Act and Articles of Fishery Regulation, with respect to the fisheries on the coast of Ireland (that is to say):

"Whereas by an Act, passed in the session of Parliament held in the second and third years of the reign of Her present Majesty, intituled An Act to carry into effect a convention between Her Majesty and the King of the French,

concerning the fisheries in the seas between the British islands and France,' it is, amongst other things, enacted, that it shall be lawful for the Lords of the said Committee, by a rule or rules to be made by them, from time to time, and approved of by Her Majesty, with the advice of Her Privy Council, to suspend the operation of the said Articles and of this Act, or such part of them as to them shall seem fit, with respect to the fisheries on the coast of Ireland, or on any part thereof, so long as such fisheries shall be carried on exclusively by the subjects of Her Majesty, and also, with the like approval, to make such bye laws as to them shall seem fit for enforcing the said Articles and this Act, on the said coast of Ireland, or on any part thereof, as soon as the same shall be frequented for the pur? pose of fishery by French fishermen:

"We, therefore, in pursuance of the powers of the said Act, do hereby make the following rule, subject to the approbation of Her Majesty (namely), that the said Act and Articles of Regulation shall be suspended, with respect to the fisheries on the whole of the coasts of Ireland, so long as such fisheries shall be carried on exclusively by the subjects of Her Majesty."

King George the Fourth in Council, bearing date the sixteenth day of July one thousand eight hundred and twenty-seven, His said Majesty, with the advice of His Privy Council, did declare and grant, that it should be lawful for French ships to import into the British possessions on the western coast of Africa, and into the colony of the Cape of Good Hope, and into the island of Ceylon, and into His Majesty's settlements in the island of New Holland, and into the island of Van Dieman's Land, and into the several islands and territories dependent upon and belonging to the several settlements or colonies

aforesaid, from the dominions of His Most Christian Majesty, such goods being the produce of those dominions as are mentioned and enumerated in an Order in Council, bearing date the first day of June one thousand eight hundred and twenty-six, and which is recited in the Order now in recital; and by the said Order now in recital, His said late Majesty, by the advice of His Privy Council, was pleased to declare and grant, that it should and might be lawful for ships of or belonging to any kingdom or state within the limits of the East India Company's charter, to import from the dominions to which they respectively belong, goods, the produce of such dominions, into the colony of the Cape of Good Hope, and into the island of Eeylon, and into the island of Mauritius, and into His Majesty's settlements in the island of New Holland, and in the island of Van Dieman's Land, and into the several islands and territories dependent upon and belonging to the several settlements or colonies aforesaid; and to export goods from such several settlements or colonies, or their respective dependencies, to be carried into any foreign country whatever:

And whereas by an Act, passed in the session of Parliament held in the third and fourth years of the reign of His late Majesty King William the Fourth, intituled "An Act to regulate the trade " of British possessions abroad," and which is hereinafter referred to as, the "British Possessions " Act," after reciting that, by the law of navigation, foreign ships are permitted to import into any of the British possessions abroad, from the countries to which they belong, goods, the produce of those countries, and to export goods from such possessions, to be carried into any foreign country whatever; and that it is expedient that such permission should be subject to certain conditions, It is enacted, that the privileges thereby granted to foreign ships shall be limited to ships of those countries, which, having colonial possessions, shall grant the like privileges of trading with those possessions to British ships, or which, not having colonial possessions, shall place the commerce and navigation of the country and of its possessions abroad upon the footing of the most favoured nation, unless His Majesty, by His Order in Council, shall, in any case, deem it expedient to grant the whole or any part of such privileges to the ships of any foreign country, although the con-

ditions aforesaid shall not, in all respects, be fulfilled by such foreign country:

And whereas, in the year one thousand eight hundred and forty, Her Majesty, having acquired the sovereignty of a great portion of the islands of New Zealand, was pleased to place the same under the Government of New South Wales:

And whereas, on the twentieth November one thousand eight hundred and forty, Her Majesty, in pursuance of the power in Her vested by an Act, passed in the session of Parliament held in the second and third years of Her present Majesty. intituled " An Act to continue, until the thirty-" first of December offe thousand eight hundred " and forty-one, and to the end of the then next " session of Parliament, and to extend the pro-" visions of an Act to provide for the administra-" tion of justice in New South Wales and Van " Diemen's Land, and for the more effectual go-" vernment thereof, and for other purposes relating " thereto," was pleased, by letters patent under the great seal of the United Kingdom, to erect the islands of New Zealand into a distinct and separate colony:

And whereas inasmuch as the colory of New Zealand is not expressly mentioned in the said recited Order in Council of the fifteenth July one thousand eight hundred and twenty-seven, and is not dependent or belonging to any of the settlements or colonies in the said Order and hereinbefore mentioned, doubts are entertained whether the privileges granted to French ships and to ships of India, by the said recited Order, extend to the colony of New Zealand; and Her Majesty, with the advice of Her Privy Council, doth accordingly deem it expedient to make such Order as hereinafter is expressed:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and in pursuance and exercise of the power and authority in Her vested by the said "British Possessions Act," doth declare and grant, that French ships, and ships of or belonging to any kingdom or state within the limits of the East India Company's Charter, shall have such and the like privileges of trading with the said colony of New Zealand as such ships are respectively entitled to under authority of the said recited Order, with reference to the colonies, settlements, and islands named and described on the said recited Order as hereinbefore is mentioned:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, are to give the necessary directions herein accordingly.

WHEREAS by an Act, passed in the session of Parliament held in the fifth and sixth years of the reign of Her present Majesty, intituled " An Act to amend the laws for the regulation of "the trade of the British possessions abroad," it was enacted, that there should be raised, levied, collected, and paid to Her Majesty the several duties of customs, as the same are respectively set forth in figures in the table of duties thereinafter contained, upon goods, wares, and merchandize, not being the growth, production, or manufacture of the United Kingdom, or of any of the British possessions in America, or of the Mauritius, or of any of the British possessions within the limits of the East India Company's charter, or the produce of any of the British fisheries imported or brought into any of the British possessions in America, or the Mauritius, by sea or inland carriage or navigation; and whereas divers articles are enumerated in the said table of duties, and certain duties therein mentioned are therein made payable upon such articles respectively; and the duty of four per centum ad valorem is made payable on articles not enumerated, except such as are comprized or referred to in the table of exemptions subjoined to the said table of duties; and whereas it is also enacted by the said Act now in recital, that it shall and may be lawful for Her Majesty, by and with the advice of Her Privy Council, by any Order or Orders in Council to be issued from time to time; to direct that any article described in such Order, being an article chargeable under this Act as an enumerated article, with a duty of four per centum ad valorem, shall be added to the list of exemptions thereinbefore set forth, and shall be free from such duty, and from and after the time mentioned in such Orders for the commencement of such exemptions, not being less than six months from the date thereof, such exemption shall take effect, and such article shall thenceforth, while such Order shall continue in force, be free from such duty accordingly; and any such Order may at any time be suspended or revoked by Her Majesty, with the advice of Her Privy Council, by any other Order in Council:

And whereas specimens, illustrative of natural history, are not enumerated in the said table of duties, neither are they comprized or referred to in the said table of exemptions; and whereas Her Majesty, with the advice of Her Privy Council, hath thought fit, for the encouragement of the study of natural history, that specimens, illustrative of natural history, should be exempted from the duties imposed by the said recited Act:

Now, therefore, under and by virtue of the said Act of Parliament, and in exercise of the powers thereby in Her Majesty in Council in that behalf vested, Her Majesty, by and with the advice of Her Privy Council, doth order, and it is hereby ordered accordingly, that specimens, illustrative of natural history, being articles chargeable under the said Act with a duty of four per centum ad valorem, shall be, and the same are hereby, added to the list of exemptions in the said recited Act set forth; and that, from and after the first day of February one thousand eight hundred and fortyfour, the said articles shall be free from such duty, as fully and effectually as if such articles had been inserted and enumerated in the said table at the time of passing the said Act:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, are to give the necessary directions herein accordingly.

The QUEEN's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the session of Parliament held in the third and fourth years of the reign of His late Majesty King William the Fourth, intituled "An Act to regus"

" late the trade of the British possessions abroad," after reciting that, by the law of navigation, foreign ships are permitted to import into any of the British possessions abroad, from the countries to which they belong, goods, the produce of those countries, and to export goods from such possessions, to be carried to any foreign country whatever; and that it is expedient that such permission should be subject to certain conditions, it is cnacted, that the privileges thereby granted to foreign ships shall be limited to the ships of those countries which, having colonial possessions, shall grant the like privileges of trading with those possessions to British ships, or which, not having colonial possessions, shall place the commerce and navigation of this country, and of its possessions abroad, upon the footing of the most favoured nation, unless His Majesty, by His Order in Council, shall in any case deem it expedient to grant the whole or any part of such privileges to the ships of any foreign country, although the conditions aforesaid shall not, in all respects, be fulfilled by such foreign country:

And whereas Her Majesty, by and with the advice of Her Privy Council, doth deem it expedient to grant the aforesaid privileges of trading with the British possessions abroad to the ships of the Republic of Hayti:

Now, therefore, Her Majesty doth, by the advice aforesaid, and in pursuance and exercise of the power and authority in Her respectively vested by the said recited Act, order, declare, and grant, that, from the date hereof, and, in the mean time, until Her Majesty in Council shall be pleased to revoke or determine this Order by any other Order in Council, it shall be lawful for vessels to import, from the territories of the Republic of Hayti, into any of the British possessions abroad, goods, the produce of the said territories of the Republic of Hayti, and to export goods, from such possessions, to be carried into any foreign country whatever:

Provided always, that nothing herein contained shall be construed to prevent the vessels of the Republic of Hayti from trading with any of the British possessions in Europe, to such extent and in such manner as they lawfully may under the laws of navigation now in force:

Provided further, that nothing hereinbefore contained shall extend or apply to the possessions of the East India Company:

Provided always, that the privileges hereby granted shall be confined to vessels of the Republic of Hayti, built, owned, and navigated as required by the British laws of navigation for the time being in force:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, one of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein accordingly.

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years

of the reign of His late Majesty King William the Fourth, intituled " An Act for carrying into " effect the reports of the Commissioners ap-" pointed to consider the state of the Established " Church in England and Wales, with reference " to ecclesiastical duties and revenues, so far as " they relate to episcopal dioceses, revenues, and " patronage;" and of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled " An Act to carry into effect, with certain " modifications, the fourth report of the Commis-" sioners of Ecclesiastical Duties and Revenues;' and of another Act, passed in the last session of Parliament, intituled "An Act to alter and " amend the law relating to ecclesiastical houses " of residence," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for improving the demesne lands belonging to the see of Bangor.

"Whereas by the secondly recited Act it is enacted, that, by the authority therein provided, and for the purpose of fully carrying into effect any of the provisions of the same Act, any arrangement may, from time to time, be made, with the consent in writing, under the corporate seal of any bishop, for the sale, transfer, or exchange of any lands, tithes, or other hereditaments belonging to the see of such bishop, or for the purchase of other lands, tithes, or other hereditaments in lieu thereof:

And whereas by the thirdly-recited Act it is enacted, that, whenever it shall appear to be expedient to improve any episcopal house of residence, or the demesnes thereof, it shall be lawful, by the authority in the said first-recited Act provided, with the consent under the hand and episcopal seal of the bishop, to make such arrangements as may by such authority be deemed most expedient for improving any episcopal house of residence, or for improving the demesnes adjoining to any such house, by the purchase of any land, tenement, or hereditament in the immediate neighbourhood, or within the view thereof:

"And whereas by the said thirdly-recited Act it is further enacted, that the provisions of the said secondly-recited Act, relating to the sale, transfer, or exchange of any lands or other hereditaments belonging to any bishop, shall extend and may be

applied to any of the purposes of the now reciting Act:
