THE following is a copy of an Order of Her Majesty in Council, assigning a consolidated district to the chapel, at Hoddesdon, taken from contiguous parts of the respective parishes of Broxbourne and Great Amwell, in the county of Hertford, under the 6th section of the 59th Geo. 3., cap. 134:

At the Court at Windsor, the 10th of November 1843, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fiftyeighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things,

enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments which will by such division arise and accrue, and remain and be, within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and it is by the 21st section of the said Act further enacted, "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such

complete, separate, and distinct parishes as afore- person shall thenceforth belong to such person or said, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the bishop, signified under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:"

And whereas by an Act, passed in the fiftyninth year of His late Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," reciting that a considerable population is frequently collected together at the extremities of, and locally situate in, parishes or extra-parochial places contiguous to each other, at a distance from the respective churches or chanels of such respective parishes or extra-parochial places, it is, amongst other things, enacted, that it shall be lawful for the said Commissioners, with such consent as is required by the said recited Act in the case of district parishes, to unite and consolidate any such contiguous parts of such parishes and extra-parochial places into a separate and distinct district for all ecclesiastical purposes, and to cause such district to be named, ascertained, and marked out by described bounds, and such name, and the description of such bounds, when approved by His Majesty in Council, to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese to which such district shall belong, under the provisions of this Act; and to make grants or loans for or towards the building of, or to build, any chapel or chapels, with or without cemeteries, in and for the use of the inhabitants of any such district, in such manner, and under such regulations as may, in the judgment of the Commissioners, appear from the circumstances to be most expedient, and to constitute any such district a consolidated chapelry; and every such chapelry shall be under the superintendance of such spiritual person as shall be appointed under the provisions of this Act to serve any such chapel, and such spiritual person shall have cure of souls in such district; and the right of presentation and appointment of such spiritual

persons, and be exercised in such manner as may be agreed by the several patrons of the churches or chapels of such parishes and extra-parochial places respectively, with the approbation of the Commissioners; and banns of marriage may be published, and marriages, christenings, churchings, and burials may be solemnized and performed in any such chapel, immediately and at all times after the consecration thereof, and the pew rents in such chapel shall be fixed, and salaries to the minister and clerk assigned therefrom, in such manner as is directed in the said recited Act, or in this Act, concerning pew rents and salaries in separate or district parishes; and all fees and offerings which may arise and accrue within such chapelry, according to such table of fees as the Commissioners shall make, with the approbation of the bishop, may be demanded, received, sued for, prosecuted, and recovered by the spiritual person having cure of souls therein, and by the clerk and sexton of such chapelries, in like manner as if every such chapelry was a distinct parish; and it shall be lawful for the said Commissioners, and they are hereby required in every such case, to ascertain and make compensation, in manner directed in like cases under the said recited Act, for any loss which may be sustained by the incumbent of any contiguous parish or extra-parochial place, which shall form part of any such district, by reason of any fees, oblations, and offerings being transferred to the spiritual person serving any such chapel; and all such chapelries shall be deemed to be benefices, and be subject to the jurisdiction of the bishop and archdeacon within whose diocese and archdeaconry the altar of such chapel shall be locally situate, and to all the laws in force concerning presentation and appointment to benefices and churches, and lapse, and all other laws relating to the holding of benefices and churches: and whereas it is further enacted, " that it shall be lawful for the Commissioners, in the same manner and with the like consents as are required in case of division into ecclesiastical districts under the said recited Act, or this Act, to assign a particular district to any chapel of ease or parochial chapel already existing, or to any chapel built, or which may hereafter be built or acquired under the powers of the said Act, or this Act; and such district shall be under the immediate care of the curate appointed to serve such chapel, but subject, nevertheless, to the superintendence and controul of the incumbent of the parish church; and all such curates shall be nominated by the incumbent of the parish to the bishop for his licence, except where the right of nomination shall already be legally vested in any other person or persons, and in every such case by the person or persons possessing such right of nomination, subject to all the laws in force relating to stipendiary curates, except as to the assigning of salaries to such curates; provided always, that it shall be lawful for the Commissioners, with the consent of the bishop of the diocese, to determine whether any and what part or proportion of the fees or dues for marriages, baptisms, churchings, and burials shall be assigned to any such curate; and whether banns of hundred and eighty-six persons; the adjoining marriage shall be published, and marriages or bap- parish of Great Amwell, in the same county and marriage shall be published, and marriages or baptisms, churchings or burials, shall be solemnized or performed in any such chapel or not; and in any case in which marriages shall be allowed in any such chapel, the Commissioners shall cause the boundaries of the district assigned to such chapel to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese, any thing in the said recited Act to the contrary notwithstanding; and no such chapelry shall become a benefice by reason of any augmentation of the maintenance of the curate, by any grant or bounty under the provision of any Act or Acts of Parliament, or law or laws, for augmenting small livings, any thing in such Act or Acts of Parliament, or law or laws, to the contrary notwithstanding:"

And whereas by another Act, passed in the seventh and eighth years of the reign of His late Majesty King George the Fourth, intituled "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and by another Act, made and passed in the first and second years of His late Majesty King William the Fourth, intituled "An Act to amend and render more effectual an Act, passed in the seventh and eighth years of the reign of His late Majesty, intituled 'An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and ditional churches in populous parishes;" and also by another Act, made and passed in the second and third years of His said late Majesty, intituled "An Act to render more effectual an Act, passed in the fifty-ninth year of His late Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" further provisions are made for carrying such divisions into

And whereas the said Commissioners have made a representation to Her Majesty in Council, bearing date the twenty-first day of October one thousand eight hundred and forty-three, in the words following, viz.

" Your Majesty's Commissioners for building new churches, appointed by virtue of an Act, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes;" continued by an Act, passed in the seventh and eighth years of the reign of His Majesty King George the Fourth, intituled "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and further continued by an Act, passed in the first year of your Majesty's reign, intituled "An Act to prolong, for ten years, Her Majesty's Commission for building new churches;" beg leave humbly to represent to your Majesty, that, when the last census was taken, the parish of Broxbourne, in the county of Hertford and diocese of London, hamlet of Hoddesdon, and certain detached per-contained a population of two thousand three tions of the parish of Great Amwell, with boundary

diocese, contained a population of one thousand five hundred and forty-five persons; and the hamlet of Hoddesdon, in the said parish of Broxbourne, contained a population of one thousand seven hundred and forty-one persons; and that part of the said parish of Great Amwell, which is surrounded by the said hamlet of Hoddesdon, contained a population of four hundred and twenty persons; that the parish church of Broxbourne affords accommodation to about one thousand persons; and the parish church of Great Amwell to about three hundred and fifty persons; that there is a consecrated chapel, at Hoddesdon, on the confines of the said two parishes of Broxbourne and Great Amwell, the altar of the said chapel being within the said parish of Great Amwell, which affords accommodation to six hundred and thirty-six persons, including four hundred and twenty-four free seats appropriated to the use of the poor:

" That the said chapel, at Hoddesdon, is distant from the parish church of Broxbourne about one mile and a half, and from the parish church of Great Amwell two miles and a quarter, which are the places nearest to the said chapel appropriated to the celebration of divine service according to the rites of the Church of England:

"That the extremities of the said parishes of Broxbourne and Great Amwell which lie contiguous to each other at Hoddesdon, and are delineated in the accompanying plan, contain a population of two thousand and six persons:

" Your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances above mentioned, it appears to them to be expedient to unite and consolidate the northernmost part of the said hamlet of Heddesdon and those detached parts of the parish of Great Amwell which are surrounded by the said hamlet of Hoddesdon, and form a separate and distinct district, to be assigned to the said chapel at Hoddesdon, for all ecclesiastical purposes, and to constitute such district a consolidated chapelry, under the sixth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," for the purpose of affording accommodation for attending divine service to the persons residing in the said district, and for enabling the spiritual person serving such chapel to perform all ecclesiastical duties within the said district attached to such chapel, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the moral habits of the persons residing therein; and that such district should be named, "The Consolidated Chapelry District of Hoddesdon," and consist of the northernmost portion of the ries as follows (that is to say), on the east by the parishes of Nazing, Royden, and Stanstead; on the north by the parish of Amwell; on the west by the parish of Saint John, Hertford; and on the south by the remaining part of the hamlet of Hoddesdon, from which it is separated by proceeding along Spital-brook in an easterly direction as far as Short-mead; it then turns in a northerly direction up the hedge separating Short-mead from Longmead, to the south west corner of Lowfield-common, and proceeds along the south boundary of the said common, in an easterly direction, to the corner of the wall of a garden and house belonging to Mr. Hugh Hughes, and, taking the south side thereof, enters the High-street, down the middle of which it proceeds, in a southerly direction, as far as the southern end of Newport Charity; it then proceeds in an easterly direction to the back wall of the premises, and then takes a northerly direction to the fence separating the property of Miss Ann Warmsley from the properties of Mr. Caius Chaffins and Mr. John Warner, along which fence it proceeds in an easterly direction, crossing the New River, to the ditch separating the property of Mr. J. P. Manser from the Town-marsh; it then proceeds up the ditch in a north easterly direction to the pond at the top of the marsh, and following the foot path and south side of the pond, in an easterly direction, to the houses between the ponds, enters Lynch Mill-stream, and following the course thereof, in a southerly direction, till it meets the boundary of the parish of Nazing, opposite to Calais-point, where the boundary commenced, as is shewn on the map hereunto annexed, and thereon coloured pink and green:

"That the consent of the Lord Bishop of London has been obtained thereto, as required by the above-mentioned section of the said Act of the fifty-ninth year of the reign of His Majesty King George the Third; and, in testimony of such his approbation, the said Lord Bishop of London

hath signed and sealed this instrument:

"Your Majesty's said Commissioners beg leave, therefore, to lay before your Majesty the above-stated circumstances, and humbly to pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty's royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed consolidation and assignment be accordingly made and carried into effect, agreeably to the provisions of the said Acts.

Bye Laws, pursuant to the Act, sixth and seventh Victoria, cap. 101, for the Registration and Regulation of the Coal Whippers in the Port of London.

from Wednesday the 3d January 1844, to Saturday the 13th, both days inclusive (Sunday excepted), and after that day from twelve at noon until two o'clock in the afternoon (Sundays excepted), for the purpose of registering, under the provisions of the Act, all such able bodied male persons as shall be desirous of following, or continuing to follow, the employment of a coal whipper, and shall make application to be so registered; when every such applicant shall be required to state his name, place of abode, age, present or late occupation, single or married, if able to read and write, if a basket man, and how long he has been so; all which shall be entered in the register against the number in the order of application, which being done, and upon the payment of four pence, the Registrar shall then deliver to the applicant a certificate, according to the terms of the Coal Whippers' Act.

2. At the expiration of the period, first beforementioned, a selection shall be made of one ninth from the whole of the men registered as coal whippers, who shall appear to the Commissioners the most eligible and best conducted, who shall be appointed foremen, and for the purposes of the Act shall be, and be called, "Basket Men."

3. Each basket man shall give security to the Commissioners for the amount of ten pounds, by approved sureties, for his faithfully accounting and duly paying over to the Registrar all monies which he shall receive, as the person authorized to collect the same, on account of the Commissioners, under

the provisions of the Act.

- 4. The basket man shall sign a contract upon undertaking a job, on the part of himself and men appointed under him (which shall be binding upon them), for the due performance of the engagement then entered into; and when not employed shall attend at the office with his gang, at such hours as shall be directed by the Registrar for giving out orders; he shall be accountable, as far as is practicable, for the orderly conduct of his gang, and shall report all acts of drunkenness or insubordination of the men, during the hours of labour, to the Registrar, who shall have the power of suspension until the next meeting of the Commissioners.
- 5. The basket man shall use his best endeavours to expedite business, and on the completion of the job shall receive from the master or other person in charge of the ship all monies due for labour performed, baulk days, and for hire of tackle, and shall give a receipt for the same on account of the Commissioners, and shall forthwith pay the amount over to the Registrar (to be disposed of according to the provisions of the Act), together with a certificate, which he shall require the master or other person in charge of the ship to sign, detailing the name of the ship, the name of the master, the quantity of coals which have been worked by himself and gang in the job just completed, the amount of money received by him, specifying, under different heads, the proportion for labour, baulk days, and for hire of tackle, for which he shall be entitled to receive, and the Registrar is hereby directed to pay him, out of the funds of the office, a commission, after the rate of

one penny in the pound, for his own use, over and above any share that he may be otherwise entitled

6. On the completion of each job, the basket man shall enter his name, on behalf of himself and gang, in a rotation book, which shall entitle them to the offer of another job in due course of rotation, upon the terms and according to the provisions of the Act.

7. The Commissioners, as they shall deem it expedient, shall, from time to time, appoint, out of the registered men, such other men of good character as they may consider most eligible to fill the

office of basket man.

8. A numerical and alphabetical list shall be made of practised coal whippers registered; one class under the age of thirty years; another between the ages of thirty and forty; and another of forty and upwards; and similar lists of other registered men, not being practised coal whippers; and with the view to equalize the labour, and to appoint the most efficient men for expediting the work to be performed under the provisions of the Act, and to complete the gang under each basket man, there shall be added, by lot, eight other men, consisting of a due proportion from each of the above classes of coal whippers.

9. In case there shall be any practised coal whippers registered, who remain unappointed to gangs as above mentioned, they shall be called Supernumeraries, and shall, in the numerical order in which they are registered, be appointed to fill up vacancies as they occur in the regular gangs by

death or otherwise.

10. In order to keep up a succession of efficient coal whippers, all casual absence, by illness or otherwise, of the men from their gangs, when required to labour (which cannot be supplied from the supernumerary list), shall be provided for in the following manner, viz. for every absent coal whipper, two registered men, not being practised coal whippers, shall be appointed to act in lieu of such absent coal whipper, and they shall divide the earnings that would have been receivable by the absent coal whipper, between them, in equal shares, the said two men shall be the two first men who shall answer to their names on being called according to their numerical order of entry on the registration; but in all cases, when there shall not be two such men in attendance when called, then the temporary or casual vacancy shall be filled up by an unemployed practised coal whipper; and when each of such men, not being practised coal whippers, shall have been appointed, in manner before mentioned, to labour, twenty days in the whole, he shall be deemed qualified as a coal whipper, and be added to the list of supernumeraries, in regular order, as though he had been registered as a practised coal whipper, and was unappointed to a gang, as before mentioned, and shall take his turn for regular appointment accordingly.

11. All persons registered under the Act, who when required to attend shall fail to answer when called for five successive occasions, shall cease to

name, at the expiration of fourteen days afterwards, shall be removed from the register, and he shall not again be permitted to register till after the expiration of three months; but in every case, where it shall be satisfactorily shown to the Registrar that a man's absence was caused by illness, he shall not be deprived of his privilege; and for the better regulating this office, and for improving the condition of the men employed under the provisions of the Act, the Commissioners will, on proof being given of any misconduct or insubordination, visit the offenders with the punishment of suspension or expulsion from the registry, or otherwise, under the provisions of the Act, as they

12. Cargoes, or parts of cargoes, as the case may be, shall be worked after the rate of not less than forty-nine tons per day (according to the existing practice of the coal trade), unless any special written application and agreement shall be made to the contrary. And in case one or more baulk days shall occur from any cause other than the default of the coal whippers, according to the contract written or implied, as the case may be, the master or other person in charge of the ship shall pay, in addition to the charge for labour performed for each baulk day, a sum equal to the amount which the coal whippers would have earned if the work had been regularly performed according to the contract written or implied as above.

Provided always, that when the Commissioners are satisfied that the regular discharge of colliers is prevented by the accumulation of ice, or other extraordinary cause, and signify the same by notice by placards publicly exhibited at their office, and on the coal market, the charge for baulk days shall be suspended from the date specified in such notice, until the Commissioners shall give a similar notice to the contrary.

13. In order to prevent the detention of vessels when the discharge of their cargo is completed, and to provide against delay in the payment of wages and settlement of demands, the Commissioners direct, that in all cases where the master or other person in charge of the ship shall dispute the claim made upon him for baulk days, on the ground that one or more of the baulk days occurred through the default of the coal whippers, he shall forthwith deposit, or cause to be deposited, the amount in dispute with the Registrar, at the office, with a notice in writing, stating his objection, and the amount so deposited shall not be paid to the coal whippers until after the expiration of thirty days; and, if within that time the objection shall be established to the satisfaction of the Commissioners, the amount shall be repaid to the master or other person by whom the same was deposited, or to his agent.

And in case any master or other person in charge of the ship shall, on being required to do so, neglect or refuse, immediately after the discharge of the cargo or part of cargo by the coal whippers, sent from the Coal Whippers' Office, shall be finished, to pay the full amount due for wages and hire of tackle, if any, or to pay or deposit with the be entitled to the privilege of registration, and his Registrar the amount claimed for baulk days, or if any such master or other person shall in any other way attempt to evade or obstruct the operation of the Act, he shall forfeit for every such offence a penalty not exceeding five pounds.

14. That the deduction to be made out of the wages for the purposes of the Act shall be at the

rate of one farthing in each shilling.

15. When tackle shall be required from the Coal Whippers' Office for the delivery of coals, the master or other person in charge of the ship shall pay, on the discharge of the cargo, or upon such part thereof as shall be delivered by the tackle so required, for the use or hire thereof, the sum of seven shillings and six pence upon every vessel of two hundred and fifty tons burthen, or upwards, and five shillings upon every vessel of less buthen than two hundred and fifty tons.

16. For the purposes of the Coal Whippers' Act, the port of London shall be considered to extend from the ferry known as Regent's-ferry, in Woolwich-reach, to London-bridge, and to include all rivers, docks, and canals communicating therewith, which are comprised within the said port of London. — Guildhall, London, 30th December C. NOTICE TO MARINERS.

SKERRYVORE LIGHTHOUSE.

Edinburgh, December 23, 1843.

THE Commissioners of the Northern Lighthouses hereby give potice hereby give notice, that a lighthouse has been erected upon the Skerryvore Rock, which lies off the island of Tyree, in the county of Argyle, the light of which will be exhibited on the night of the 1st February 1844, and every night thereafter, from sun-set to sun-rise.

The following is a Specification of the Position of the Lighthouse, and the Appearance of the Light, by Mr. Alan Stevenson, Engineer to the Commissioners:

The Skerryvore Rock lies off the island of Tyree, in lat. 56° 19' 22" N. long. 7° 6' 32" W.

By compass, the lighthouse bears from Barrahead Lighthouse, S. & E. distant 33 nautic miles; from Hynish Point, in Tyree, W. S. W. & W. distant 10\frac{1}{3} miles; from Iona Island, W. N. W. \frac{3}{4} N. distant 20 miles; from Rhinns of Islay Lighthouse, N. ½ E. distant 44 miles; and from Innistrabull Lighthouse, in Ireland, N. E. by N. distant 53½ miles.

Owing to the distance to which the foul ground extends on every side of the rock on which the lighthouse is placed, and the weight of sea which breaks on the shallow ground all round it, it is necessary to give the light a wide berth. better to enable seamen to judge of this, their attention is called to a chart, prefixed to a separately printed notice, which exhibits the relative position of the Skerryvore Rock, and the various dangers around it. In particular, it is necessary to notice the position of those rocks which lie seaward of the lighthouse, viz. Mackenzie's Rock, about 3 miles

W. by S. & S. from the lighthouse; Stevenson's,

 $2\frac{1}{4}$ miles W. $\frac{1}{2}$ N.; and Fresnel's, which lies between these two rocks. Copies of the notice, with the chart prefixed, will be extensively circulated to all the Custom-houses of the United Kingdom, and will be seen by any mariner on application.

The Skerryvore Light will be known to mariners as a revolving light, producing a bright flash once The lantern, which is open all every minute. round, is elevated 150 feet above the level of the sea. In clear weather, the flashes of the light will be seen at the distance of six leagues, and at lesser distances, according to the state of the atmosphere; and to a near observer, in favourable circumstances, the light will not wholly disappear between the flashes.
