AT the Court at *Windsor*, the 13th day of *December* 1843,

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fourth year of the reign of His late Majesty King George the Fourth, cap. 77, intituled "An Act to authorize His Majesty, under certain circumstances, to regulate the duties and drawbacks on goods imported or exported in foreign vessels, and to exempt certain foreign vessels from pilotage," it was, amongst other things, enacted, that it should be lawful for His Majesty, by and with the advice of His Privy Council, or by any Order or Orders in Council, in all cases in which British vessels, of less burthen than sixty tons, are not required by law to take pilots, to exempt foreign vessels, being of less burthen than sixty tons, from taking on board a pilot to conduct them into or from any of the ports of the United Kingdom, any law, custom, or usage to the contrary notwithstanding:

"And whereas His said late Majesty King George the Fourth in Council did, by six several Orders, respectively bearing date the twenty-first July one thousand eight hundred and twenty-three, the eighteenth November one thousand eight hundred and twenty-three, the tenth March one thousand eight hundred and twenty-four, the tenth March one thousand eight hundred and twenty-four, the twenty-fifth May one thousand eight hundred and twenty-four, and the nineteenth October one thousand eight hundred and twenty-four, issued in pursuance of the said recited Act, grant the exemption, by the said Act authorized to be granted as hereinbefore is mentioned, to vessels of less burthen than sixty tons, belonging to the following countries and places (that is to say),

The Netherlands,
Hanover,
Denmark,
Hamburgh,
Lubeck, and
Bremen:

And whereas by an Act of Parliament, passed in the sixth year of the reign of His said late Majesty King George the Fourth, intituled "An Act for the amendment of the law respecting pilots and pilotage, and also for the better preservation of floating lights, buoys, and beacons," it is enacted, that the several Acts therein recited, and all and every the clauses, provisions, powers, penalties, forfeitures, matters, and things relating as well to pilots appointed by the Corporation of the Trinity-house of Deptford Strond, as to pilots of the Fellowship of Dover, Deal, or the isle of Thanet, aid to the pilotage by, and regulation of, all such pilots as aforesaid, and also as to the conduct of all persons in matters of pilotage within the jurisdiction of the said Corporation of the Trinity-house of Deptford Strond, and the liberty of the Cinque Ports, which are contained in any Act or Acts of Parliament theretofore made, shall be and the same are thereby repealed:

And by the said Act now in recital it is enacted, that the master of any ship or vessel, not exceeding the burthen of sixty tons, and having a British register, may lawfully pilot his own ship, so long as he shall pilot the same without the aid of any unlicensed pilot, or other persons than the ordinary crew of the ship:

And by the said Act now in recital it is also enacted, that, after the passing thereof, it shall be lawful for His Majesty, by any Order in Council, to permit and authorize ships and vessels, not exceeding the burthen of sixty tons, and not having a British register, to be piloted and conducted

without having a duly licenced pilot on board, upon the same terms and conditions as are, by the said Act, imposed on British ships and vessels not exceeding the like burthen :

And by the said Act now in recital it is likewise enacted, that nothing therein contained shall extend to the taking away, abridging, defeating, or interrupting of any grants, liberties, franchises, or privileges heretofore granted by any charters or Acts of Parliament to the pilots of the Trinity-house of the town of Kingston-upon-Hull, or the Trinity-house of Newcastle-upon-Tyne, or to alter or repeal any provisions contained in any Act of Parliament relating to the pilots of any ports or districts in relation to which particular provision shall have been made in any Act of Parliament as to the pilots or pilotage, or to the pilotage within the limits prescribed by any Act of Parliament relating to pilotage for such ports, or to the burthen of vessels navigating to or from such ports :

And whereas Her Majesty is desirous of confirming the exemption so granted as aforesaid to the vessels of the countries and places heretofore mentioned, and of placing such vessels as are hereinafter described, being under sixty tons burthen, upon the same footing, with regard to exemption from pilotage, as vessels of like burthen having a British register, and for that purpose to exercise the powers so vested in Her as hereinbefore is mentioned, in manner hereinafter expressed :

Now, therefore, Her Majesty, by virtue and in exercise of the powers vested in Her by the said recited Acts respectively, and of every other power authorizing Her Majesty in that behalf, and by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that from and after the date of this Order, as respects the ports and places following, namely,

The port of Kingston-upon-Hull,

The port of Newcastle-upon-Tyne, and the ports or places being members thereof, respectively, and all other ports and places in respect of which the power vested in Her Majesty by virtue of the said recited Act, of the fourth year of the reign of His said late Majesty King George the Fourth, is still subsisting, all such vessels as are described in the schedule to this Order annexed, being of less burthen than sixty tons, which shall enter into or clear out from any of the said ports or places, shall be, and they are hereby, exempted from taking on board a pilot to conduct them into or from any such port or place, in all cases where British vessels, being of less burthen than sixty tons, are not required by law to take pilots, any law, custom, or usage to the contrary notwithstanding :

And it is hereby further ordered, that from and after the date of this Order, respects all other ports and places in the United Kingdom, all such vessels as are described in the schedule to this Order annexed, being of less burthen than sixty tons, which shall enter and clear out of any of such ports and places, shall be, and they are hereby, authorized and permitted to be piloted and con-

ducted without having a duly licenced pilot on board, upon the same terms and conditions as by the said recited Act, of the sixth year of the reign of His said late Majesty King George the Fourth, are required upon British ships and vessels not exceeding the like burthen :

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions accordingly.

THE following is a copy of an Order of Her Majesty in Council, assigning a consolidated chapelry district, under the 6th section of the 59th Geo. 3., cap. 134, to St. Thomas's Church, at Mow Cop, in the parish of Wolstanton, in the county of Stafford, formed from contiguous parts of that and the adjoining parish of Biddulph, in the same county :

At the Court at Windsor, the 2d of October 1843, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fifty-eighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal ; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments which will by such division arise and accrue, and remain and be, within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions ; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division ; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided ;" and it is by the 21st section of the said Act further enacted, "that in any case, in which the said Commissioners shall be

of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the bishop, signified under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described ; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division."

And whereas by an Act, passed in the fifty-ninth year of His late Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," reciting that a considerable population is frequently collected together at the extremities of, and locally situate in, parishes or extra-parochial places contiguous to each other, at a distance from the respective churches or chapels of such respective parishes or extra-parochial places, it is, amongst other things, enacted, that it shall be lawful for the said Commissioners, with such consent as is required by the said recited Act in the case of district parishes, to unite and consolidate any such contiguous parts of such parishes and extra-parochial places into a separate and distinct district for all ecclesiastical purposes, and to cause such district to be named ascertained, and marked out by described bounds, and such name, and the description of such bounds, when approved by His Majesty in Council, to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese to which such district shall belong, under the provisions of this Act ; and to make grants or loans for or towards the building of, or to build, any chapel or chapels, with or without cemeteries, in and for the use of the inhabitants of any such district, in such manner, and under such regulations as may, in the judgment of the Commissioners, appear from the circumstances to be most expedient, and to constitute any such district a consolidated chapelry ; and every such chapelry shall be under the superintendence of such spiritual person as shall be appointed under the provisions of this Act to serve any such chapel, and such spiritual person shall

have cure of souls in such district ; and the right of presentation and appointment of such spiritual person shall thenceforth belong to such person or persons, and be exercised in such manner as may be agreed by the several patrons of the churches or chapels of such parishes and extra-parochial places respectively, with the approbation of the Commissioners ; and banns of marriage may be published, and marriages, christenings, churchings, and burials may be solemnized and performed in any such chapel, immediately and at all times after the consecration thereof, and the pew rents in such chapel shall be fixed, and salaries to the minister and clerk assigned therefrom, in such manner as is directed in the said recited Act, or in this Act, concerning pew rents and salaries in separate or district parishes ; and all fees and offerings which may arise and accrue within such chapelry, according to such table of fees as the Commissioners shall make, with the approbation of the bishop, may be demanded, received, sued for, prosecuted, and recovered by the spiritual person having cure of souls therein, and by the clerk and sexton of such chapelries, in like manner as if every such chapelry was a distinct parish ; and it shall be lawful for the said Commissioners, and they are hereby required in every such case, to ascertain and make compensation, in manner directed in like cases under the said recited Act, for any loss which may be sustained by the incumbent of any contiguous parish or extra-parochial place, which shall form part of any such district, by reason of any fees, oblations, and offerings being transferred to the spiritual person serving any such chapel ; and all such chapelries shall be deemed to be benefices, and be subject to the jurisdiction of the bishop and archdeacon within whose diocese and archdeaconry the altar of such chapel shall be locally situate, and to all the laws in force concerning presentation and appointment to benefices and churches, and lapse, and all other laws relating to the holding of benefices and churches : and it is by the said Act further enacted, “ that it shall be lawful for the Commissioners, in the same manner and with the like consents as are required in case of division into ecclesiastical districts under the said recited Act, or this Act, to assign a particular district to any chapel of ease or parochial chapel already existing, or to any chapel built, or which may hereafter be built or acquired under the powers of the said Act, or this Act ; and such district shall be under the immediate care of the curate appointed to serve such chapel, but subject, nevertheless, to the superintendence and controul of the incumbent of the parish church ; and all such curates shall be nominated by the incumbent of the parish to the bishop for his licence, except where the right of nomination shall already be legally vested in any other person or persons, and in every such case by the person or persons possessing such right of nomination, subject to all the laws in force relating to stipendiary curates, except as to the assigning of salaries to such curates ; provided always, that it shall be lawful for the Commissioners, with the consent of the bishop of the diocese, to determine whether any and what

part or proportion of the fees or dues for marriages, baptisms, churchings, and burials shall be assigned to any such curate ; and whether banns of marriage shall be published, and marriages or baptisms, churchings or burials, shall be solemnized or performed in any such chapel or not ; and in any case in which marriages shall be allowed in any such chapel, the Commissioners shall cause the boundaries of the district assigned to such chapel to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese, any thing in the said recited Act to the contrary notwithstanding ; and no such chapelry shall become a benefice by reason of any augmentation of the maintenance of the curate, by any grant or bounty under the provision of any Act or Acts of Parliament, or law or laws, for augmenting small livings, any thing in such Act or Acts of Parliament, or law or laws, to the contrary notwithstanding : ”

And whereas by another Act, passed in the seventh and eighth years of the reign of His late Majesty King George the Fourth, intituled “ An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes ; ” and by another Act, made and passed in the first and second years of His late Majesty King William the Fourth, intituled “ An Act to amend and render more effectual an Act, passed in the seventh and eighth years of the reign of His late Majesty, intituled ‘ An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes ; ’ ” and also by another Act, made and passed in the second and third years of His said late Majesty, intituled “ An Act to render more effectual an Act, passed in the fifty-ninth year of His late Majesty King George the Third, intituled ‘ An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes ; ’ ” further provisions are made for carrying such divisions into effect :

And whereas the said Commissioners have made a representation to Her Majesty in Council, bearing date the first day of September one thousand eight hundred and forty-three, in the words following, viz.

“ Your Majesty’s Commissioners for building new churches, appointed by virtue of an Act, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled “ An Act for building, and promoting the building, of additional churches in populous parishes ; ” continued by an Act, passed in the seventh and eighth years of the reign of His Majesty King George the Fourth, intituled “ An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes ; ” and further continued by an Act, passed in the first year of your Majesty’s reign, intituled “ An Act to prolong, for ten years, Her Majesty’s Commission for building new churches ; ” beg leave humbly to represent to your Majesty, that, when the last census was taken, the parish of Wolstanton, in

the county of Stafford and diocese of Lichfield (exclusive of the district parish of Tunstall), contained a population of seven thousand one hundred and eighty-seven persons; and the parish of Biddulph, in the same county and diocese, contained a population of two thousand two hundred persons:

"That, besides the parish church of Wolstanton, which affords accommodation to five hundred persons, there are two consecrated chapels in the said parish, one of which is situate at Mow Cop, built partly by a grant in aid from your Majesty's said Commissioners, and called St. Thomas's, affords accommodation to five hundred and twelve persons, including three hundred and twenty-seven free seats appropriated to the use of the poor; and the parish church of Biddulph affords accommodation to six hundred and fifty persons:

"That the said chapel of St. Thomas is distant six miles from the parish church of Wolstanton, two miles from that of Biddulph, and two miles from the chapel called New Chapel, in the said parish of Wolstanton:

"That the extremities of the said parishes of Wolstanton and Biddulph, which lie contiguous to each other, and are delineated in the accompanying plan, contain an estimated population of one thousand four hundred persons:

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances above mentioned, it appears to them to be expedient to unite and consolidate the said contiguous parts of the said parishes of Wolstanton and Biddulph into a separate and distinct district, to be assigned to the said chapel at Mow Cop, for all ecclesiastical purposes, and to constitute such district a consolidated chapelry, under the sixth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," for the purpose of affording accommodation for attending divine service to the persons residing in the said district, and for enabling the spiritual person serving such chapel to perform all ecclesiastical duties within the said district attached to such chapel, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the moral habits of the persons residing therein; and that such district should be named, "The Consolidated Chapelry District of St. Thomas, Mow Cop:"

"The consolidated chapelry district of Saint Thomas, Mow Cop, is to consist of contiguous parts of the parishes of Wolstanton and Biddulph; the boundary thereof to commence at the north east corner of the parish of Wolstanton, where it joins the parish of Biddulph, at the point marked A on the map; and to proceed in a south westerly direction along the boundary line marked B, C, D, E, F, that divides the parish of Wolstanton from the parishes of Astbury and Lawton, as

well as the county of Stafford from the county of Chester, to the point marked G on the map; then to proceed south east in a straight line through a field belonging to Mosshouse-farm, to an oak tree meeting a lane from the Red Bull at the point H; from thence to proceed in a north east direction of Cobmore-lane, in which lane it will cross the Trubshaw waggon-road, at the points I and J; thence by the Oulery-lane to the point K; then to proceed in an easterly direction down a road, leading to New Chapel, to the point L, where it meets a road leading north to Mow Cop, and to continue up the middle of that road, including the west side thereof, to the point M; there to turn south east, and follow the line of a hedge which divides R. Williamson's land from three fields held by Mr. Hancock, F. Williams, and C. Dale, to the point N, where it meets a road called Long-lane; thence to proceed on the north side of that road to the point O, where it joins the parish of Biddulph; thence to continue along the same lane to the point P, where it meets a road leading south to the Black Bull, down which road to proceed to the point Q, where a road turns off to Biddulph New Pool; then to turn in a northerly direction along the line of J. Bateman, Esquire's property, to the points R and S, at which latter point it enters the high road leading east to Biddulph Church; to continue along the same road to the point T, where it meets a bye road leading north through the property of Thomas Jackson, a lunatic; and to proceed along the same till it meets the main road leading from Biddulph Church to Congleton, at the point U; to run along the same high road, leading from Biddulph Church to Congleton, to the point W, where it meets the parish of Astbury; then to proceed in a westerly direction along the boundary line that divides the parishes of Biddulph and Astbury, as well as the counties of Stafford and Chester, to the point A, where the boundary commenced, as shewn on the plan, and thereon tinted red and yellow:

"That the consent of the Lord Bishop of Lichfield has been obtained thereto, as required by the above-mentioned section of the said Act of the fifty-ninth year of His Majesty King George the Third; in testimony whereof the said Lord Bishop has signed and sealed this present instrument:

"Your Majesty's said Commissioners beg leave, therefore, to lay before your Majesty the above-stated circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed consolidation and assignment be accordingly made and effected, agreeably to the provisions of the said Acts.
