Lord Chamberlain's-Office, February 26, 1844. ORDERS for the Court's change of Mourning, On Thursday the 7th of March next, for His late Royal Highness the Duke of Saxe-Coburg-Gotha, Father of His Royal Highness Prince

Albert, and Uncle and Father-in-law to Her Majesty, viz. The Ladies to wear black silk, fringed or plain linen, white gloves, necklaces and ear-rings, black

or white shoes, fans and tippets.

The Gentlemen to wear black, full trimmed, fringed or plain linen, black swords and buckles.

The Court to change the Mourning further, on Thursday the 14th of March next, viz.

The Ladies to wear black silk or velvet, coloured ribbons, fans and tippets, or plain white, or white and gold, or white and silver stuffs, with black ribbons.

The Gentlemen to wear black coats, and black or plain white, or white and gold, or white and silver stuff waistcoats, full trimmed, coloured swords and buckles.

And, on Thursday the 21st of March next, the Court to go out of Mourning.

The Queen has been pleased to grant unto Commander James-Anlaby Legard, of the Royal Navy, Her royal licence and permission, that he may accept and wear the insignia of a Knight of the Royal Portuguese Military Order of the Tower and Sword, which the Queen of Portugal hath been pleased to confer on him, in testimony of Her Most Faithful Majesty's approbation of the very gallant services rendered by him to the cause of Her Most Faithful Majesty during the siege of Oporto, in the year 1832; and that he may enjoy all the rights and privileges thereunto annexed; provided, nevertheless, that Her Majesty's said lience and permission doth not authorize the assumption of any style, appellation, rank, precedence, or privilege appertaining unto a Knight Bachelor of these realms:

And also to command, that Her Majesty's said concession and especial mark of Her royal favour be registered, together with the relative documents, in Her Majesty's College of Arms.
