the provisions of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and that such district should be named "The Chapelry District of Christ Church, Nailsea," with boundaries as follow:

"The boundary commences at the stream which divides the parishes of Nailsea and Tickenham, at the termination of the Moore End Drove, along the middle of which it proceeds, in a southerly direction, until it meets and crosses Jacklands Drove, and then follows, in a southerly direction, a fence (being one of the lines of Nailseaheath enclosure) which separates the lands belonging to J. E. Homer, Esq. and others on one side, and to R. H. Bean, Esq. on the other side; and then, proceeding along a fence which encloses and belonging to Mr. S. Lovell, to the road or highway commonly called Silver-street, exactly opposite to the entrance of the Back-lane, along the middle of which it runs for about one hundred yards; then, crossing the little stream, commonly called the Engine Stream, and following the line of fence which encloses the lands of Mizzy Mead Farm, until it reaches the brook or water-course, called Mizzy Mead Ditch, which it follows to its extremity, in an easterly direction; and thence, along the south eastern boundary of Mizzy Mead Farm to Little Nailsea road, along the middle of which road it proceeds, in an easterly direction, to the houses, commonly called East Hayes, or Ash Hayes, which it encloses; it then crosses the road, commonly called Bucklands, or Bullock's-road, and continues along the middle of the road or the lane leading to the East End Colliery, until it reaches the fence which divides the lands belonging to Mrs. Mary Wedmore, on one side, and Mr. George Young, on the other side, along which it proceeds, until it reaches the boundary of Wraxall parish, which it continues to follow (and includes a small detached portion of the parish of Nailsea, lying to the eastward of the district, and entirely surrounded by the said parish of Wraxall) till it arrives at the point at which Wraxall parish and Tickenham parish meet; from thence it proceeds, in a westerly direction, along the brook which divides the parish of Nailsea from the parish of Tickenham, until it reaches the point where the boundary commenced, as shewn on the map hereunto annexed, and thereon

"That marriages, baptisms, churchings, and burials should be solemnized and performed in the said chapel; and that the fees arising there-from should be received by and belong to the Minister of the said chapel:

"That the consent of the Lord Bishop of Salisbury, acting for and on behalf of the Lord Bishop of Bath and Wells, under letters patent, bearing date the twentieth day of December one thousand eight hundred and forty-three, has been obtained thereto, as required by the abovementioned section of the said Act, passed in the

fifty-ninth year of His Majesty King George the Third; in testimony whereof, the said Lord Bishop of Salisbury has signed and sealed this present instrument

" Your Majesty's Commissioners, therefore, beg leave to lay before your Majesty the before-mentioned circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made, and the recommendations of the said Commissioners, in respect of the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts.
