> At the Court at Buckingham-Palace, the 31st of January 1844, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fiftyeighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful
