

the borough of Manchester;" and also of an Act, passed in the second and third years of the reign of His late Majesty William the Fourth, intituled "An Act for improving and regulating the township of Chorlton-upon-Medlock, in the county of Lancaster;" and also of an Act, passed in the fifth year of the reign of His late Majesty George the Fourth, intituled "An Act for lighting, cleansing, watching, and improving the township of Hulme, in the county of Lancaster, and for regulating the police thereof;" and also of a certain other Act, passed in the sixth year of the reign of His late Majesty George the Fourth, intituled "An Act for lighting, cleansing, watching, and improving the township of Ardwick, in the county of Lancaster, and for regulating the police thereof."

And it is proposed by the said intended Act or Acts, for the purpose of widening, ventilating, and improving certain of the streets and public thoroughfares within the said borough of Manchester, with a view to the improved sanatory condition of the inhabitants thereof, and otherwise, to enable the mayor, aldermen, and burgesses of the borough of Manchester, or the council thereof for the time being, to purchase lands and buildings, by compulsion or agreement; and also to vary, repeal, or extinguish all existing rights and privileges connected with such lands and buildings, or which would in any manner impede or interfere with the execution of the purposes aforesaid; and also to enable the said mayor, aldermen, and burgesses, or the said council, to alter the mode of application of the rates and other moneys arising under the authority of the said recited Acts, or some of them; and also to raise a further sum of money for the purposes aforesaid, and for other the purposes of the said intended Act or Acts, or of the said recited Acts, or some of them, on the credit of the several rates, or any of them, which are now payable thereunder, or on the credit of any property belonging, or which may hereafter belong, to the said mayor, aldermen, and burgesses; and, if necessary, to increase such rates, or any of them, for carrying into effect the purposes aforesaid.

And notice is hereby further given, that application is also intended to be made for an Act for the more effectual constitution and regulation of the court of record within the said borough of Manchester, and for extending the jurisdiction of the said court with respect to the amount of debts and damages to be recovered therein; and for altering, improving, and simplifying the practice thereof, and for settling and regulating the fees, costs, and other sums of money payable in respect of proceedings therein.
