THE Remains of Her late Royal Highness the Princess SOPHIA-MATILDA, daughter of His late Royal Highness William-Henry Duke of Gloucester, lay in State at the Ranger's house, Blackheath, attended by Ladies and others of Her late Royal Highness's Household, during Monday the 9th instant. The public were admitted to the State Apartment from twelve o'clock at noon till four o'clock in the afternoon.

A Guard of Honour, from the 2d Battalion of Coldstream Guards, mounted in front of the Ranger's house, at half past eleven A. M. and remained on duty till four o'clock in the afternoon.

On the following day, Tuesday the 10th instant, at twelve o'clock at noon, the same Guard of Honour mounted in front of the Ranger's house; and at a quarter before one o'clock P. M. the Remains of Her late Royal Highness, escorted by a detachment of the 1st Regiment of Life Guards, were removed for private interment in the Choir of the Royal Chapel of Saint George at Windsor, in the following order:

A Mourning Coach, drawn by six horses, conveying the Executors and Executrices named in the will of Her late Royal Highness.

A Mourning Coach, drawn by six horses, conveying the Medical Attendant of Her late Royal Highness.

A Mourning Coach, drawn by six horses, conveying Edward M. Browell and George M. Bainbridge, Esqrs. Officers of the Lord Chamberlain of Her Majesty's Household.

The Carriage of Her Royal Highness the Duchess of Gloucester, drawn by six horses.

(The road from Blackheath to Paddington was kept by the Metropolitan Police).

Upon arriving at the Terminus of the Great Western Railway at Paddington, at ten minutes before five o'clock P. M., the Body was received by a Guard of Honour from the 2d Battalion of Coldstream Guards, when the Escort retired.

The Guard of Honour remained on duty till the departure of the Special Train conveying the Remains, at a quarter before six o'clock.

Upon arriving at Slough, at a quarter before seven P. M., the Body was received by a Guard of Honour from the 1st Battalion of Scots Fusilier Guards; and, at a quarter past seven o'clock, the procession moved, in the following order, to Windsor-Castle, the Body being escorted by a detachment of the Royal Horse Guards, every man bearing a flambeau :

Four of the Queen's Marshalmen.

Eight of the Queen's Grooms, in State Livery, bearing flambeaux.

The Mourning Coaches, the Carriage of Her late Royal Highness, and the Hearse, in the same order in which they proceeded from Blackheath to Paddington.

The Carriage of Her Majesty the Queen Dowager, drawn by six horses, the ten Servants in State Livery.

The Carriage of His Royal Highness the Duke of Cambridge, drawn by six horses, the nine Servants in State Livery.

The Carriage of Her Royal Highness the Duchess of Gloucester, drawn by six horses, the nine Servants in Deep Mourning.

The Carriage of Her Royal Highness the Princess Sophia, drawn by two horses, the four Servants in State Livery.

The Carriage of Her Royal Highness the Duchess of Kent, drawn by six horses, the nine Servants in State Livery.

(The Royal Horse Guards, every third man bearing a flambeau, kept the road from Slough to Windsor-Castle, whilst the Body was passing).

Upon arrival at Windsor-Castle, at twenty minutes past eight o'clock, the Escort filed off, the carriages of the Royal Family proceeding up the Castle-hill; and from the Castle-gate the procession was flanked by the 1st Battalion of Scots Fusilier Guards, every man bearing a flambeau, to the entrance of St. George's Chapel, where the Body was received by a Guard of Honour, the Regimental Band playing the "Dead March" in Saul as the procession passed from the gate to the Chapel; and the Marshalmen and Grooms filed off without the door.

At the entrance of Saint George's Chapel, the Dean and Canons, attended by the Choir, received the Body, and the procession, having been previously formed, moved down the south aisle, up the nave, into the choir in the following order :

Mrs. Powell and Miss Cavanagh, the Dressers of Her late Royal Highness, closed the procession.

Upon arrival within the Choir, the procession advanced near to the Altar, when the Body was placed upon tressels (the feet towards the Altar), and the Coronet and Cushion laid thereon; the Chief Mourner sat at the head of the Corpse; the Supporters on each side; the Supporters of the Pall near the Body; the Lord Chamberlain of Her Majesty's Household stood at the feet of the Corpse; and others of the procession were conducted to their several places.

His Royal Highness Prince Albert was present in his Stall during the Ceremony, attended by the Groom of the Stole to His Royal Highness, the Marquess of Exeter, K.G. and by Major-General Sir Edward Bowater, K.C.H. Equerry to His Royal Highness.

The part of the Service before the Interment and the Anthem having been performed, the Corpse was deposited in the Vault near the Sovereign's Stall; and the Dean having concluded the Burial Service, Garter Principal King of Arms proclaimed, near the Grave, Her late Royal Highness's Style, as follows:

" Thus it hath pleased Almighty God to take out of this transitory life, unto His Divine Mercy, the
 " late Most Illustrious Princess Sophia-Matilda, Daughter of His late Most High, Most Mighty,
 " and Illustrious Prince William Henry Duke of Gloucester and Edinburgh, Earl of Connaught,
 " and Knight of the Most Noble Order of the Garter, Cousin of Her Most Excellent Majesty
 " Victoria, by the Grace of God, of the United Kingdom of Great Britain and Ireland, Queen,
 " Defender of the Faith, whom God bless and preserve with long life, health, and honour, and
 " all worldly happiness."

After which His Royal Highness Prince Albert, attended by the Groom of the Stole and Equerry in Waiting to His Royal Highness, was conducted out of the Chapel by the Lord Chamberlain of Her Majesty's Household; and the other persons composing the procession also retired.

WHEREAS by an Act, passed in the seventh and eighth years of Her Majesty's reign, intituled "An Act to amend the law respecting the office of county coroner," it is enacted, that when and as often as it shall seem expedient to the justices of any county, that such county should be divided into two or more districts for the purposes of that Act, or that any alteration should be made of any division theretofore made under that Act, it should be lawful for the said justices, in general or quarter sessions assembled, to resolve, that a petition should be presented to Her Majesty, praying that such division or alteration be made, and thereupon to adjourn the further consideration of such petition until notice thereof should be given to the coroner or coroners of such county as thereafter provided:

And it is thereby further enacted, that the clerk of the peace should give notice of any such resolution to every coroner for such county, and of the time when the petition would be taken by the said justices into consideration, and the justices should confer with every such coroner who should attend the meeting of the justices for that purpose, touching such petition, having due regard to the size and nature of each proposed district, the number of the inhabitants, the nature of their employments, and such other circumstances as should appear to the justices fit to be considered in carrying into execution the provisions of that Act, and such petition, with a description of the several proposed districts, and of the boundaries thereof, with the reasons upon which the petition is founded, should be certified to Her Majesty, under the hands and seals of two or more of the justices present when such petition should be agreed to, and the clerk of the peace for such county should

forthwith give or send a true copy of such petition, certified under his hand, to every coroner for such county:

And it is further enacted, that it should be lawful for Her Majesty, if she should think fit, with the advice of Her Privy Council, after taking into consideration every such petition, and also any petition which might be presented to her by any coroner of the same county concerning such proposed division or alteration, or whenever it should seem fit to Her Majesty, to direct the issue of a writ de coronatore eligendo, for the purpose of authorising the election of an additional coroner above the number of those who had been customarily elected to such county, to order that such county should be divided into such and so many districts for the purposes of that Act as to Her Majesty, with the advice aforesaid, should seem expedient, and to give a name to each of such districts, and to determine at what place within each district the court for the election of coroner for such district should be holden as thereafter provided, and every such order should be published in the London Gazette: and whereas the justices of the peace for the county of Montgomery, assembled in quarter sessions on the seventeenth day of October one thousand eight hundred and forty-four, did resolve, that an humble petition should be presented to Her Majesty, praying for such division or alteration as thereafter mentioned, and did adjourn the further consideration thereof until an adjourned quarter sessions, holden on the twenty-sixth day of October one thousand eight hundred and forty-four: and whereas the said justices did, on the thirty-first day of October one thousand eight hundred and forty-four, present their petition to Her Majesty, representing that heretofore two coroners have been elected for the county of Montgomery, and that the county has been customarily divided into two districts, for the purpose of holding inquests during the space of seven years before the passing of an Act of Parliament, in the seventh and eighth years of Her Majesty's reign, intituled "An Act to amend the law respecting the office of county coroner:"

Within which, Charles Milward Dovaston Humphreys, Esq. customarily acted as coroner:

That the said Charles Milward Dovaston Humphreys is now lately deceased, that is to say, on the thirteenth day of October one thousand eight hundred and forty-four:

That Her Majesty's justices, being desirous of removing the difficulties and the inconveniences hitherto felt in holding inquests within the said larger district, by availing themselves of the aforesaid Act, and being assembled in quarter sessions on the seventeenth day of October one thousand eight hundred and forty-four, did resolve, that an humble petition should be presented to Her Majesty, praying that Her Majesty would be graciously pleased to direct that the county of Montgomery be divided into three districts, for the purposes of the aforesaid Act; and that the further consideration of the said petition should be adjourned to the twenty-sixth day of October one thousand eight hundred and forty-four (to which day the said quarter sessions were also adjourned):

That, in pursuance of the provisions of the said Act, the clerk of the peace, by the direction of the court, caused a notice to be served on the said Hugh Lloyd, Esq. coroner of the said lesser district of the county, on the twenty-second day of October one thousand eight hundred and forty-four, a copy of which is here inserted:

"To Hugh Lloyd, Esq. one of the coroners of the county of Montgomery:

"I, the undersigned, Joseph Jones, clerk of the peace for the county of Montgomery, do hereby give you notice, that at the last quarter sessions held for this county, on the seventeenth day of the present month of October, the justices at that sessions resolved, that a petition should be presented to Her Majesty, praying that the county of Montgomery may be divided into three districts, for the purposes of the Act, passed in the session

of Parliament held in the seventh and eighth years of the reign of Her present Majesty, 'to amend the laws respecting the office of county coroner;' and that the said petition will be taken into further consideration by the justices of the county, at an adjourned quarter sessions to be held at the Town-hall, in Welshpool, on Saturday the twenty-sixth day of the present month of October, at the hour of two in the afternoon, at which time and place your attendance is required. Dated this nineteenth day of October one thousand eight hundred and forty-four. Joseph Jones."

That the said notices, together with the said coroner's acknowledgement of the same, were duly laid before the said Court, at the said adjourned sessions, holden on the said twenty-sixth day of October:

That at the said adjourned sessions Her Majesty's justices took the matter into their further consideration, and having carefully examined the districts heretofore customarily made in the said county, and having regard to the inconveniences of holding inquests within the larger districts thereof, did resolve:

That it would be advisable and expedient that the county of Montgomery should be divided into three districts; and therefore praying that Her Majesty would be graciously pleased to direct that the said county be divided into three districts, for the purposes of the said Act:

That the lesser of the districts, customarily used, as aforesaid, for the space of seven years before the passing of the said Act, within which the said Hugh Lloyd, Esq. has acted as coroner, be constituted a district, for the purposes of the said Act, by the name of "The Machynlleth District," and be assigned to the said Hugh Lloyd, Esq. and that the place of election of coroner for the said district be at Machynlleth:

That the larger district, now vacant by the decease of the said Charles Milward Dovaston Humphreys, be divided into two districts:

That one of the districts comprise the hundreds of Llanidloes, with a population of 12641
Newtown 13776
And Montgomery 5628

Whereof the population is principally agricultural:

That this district be styled, the "Welshpool District," and that the place of election of a coroner within the said district be Welshpool:

They also humbly submitted to Her Majesty, that the means of communication within the said districts of Newtown and Welshpool are easy and convenient to their respective inhabitants; and they further humbly submitted to Her Majesty the proposed districts as coroners' districts, having adapted the ancient boundaries of hundreds as being well known boundaries, and usually adhered to in discharging the public business of the county:

Now, therefore, Her Majesty, having taken the said petition into consideration, doth, pursuant to the said Act of the seventh and eighth years of Her reign, by and with the advice of Her Privy Council, declare, order, and direct, that such county shall be divided into three districts for the purposes of the said Act, to be called by the several and respective names following, that is to say, "the Machynlleth District," "the Newtown District," and "the Welshpool District;" and it is hereby further declared, ordered, directed, and determined, that the courts to be holden for the purpose of the election of any coroner, if any one or more of the said districts, respectively, when and as the same shall become necessary under the provisions of the said recited Act, shall be as follows, that is to say, for the Machynlleth district at Machynlleth, for the Newtown district at Newtown, and for the Welshpool district at Welshpool; and it is hereby further declared, ordered, and directed, that this Order shall be published in the London Gazette.

THE following is a copy of an Order of Her Majesty in Council, assigning chapelry districts, under the 16th section of the 59th Geo. 3, cap. 134, to the chapels at Gwernafield, Nerquis, Pontblyddyn, and Bistre, in the parish of Mold, in the county of Flint:

At the Court at Buckingham-Palace, the 23d of May 1844, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fifty-eighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall
