And notice is hereby further given, that it is intended by the said Bill or Bills to authorize and empower the Grand Junction Railway Company, the Blackburn, Darwen, and Bolton Railway Company, the East Lancashire Railway Company, and the Liverpool and Bury Railway Company out of their corporate or other funds, and either jointly or severally, to take shares in and to subscribe for or towards the making, maintaining, working, and using the said intended extension or branch railway and works firstly hereinbefore mentioned, or any part thereof, or to purchase, rent, work, or construct the same extension or branch railway and works or any part of the same, and to take tolls upon or in respect thereof, and to raise money for the purposes aforesaid; and also to enable the said Company of Proprietors of the Manchester, Bolton, and Bury Canal Navigation and Railway, and the said Grand Junction Railway Company, to enter into mutual arrangements with reference to the use and occupation of, or the passage of traffic along, any portion of the railway belonging to the said Grand Junction Railway Company, called the Liverpool and Manchester Railway, and for carrying into effect all or any of the objects aforesaid, it is intended to apply for powers to alter, amend, extend, and enlarge the provisions of the several Acts relating to the Grand Junction Railway Company, passed respectively in the sessions of Parliament held in the third and fourth, and in the fourth and fifth, and in the fifth and sixth years of the reign of His late Majesty King William the Fourth, and in the first and second, and in the third and fourth, and in the eighth and ninth years of the reign of Her present Majesty Queen Victoria, and of the Blackburn, Darwen, and Bolton Railway Company, passed in the eighth and ninth years of the reign of Her said present Majesty, and of the
