And to terminate at or near and to communicate with the intended port or harbour, piers, docks, basins, landing places, and other works hereinafter mentioned, in the said parish of Stogursey otherwise Stoke Courcy, in the said county of Somerset.

And also for making and maintaining one or more branch railway or railways, diverging from and out of the said intended main railway in the parish of Taunton Saint James aforesaid, and passing thence from, in, through, or into the several parishes, townships, extra-parochial and other places of Taunton and Taunton-Dean Hundred, Taunton, Taunton Borough, Taunton Saint James, North Town, Plaistreet, Firepool, and Obridge, or some of them, in the said county of Somerset, and terminating by a junction or junctions with the said Bristol and Exeter Railway, near Obridge, in the parish of Taunton Saint James.

Also one or more branch railway or railways diverging from and out of the said intended main railway near to a place called Ford Gate, in the said parish of North Petherton, in the county of Somerset, and passing thence from, in, through, or into the several parishes, townships, extra-parochial and other places of North Petherton Hundred, North Petherton, Huntworth, Newton, North Newton, Town-Denison, Buckland-Fee, Woolmersdon, and Petherton-Limit, or some of them, in the said county of Somerset, and terminating by a junction or junctions with the said Bristol and Exeter Railway, in the said parish of North Petherton.

Also one or more branch railway or railways diverging from and out of the said intended railway at or near to certain tenements and gardens, reputed to belong to the company of proprietors of the Bridgewater and Taunton Canal Navigation, in the occupation of John Farrance and Edward Masey, in the parish of North Petherton, in the county of Somerset, and passing thence from, in, through, or into the several parishes, townships, extra-parochial and other places of North Petherton Hundred, North Petherton, Huntworth, Newton, North Newton, Town-Denison, Buckland-Fee, Woolmersdon, and Petherton-Limit, or some of

them, in the said county of Somerset, and terminating by a junction or junctions with the said Bristol and Exeter Railway, at or near to the said tenements and gardens, in the parish of North Petherton aforesaid.

Also one or more branch railway or railways diverging from and out of the said intended main railway, at or near to a plot of ground reputed to belong to the said company of proprietors of the Bridgewater and Taunton Canal Navigation, and in the occupation of William Simmonds, in the said parish of Bridgewater, and passing thence over and across the river Parret on the southward side of the town of Bridgewater, from, in, through, or into the several parishes, townships, extra-parochial and other places of North Petherton Hundred, Bridgewater, borough of Bridgewater, and East Bower, or some of them, in the said county of Somerset, and terminating by a junction or junctions with the said Bristol and Exeter Railway, at or near to the Bridgewater Station of that railway, in the parish of Bridgewater, in the county of Somerset.

Also one or more branch railway or railways diverging from and out of the said intended main railway, in the parish of Wembdon, in the county of Somerset, and passing thence over and across the said river Parret on the northward side of the said town of Bridgewater, from, in, through, or into the several parishes, townships, and extra-parochial and other places of North Petherton Hundred, Wembdon, Durleigh, East Street, Bridgewater, borough of Bridgewater, and East Bower, or some of them, in the said county of Somerset, and terminating by a junction or junctions with the said Bristol and Exeter Railway, at or near to the Bridgewater Station of that railway, in the said parish of Bridgewater.

And also one or more branch railway or railways diverging from and out of the said intended main railway, near Combwich Pill, in the parishes of Cannington and Otterhampton, in the county of Somerset, or in one of them, and passing thence, from, in, through, or into the several parishes, townships, and extra-parochial and other places of Cannington Hundred, Cannington, Edstock, Beer, Otterhampton, and Combwich, or some of them, in the said county of Somerset, and terminating at or near to the river Parret, at or near to Combwich Pill aforesaid, in the said parishes of Cannington and Otterhampton, or one of them.

And also for making a portion or portions of the said main railway, and some or one of the said branch railways, and a portion or portions thereof respectively.

And also a port or harbour, with proper piers, jetties, breakwaters, walls, locks, docks, basins, landing-places, quays, wharfs, warehouses, approaches, and other works and conveniences connected therewith, at, upon, and near to the sea beach, shore, or coast, and bed of the river Parret, or of the Bristol Channel, in the bay of Bridgewater, at or near to the Wick otherwise Week Rocks, below or near to the town of Stoford otherwise Stolford, in the parish of Stogursey otherwise Stoke Courcy, in the county of Somerset.

And also for making and maintaining a cut or channel from and out of, and having communication with the said intended dock or docks, basin or basins, through the said sea beach, shore, or coast, and bed of
