PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the session of Parliament held in the eighth and ninth years of the reign of Her present Majesty, intituled "An Act for the general regulation of the Customs," it is, amongst other things, enacted, that the several sorts of goods enumerated in the table therein following, denominated "a table of prohibitions and restrictions inwards," shall either be absolutely prohibited to be imported into the United Kingdom, or shall be imported only under the restrictions mentioned in such table:

And whereas, among other sorts of goods, the following are enumerated in the said table, viz.

" Goods of places within the limits of the East India ('ompany's charter, except into ports approved of by the Lords of the Treasury, and declared, by Order in Council, to be fit and proper for such importation:"

And whereas the port of Galway has been approved of by the Lords of Her Majesty's Treasury for that purpose:

Now, therefore, Her Majesty, by and with the ndvice of Her Privy Council, is thereupon pleased to declare, and it is hereby declared, that the port of Galway is fit and proper for the imporlation of goods from places within the limits of the East India Company's charter:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.

An Act to apply the sum of eight millions out of the Consolidated Fund to the service of the year one thousand eight hundred and forty-six.

An Act to make further provisions as to unclaimed stock and dividends of the South Sea Company.

An Act to repeal so much of an Act, passed in the fourth year of the reign of His late Majesty King George the Fourth, intituled "An Act for naturalizing Henry Robert Ferguson," as enacts that the said Henry Robert Ferguson should not thereby be enabled to be of the Privy Council, or a Member of either House of Parliament, or to take any office or place of trust either civil or military, or to have any grant of lands, tenements, or hereditaments from the Crown to himself, or any other person or persons in trust for him.
