HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the eighteenth day of February, in the year one thousand eight hundred and forty-six, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act "to make better provision for the spiritual care "of populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes out of the ancient

parochial chapelry of Oldham, and the parish of Ashton-under-Lyne, both in the county of Lancaster, and in the diocese of Chester.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent, and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to ! the patron or patrons of the church or chapel of any parish, chapelry, or district, out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the meantime, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shall be increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

"And whereas the said chapelry of Oldham and parish of Ashton-under-Lyne are respectively of great extent, and contain a large population, and the provision for public worship and for pastoral superintendence therein is insufficient for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it would promote the interests of religion, that the particular parts of the said chapelry and of the said parish hereinafter mentioned, neither of which parts at present contains within its limits any consecrated church or chapel in use for the purposes of divine worship, should be together constituted a separate district in manner hereinafter set forth:

" And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of the district so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to petual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid, by equal half-yearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE.

" The district of LEESFIELD, being-

" All that part of the ancient parochial chapelry of Oldham, in the county of Lancaster, and in the diocese of Chester, and also all that part of the parish of Ashton-under-Lyne, in the same county and diocese, comprised within and bounded by an imaginary line commencing at a point (marked a on the map or plan hereunto annexed) on the boundary between the new parish of Glodwick, in the same county and diocese, and the said parish of Ashton-under-Lyne, at the extreme south western angle of such new parish, near Cherry Valley, and thence extending towards the north east, along such boundary, to the south eastern angle of the said new parish, and thence northward, along the eastern boundary thereof, to a point (marked b as aforesaid) opposite to the middle of a certain footpath leading from 'New Earth' to 'Green Acres,' and thence also northward, along the middle of such footpath, as far as the boundary of the district of Waterhead, in the same county and diocese, and thence towards the south west, along such boundary, to the extreme southern angle of the said district, and thence, also towards the south west, and in a straight direction, towards Spring Head Mill, as far as the boundary between the said county of Lancaster and the county of York, and thence along such boundary as far as the boundary between the divisions of Knottlanes and Hartshead, and thence westward, along such last-mentioned boundary, as far as the river Medlock, and thence, along the middle of such river, as far as Deanshut Clough, and thence northward, along the middle of such clough, to the point where the said imaginary line commenced."

And whereas the draft of the said scheme has been transmitted to the incumbents and to the patrons of the churches of the parishes, and of the the churches or chapels of the districts, out of which it is intended that the district therein

recommended to be constituted shall be taken, pursuant to the provisions of the said Act; and one calendar month has expired since such draft was so transmitted:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Chester.

"And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of so recommended be conthe district to stituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, of one hundred and fifty pounds, as the case may be shall be paid, by equal half-yearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

" SCHEDULE.

" The district of MOUNT HAWKE, being-

" All that part of the chapelry of Saint Agnes, in the county of Cornwall, and in the diocese of Exeter, situate on the western side of an imaginary line extending southward from the northern boundary of the said chapelry at Chapel Porth, along a certain rivulet known by the name of Minggose River, to the corner of Bann's Estate, and thence in a straight direction towards the south west to Towan Cross, and thence towards the south east, along the middle of the main road leading into the turnpike road from Saint Agnes to Truro, as far as Mingoose Barrow, and thence towards the south west, along the eastern boundary of a certain estate called Trenithick, to the south castern corner thereof, and thence also towards the south west and in a straight direction to the north eastern corner of the Goosewarra Estate, and thence in a like direction to the north western corner of a certain field now in the occupation of Richard Trurau, and numbered 3056 on the parish map of Saint Agnes, and thence southward, along the middle of a certain road leading to Edwards's Brewery at Blackwater, as far as the

southern boundary of the said chapelry of Saint Agnes; and also all that part of the parish of Illogan, in the same county and diocese, situate on the eastern side of an imaginary line extending northward from the boundary between the said parish of Illogan and the parish of Redruth, in the same county and diocese, along the western fence or boundary of the estate called Kite's Enclosure, across the high road to Portreath, and along the middle of a certain road or lane leading to Fiddle Bottom, and thence towards the north west along a certain small stream or rivulet to the north western boundary of the said parish of Illogan at Kerriar Cove."

And whereas the draft of the said scheme has been transmitted to the incumbent and to the patron of the church of the parish, and of the church or chapel of the chapelry, out of which it is intended that the district therein recommended to be constituted shall be taken, pursuant to the provisions of the said Act; and such incumbents and patrons have respectively consented to the said scheme:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Exeter.

HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the provisions of the fourth section of an Act, passed in the session of Parliament holden in the seventh and eighth years of Her Majesty's reign, intituled "An Act concerning banns and marriages."

"in certain district churches or chapels," duly prepared and laid before Her Majesty in Council a representation, bearing date the sixth day of May one thousand eight hundred and forty-six, in the words following, viz.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, under the provisions of the sixteenth section of an Act, passed in the fiftyninth year of the reign of His late Majesty King George the Third, intituled "An Act to amend " and render more effectual an Act, passed in the " last session of Parliament, for building, and " promoting the building, of additional churches " in populous parishes," a particular district was, by virtue of an Order of your Majesty in Council, bearing date the thirty-first of July one thousand eight hundred and thirty-nine, duly assigned to the consecrated church, called All Saints' Church, situate in Trinity district parish, Islington, in the county of Middlesex, and within the diocese of London:

"That the said Order in Council did not direct that marriages should be performed in the said church:

" Your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances of the district so assigned to the said church, called All Saints' Church, it appears to them to be expedient, that banns of marriage should be published, and that marriages should be performed in the said church; and that a supplemental Order for that purpose should be made, pursuant to the provisions of the fourth section of an Act, passed in the session of Parliament holden in the seventh and eighth years of your Majesty's reign, intituled " An Act concerning banns and marriages in " certain district churches or chapels;" and that all the fees arising from the publication of banns of marriage and the performance of marriages in the said church, called All Saints' Church, should be paid and belong to the incumbent of such church for the time being:

"That the consent of the Right Honourable and Right Reverend Charles James Lord Bishop of London has been obtained thereto, as required by the last-mentioned Act and section; in testi-

mony whereof, the said Charles James Lord Bishop of London has signed and sealed this representation:

"Your Majesty's Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the recommendations of the said Commissioners, in respect of the publication of banns and solemnization of marriages, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Act.

HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act" to amend and render more effectual an Act, "passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," duly prepared and laid before Her Majesty in Council a representation, bearing date the fifteenth day of June one thousand eight hundred and forty-six, in the words following, viz.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, having taken into consideration all the circumstances of the parish of Wolstanton, in the county of Stafford, and in the diocese of Lichfield, it appears to them to be expedient, that a particular district should, under the provisions of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His late Majesty King George the

Third, intituled "An Act to amend and render "more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," be assigned to the consecrated chapel called Saint James's Chapel, situate at a place called New Chapel, in the said parish of Wolstanton, and that such district should be named. "The Chapelry District of Saint James New Chapel," and be bounded as follows:

" Commencing at the west corner of Brieryhurst at the point marked A on the plan hereinafter referred to, where the parishes of Audley, Wolstanton, and Lawton meet, and proceding in a north eastwardly direction along the boundary line of the parishes of Wolstanton and Lawton, as far as the road leading from Hall-green to New Chapel, and along the said road, in an easterly direction, twice crossing the railroad belonging to the Trubshaw Colliery, and up a lane called Alderhay-lane, in a north eastwardly direction, keeping the south eastern side of the said road to the point, where the townships of Brieryhurst, Stadmoreslow, and Thursfield meet; then turning in a south eastwardly direction along the boundary line of Stadmoreslow and Thursfield townships until it meets a road called Long-lane, along which lane it then proceeds, keeping on the south side thereof, in an eastwardly direction, as far as the parish of Biddulph; thence proceeding in a north eastwardly direction along the boundary line which separates the parish of Wolstanton from the parishes of Biddulph and Norton in the Moors to the point where a brook course which runs at the bottom or south side of the Heathfield belonging to Charles Bowyer Adderley, Esq. at the point E on the plan; then turning westwardly up the lastmentioned brook course, where the parishes of Burslem, Norton in the Moors, and Wolstanton meet; thence westwardly, along the boundary line of the parishes of Wolstanton and Burslem as far as Chell-brook, at the point G on the plan, and along the said brook course, in a northerly direction, to the point marked H on the plan, where the township of Tunstall, Oldcott, and Thursfield join, still in a north eastwardly direction along the brook to Colclough-lane, crossing the said lane and continuing northwardly along the boundary line dividing the township of Oldcott, from the township of Thursfield to the point where the township of Brieryhurst joins the townships of Oldcott and Thursfield; thence in a southwardly direction to a brook course which separates the townships of Oldcott and Brieryhurst; and then proceeding in a westwardly direction along the brook course to the point A, being the south point of the coal wharf belonging to Thomas Kinnersley, Esq. where the boundary commenced, as the same is more particularly delineated on the plan hereunto annexed, and thereon coloured red:

"That banns of marriage should be published, and that marriages, baptisms, churchings, and burials should be solemnized and performed in the said chapel, called Saint James's Chapel; and that the fees arising therefrom should be reserved for, on account of, and paid to, the present Vicar of the said parish of Wolstanton during his incumbency thereof; but, upon his avoiding the vicarage or parish church of the said parish of Wolstanton, the said fees should belong to the incumbent for the time being of the said chapel, called Saint James's Chapel:

"That the consent of the Right Reverend John Bishop of Lichfield has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof, the said John Bishop of Lichfield has signed and sealed this representation:

"Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the publication of banns and the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Act.

A PROCLAMATION.

VICTORIA, R.

HEREAS by our Order in Council of the nineteenth of May, in the present year of our Lord, one thousand eight hundred and fortysix, and in the ninth year of our reign, we were graciously pleased, for the reasons therein contained, to annul the Royal Proclamation of His late Majesty King William the Fourth of the third day of February one thousand eight hundred and thirty-six, directing that distribution should be made of the net proceeds of prizes captured from the enemy, of captures and seizures, under the several Acts passed relating to the revenues of Customs, and to trade and navigation, for the abolition of the slave trade, and for the capture and destruction of piratical vessels, and of the rewards conferred for the same, as well as of awards and allowances of salvage granted to the officers and men of ships and vessels of war, when not otherwise specially apportioned by the terms of the respective awards and allowances: and whereas in the recital of the said Order in Cottneil in our Royal Proclamation, dated the said nineteenth day of May one thousand eight hundred and forty-six, the following words, that is to say, "as well as of "awards and allowances of salvage granted to the "officers and men of ships and vessels of war, when "not otherwise specially apportioned by the terms " of the respective awards and allowances," were by mistake omitted, and it is expedient that such mistake should be corrected: now, therefore, we do make known to all our loving subjects, and all others whom it may concern, by this our Royal Proclamation, by and with the advice and consent of our Privy Council, that our said Proclamation of the said nineteenth day of May one thousand eight hundred and forty-six shall have the same torce and effect, to all intents and purposes, as if the said words so omitted by mistake had been inserted therein.
