A T the Court at Buckingham-Palace, the 6th day of July 1846,

PRESENT.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-fourth day of June, in the year one thousand eight hundred and forty-six, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act "to make better provision for the spiritual care "of populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes out of the parishes of Audley-cum-Talk and Wolstanton, in the county of Stafford, and in the diocese of Lichfield.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent. and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district, out of which it is

recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the meantime, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shall be increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

" And whereas the said parishes of Audleycum-Talk and Wolstanton are respectively of great extent, and contain a large -population, and the provision for public worship and for pastoral superintendence therein is insufficient for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it 'would promote the interests of religion, that the particular part of each of such parishes hereinafter mentioned and described, neither of which parts at present contains within its limits any consecrated church or chapel in use for the purposes of divine worship, should be together constituted a separate district in manner hereinafter set forth:

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend John Bishop of Lichfield, in testimony whereof he has signed and sealed this scheme, that all that part of the said parish of Audley-cum-Talk, and also all that part of the said parish of Wolstanton, described in the schedule hereunto annexed, all which parts, together with the boundaries thereof, are delineated and set forth in the map or plan hereunto also annexed, shall be together constituted a separate

district for spiritual purposes accordingly; and that the same shall be named, "The District of Chesterton."

" And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of the district so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid, by equal half-yearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

"And we further recommend and propose, that nothing herein contained shall prevent us from

recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE.

" The district of CHESTERTON, being-

" All that part of the parish of Audley-cum-Talk, in the county of Stafford, and in the diocese of Lichfield, and also all that part of the parish of Wolstanton, in the same county and diocese, comprised within and bounded by an imaginary line commencing at a point (marked a on the map or plan hereunto annexed) to the south of the Apedale Furnaces, where the boundary of the lordship of Apedale joins that of the township or liberty of Chesterton, and thence extending westward along the southern boundary of the said lordship to the middle of the road leading from Alsager's Bank to Newcastle, and thence towards the north west along the middle of such road to a point (marked b as aforesaid) opposite to the south east corner of a certain field called Delph Hay, now in the occupation of Joseph Brayford, and thence towards the south west along the boundary of the said lordship to the boundary between such lordship and the parish of Keele, in the same county and diocese, thence northward along the boundary of such last-mentioned parish to the middle of the road leading from Podmore Hall to Scot Hay, and thence westward along the middle of such road to the eastern boundary of the parish of Madeley, in the same county and diocese, and thence northward along such last-mentioned boundary as far as Hayes Wood, and thence first eastward along the southern and eastern boundary of such Wood to the north western corner (marked c as aforesaid) of a certain field called Bankey Field, now in the occupation of Benjamin Leighton, and thence eastward along the northern boundary fence of such last-mentioned field, and northward along the western boundary fences of two other fields (marked respectively d and e as aforesaid), to the middle of the road leading from Nantwich to Audley, and thence eastward along the middle of such last-mentioned road to a point (marked f as aforesaid) opposite to the middle of Halmerend Lane, and thence towards the south east along the middle of such lane, as far as a certain open space called the Green, and thence

eastward along the northern boundary of the said green, and towards the north east along the middle of another lane called Holly Lane as far as Miles Green, and thence towards the south east alongthe middle of a certain lane leading thence to Wood Lane, and in the same direction along the middle of such last-mentioned lane to a point (marked g as aforesaid) opposite to the middle of Megacre Lane, and thence towards the north east along the middle of such last-mentioned lane to a point (marked h as aforesaid) opposite to the north eastern corner of another field called Megacre Field, and now in the occupation of Arthur Tom. kinson, and thence southward along the north. eastern boundary of the said lordship of Apedale as far as the township of Chesterton aforesaid, and thence eastward along the northern boundary of such township as far as the township of Chatterley, and thence in the same direction along the northern boundary of such township as far as the middle of the new road from Newcastle to Talk o' the Hill, and thence southward along the middle of such road to a point (marked i as aforesaid) where the same crosses the south eastern boundary of the said township of Chesterton, and near a certainpublic footpath from the village of Chesterton to Wolstanton, and thence first towards the south west along such last-mentioned boundary to the point where the said imaginary line commenced."

And whereas the draft of the said scheme has been transmitted to the incumbents and to the patrons of the churches of the parishes out of which it is intended that the district therein recommended to be constituted shall be taken, pursuant to the provisions of the said Act; and such incumbents and patrons have respectively consented to the said scheme:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Lichfield.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled " An Act to carry into effect, with " certain modifications, the fourth report of the " Commissioners of Ecclesiastical Duties and " Revenues;" and of another Act, passed in the session of Parliament held in the fifth and sixth years of Her Majesty's reign, intituled " An Act " for enabling ecclesiastical corporations, aggre-" gate and sole, to grant leases for long-terms of " years," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-sixth day of November one thousand eight hundred and forty-five, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled " An " Act to carry into effect, with certain modifi-4 tions, the fourth report of the Commissioners " of Ecclesiastical Duties and Revenues;" and of another Act, passed in the session of Parliament held in the fifth and sixth years of your Majesty's reign, intituled "An Act for enabling eccle-" siastical corporations, aggregate and sole, to " grant leases for long terms of years," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for determining the portion, of the improved value to be made payable to us in a certain mining lease about to be granted by the Reverend John Webster Hawksley, Clerk, Rector of the parish of Redruth, in the county of Cornwall, and in the diocese of Exeter.

"Whereas by the said last recited Act it is enacted, that it shall be lawful for any ecclesiastical corporation, aggregate or sole (excepting as therein is excepted, which exception does not include the case of a rector,), from time to time, with the consents in that behalf, thereby required, and subject to the provisions in the same Acts contained, to grant or demise by lease, for

any term not exceeding sixty years, any mines, minerals, quarries, or beds belonging to such corporation:

"And whereas, in pursuance of the powers contained in the said recited enactment, it is proposed by the said John Webster Hawksley, as such rector as aforesaid, with the consents required by the same Acts, to grant and demise, by lease, certain mines, with the produce thereof, in and under certain lands, being part and parcel of the glebe lands of the said parish, and situate, lying and being therein:

"And whereas by the same Act it is further enacted, that, in case of any lease of mines, minerals, quarries, or beds granted thereunder, such portion of the improved value accruing under such lease, as by the authority provided in the first recited Act shall be determined, not being more than three fourth parts nor less than one moiety of such improved value, shall forthwith, and from time to time as the same shall accrue, be paid to us, and shall be subject to the provisions relating to monies payable to us:

"And whereas the improved value to accrue under the lease so proposed to be granted as aforesaid will, according to the meaning of the same Act, be the whole net amount of the reservation or reservations to be made in such lease:

" Now, therefore, we humbly recommend and propose, that one half of the whole net amount of the reservation or reservations to be made in the said lease so to be granted, whether consisting of rent, royalty, or otherwise, shall, by such lease, be made directly payable to us; and that we shall. have all the like remedies, in respect of such one half of any such reservation as aforesaid, as if the same were a separate rent reserved to us as lessors or grantors and reversioners of the premises comprised in such lease, independently of the rights and remedies of the said John Webster Hawksley, and his successors, rectors of Redruth, in respect of the remaining one half thereof, without any priority or preference between us and the said rector for the time being; and further, that we shall have full benefit and advantage, either jointly with or separately from the said John Webster Hawksley, and his successors, rectors of Redruth for the time being, of all or any of the covenants, conditions, and agreements in the said lease to be con-

tained on the lessee's part, in like manner as if we had been grantors, lessors, and reversioners as aforesaid, and as in such lease shall be expressed; and that, for effectuating such objects, the said fease shall and may be framed in such manner; and contain all such clauses and provisions as we shall approve, and shall have full force accordingly, any rule of law, statute, or custom to the contrary notwithstanding.

" And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said recited Acts, or of any other Act of Parliament."

And whereas notice of the said scheme has been given to the said John Webster Hawksley, as such rector as aforesaid, in accordance with the provisions of the first recited Act, and he has made no objection thereto:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Exeter.

THEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act, passed in the session of Parliament holden in the eighth and ninth years of Her Majesty's reign, intituled " An Act " for the further amendment of the church " building Acts," duly prepared and laid before

date the fourteenth day of May one thousand eight hundred and forty-six, in the words following, viz.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent toyour Majesty, that, having taken into consideration all the circumstances attending the parishes of Broad Hinton and Cliffe Pypard, in the county of Wilts, and within the diocese of Salisbury, it appears to them to be expedient to unite certain. contiguous parts of the said parishes, and to form. the same into one consolidated chapelry, for alk ecclesiastical purposes, for the consecrated church, called Christ Church, situate at Broad-town, in the said parish of Broad Hinton, under the provisions of the ninth section of an Act, passed in the sessions of Parliament holden in the eighth and ninth years of your Majesty's reign, intituled "An " Act for the further amendment of the church " building Acts;" and that such consolidated chapelry should be named, "The Consolidated Chapelry of Broad-town;" and be bounded as follows:

"On the north by the parish of Wootten Bassett; on the north east by the parish of Lydiard Tregoze (so as to include within the said consolidated chapelry a detached part of the said parish of Broad Hinton, marked No. 55 on the tithe commutation map of such last-named parish, and also on the plan hereinafter referred to); on the south east by the remaining part of the said parish of Broad Hinton, from which it is separated by proceeding in a south westerly direction from the said parish of Lydiard Tregoze, along the southern fence of an enclosure marked No. 177 on the said plan, and continues along the south eastern fence of enclosure No. 179, and the southern fence of No. 171, to the eastern fence of No. 187, along the eastern and southern fences of which enclosure it proceeds to the eastern fence of No. 188, and continues south westerly along the south eastern fences of Nos. 188 and 196, as far as the road to Marlborough, and crossing that road it continues along the eastern and southern fences of No. 226, and enters the said parish of Cliffe Pypard; the said consolidated; chapelry is then bounded on the south and west by the remaining part of the said parish of Cliffe Pypard, from which it is separated by proceeding Her Majesty in Council a representation, bearing westerly from the said parish of Broad, Hinton, along the southern fences of inclosures Nos. 190, 192, and 195, in the said parish of Cliffe Pypard; it then turns northward up the western fences of enclosures Nos. 195 and 201 to the southern fence of No. 202, and proceeds westerly along the said fence, No. 202, and then along the southern fence of No. 124, in the said parish of Broad Hinton; it then turns northerly along the western fences of of Nos. 124 and 123, in the said parish of Broad Hinton, then easterly along the northern fence of No. 123 to the western fence of No. 210, in the said parish of Cliffe Pypard; it then turns northerly up that fence and follows the south eastern and southern fences of No. 122, in the said parish of Broad Hinton, in a westerly direction; it then proceeds northerly up the western fences of Nos. 122, 121, and 120, in the said parish of Broad Hinton, and Nos. 254, 253, 276, 277, 278, 279, and 280, in the said parish of Cliffe Pypard, and crossing the road from Thornhill continues in a straight line northerly up the western fence of No. 293, and then continues in a straight line across No. 291, in the said parish of Cliffe Pypard, to the south western corner of No. 2, in the said parish of Broad Hinton, and continues northerly along the western fences of Nos. 2 and 1 in that parish; it then turns easterly along the northern fence of No. 1, and continues along the northern fences of No. 295, in Cliffe Pypard aforesaid, and No. 12, in Broad Hinton aforesaid; it then turns north easterly along the eastern and northern fences of No. 13, in Broad Hinton aforesaid, as far as the western fence of No. 82, in Cliffe Pypard aforesaid, and continues up the western fences of Nos. 82, 81, 60, and 79, in Cliffe Pypard aforesaid, as far as the said parish of Wootten Bassett, as the whole of the foregoing is more particularly delineated on the plan hereunto annexed, and thereon coloured pink and blue (excluding, however, from the said consolidated chapelry, the Endowed Free Grammar School, and the grounds and premises belonging thereto, in the said parish of Cliffe Pypard):

"Your Majesty's Commissioners beg leave further to represent to your Majesty, that it has been mutually agreed between the patrons of the parish churches of the said parishes of Broad Hinton and Cliffe Pypard, with the approbation of your Majesty's said Commissioners, and with the agnsent of the Right Reverend Edward Bishop of

Salisbury, in whose diocese the said two parishes are situate, that the right of presentation, nomination, and appointment of an incumbent or perpetual curate to the said church of Christ Church and consolidated chapelry of Broad-town should, for one turn only, be vested in, belong to, and be exercised by the said Edward Bishop of Salisbury; and that, for ever afterwards, the same right of presentation, nomination, and appointment should be vested in, belong to, and be exercised by the vicars or incumbents for the time of the said parishes of Broad Hinton and Cliffe Pypard alternately, the vicar or incumbent of the said parish of Broad Hinton having the first or prior turn of presentation:

"That the consents of the said Edward Bishop of Salisbury, as bishop of the diocese in which the said parishes are situate, and of the Reverend George Ernest Howman, Master of Saint Nicholas-hospital, at Salisbury, the patron (in right of his office as master of the said hospital) of the parish church of the said parish of Broad Hinton, and of Horatio Nelson Goddard, of Cliffe Pypard aforesaid, Esq. the patron of the parish church of the said parish of Cliffe Pypard, have been severally obtained thereto, as required by the Act and section before mentioned; in testimony whereof, the said Edward Bishop of Salisbury, George Ernest Howman, and Horatio Nelson Goddard, have respectively signed and sealed this representation:

"Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed consolidation and assignment be made, and accordingly the agreement, respect of the right of presentation, nomination, and appointment of an incumbent or perpetual curate to the said church and consolidated chapelry, be carried into effect, agreeably to the provisions of the said Act. A PROCLAMATION.

VICTORIA, R.

HEREAS by our Order in Council of the nineteenth of May, in the present year of our Lord, one thousand eight hundred and fortysix, and in the ninth year of our reign, we were graciously pleased, for the reasons therein contained, to annul the Royal Proclamation of His late Majesty King William the Fourth of the third day of February one thousand eight hundred and thirty-six, directing that distribution should be made of the net proceeds of prizes captured from the enemy, of captures and seizures, under the several Acts passed relating to the revenues of Customs, and to trade and navigation, for the abolition of the slave trade, and for the capture and destruction of piratical vessels, and of the rewards conferred for the same, as well as of awards and allowances of salvage granted to the officers and men of ships and vessels of war, when not otherwise specially apportioned by the terms of the respective awards and allowances: and whereas in the recital of the said Order in Council in our Royal Proclamation, dated the said nineteenth day of May one thousand eight hundred and forty-six, the following words, that is to say, "as well as of "awards and allowances of salvage granted to the "officers and men of ships and vessels of war, when "not otherwise specially apportioned by the terms "of the respective awards and allowances," were by mistake omitted, and it is expedient that such mistake should be corrected: now, therefore, we do make known to all our loving subjects, and all others whom it may concern, by this our Royal Proclamation, by and with the advice and consent of our Privy Council, that our said Proclamation of the said nineteenth day of May one thousand eight hundred and forty-six shall have the same torce and effect, to all intents and purposes, as if the said words so omitted by mistake had been inserted therein.
