WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with certain modifications, the fourth report of the Commissioners of Ecclesiastical Duties and Revenues," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-first day of August, in the year one thousand eight hundred and forty-six, in the words following that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into effect, with certain modifications, the fourth report of the Commissioners of Ecclesiastical Duties and Revenues," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for making better provision for the cure of souls in the parish of Merrington, in the county and diocese of Durham.

"Whereas, upon the passing of the said recited Act, the deanery of the cathedral church of Durham being then vacant, all the estate and interest which the succeeding dean thereof would have had, if the said Act had not been passed (amongst other property usually held or enjoyed with the said deanery), in the tithes hereinafter particularly described, became, by virtue of the said Act, absolutely vested in us and our successors for the purposes of the said Act :

"And whereas it was by the said Act enacted that, except as therein otherwise specified, all the monies and revenues to be paid to us, and all the rents and profits of the lands, tithes and other hereditaments vested and to be vested in us by and under the authority of that Act, together with all accumulation of interest produced by and arising therefrom, should be from time to time carried over by us to a common fund; and by payments or investments made out of such fund, or if in any case it should be deemed more expedient

by means of an actual conveyance and assignment of such lands, tithes or other hereditaments, or of a portion thereof, additional provision should be made, by the authority thereafter provided, for the cure of souls in parishes where such assistance was most required, in such manner as by the like authority should be deemed most conducive to the efficiency of the Established Church; provided always, that in making any such additional provision out of any tithes or any lands or other hereditaments allotted or assigned in lieu of tithes so vested or to be vested in us, or out of the rents and profits thereof, due consideration should be had of the wants and circumstances of the places in which such tithes then arose, or had theretofore arisen :

"And whereas, after due consideration of the wants and circumstances of the said parish of Merrington, we have deemed it expedient to make additional provision for the cure of souls therein, in manner hereinafter mentioned :

"We, therefore, humbly recommend and propose, that all our estate and interest in the tithes of the township of Merrington, in the said parish of Merrington, or the rent charge or rent charges allotted or to be allotted in lieu thereof, shall forthwith and without any assurance in the law other than this scheme and any duly gazetted Order of your Majesty in Council, ratifying the same, become and be transferred to and absolutely vested in the Reverend John Tyson, the present Vicar of Merrington in the county and diocese of Durham, and his successors Vicars of Merrington, for ever.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London

Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Durham.

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry into effect, with certain modifications, the fourth report of the Commissioners of Ecclesiastical Duties and Revenues," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for making better provision for the cure of souls in the parish of Alton Pancras, in the county of Dorset, in the diocese of Salisbury.

"Whereas it was by the said recited Act enacted that, except as therein otherwise specified, all the monies and revenues to be paid to us, and all the rents and profits of the lands, tithes and other hereditaments vested and to be vested in us by and under the authority of that Act, together with all accumulations of interest produced by and arising therefrom, should be from time to time carried over by us to a common fund; and by payments or investments made out of such fund, or if in any case it should be deemed more expedient by means of an actual conveyance and assignment of such lands, tithes or other hereditaments, or of a

portion thereof, additional provision should be made, by the authority thereafter provided, for the cure of souls in parishes where such assistance was most required, in such manner as by the like authority should be deemed most conducive to the efficiency of the Established Church; provided always, that in making any such additional provision out of any tithes or any lands or other hereditaments allotted or assigned in lieu of tithes so vested or to be vested in us, or out of the rents and profits thereof, due consideration should be had of the wants and circumstances of the places in which such tithes then arose, or had theretofore arisen:

"And whereas, by reason of the vacancy of the respective prebends of Alton Australis and Alton Borealis, in the cathedral church of Salisbury and under the provisions of the said recited Act, all the lands and other hereditaments belonging to the said prebends are, subject to any legally subsisting leases thereof, now vested in us for the purposes of the said recited Act:

"And whereas the lands and hereditaments particularly described in the schedule hereunto annexed are part and parcel of the same lands and hereditaments:

"And whereas, by a certain arrangement duly carried out and perfected in law, to which the Governors of the Bounty of Queen Anne have been parties, the whole interest in and under certain subsisting leases of the said lands and hereditaments so described in the said schedule has been and now is transferred to and vested in the Reverend Robert Shittler, Clerk, Vicar of the said parish of Alton Pancras, and his successors Vicars thereof; and we have deemed it expedient to make additional provision for the cure of souls therein by assigning and confirming to the Vicar thereof our absolute interest in fee simple in the same lands and hereditaments:

"We, therefore, humbly recommend and propose, that all our estate and interest in the lands and hereditaments so described in the said schedule shall forthwith, and without any assurance in the law other than this scheme and any duly gazetted Order of your Majesty in Council ratifying the same, become and be vested in the said Robert Shittler, Vicar of the said parish of Alton Pancras aforesaid, and his successors Vicars of the said parish, for ever.

" And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matter aforesaid, in conformity with the provisions of the said recited Act or of any other Act of Parliament.

" SCHEDULE.

" All that plot, piece or parcel of ground allotted out or fenced off from a certain field called the Higher Field, or Eleven Acres, numbered 134 on the parish map, and forming part of the same field, containing, by admeasurement, one acre and thirty-five perches (more or less); and also all that cottage or dwelling-house called Collins's, with the plot, piece or parcel of garden ground thereto adjoining and belonging, numbered 124 on the said map, containing, by admeasurement, one rood and twenty-five perches (more or less); and also all that other plot, piece or parcel of ground commonly called or known by the name of Corner-field, or Proctor's-mead, and numbered 123 on the said map, containing, by admeasurement, three roods and ten perches (more or less), all which said hereditaments and premises are situate, lying and being in the parish of Alton Pancras aforesaid; and also all that the right of way in, over and upon a certain footpath, formerly used by the public but lately stopped up, leading through the said hereditaments and premises to the church of Alton Pancras aforesaid, for the said Robert Shittler, his successors and assigns, with full and free liberty for him and them to use and enjoy the same as he or they shall think fit."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Salisbury.

" We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled " An Act to carry into effect, with certain modifications, the fourth report of the Commissioners of Ecclesiastical Duties and Revenues;" and of another Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled " An Act to explain and amend two several Acts relating to the Ecclesiastical Commissioners for England;" and of another Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled " An Act to make better provision for the spiritual care of populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for substituting a money payment to the prebendary of the prebend of Langford Ecclesia, in the cathedral church of Lincoln, for certain property belonging to him as such prebendary, and also for authorizing the sale of a portion of

such property and of certain other property lately belonging to the prebend of Langford Manor, in the same cathedral church.

“Whereas, under the provisions of the first and secondly recited Acts, the whole of the property belonging to any prebend not residentiary in any cathedral church in England (excepting any right of patronage) becomes, upon the first avoidance of such prebend, absolutely vested in us for the purposes of the said Acts; and the chief of such purposes is that of making better provision for the cure of souls in parishes where such assistance is most required :

“And whereas it is by the same Acts enacted, that, by the authority therein provided, and for the purpose of fully carrying into effect any of the provisions thereof, any arrangement may from time to time be made, with the consent in writing under the hand of any prebendary of any cathedral church, for the sale, transfer, or exchange of any lands, tithes, or other hereditaments belonging to such prebendary, or for the purchase of other lands, tithes, or hereditaments in lieu thereof, or for substituting in any case any lands, tithes, or other hereditaments for any money payment,—or any money payment for any lands, tithes, or other hereditaments :

“And whereas the property now belonging to the prebend of Langford Ecclesia, in the cathedral church of Lincoln, consists, amongst other things, of certain lands, tenements, and other hereditaments in the counties of Berks and Oxford, which have been from time to time and now are demised by leases for lives :

“And whereas the following arrangement, for substituting a money payment for such property as aforesaid, appears to us and to the Reverend Richard Pretyman, the present Prebendary of the said prebend of Langford Ecclesia, to be expedient, with a view to sooner carrying into effect the purpose of the said Acts hereinbefore particularly mentioned; and, after full inquiry and calculation, we and the said Richard Pretyman are satisfied that such money payment should be the annual sum hereinafter mentioned to be paid by us to him during his incumbency of the said prebend :

“We, therefore, with the consent of the said Richard Pretyman, testified by his having signed this scheme, humbly recommend and propose, that,

without any other conveyance or assurance in the law than this scheme, and any duly gazetted Order of your Majesty in Council for ratifying the same, and upon and after the day of such gazetting, all lands, tithes, tenements, and hereditaments whatsoever (except any right of patronage) now forming the endowment of the said prebend of Langford Ecclesia, or which shall now belong to the same, or to or in which he, the said Richard Pretyman, as such Prebendary, has, or ought to have, any right, title, or interest, together with all right, title, and interest therein, shall be, and be held to be, for the consideration hereinafter mentioned, transferred and conveyed from and by the said Richard Pretyman to us, and shall then and thereupon become and be absolutely vested in us for the purposes of the said Acts, subject only to any now legally subsisting lease or leases thereof, or of any part or parts thereof; and that, in consideration of and for such transfer and conveyance as aforesaid (provided that no renewal of any such lease, nor any new lease of the lands, tithes, tenements, and hereditaments last aforesaid, or of any part thereof, shall, after the day of the date of this scheme, be granted or made by the said Richard Pretyman), there shall be paid by us to the said Richard Pretyman, in each and every year, so long as he shall continue to hold the said prebend of Langford Ecclesia, and no longer, the annual sum of two hundred and sixty pounds, by equal half-yearly payments, on the twenty-first day of February and the twenty-first day of August, the first such payment being made on the twenty-first day of February next; and that if the next avoidance of the said prebend shall happen on any other day than one of the two regular half-yearly days of payment, then a proportionate sum only shall be paid to the said Richard Pretyman, or his representative or representatives.

“And whereas by reason of the vacancy of the said prebend of Langford Manor in the same cathedral church, on the day of July, in the year one thousand eight hundred and forty-four, all the property and endowments, formerly belonging thereto, are now, under the provisions of the same Acts, vested absolutely in us for the purposes thereof :

“And whereas it is by the thirdly-recited Act enacted, that all the same and the like powers

and rights of ownership, as are possessed and enjoyed respecting and over any lands, tenements, or other hereditaments whatsoever by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent charges, tenements, and other hereditaments vested and liable to be vested in us under certain Acts therein mentioned (being the Acts hereinbefore mentioned), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us by proper instruments, in writing, duly executed according to law; with a proviso, that none of such lands, tithes, tenements, or other hereditaments as aforesaid be sold, transferred, or conveyed except by the authority of a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying the same :

“ And whereas the lands, tenements, hereditaments, and premises, described in the schedule hereunto annexed, marked A, form a portion of the property and estates of the prebend of Langford Ecclesia aforesaid, and the lands, tenements, and premises, described in the schedule hereunto annexed, and marked B, lately formed a portion of the property and estates of and belonging to the prebend of Langford Manor aforesaid, now so vested in us as aforesaid, subject only to the determination of certain leases thereof for lives:

“ And whereas a negotiation is now pending between us and William Vizard, of New-street, Spring-gardens, in the county of Middlesex, Esquire, for the sale to him of all our estate and interest in all the said lands, tenements, hereditaments, and premises, so described in the said two several schedules, marked A and B :

“ We, therefore, further recommend and propose, that we may be authorized to sell and duly to convey to the said William Vizard, or as he shall direct or appoint, and for such consideration as may be agreed upon, all our estate and interest in the same lands, tenements, hereditaments, and premises, or any part or parcel thereof.

“ And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, in conformity with the said recited Acts, or any other Act of Parliament.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of His late Majesty's reign, intituled "An Act for carrying into effect the reports of the Commissioners appointed to consider the state of the Established Church in England and Wales, with reference to ecclesiastical duties and revenues, so far as they relate to episcopal dioceses, revenues, and patronage," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-ninth day of April, in the year one thousand eight hundred and forty-six, in the words following, that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for carrying into effect the reports of the Commissioners appointed to consider the state of the Established Church in England and Wales, with reference to ecclesiastical duties and revenues, so far as they relate to episcopal dioceses, revenues, and patronage," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for carrying into effect certain alterations in the dioceses of Oxford and Salisbury.

"Whereas it was by the said Act provided, that the diocese of Oxford should be increased by the county of Buckingham, then in the diocese of Lincoln, and by the county of Berks, then in the diocese of Salisbury ; and that such variations should be made in the proposed boundaries of the different dioceses as might appear advisable, after more precise information respecting the circumstances of particular parishes or districts :

"And whereas it was by the same Act enacted, that it should be competent to us to propose, in any scheme prepared and laid before your Majesty in Council under the provisions thereof, that all parishes, churches, or chapelries locally situate in

any diocese, but subject to any peculiar jurisdiction other than the jurisdiction of the bishop of the diocese in which the same were locally situate, should be only subject to the jurisdiction of the bishop of the diocese in which the same were locally situate :

"And whereas by an Order of His said late Majesty in Council, bearing date the fifth day of October, in the year one thousand eight hundred and thirty-six, and duly registered and gazetted, it was provided, that the whole county of Berks, and those parts of the county of Wilts which were insulated therein, forming together the archdeaconry of Berks, and part of the diocese of Salisbury, should be forthwith absolutely detached and dissevered from the said diocese, and permanently annexed and united to and included in and should form part of the said diocese of Oxford :

"And whereas by an Order of your Majesty in Council, bearing date the nineteenth day of July, in the year one thousand eight hundred and thirty-seven, also duly registered and gazetted, it was provided that, upon the first avoidance of the see of Oxford, the whole county of Buckingham, forming the archdeaconry of Buckingham, and part of the said diocese of Lincoln, should be absolutely detached and dissevered from the said diocese, and permanently annexed and united to and included in and should form part of the same diocese of Oxford :

"And whereas another Order of your Majesty in Council, relating, amongst other dioceses, to the said diocese of Lincoln, but not to the said diocese of Oxford, which Order bore date the eighth day of August, in the year one thousand eight hundred and forty-five, and was duly gazetted, contained certain provisions relating to the same county and archdeaconry of Buckingham, then in the said diocese of Lincoln ; but the said provisions were not to come into operation until the first day of this present year ; and, in the mean time, the said county and archdeaconry became transferred from the said diocese of Lincoln to the said diocese of Oxford, under the secondly herein-mentioned Order, upon and by the avoidance of the last-mentioned see in the month of November in the same year one thousand eight hundred and forty-five :

" And whereas the parishes of Hungerford and Chilton Folliatt are locally situate partly in the said county of Berks and partly in the said county of Wilts; and although the church of the said parish of Hungerford is in that part of the same parish which is locally situate within the county and archdeaconry of Berks, and the church of the said parish of Chilton Folliatt is in that part of the same parish which is locally situate within the county and archdeaconry of Wilts, doubts have been suggested respecting the episcopal jurisdiction over those parts of the said parishes which are locally situate within the other of the said two counties respectively :

" We, therefore, humbly recommend and propose, that it be declared and provided that the whole of the said parish of Hungerford, and the clergy and others therein, are and shall be in the diocese of Oxford and archdeaconry of Berks, and subject only to the jurisdiction and authority of the Bishop of Oxford and the Archdeacon of Berks for the time being; and that the whole of the said parish of Chilton Folliatt, and the clergy and others therein, are and shall be in the diocese of Salisbury and archdeaconry of Wilts, and subject only to the jurisdiction and authority of the Bishop of Salisbury and the Archdeacon of Wilts for the time being.

" And we further recommend and propose, with the consent of the Right Honourable and Most Reverend William Archbishop of Canterbury, so far as relates to the peculiar jurisdiction of the Archbishop of Canterbury in and over certain parishes and places locally situate within the said diocese of Oxford, and of the Right Honourable and Right Reverend Charles James Bishop of London, so far as relates to the jurisdiction of the Bishop of London and the Archdeacon of Saint Albans in and over certain parishes and places locally situate within the said county of Buckingham, which consents are testified by their having respectively signed and sealed this scheme, that upon and after the twenty-first day next after the day upon which any Order of your Majesty in Council, ratifying this scheme, shall be published in the London Gazette, all parishes and places locally situate within the limits of the said several dioceses of Oxford and Salisbury, and of the several archdeaconries thereof respectively,

and all churches and chapels, and the whole clergy and others your Majesty's subjects, locally situate within the limits of such parishes and places respectively, shall, notwithstanding any peculiar or other ecclesiastical jurisdiction or exemption from jurisdiction which any of such parishes, places, churches, chapels, or clergy may now possess or be subject to, or claim to possess or be subject to, be respectively under and subject only to the jurisdiction and authority of the bishops of the said two several dioceses and the archdeacons of the several archdeaconries of such several dioceses within the limits of which several dioceses and archdeaconries they shall respectively be so locally situate; except that the cathedral churches of and within the said several dioceses, and the royal residence and your Majesty's free chapel of Saint George within your Majesty's castle of Windsor, shall respectively remain and be subject to the jurisdiction and visitation, if any, to which they are now by law respectively subject, and to none other; and we further recommend and propose, that, with the like exceptions, all and each of such parishes, places, churches, and chapels so possessing or being subject to, or claiming to possess or be subject to, any such peculiar jurisdiction or exemption from jurisdiction, and all other parishes, places, churches, and chapels locally situate within the said several dioceses, shall severally and respectively be included in and form part of the dioceses and archdeaconries respectively within the limits of which they shall respectively be so locally situate; provided always, that nothing herein contained shall in any manner prejudice or affect any rights, privileges, or exemptions of the University of Oxford, or of any college or hall thereof, except so far as relates to the exercise of any ecclesiastical jurisdiction, by any such college or hall or the head thereof, over any parish or the churches or chapels of such parish or the clergy or others within the same; provided also, that nothing herein contained shall deprive the collegiate church and parish of Eton of their present exemption, if any, from the jurisdiction of the archdeacon of Buckingham.

" And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures

relating to the matters aforesaid, or any of them, in conformity with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrars of the several registries of the dioceses of Canterbury, London, Lincoln, Oxford and Salisbury.

DISPATCHES have been received, at this Office, from Rear Admiral Sir Thomas Cochrane, C.B. addressed to the Secretary of the Admiralty, of which the following are copies :

Spiteful, off the city of Brune,
SIR, *Borneo Proper, July 9, 1846.*

I REQUEST you will inform my Lords Commissioners of the Admiralty, that, for the reason assigned in a separate dispatch, I determined with a competent force to ascend to the city of Brune, and call upon the Sultan for an explanation of his conduct with regard to the atrocities attributed to him.

Neither the *Dædalus* nor *Pluto* having joined me from Hong Kong, I made the necessary dispositions of the force at my command, as more fully detailed in the accompanying programme.

I had received information that the approach to the island of Cherimon was defended by two batteries, and that five others were planted at the narrows formed by the island of Bungore and the right bank of the river, and that three heavy batteries protected the city.

While the arrangements for the expedition were in progress, I, accompanied by Mr. Brooke,

reconnoitred the isle of Cherimon, and found that although there was one battery of five guns established on it, and four guns on Pulo Coin Arrang admirably placed for enfilading the approach over the bar, which lies immediately in front of and close to them; they were, however, not perfected, and both islands were abandoned; and as I had no distinct authority for considering that these batteries were intended to act hostilely towards us, I in no manner interfered with them, either by spiking or otherwise injuring the guns.

On my return on board, I received a letter from the Sultan, of which the accompanying is a translation, having attached to it the seals of Pangeran Muda Mahomed, legitimate son of the late Sultan, and that of Pangeran Moumein, in addition to his own. These seals Mr. Brooke believed to be forgeries; the letter, however, neither prohibited an approach by an armed force, nor threatened resistance if it did so.

On the 7th instant, I hoisted my flag on board this ship, commanded by Commander William Maitland, and taking in tow the *Hazard* and *Royalist*, and preceded by the *Phlegethon*, ascended the river to Cherimon; but it was not till yesterday morning I was enabled to overcome the difficulties of the bar, and was then obliged to leave the *Hazard* aground upon it.

Having my whole available force collected, I proceeded towards the city, which lies about nine miles up a very picturesque river. The *Phlegethon* led, for the purpose of sounding its intricate approaches, having in tow the gun-boats; the *Spiteful* followed, towing the *Royalist*; and astern of her, the boats intended for landing the seamen and marines.

On approaching Pulo Bungore, five forts opened to view, admirably placed for denying a passage beyond them, two were erected on our right hand, one on the left shore over the narrow formed by Pulo Bungore and the main, and the largest of the whole on the side of a hill, elevated about one hundred feet (immediately in front of the narrows), and which sandbanks compel you to stand directly for, and to pass within from seventy to eighty yards; the fifth battery was further up the river on the same side.

Shortly after we were discovered, the fifth battery fired a gun, and within a few minutes the largest hoisted a flag, which Mr. Brooke informed me was the flag of our friend, Muda Hassin, who had been murdered; and we were in doubt whether this was not intended as an intimation that we should be received as friends; we were not however left long in suspense upon this subject, as the moment the *Phlegethon* had passed the narrows, the battery commenced a spirited fire, which was promptly returned; the gun-boats, commanded by Captain Mundy, of the *Iris*, and assisted by Lieutenant G. E. Patey, First Lieutenant of the *Agincourt*, with rapidity cast off from the steamer, formed in a line, and opened their fire, and so soon as the enemy's fire had slackened, pushed for the shore, and gallantly mounted the steep ascent

to the fort, but from whence the garrison retreated precipitately, leaving the Sultan's flag to be hauled down by the assailants.

Being anxious to proceed to the city and finish my operations against it before dark, I only gave Captain Mundy time to spike the guns and throw them over the walls, and blow up the magazine, when I proceeded to my main object.

Aware that the Sultan had a heavy battery, a fleur d'eau, pointing directly down to a bend of the river, from which it was distant about eight hundred yards, and round which we must turn, and understanding that he had heavy works on the hills not far in the rear, I anchored immediately behind the point that protected us from them, to make my final arrangements for landing, &c. &c. These arrangements were, however, overturned by the violence of the ebb tide, which set down the river with a rapidity against which a row boat could with difficulty contend. I was therefore under the necessity of towing both gun boats and the division for landing; the former by the Phlegethon, and the latter by the Spiteful.

Having given the people their dinners, I again weighed, and no sooner did the ships open the point, than the batteries commenced a sharp and extremely well directed fire, and at the same time a play of musketry from the woods on our right, and to which the Spiteful was obliged to submit without retaliation. The critical situation in which she was placed (with the beach but a few yards beyond her paddle boxes, the Royalist in tow, and the boats filled with the whole of the landing force), requiring the utmost silence and attention to prevent the whole being thrown on shore. But the Phlegethon very promptly returned the fire from her own guns, which, with the battery of field pieces placed round her bows, and the admirable fire from the brigade of rockets planted upon her bridge (both field pieces and rockets under the immediate command of Lieutenant Paynter), together with the now rapid progress of the whole force directly up the river, so astonished and dismayed the enemy, that they fled before the steamers could reach their works, or the storming party carry out the service intended for it. As quickly as possible the landing was effected, and the marines, under Captain Hawkins, immediately took possession of the heights which command the town.

The battery, fleur d'eau, was found to consist of eight brass and two iron guns, from sixty-eight to nine pounders, as more particularly detailed in the accompanying schedule. The one upon the heights immediately above it, of four guns, nine and six pounders, and four more upon another height commanding the latter, and a hundred yards in the rear of it; the whole are now in course of embarkation.

I much regret to add, that this service was not accomplished without loss, two men being killed and seven wounded; and the Phlegethon received several shot through her hull, and other damages in her paddle box, cooking boilers, &c. and which are now in course of repair.

So soon as the preliminary arrangements were made for the security of the city, I despatched Captain Mundy with the gun boats to destroy the five forts we had passed, and which he effected the same evening, having disabled seventeen iron, and brought away three brass guns.

The Sultan, I am informed, has fled into the interior with a large body of men, and many guns. I am now preparing a force to send in pursuit of him, so soon as I have accurate information of his place of retreat.

The gratifying duty now devolves on me, of assuring their Lordships of the zeal and devotion to the service of every individual I had the honour to have under my command. I have already mentioned the name of Lieutenant Patey, the First Lieutenant of the Agincourt, as second in command under Captain Mundy in the gun boats, and of whom Captain Mundy speaks in the highest terms; and I must bring to their Lordships' notice Lieutenant Paynter, the gunnery Lieutenant of the same ship. He was Adjutant of the landing party, and also commanded the rocket brigade at Malloodo Bay last year, and the field piece and rocket brigades on the present expedition. On every occasion that his services have been required, I have remarked his zeal and intelligence, and to his assiduity and attention is mainly to be attributed the present state of gunnery discipline of the Agincourt, and the precision with which the field pieces, and particularly the rockets, were fired, affords a practical proof of the value of his instructions.

Upon two former services, Captain Hawkins has commanded the marines, amounting on this occasion to nearly 200 men, and the same zeal and attention has marked his conduct in the present, as in every former instance; and I have invested him with the charge of the protection of the town.

I must not omit to mention the care and assiduity displayed by Mr. J. E. Elliott, the Master of the Agincourt, in sounding the various intricacies of our approach, and preparing himself for the responsibilities of a pilot in a part hitherto unknown to him.

Although I have thus extremely limited the list of Officers brought prominently before their Lordships, I trust their Lordships will not for an instant believe that such restriction arises from insensibility to the merits of all engaged; but where zeal has been general and equal, I feel a delicacy in drawing attention to one to the exclusion of another. Their Lordships will have before them the programme already referred to, containing the name of every Officer employed, and the duties assigned him; and I have the authority of the Captains and Officers under whom they served, for assuring their Lordships, that one principle of zeal and devotion influenced the whole.

The Phlegethon, Honourable East India Company's steamer, commanded by Mr. R. S. Ross, was placed under my command, as their Lordships are already aware, by the Governor of

the Streights; and it is a pleasing duty I have to perform, in assuring their Lordships that the good opinion I had already formed of this Officer, when formerly under my orders in China, has, through his great zeal and activity, been fully maintained on the present occasion; and that it is my intention to make a similar communication to the Governor-General of India.

I may not close this dispatch without conveying to Mr. Brooke, through its medium, my best thanks for the solicitude he has manifested for the success of the expedition, and the kind and important assistance I have received from him towards securing its favourable result; and I feel persuaded I shall not be disappointed in my expectation, that he will cheerfully permit me to draw still further upon his services.

Rear-Admiral and Commander-in-Chief, compliments, &c.

THIS letter is from Sultan Omar Ali Saifudee, who is sitting upon the throne of the kingdom of Borneo and its dependencies, together with the under-mentioned Nobilities belonging to the said kingdom, viz., Pangeran Muda Mahomed, Pangeran Moumein, Pangeran Tuzzoodim, Pangeran Hassim, Pangeran Mat Sallay, Pangeran Khahar, Pangeran Bahar and all his sons, Pangeran Sora, Pangeran Sariam, Pangeran Bedurudeen, Pangeran Hassim, and all the Rajahs under them.

We are happy to learn that our friend has arrived, and in consequence we send a small boat to meet our friend James Brooke, Esq., Pangeran Muda Mahomed sends many compliments, and wishes to state some particulars about a ship which lately came to Borneo. When the news arrived in the city, within four or five hours afterwards the Sultan ordered a boat with two Pangerans, the chief of whom was Pangeran Sora, and Pangeran Hashim. On arriving at the ship they met the captain, and on finishing their conversation with him they requested leave to return, and the captain remarked—"at eight o'clock to-morrow I shall come up and meet the Sultan."

The Sultan was pleased to learn this, and waited two days without the captain coming, therefore he sent a boat with two Pangerans with a present of a bullock and fowls, and the provisions of the place. On arriving at the ship the captain would not receive them, and ordered them to return, not allowing them to approach.

On her returning to the city the Sultan required the news, and was very sorry, as was likewise the Pangeran Muda Mahomed, that the boats and presents of the Sultan had not been received. A follower of the Pangeran Bedurudeen, by name Si Japper, whom the Pangeran Muda Mahomed wished to detain, fled to the ship, and it was in consequence of this the captain did not receive the boat, because he was very angry. The Pangeran

Muda Mahomed, with many compliments, requests our friend not to believe any thing Si Japper may have stated. Even the Sultan himself our friend cannot believe, without being certain of the facts from the other Rajahs, the Ministers and Nacodahs, and the people in general.

With our compliments we state our friend can consider the facts.

THE following arrangements are intended for carrying out the service on which the squadron is about to be employed, viz., the landing party to comprise the marines and small arm men of Her Majesty's squadron:—

Agincourt—seamen, 186.

Iris—seamen, 64.

Hazard—seamen, 50.

Ringdove—seamen, 40.

Royalist—seamen, 20.

Spiteful—seamen, 40.

Total number of bayonets, 600.

List of the boats of the squadron that are to land the marines and small arm men:—

Spiteful's paddle box boats, 2 boats, 8 boat keepers, 130 marines and small arm men.

Agincourt's pinnace, 1 boat, 2 boat keepers, 46 marines and small arm men.

Agincourt's cutters, 2 boats, 4 boat keepers, 48 marines and small arm men.

Iris's cutters, 2 boats, 4 boat keepers, 48 marines and small arm men.

Ringdove's cutter, 1 boat, 2 boat keepers, 20 marines and small arm men.

Hazard's cutter, 1 boat, 2 boat keepers, 20 marines and small arm men.

Phlegethon's cutters, 4 boats, 4 boat keepers, 74 marines and small arm men.

Total—13 boats, 26 boat keepers, 386 marines and small arm men.

As the boats cannot land all the force at one landing, it is to be disembarked in the following order:—

1st. All the marines.

2d. Agincourt's seamen.

3d. Iris, Ringdove, Hazard, and Royalist's.

The boats, after landing the first party, will return with all expedition for the remainder.

Field Pieces, Mortar and Rocket Battery.

Field Pieces.—Agincourt, 1 six-pounder, 10 men.

Iris, 1 six-pounder, 10 men. Spiteful, 1 twelve-

pounder howitzer, 10 men. Phlegethon (N.B.), these field pieces to be manned by the Agincourt's men, 2 six-pounders, 20 men.

Total—5 six-pounders, 50 men.

Mortar — Agincourt, 1 twenty-four pounder, 6 men.

Rocket Tubes—Agincourt, 2 twenty-four pounders, 26 men. Phlegethon's tubes (these tubes are manned by the Agincourt's men), 3 six-pounders, 18 men. Agincourt's tubes (these tubes are manned by the Iris's men), 2 three-pounders, 8 men.

Total—7 guns, 108 men.

To land Field Battery.

Ships' Boats :—

Spiteful's spare boat lands 2 field pieces, 1 six-pounder rocket.

Spiteful's first cutter lands 1 twenty-four pounder rocket, and 1 six-pounder.

Spiteful's second cutter lands 1 twenty-four pounder rocket, 1 six-pounder rocket.

N.B. These field pieces and rocket tubes to be landed at the same time as the marines.

Agincourt's pinnace and cutter, after landing small arm men, to return for field pieces on board Phlegethon, 2 field pieces.

Iris's cutter, after landing small arm men, to return and land her field piece from Phlegethon, 1 field piece.

Phlegethon's boats, on returning to land Iris's rocket tubes and men, 2 three-pounder rockets.

Total—5 field pieces, 7 rockets.

Gun Boats :—

Agincourt's launch, 1 twenty-four pounder howitzer, 19 men.

Agincourt's second barge, 1 eighteen-pounder carronade, 15 men.

Iris's barges, 2 twelve-pounders carronade, 26 men.

Spiteful's barge, 1 twelve-pounder carronade, 13 men.

Ringdove's pinnace, 1 twelve-pounder carronade, 13 men.

Hazard's pinnace, 1 twelve-pounder carronade, 13 men.

Total—7 guns, 99 men.

The whole of the marines to be embarked on board the Spiteful.

The Agincourt's small arm men to be embarked on board the Spiteful.

The rocket, mortar, and field-piece batteries and men to be embarked on board the Phlegethon.

The Iris's small arm men to be embarked on board the Royalist.

The seamen of the Ringdove will be assigned a ship, on ascending the river and quitting their own.

The gun boats and crews will be assigned a ship as a rendezvous.

One gig is to be in attendance from each ship.

If the gun boats are not required, they will be employed in landing marines and small arm men, and their crews are to join their respective companies.

The landing-boats, when required to row, to be manned temporarily from such division of seamen as can at the moment be spared.

Each boat, on landing the force, to be supplied with the number of boatkeepers assigned to it, and to be under the orders of the beachmaster, to whom the names of the boatkeepers are to be given; and the beachmaster will take particular care that the boats are kept afloat, and properly arranged, and that on passing and repassing between the ships and the shore, due arrangement is observed, and the duty performed with the utmost alacrity.

Two days' provisions for each person to be cooked on board their ships, when the signal is made for that purpose.

The Agincourt is to supply the Phlegethon with one week's provisions for one hundred men.

Each marine to have sixty rounds of ball cartridge in his pouch.

Each seaman thirty ditto.

Each gun-boat to carry one hundred rounds of shot, and as much ammunition for that number as the magazine will contain, the remainder to be sent on board the Spiteful, together with the reserve ball cartridge ammunition, to the extent of thirty rounds for each man; one hundred rounds of ammunition for each field piece, and the whole of the rocket ammunition.

The marines to be under the immediate command of Captain Hawkins.

The whole of the seamen, small arm men, field piece and rocket parties, to be under the command of Captain Johnstone, assisted by Commander Egerton.

The fieldpiece and rocket brigade to be under the immediate command of Lieutenant Paynter, assisted by Lieutenant Heath.

The gun-boats to be under the command of Captain Mundy, assisted by Lieutenant Patey.

Doctor Reid to superintend the medical department.

One assistant surgeon from the Agincourt to be attached to the marine brigade.

Dr. Anderson to attend the Agincourt's seamen.

One medical officer from the Hazard, Ringdove, and Spiteful, to attend the seamen, small arm men.

The divisions of small arm men are each to be commanded by a Lieutenant.

Lieutenant Hankey, of the Hazard, to be beachmaster.

The landing party to take their flannels and one blanket with each man. The officers may wear round jackets, hats or caps, and either cloth, flannel or duck trousers, as they please, boots or shoes, gaiters, &c.

The whole under the orders of the Commander-in-Chief.

SIR, *Spiteful, River Bruné,

HAVING received such information as to the retreat of the Sultan, as to hold out some hope of his capture, I directed Captain Mundy to take under his command, in addition to the gun-boats, one hundred and fifty marines, and a detachment of seamen, small-arm men and rocket party, and to proceed in the direction pointed out to him in pursuit of his Highness.

I have the honour to inclose a letter I have received from Captain Mundy, narrating his proceedings during a period of six days; and although the object of our pursuit has escaped us, it has offered an opportunity for the display of further zeal and cheerful obedience on the part of the officers and men, in a situation altogether novel to them; and afforded a gratifying proof of what their conduct would have been had their exertions been rewarded by the presence of an enemy.

*Honourable Company's steam vessel Phlegethon,
off City of Borneo, July 19, 1846.*

SIR,

I HAVE to acquaint your Excellency, that on the morning of the 10th instant I moved up the river Borneo, with the force which you did me the honour to place under my command; the strength of which, including the gun-boat division, I herewith annex (A).

Having understood from your Excellency that it was the intention of Mr. Brooke to accompany the expedition, the main object of which was to endeavour to penetrate into the interior as far as the village of Damuan, distant about thirty miles from this city, where it was reported the Sultan had fixed his head quarters, and with a body of five hundred men was determined to make a stand; I consulted Her Majesty's agent as to the best mode of carrying out your orders; and he coinciding in my opinion, that as rapid a march as possible should be made towards the Damuan district, I decided on carrying this plan into effect as soon as we could discover a place of disembarkation.

As your Excellency accompanied the expedition ten miles up the river, I shall commence my report from that time.

The boats, nineteen in number, containing nearly 500 men, on parting company with your Excellency, at 10 A.M., continued to ascend the river for half a mile, when they turned abruptly into a small creek on the left bank, which the native guides assured Mr. Brooke led to a village called Kabirun Battoo, where Hadji Assim, an adopted son of the Sultan, and one of the principal enemies of civilization, had retreated the day before the capture of the city.

After paddling and tracking the boats for three hours through intricate windings, with mangrove swamps on either hand, and overhanging trees level with the water's edge, affording constant work for our pioneers, and, owing to the rapid current, presenting considerable difficulty to the advance, particularly of the paddle-box boats laden with the detachment of royal marines, we finally gained a landing-place, the depth of water admitting the division of boats of the greatest draught to maintain their stations.

Having disembarked the party, we commenced our march without loss of time; a body of marines, forty strong, under the orders of Lieutenant Alexander, R.M.A., and a detachment of pioneers, advancing through the jungle in Indian files, about a hundred yards in advance of the main body, Mr. Brooke, myself, and two guides accompanying former. After a walk of twenty minutes, to our great surprise, the guides informed us that on emerging from the jungle we should be close on the village of Kuberan Battoo. This report we found correct; and having gained the open ground, I threw out flanking parties to the right and left, and surrounded the principal mansion—a building of considerable size, erected on piles, according to the Dyak fashion. It turned out to be deserted by the owners, but was full of valuable property

secured in massive chests; also arms, ammunition, &c., both for great guns and small arms, and several tin cases of fine English powder; and a villager who was subsequently brought in confirmed the deposition of our guides that the whole property belonged to Hadji Assim, who, two days previously, on a requisition from the Sultan, had joined His Highness at Damuan.

Our Kadyan prisoner, after some persuasion, next informed us that there was a battery in course of erection close at hand in the jungle for the protection of the causeway leading to the house, I therefore ordered Lieut. Mathews, commanding the seamen, small arm men of the Iris and Royalist, to reconnoitre with one of our guides; and he shortly returned with the report, that six pieces of brass ordnance of considerable dimensions were raised on an adjoining eminence in readiness for mounting, and that they completely commanded the path from our place of landing; these I took possession of and delivered over to the charge of Lieut. Patey, who, with a party from the gun boats, was ordered to guard the village and hold it for the main body of the expedition to fall back on.

At three P.M. we commenced our march from Kabiran towards Damuan, the rain falling heavily, and before the rear-guard had cleared the village we entered a marshy swamp, having apparently a broad buffalo path through which we moved on knee deep in mud. As we slowly advanced the swamp gradually deepened, the men were occasionally up to their middle in water floundering in the mud, and with difficulty keeping their ammunition dry; after struggling for an hour against such an unpromising road, and seeing in the distance no prospect of rising ground, moreover having in the mean time learnt from the natives that Damuan would be easier got at by returning to Borneo and ascending another creek, and being otherwise suspicious of our guides, I informed Mr. Brooke of my determination not to proceed further, as I considered it under all the circumstances of our position, in an unknown country and amongst hostile tribes, imprudent to attempt a further advance, I consequently ordered a retreat on Kabiran, where we bivouacked for the night amongst musquitoes and torrents of rain.

The following morning (July 11th), the expedition was again in movement at an early hour in two divisions, and the seamen under Lieut. Mathews reached a Kadyan village after two hours march, when, finding the pathway even more inaccessible from the rain of the previous night, and the guides constant in their statement by pointing to the sun that Damuan was yet six hours distant with, in some parts, passages over a country breast-high in water, I reluctantly gave up all hopes of reaching the Sultan's retreat by this route, and being convinced that my proper course was to fall back upon head quarters, and from thence to retrace our steps to the ships off Borneo, where I might replenish provisions and make a fresh start, should your Excellency approve of the plan. I informed Mr. Brooke of my decision, and having destroyed all the magazines,

ammunition, and property belonging to Hadji Assim, and conveyed the brass ordnance, which were Spanish guns of great beauty, into the boats, I re-embarked at one P.M.; on getting clear of the Creek, I had the pleasure of finding your Excellency in the main branch of the river, and I trust I may be allowed to express the gratification experienced by Mr. Brooke and myself at your consideration in bringing up the Phlegethon to assist our return, and also how gratified I felt at your approval of my proceedings, and at your giving me orders to prosecute the original plan by the other route, should Mr. Brooke's information obtained at Kabiran receive further confirmation.

On our arrival at the capital, the result of the inquiries made on the subject were so decidedly favourable, as to induce Mr. Brooke to request that your Excellency would give directions for the expeditionary force to make a second attempt by the new route; and having received your orders to this effect, I started again from Bruné at 6.30 A.M. on the 13th, giving the people the previous day (Sunday) to rest.

The detachment of marines carried sixty rounds in their cartouche-boxes, the small arm party thirty rounds, with a hundred rounds of spare ammunition for each bayonet in the boats. Four days provisions were issued to each man, two being cooked and carried in the haversacks.

On leaving the city, instead of proceeding several miles up the river, as on the former occasion, we took the first large branch on the left bank, not a mile distant from the shipping, and continued ascending that stream in a south-westerly direction, with occasionally only four feet at low water till noon, when we entered the Damuan river, and half an hour afterwards pushed into a creek of a similar character to that leading to Kabiran, but more difficult of access, as was proved by the launch being unable to make any progress. At one P.M. the leading and smaller boats effected a landing at a place which, we were informed by some natives taken from their canoes, was called Palihong, and that a road led from thence direct to Damuan, distant a march of twelve hours. A closer inspection, however, showed us that a morass, rendered impassable by the continued heavy rain of the last week, lay between us and the higher jungle ground.

At this unpleasant juncture of affairs, Mr. Brooke was assured that, by retracing our steps into the Damuan river, and then ascending it for a few miles, we should find another creek leading to the village of Malbout, which village was on the road to Damuan, and through which the force must have passed had it been able to prosecute the journey by land from Palihong. Our boats were accordingly retracked to the creek's entrance, and then moved up the Damuan river, in itself so confined at this part as to preclude our advance without the constant aid of our pioneers, who, in three cutters ahead under that efficient Officer, Lieutenant Heath, cleared the passage.

At three P.M. we entered the second creek, which was even more intricate than the last; and finally,

at 4:30, after being ten hours at the paddles, we reached the edge of a swamp, which our guides informed us was the quay of Malbout.

I may here be allowed to express my great disappointment at such a termination to the maritime part of our expedition, and also to confess that I felt very great doubts as to the fidelity of our guides. The country, so far as the eye could trace, was one sheet of water, terminating in a jungle, the nearest angle of which might be a quarter of a mile distant. To this point I determined to direct our steps; and, accompanied by Mr. Brooke, with a guard of forty marines under Lieutenant Mansell, and by Lieutenant Vansittart, whom you kindly allowed to act as my aide-de-camp, we pushed on rapidly in the hope of discovering firm ground for the force to encamp on. The march as usual was knee deep, but on entering the jungle we discovered a tolerable path with a gentle rise, and half an hour's walk brought us to the promised village, which, with the exception of a few individuals, was entirely abandoned.

I despatched Lieutenant Vansittart to the boats to desire that the marines and the seamen of the marching party should be landed forthwith, and endeavour to get up before dark, leaving such of the gun-boats as had been able to penetrate the labyrinth of the creek to guard the provisions and spare ammunition. At this time the rain fell heavily, but the houses were fortunately waterproof; and being, moreover, built on piles, moderate shelter was afforded to the detachments as they arrived; and by seven P.M. all the force was collected, and I received a report from Lieutenant Patey that the gun-boat division was all right.

Having detained some of the natives with a promise that their property should be protected if they would guide us to the Sultan's retreat, we enlisted three into our service, who appeared desirous of accepting the terms. These men assured Mr. Brooke that the Sultan, with a large body-guard, had passed up the river Damuan a week ago, and that he had blocked up the passage after him. I observed, however, that as we advanced the number of the Sultan's fighting men, as given by the guides, was rapidly diminishing, and, instead of five hundred, they were now reduced to half.

From the time occupied, and rate of progress, I imagine that at this place (Mallout) we were about twenty miles in a south-westerly direction from the capital, and amidst a race called Kadyans; they seemed a quiet, inoffensive people, and far less savage in appearance than the Dyaks at Kanowitt.

The rain continued incessant till five A.M. on the next morning, the 14th, when it cleared up. My plans were arranged for commencing the march into the interior at daylight, but the waters had risen so much on the lower ground during the night as to render access to the landing place a difficult operation, and it was six A.M. before Lieutenant Dunbar arrived with his detachment of blue jackets, which I ordered to garrison the village during our absence.

In order to test the fidelity of our guides, Mr. Brooke requested that they might be perfectly free

during the night, and as they were still in the camp at daylight, we commenced our march with some confidence. On quitting the village, half an hour's march brought us to the termination of the jungle, and here we once more entered on a swampy flat of long grass, breast high, the beaten track through it being every where from two to three feet deep—water and mud, but the depth being uniform, and large forest trees in view on the opposite side, our whole force had passed over in three-quarters of an hour, and a mile's tramp in the jungle brought us to the village of Tanjong, where we found a white-flag suspended from the roof of the largest building, but the women and children, and the greater part of the inhabitants, had fled. Here we learnt that all these spots of higher and cultivated land were termed islands by the natives; they were covered with fruit and cocoa-nut trees, and many shrubs and creepers of great freshness and beauty, and the general character of the country, as we advanced, was decidedly improving.

Rigorous orders had been given to respect the property as we passed through the different villages, which was well observed, and we continued our march alternately, through swamp and jungle, blazing the paths in every direction to secure our distinguishing the road back, should the guides desert us.

At 10:30 we came suddenly upon a larger building than any we had hitherto seen, erected close to a running stream, at the foot of a high and well wooded bank. The house was evidently new, and on examination found to have been lately inhabited.

A strict search for arms and ammunition was instituted, and two shields were shortly discovered, the largest of which, five feet long, ornamented with gilt, and having an imperial crown on the top, supported by two lions (not badly executed), was immediately recognized by Mr. Brooke as belonging to the Sultan, the sword-bearer having carried it before him at the reception given to your Excellency last year at the capital.

The usual quantity of arms, &c. were found, and several mats of great beauty, about thirty feet in length and ten feet wide, with furniture to correspond, the whole arrangement of the interior giving evidence that the Sultan had lately been a tenant, with the Pangerans who accompanied him in his flight. Observing that no injury was done to private property several of the natives here joined us, offering their services as guides, and assuring Mr. Brooke that the Sultan had only moved across the river, about two miles distant to another house, more difficult of access.

We, accordingly, pushed on without loss of time, once more buoyed up with the hope that the Sultan had determined to make a stand.

On arriving at the river, which was there about thirty yards wide, we found the bridge three feet under water, and owing to the strength of the stream quite impassable, the pioneers commenced at once to cut down the largest trees, which were close to the water's edge, and three of them falling at the same time directly across to the opposite bank, a compact bridge was soon formed and well

knitted together by the creepers. In executing this service, which was specially under the charge of Lieutenant Heath, I remarked the exertions of Mr. Simpson, chief officer of the *Phlegethon*, whose small party of Javanese were most useful.

I may also mention, that on my calling for volunteers, Edward Burchatt, carpenter's crew of the *Iris*, swam the river, with his heavy axe in his hand, at the great risk of his life; John Martin, carpenter's mate of the *Iris*; Alexander Lucas, C.C., of the *Agincourt*, and the artificers and pioneers of all the ships worked heartily. On crossing the river our march was continued amidst a swampy jungle, with thicker underwood than we had previously experienced; but our guides pointing to some cocoa nut and palm trees in the distance, informed us that amongst them we should discover the Sultan's retreat; just before reaching this secluded spot, the natives rushed into the bush, and our whole party advanced, and on gaining the open country we found ourselves directly in face of a large and isolated building, standing on piles, with a rivulet ten feet broad passing in its rear, and the whole country round completely flooded. A glance at the desolated appearance of the place showed us at once that no enemy was there to oppose us. It had been evacuated probably the day before by the Sultan and his followers; magazines of powder, ammunition for guns of different calibre, and cartridges admirably made for musketry were found in considerable quantity, and one brass swivel gun of small dimensions, but the greater part of the valuable property had been carried off. Having destroyed the powder and well reconnoitred the swamp and jungle around, I directed Lieutenant Heath to expend his damp rockets on the building, which was then fired and burnt to the water's edge, which service concluded, we recrossed the river with our whole force, and after a march of seven hours from leaving Mallout encamped on the rising ground by the new house, in which was found the Sultan's shield. The rain had set in as usual in torrents at 3 p.m., and there being only shelter for half the force, the remainder bivouacked under bamboo sheds erected by themselves; during the whole night there was no cessation of the rain, no wind, and myriads of mosquitoes.

On the next morning, Wednesday, July 15th, we commenced our march at an early hour to return to Mallout, a decision which Mr. Brooke and myself had come to in consequence of the whole of our guides who were acquainted with this part of the country having left us, and it was therefore impossible to obtain further intelligence of the Sultan's movements. As the rear-guard passed out into the swamp, the Sultan's house was fired, and with the adjoining buildings and all the property, burnt to the ground.

Passing through Tanjong we reached Mallout in the afternoon, where I found Lieut. Dunbar and party. The water in the creek had fallen between three and four feet, and the launch with the other gun boats had dropped out into the river. As it was too late in the day to ensure the embarkation of the force before dark, we bivouacked at Mallout for the night, and at four

the following morning, the 16th, were in movement for the beach. The embarkation occupied three hours, the large boats being two miles from our first place of landing, and the swamp was now nearly dry across.

We reached the main stream without difficulty, and I had again the pleasure of meeting your Excellency coming up to look after us, and of reporting to you that though the Sultan had eluded us, we had this time effected our march on Damuan, and that every man of the party had returned in safety, and very few cases of sickness.

I have much satisfaction in acquainting your Excellency with the uniform good conduct of all the officers, petty officers, seamen, and marines under my command.

During the six days occupied in the double expedition, I had no complaint of straggling or misconduct, and though the enemy offered no opposition to our advance, I hope I may be excused for bearing testimony to the cheerfulness of all under the discouraging circumstances of continued marching in jungle and swamps, knee deep, with heavy rain during the whole period, constantly wet to the skin, and rest at night impossible.

I was much indebted to Captain Hawkins, commanding the detachment of royal marines, for his exertions during the march, and to Lieutenants Matthew, Heath, and Newland, who commanded divisions of seamen, and to Lieutenant Vansittart, my Aid-de-camp.

Mr. Reeves and Mr. Quin, Mates of *Agincourt* and *Royalist*, were attentive to their duties.

I was highly satisfied with the zeal and intelligence of Lieutenant Patey, in immediate command of the gun boats, and he was cheerfully assisted by Lieutenants Norcock, Dunbar, and Morgan, and by Mr. Loane and Mr. Sullivan, Second Masters of the *Agincourt* and *Iris*.

Mr. Brooke, throughout the march, shewed the greatest anxiety to spare the houses and property unconnected with the Sultan.

REFERRING to my letter of the 30th May last, No. 95, relative to Borneo, I have the honour to acquaint you, for the information of the Lords Commissioners of the Admiralty, that on my arrival at Singapore, I received from Captain Sir Edward Belcher, of the Samarang, the accompanying narrative of events that had occurred on that part of the Bornean coast he had recently visited, and which, more or less, bear upon the disastrous transactions that had taken place in the capital.

On my arrival at the Sarawak, on the 24th ultimo, and meeting Mr. Brooke, I learnt from him that subsequent reports to those already transmitted to their Lordships led him to believe that his first information had not been exaggerated. Under these circumstances, I invited Mr. Brooke (and he readily accepted the invitation) to accompany me to the seat of government, for the purpose of assisting in the investigation of the outrages alleged to have been committed.

We arrived off Navarro Island, at the entrance of Bruné River, on the 4th instant, and it was not long before we were visited by some fishermen belonging to the city, from whom we learnt with regret that the reality had gone far beyond the report; that Rajah Muda Hassim, one of his sons, Panjeran Bedurudeen, seven brothers, one sister, and other relations, and about a similar number of other persons, had been put to death at the same time. Subsequently two of the remaining princes were sacrificed, upon it being ascertained that the person named Japper (alluded to by Mr. Brooke in his letter inclosed in my despatch No. 95, of the 30th May,) as having fled to him to bring information of the transaction was known to have departed, leaving in existence of that family only two brothers, and the son and heir of the Rajah, who were protected by the most powerful remaining Pangeran, named Moumein, who,

although son-in-law of the Sultan, disapproved of the deed, but confined his interference to the protection of those parties.

The cause of this sudden change of conduct on the part of the Sultan (who, their Lordships are already aware, is a very weak as well as ill-conditioned character) was the fate that had attended Pangeran Usop, whom, their Lordships will remember, I, at the Sultan's request, last year attacked and drove from the city, and who was subsequently taken and put to death by Bedurudeen, in consequence of an attack he made upon it after my departure. It would appear that the Sultan's reputed son, a man of worthless character, Pangeran Hassim, had married Usop's daughter, and, partaking of his father-in-law's hostility to the English and disposition to piracy, as well as deeply resenting his fall, and exercising the very great influence he had over the mind of the Sultan, he, in conjunction with a very clever and artful man named Hadgi Samoad, at last brought His Highness to consent to this deed of revenge.

Our informants further stated, that so soon as this crime had been perpetrated, the Sultan began to place the river and city in a state of defence, and Commander Egerton, of the Hazard, corroborated the statement that a trap had been laid for him to get him to the city, and, as alleged by the informants, with the view of putting him to death.

Under all the foregoing circumstances, and those considerations alluded to in my letter No. 95, before referred to, there did not appear to me the shadow of a doubt as to my right with reference to those principles which govern European states under similar circumstances, to proceed with an armed force, and demand an explanation of these hostile deeds; and, acting upon this conviction, the result is communicated to their Lordships in my letter of the 9th instant, No. 113.

On our arrival at the city, we found it entirely deserted by the inhabitants; those fled who felt they were compromised, and the remainder, no doubt, from apprehension of being confounded with them.

By means, however, of Japper, we managed to open a communication with those friendly to us; and on the following day I was visited by Pangeran Moumein, Pangeran Baher, and Pangeran Muda Mahomed, and had a long interview with them on that occasion. Their story was nearly to the same effect, and in unison with that which had already reached us.

The future then became the most interesting subject for discussion. The Sultan had fled, and they were, in fact, without a government. I invited them to come to some determination as to the course they would pursue for the well being of their country, but they appeared to be entirely paralyzed.

Pangeran Moumein, although condemning the Sultan's proceedings and himself very respectable in character, yet was most timid, and seemed to have an aversion to setting the Sultan aside; and the others, although very violent against him, had neither talent nor weight to undertake the formation of a new government.

Mr. Brooke landed on the following day, and at Moumein's house had a meeting on an enlarged scale, and stated to it my readiness to assist them in any measure that would have the effect of putting an end to the existing anarchy, or that might give permanent security to life and property; but on this, and subsequent occasions, he found the same timidity and irresolution to prevail as at their conference with me. In point of fact, the massacre had been of that sweeping character, as to cut off every man of weight or intelligence, and leave the survivors in an irrecoverable state of helplessness and dismay.

In the meantime, the common people had recovered from their panic, and commenced returning to the town; and by the fourth or fifth day nearly every house was inhabited, and the same busy scene presented itself as on ordinary occasions; the boats flocking round the ships to sell or exchange their produce, with as much confidence as in any English port; and I am persuaded nothing would have been more gratifying to them than to have learnt from me that I was authorized to establish an Englishman (such an one, for instance, as Mr. Brooke) as their governor and chief, under whom they would have felt confident of the undisturbed enjoyment of the produce of their industry, and of protection from uncertain and despotic exactions.

My letter of the 20th instant, No. 115, will have informed their Lordships of my unsuccessful attempt to obtain possession of the person of the Sultan. The other individual, named Hadji Samod, already alluded to, appeared to be a particular object of hatred on the part of the people, both as the Sultan's adviser and supporter; and at their suggestion, I dispatched a small but unsuccessful expedition in search of him; and they sent several war-boats on the same mission, in another direction; but the Hadji has, as yet, escaped capture; although three of his principal adherents have been taken, and whom the authorities immediately put to death.

Having remained eleven days at the city without any prospect of securing a definite and satisfactory arrangement, it became a matter for consideration as to the next best course to be adopted that would hold out any hope of my leaving the city, and those friendly to the English, even in a temporary state of security; and Mr. Brooke concurred with me in thinking that the effect might be good were I to address a sort of proclamation to the chief persons actually in the place, to be given to the Sultan on his return, detailing the whole of the proceedings that had taken place between us during the last twelve months, pointing out the unprincipled and dishonest conduct of the Sultan—showing how entirely he and they were at my mercy—yet still holding out the olive branch to him, but declaring my determination to act with the extreme of vigor should he ever again evince hostility to Great Britain.

I accordingly framed a document, of which the enclosed (so far as the genius of the Malayan and English languages will admit) is a copy, and

having intimated that all the authorities, merchants, &c. &c. should assemble on board the *Spiteful* yesterday, to hear a proclamation read to them, they assembled in a large body, when Mr. Brooke was so kind as to explain to them the course of our proceedings, the kind feeling we had towards the country, and our desire for its prosperity and happiness.

The document was then read by the interpreter. They seemed perfectly pleased with its contents, and no less so with the intimation that I intended to leave a ship of war with them until Mr. Brooke's return.

I sailed so soon as the meeting broke up, and in a few days intend to visit, on my way to China, several ports to the north of this, where it is desirable to convince the inhabitants they are not forgotten, and that their acts are watched. Mr. Brooke will accompany me on this visit, and call here again on his return to the Sarawak, to ascertain what course things have, in the meantime, taken, and as Borneo is within the limits, I have assigned to Captain Mundy as his charge. The *Iris* and *Hazard* will remain on the coast as long as circumstances may render necessary.

I lament it is not in my power to afford a more satisfactory narration of my political proceedings with regard to this fine and interesting country, and trust that my failure to attain all I rather wished, than expected, may be attributed to circumstances over which I had no controul, rather than to any deficiency either in exertion or judgment on my part; and it will be most gratifying to me to learn that their Lordships and Her Majesty's Government approve of my conduct and proceedings on the present occasion.

SIR,

IN compliance with your directions, I have drawn up the following report from memory of the intercourse which took place between the people residing on the northern coast of Borneo, between Maluda Bay and Labuan, during my late visit. We found them particularly shy, and not inclined to intercourse until we reached the river Tampasuk and Ambong. I had entered Ambong for the purpose of obtaining astronomical observations and procuring bullocks. Our reception was that of old friends, and the Orangkayah immediately communicated "that our allies Rajah Muda Hassim and Bedurudeen had been massacred by order of the Sultan at Brunè.

On the day following, during the prosecution of my survey of the Abai river, I was visited by the Rajah Matabak, of Tampassook, and a Pangeran, whom he introduced as a brother of Bedurudeen.

The countenance I knew, but I did not recollect him at Sarawak, although from his reminding me of several circumstances relative to the submersion of the Samarang, I was satisfied that he belonged to that party. The Rajah is related to Bedurudeen, the mother of the latter being one of the Illanon princesses.

The Rajah reminded me of my visit with Mr. Brooke in October 1845, shewed me a pencil memorandum then made, and also a paper in the Malay character, with the seal and signature of your Excellency. This I have since understood was written by Bedurudeen for some purpose connected with the Illanons. These papers he sent on board for perusal.

The Rajah visited the ship on the following day, and expressed his anxiety to avenge the insult put on his family by the disgraceful murder of his relatives, "because they were attached to the Whites" (orang-putch). He first enquired, "if I would aid his force in taking Brunè." Secondly, "if I would convey his force there." Thirdly, "if I would permit them to pass my boats to Brunè."

I declined acting in concert, but gave permission for his armed boats to pass to Brunè, but without any document.

He expressed himself (as well as his people) firmly attached to Great Britain, and that the whole coast were indignant at the base conduct of the Sultan, and wished to avenge it. At this place I found a Spaniard (native of Manila), who asked for protection, having been captured by the Illanons of Tampassook four or five years since, and purchased by the Sultan. I took him on board.

On my visits to the different rivers between Amboug and Labuan, our reception was flattering, but more particularly at the Kabatuan and Kimanis. At the former I met with one of the Rajah Muda's brothers (Matahoud), and his son also a relative Matzaout. They came down in state, inquired anxiously if Mr. Brooke was coming to their aid, and were all prepared to join any expedition which might be sent against Brunè.

At the Kimanis, where Bedurudeen came up with and destroyed Pangeran Usop, I found the Orang Kayah at the beach *timid*. He was attached to the interests of Rajah Muda Hassim, but warned me "that I would meet with bad men near Pulo Tiga."

Between Pulo Tiga and Labuan the natives exhibited *distrust*, and retired inland upon our approach. As I was shifting stations, and was quietly walking along the beach, I heard the report of a musket beside me. On turning round, the seamen who accompanied me told me "that I had been fired at;" and the yell from the woods soon satisfied me that the attack was not a casualty. I found that the Spaniard I had rescued at Tampassook, and who was ten yards below me on the beach, stooping to pick up shells, was wounded in the arm, the ball passing through his shirt near the spine, and also through the sleeve. The wound was little more than a graze. Shortly

after this the natives came down with a flag of truce, or a dirty rag to represent it, attended with gestures of bravado.

Calling the boats in, I directed a fire to be opened by one of the cutters, as well as a discharge from the muskets of the gig's crew. This put them to the route, carrying off one man severely wounded.

On my reaching Labuan, the canoes approached me without fear, I inquired of the fate of the Rajah Muda Hassim and Bedurudeen, and they replied without concern, "They were killed by the Sultan four months ago." I told them "it was a very bad act;" they smiled, but made no reply. They denied that any vessel of war had visited the place within the last four months, which I knew to be untrue. I believe that they were spies.

On my arrival at Sarawak, I found that Mr. Brooke had gone in the *Phlegethon* to visit the Linga Sakkarrau and Siriki rivers, and put down some quarrels which probably had for their final object an attack upon Sarawak. By letter from him, I find that he has brought them to their senses, and induced the waverers (between allegiance to the Sultan and himself) to declare for him. Our provisions being at a very low ebb, I was compelled to return without seeing Mr. Brooke.

IT was this time last year that I heard, through James Brooke, Esq. of Sarawak, that the Sultan invited me to visit Borneo.

On my arrival off Moarro, he sent Pangerau Bedurudeen, and numerous other princes, to welcome me, stating that they had his friendship.

At the Sultan's solicitations I visited the city, he again expressed to me his confidence in his uncle Rajah Muda Hassim and Pangeran Bedurudeen, and his apprehension of Pangeran Usop. He solicited me to send a guard to protect his palace from Pangeran Usop's designs, and he invited me to attack and if possible destroy him.

He also requested me to attack Sheriff Housman, because it was Sheriff Housman's intention to ruin Brunè, in consequence of the treaty entered into by the Sultan and Muda Hassim with the Queen of Great Britain. I went and attacked Sheriff Housman, and annihilated him, at a great cost of British life.

After this James Brooke, Esq. visited the Sultan, and he returned many thanks for what we had done, and expressed himself entirely friendly to us. Yet a short time afterwards he ordered the death of his uncle the Rajah Muda Hassim, Pangeran Bedurudeen, and many other of his relations, all of whom he declared to me were his friends; and, conscious of his fault, he immediately erected forts and batteries to oppose the British.

Shortly after that he endeavoured to entrap, by false representations, the captain of the man of war I sent to Bruné.

Subsequently, on my arrival with the squadron and ascending the river, his forts and batteries fired upon our ships first, without any provocation. On that very day, in a moment as it were, his forts and batteries were destroyed, and the city was captured; and, if I were to retaliate upon him as he deserves, I should reduce the whole to ashes.

But I have pity upon the better portion of the community, and though the conduct of the Sultan is detestable in the eyes of God and the Queen, I have likewise, for this once, some pity for the Sultan, because I understand he has been instigated by wicked advisers, and that if I spare him now, he will undoubtedly drive them from his country.

I extend this clemency because clemency is the attribute of the British nation, and because I wish, if possible, to spare this fine country.

I shall send one of my ships of war, from time to time, to inquire into the conduct of the Sultan; and he may rest assured, should I find he adheres to his wicked courses, I will return. I will burn the city to the ground, and I will pursue the Sultan and expend thousands of dollars until I take him either dead or alive.

Let the Rajahs choose between good and evil, let the Sultan also choose the wise alternative—let him rule his country with justice and mercy; and at a future time he may ensure the friendship of the Queen of England, who has the will and the power to foster the good and punish the evil doer.

The Admiral requests Pangeran Moumein to let the Sultan thoroughly understand the contents of this letter, the moment he returns to the city.
