WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled "An "Act for building, and promoting the building, of "additional churches in populous parishes," duly prepared and laid before Her Majesty in Council a representation, bearing date the tenth day of

December one thousand eight hundred and fortysix, in the words following, viz.

"Your Majesty's Commissioners for building new churches, appointed by virtue of an Act, passed in the fifty eighth year of the reign of His Majesty King George the Third, intituled "An "Act for building, and promoting the building, of "additional churches in populous parishes;" continued by an Act, passed in the seventh and eighth years of the reign of His Majesty King George the Fourth, intituled "An Act to amend "the Acts for building, and promoting the building, "of additional churches in populous parishes;" and further continued by an Act, passed in the first year of your Majesty's reign, intituled "An Act "to prolong, for ten years, Her Majesty's Commis-"sion for building new churches," beg leave humbly to represent to your Majesty, that, when the last census was taken, the parish of All Saints, Wandsworth, in the county of Surrey and diocese of Winchester, contained a population of seven thousand six hundred and fourteen persons; and that, besides the old parish church of All Saints, in the said parish of Wandsworth, which affords accommodation for eight hundred persons, including one hundred and fifty free seats for the use of the poor, there are two consecrated churches in the said parish, one of which, called Saint Anne's Church, situate in the east part of the said parish, and which was erected by your Majesty's

said Commissioners, affords accommodation for six hundred persons in pews, and one thousand two hundred persons on free seats; and the other, called Saint Mary's Church, situate at Summer's-town, in the said parish, affords accommodation for about two hundred and six persons; to which lastmentioned church a district, consisting of a smallportion of that part of the said parish of All Saints, Wandsworth, which is proposed to be formed into a separate and distinct parish for the said church called Saint Anne's Church, has been assigned under the provisions contained in the tenth section of an Act, passed in the session of Parliament held in the first and second years of the reign of His late Majesty King William the Fourth, intituled "An Act to amend and render "more effectual an Act, passed in the seventh and "eighth years of the reign of His late Majesty, inti-"tuled 'An Act to amend the Acts for building, and "promoting the building, of additional churches in "populous parishes;" and the incumbent or minister of which district has by law exclusive cure of souls therein:

"And your Majesty's said Commissioners beg leave further to represent to your Majesty, that, having taken into consideration all the circumstances of the said parish of Wandsworth, it appears to them to be expedient, that such parish should, under and by virtue of the powers contained in the sixteenth section of the Act herein firstly recited, be divided into two distinct and separate parishes, and that such parishes should be named, 'The Parish of All Saints, Wandsworth,' and 'The Parish of Saint Anne, Wandsworth;' that the said church called All Saints Church should remain and be the parish church of the said parish of All Saints, Wandsworth, and that the said church called Saint Anne's Church should become and be the parish church of the said parish of Saint Anne, Wandsworth; and further, that the boundaries of such last-mentioned parish should be as follows, on the west by the river Wandle and the parish of Wimbledon, on the south by the parish of Streatham, on the east by the parish of Battersea, and on the north by the river Thames, as the same are more particularly delineated on the map or plan thereof hereunto annexed, and thereon coloured pink; and that the said district which has been assigned to Saint Mary's Church, at Summer's-town aforesaid,

and which is surrounded by a red line on the said map, should be considered as included within the said proposed new parish of Saint Anne, for vicarial rights and purposes, but so as not to interfere with the pastoral duties of the incumbent of Saint Mary's Church, at Summer's-town, as by law established, but that the present consecrated burial ground, at or near to Garrett-lane, which is situate within the aforesaid boundaries of the said new parish of Saint Anne, should be excluded from such new parish, and belong to the said parish of All Saints, Wandsworth, and which burial ground is marked on the map hereto annexed, but left uncoloured:

"And your Majesty's said Commissioners beg leave further to represent, that the part of the original parish of All Saints, Wandsworth, remaining after such division, should form the parish of All Saints, Wandsworth, as aforesaid:

"And your Majesty's said Commissioners beg leave further to represent to your Majesty, that the population of such divided parishes would be as follows, that is to say, the east division of the said parish, which is proposed to form the new parish of Saint Anne (including the district already attached to Saint Mary's Church, at Summer's-town), will contain a population of about five thousand two hundred and seventy persons; and the west division of the said parish, which is proposed to remain attached to the old parish church of All Saints, will contain a population of about two thousand three hundred and forty-three persons:

"And your Majesty's said Commissioners beg leave further to represent, that the only glebe land or property in the nature of and considered as glebe land, which now belongs to and forms part of the revenues or endowments of the Vicar of the original parish of All Saints, Wandsworth, consists of a vicarage house and garden, which is situate close to the said church called Saint Anne's Church, and which will be within the proposed limits of the boundaries hereinbefore mentioned as the boundaries of the new parish of Saint Anne, Wandsworth, and which vicarage house and garden your Majesty's Commissioners propose should cease to belong to the Vicar of the said parish of All Saints, Wandsworth, and should

belong to and form part of the revenues or endowments of the Vicar of the said parish of Saint Anne, Wandsworth:

"And your Majesty's said Commissioners beg leave further to represent, that the whole of the tithes or moduses, if any, now arising within that portion of the said parish of All Saints, Wandsworth, which will remain and belong to All Saints Church, have been commuted at or for the annual sum of two hundred and forty-eight pounds one shilling and eleven pence, and which your Majesty's Commissioners propose should continue to belong to the Vicar of such church; and further, that the tithes or moduses, if any, now arising within the said limits of the said parish, or proposed parish, of Saint Anne, Wandsworth, and which have been commuted at or for the annual sum of three hundred and ninety-one pounds eighteen shillings and one penny, your Majesty's Commissioners propose should belong to and be enjoyed by the Vicar for the time being of the said proposed parish of Saint Anne, Wandsworth:

"And your Majesty's said Commissioners beg leave further to represent, that the estimated amount of the relative proportions of commuted tithes or moduses which will belong or accrue to the Vicars of each of the said parishes will be as aforesaid, two hundred and forty-eight pounds one shilling and eleven pence to the Vicar of the said parish of All Saints, Wandsworth; and three hundred and ninety-one pounds eighteen shillings and one penny to the Vicar of the said proposed parish of Saint Anne, Wandsworth:

" And your Majesty's said Commissioners beg leave further to represent, that it is estimated that the annual amount of fees, oblations, offerings, and other ecclesiastical dues, which will accrue to the Vicar of the said parish of All Saints, Wandsworth, will amount to about one hundred and ten pounds (such sum being exclusive of a certain annual payment of five pounds ten shillings to the Vicar of the said last-mentioned parish, under the wills of the late Henry Smyth and Mrs. Tyroe, and also of a like annual payment to such Vicar of eight pounds seven shillings and six pence by Marshall's trustees); and of those which will also annually arise or accrue in the said parish, or proposed parish, of Saint Anne, Wands-

pounds (such sum being exclusive of the pew rents of the said church of Saint Anne), which were all annually assigned to the Minister for the time being thereof, except the annual sum of fifteen pounds to the clerk of the said church, by an instrument dated on or about the twenty-fifth day of January one thousand eight hundred and twentyfive, under the common seal of your Majesty's said Commissioners:

" And your Majesty's said Commissioners beg leave further to represent, that it appears to them to be expedient, with the consent of the bishop of the diocese, as required by and in pursuance of the powers in that behalf contained in the ninth section of an Act, passed in the fifty-ninth year of the reign of His late Majesty King George the Third, intituled "An Act to amend and render " more effectual an Act, passed in the last session of " Parliament, for building, and promoting the build-"ing, of additional churches in populous parishes," that a certain payment of fifteen pounds five shillings and five pence, payable by every vicar or incumbent of the said parish church of All Saints, Wandsworth, upon his induction to such church, to the Governors of the Bounty of Queen Anne, for the augmentation of the maintenance of the poor clergy; and also a certain annual payment of one pound ten shillings and six pence halfpenny, likewise payable by such vicar during his incumbency of the said last-named church to the said Governors, should, from and after the proposed division of the said parish of All Saints, Wandsworth, shall have completely taken effect, be borne and paid to the said Governors by the vicars for the time being of the said parishes of All Saints, Wandsworth, and Saint Anne, Wandsworth, in the proportions following, that is to say five pounds five shillings and five pence by the Vicar of the said parish of All Saints, Wandsworth, and his successors, and ten pounds by the Vicar of the said proposed parish of Saint Anne Wandsworth, and his successors, upon their respective inductions to those parishes; and that the annual payment of ten shillings and six pence halfpenny, part of the said annual payment of one pound ten shillings and six pence halfpenny, should be borne and paid to the said Governors by the Vicar of the said parish of All Saints, Wandsworth, and his successors; and the annual sum of worth, will amount to about one hundred and fifty one pound, being the residue of the said annual

sum of one pound ten shillings and six pence halfpenny, should be borne and paid to the said Governors by the Vicar of the said proposed parish of Saint Anne, Wandsworth, and his successors, during their respective incumbencies of the said two parishes:

"That the consent of the Right Reverend Charles Richard Lord Bishop of Winchester has been obtained thereto, as required by the beforementioned section of the said Act, passed in the fifty-eighth year of the reign of His said Majesty King George the Third, and also the consent of the Reverend Edward Robert Pemberton, the patron of the said parish church and parish of Wandsworth; in testimony whereof, the said Charles Richard Lord Bishop of Winchester and Edward Robert Pemberton have severally signed and sealed this present representation:

"Your Majesty's said Commissioners, therefore, beg leave humbly to lay before your Majesty the before-mentioned circumstances, and humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed division be accordingly made, and the recommendations of the said Commissioners, in respect of glebe land, tithes or moduses, fees, obligations, offerings, and other ecclesiastical dues, and in respect of the payments therein mentioned, be carried into effect, agreeably to the provisions of the said Act, and of the other Acts therein recited.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed

in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An "Act to amend and render more effectual an Act," passed in the last session of Parliament, for building, and promoting the building, of ad-"ditional churches in populous parishes," duly prepared and laid before Her Majesty in Council a representation, bearing date the second day of December one thousand eight hundred and forty-six, in the words following, viz.

" Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, having taken into consideration all the circumstances of the parish of Saint Alkmund, situate partly in the borough and partly in the county of Derby, and within the diocese of Lichfield, it appears to them to be expedient, that a particular district, to consist of part of the said parish, should be assigned to the consecrated church, called Saint Matthew, situate at Darley Abbey, in the said parish of Saint Alkmund, under and by virtue of the powers contained in the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His late Majesty King George the Third, intituled " An Act to amend and render more effectual an " Act, passed in the last session of Parliament, " for building, and promoting the building, of " additional churches in populous parishes," and that such district should be named, "The Chapelry District of Darley Abbey," the same being bounded on the north by the parish of Allestree; on the north west and west by the parish of Mackworth; on the south west and south by the remaining part of the township of Darley, from which it is separated by the northern fences of the property of the Misses Mainwaring, and the north western fence of the land belonging to the Poor of All Saints, Derby, as far as the turnpike road from the eastern boundary of the property of the Misses Mainwaring to the tollgate; and thence by the western side of that road southerly, as far as the northern fence of the property of the Misses Strutt; then by that fence, and the eastern fence of the same property, as far as the northern fence of the property of the Right Honourable Edward Strutt, and by that fence as far as the river Derwent; and on the east by the township of Little Chester, in the parish of Saint Alkmund, and by the parish of Breadsall, as

shewn on the map or plan hereunto annexed, and thereon coloured green:

"That banns of marriage should be published, and that marriages, baptisms, churchings, and burials should be solemnized and performed in the said church of Saint Matthew, at Darley Abbey aforesaid; and that all the fees arising therefrom should be reserved for, on account of, and paid to, the present Vicar or Incumbent of the parish church of the said parish of Saint Alkmund, during his incumbency thereof, but, upon his avoidance of such parish church, that the said fees should for ever thereafter belong to the Incumbent for the time being of the said church of Saint Matthew, at Darley Abbey aforesaid:

"That the consent of the Right Reverend John Bishop of Lichfield has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof, the said John Bishop of Lichfield has signed and sealed this representation:

"Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the publication of banns and the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Act.
