

Whitehall, March 5, 1847.

The Right Honourable Sir Thomas Wilde, Knt. Lord Chief Justice of Her Majesty's Court of Common Pleas, has appointed Richard Pidcock, of Woolwich, in the county of Kent, Gent. to be one of the Perpetual Commissioners for taking the acknowledgments of deeds to be executed by married women, under the Act passed for the abolition of fines and recoveries, and for the substitution of more simple modes of assurance, in and for the county of Kent.

The Lords Commissioners of Her Majesty's Treasury having certified to the Commissioners for the Reduction of the National Debt, in pursuance of the Act, 10th Geo. 4th, c. 27, sec. 1, that the actual surplus revenue of the United Kingdom of Great Britain and Ireland, beyond the actual expenditure thereof, for the year ended the 5th day of January 1847, amounted to the sum of two million eight hundred and forty-six thousand three hundred and seven pounds, nineteen shillings and two pence;

Westminster and part of Middlesex Sewers.

PURSUANT to the Order of the Honourable the House of Commons, notice is hereby given, that application is now making to Parliament, for an Act to explain and amend the laws of sewers relating to the city and liberty of Westminster, and part of the county of Middlesex, and that the Bill for such purpose is now pending in the Honourable the House of Commons; and by such Bill it is intended to explain and amend the laws of sewers contained in the several Acts relating to sewers generally, or to the district above mentioned, passed respectively in the twenty-third year of the reign of King Henry the Eighth, the third and fourth years of the reign of King Edward the Sixth, the thirteenth year of the reign of Queen Elizabeth, the third year of the reign of King James the First, the second year of the reign of their Majesties William and Mary, the seventh year of the reign of Queen Anne, and the forty-seventh and fifty-second year of the reign of King George the Third; and it is also intended to extend to the district under the control of the Commissioners of Sewers of Westminster and part of Middlesex, some of the provisions of the Act, passed in the third and fourth years of the reign of His late Majesty King William the Fourth, intituled "An Act to amend the laws relating to sewers."—Dated this 27th day of March 1847.
