**A**T the Court at *Buckingham-Palace*, the 24th day of *April* 1847,

PRESENT,

The **QUEEN's** Most Excellent Majesty in Council.

**W**HEREAS there was this day read at the Board an Order in Council, dated the ninth day of March last, whereby it was ordered, that notice should be given in the *London Gazette*, that after the expiration of one calendar month from the date of the publication of that Order and notice, Her Majesty, with the advice of Her Privy Council, would take into consideration the propriety of making the Order therein specified, for the purposes of an Act, passed in the last session of Parliament, intituled "An Act for the more easy recovery of small debts and demands in England:"

And whereas notice of the said Order was given accordingly, and published in the *London Gazette* on Wednesday the tenth day of March last, Her Majesty, having taken the premises into Her consideration, is thereupon pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that, from and after this present twenty-fourth day of April in this year, the Court heretofore holden at Sheffield, for the manor of Sheffield, under an Act, passed in the forty-eighth

year of the reign of His late Majesty King George the Third, intituled "An Act for regulating the proceedings in the Courts Baron of the manor of Sheffield and Ecclesall, in the county of York," shall be abolished; and that, from and after the twenty-sixth day of April in this year, the County Court of Yorkshire for the recovery of debts and demands, under the provisions of the said Act of the last session of Parliament, shall be holden at Sheffield, in addition to the places in which the said County Court is now ordered to be holden, under an Order in Council, dated the ninth day of March last; and that the name or style of the said Court shall be "The County Court of Yorkshire, holden at Sheffield;" and that the district of the said Court shall be the Superintendent Registrar's districts of Ecclesall Bierlow, Sheffield, and Wortley, constituted pursuant to an Act, passed in the seventh year of the reign of His late Majesty King William the Fourth, intituled "An Act for registering births, deaths, and marriages in England," or pursuant to any Act passed for the amendment thereof, as the same were severally constituted on the nineteenth day of December last past, except so much of Wortley as by an Order in Council, dated the ninth day of March last, is therein specified as part of the district of the County Court of Yorkshire, holden at Barnsley, and excepting also any parts of parishes and chapelries, townships, tithings, and hamlets (if any) which are detached

<p>from the main body of the parishes and chapelries, townships, tithings, and hamlets, to which such detached parts severally belong; and that the said district shall comprise all places (if any), parochial or extra-parochial, not included in the description hereinbefore given of the said district, or in the description of any of the districts specified by the said Order in Council of the ninth day of March last, which lie within the precincts or outer boundary of the district hereinbefore</p>	<p>described or are surrounded by it, or, if not wholly surrounded by it, have with it a greater common boundary than with any district described in the said Order in Council of the ninth day of March last; and that every place, included within the outer boundary of the district hereinbefore specified and described, shall be taken to be within the jurisdiction of the County Court of Yorkshire, in like manner as if it were part of such county.</p> <p style="text-align: right;"><i>Wm.
