WHEREAS an Act was passed in the fiftyninth year of the reign of His late Majesty King George the Third, intituled "An Act to "carry into effect a convention of commerce "concluded between His Majesty and the United "States of America, and a treaty with the Prince

"Regent of Portugal," whereby, after reciting

certain provisions contained in certain treaties or conventions, made between His said late Majesty and the United States of America, and between His said late Majesty and the Prince Regent of Portugal, divers provisions were made respecting the duties payable and the bounties and allowances to be granted upon the importation and exportation of goods, wares, and merchandize into or from the United Kingdom in vessels of the United States and in Portuguese vessels, and respecting the repayment to certain corporations, bodies politic and corporate, and sundry other persons, of the amount of the sums of money of which they would be deprived by means of the said Act:

And whereas by an Act, passed in the session of Parliament holden in the eighth and ninth years of the reign of Her present Majesty, intituled "An Act for granting duties of "Customs," it is, amongst other things, enacted and declared, that, from and after the ratification of any treaty heretofore made by Her Majesty, and any of Her royal predecessors, subsequently to the said first hereinbefore recited Act, or of any treaty which may hereafter be made by Her Majesty, Her heirs and successors, with any foreign power, in which treaty have been or shall be contained provisions similar to those recited in the said first hereinbefore recited Act, all and every the provisions, clauses, matters, and things in the said first hereinbefore recited Act contained, shall apply and extend to the trade and shipping of such foreign powers, respectively, as fully and effectually to all intents and purposes as to the trade and shipping of the said United States and of the said kingdom of Portugal, and also shall apply and extend to differential duties or charges on goods imported or exported in the ships of such foreign powers as well as to differential duties on the ships of such foreign powers:

And whereas by the last recited Act it is further enacted, that it shall and may be lawful for Her Majesty, Her heirs and successors, by any Order or Orders to be by Her or them made with the advice of Her or their Privy Council, and published in the London Gazette, from time to time to declare what are the foreign powers with which any such treaty or treaties aforesaid is or are subsisting, and that the said recited Acts shall apply and shall be deemed, from the time of the ratification of any such treaties, to have been applicable to the trade and shipping of such foreign countries as shall be so mentioned in any such Order or Orders in Council as aforesaid, so long as any such Order or Orders shall continue unrevoked, and no longer:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and, in pursuance and exercise of the powers vested in Her by the said Act of the eighth and ninth years of Her Majesty's reign, doth hereby declare, that a treaty has been concluded and is now subsisting between Her Majesty and His Imperial and Royal Highness the Grand Duke of Tuscany:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.

WHEREAS by an Act, passed in the session of Parliament held in the first year of Her Majesty's reign, intituled "An Act to amend an "Act for the regulation of municipal corporations in England and Wales," it is, amongst other things, enacted, that if the inhabitant bouseholders of any town or borough in England or Wales shall petition Her Majesty to grant to them a charter of incorporation, it shall be lawful for Her Majesty, by any such charter, if she shall think fit, by the advice of Her Privy Council, to grant the same, to extend to the inhabitants of any such town or borough, within the district to be set forth in such charter, all the powers and provisions of the Act of the fifth and sixth William the Fourth, cap. 76, for regulating corporations, whether such town or borough be or be not a corporate town or borough, or be or be not named in either of the schedules to the said Act; provided, nevertheless, that notice of every such petition, and of the time when it shall please Her Majesty to order that the same be taken into consideration by Her Privy Council, shall be published in the London Gazette, one month at least before such petition shall be so considered:

And whereas the inhabitant householders of the borough of Wakefield, in the west riding of the

county of York, have presented a petition to Her Majesty in Council, praying, that a charter of incorporation may be granted to the said borough; Her Majesty was this day pleased to order, and it is hereby ordered, that the said petition be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on Saturday the twenty-eighth day of August next.

#### TREASURY WARRANT.

Whereas by an Act, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by warrant under their hands, to alter and fix any of the rates of British postage or inland postage payable by law on the transmission by the post of foreign or colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such warrant; and, from time to time, by warrant as aforesaid, to alter or repeal any such altered rates, and make and establish any new or other rates in lieu thereof; and, from time to time, by warrant as aforesaid, to appoint at what time the rates that may be payable are to be paid; and it is provided, that the power thereby given should extend to any increase or reduction or remission of postage:

And whereas by divers warrants under the hands of three of the Commissioners of Her Majesty's Treasury, the said Commissioners, in exercise of the power for such purpose vested in them by the said Act, have fixed and established rates of postage on letters passing direct between the United Kingdom and Hamburgh:

And whereas, in consequence of communications opened with the Post-office at Hamburgh, it is considered expedient to fix and establish certain rates of postage on printed newspapers, and other printed papers, conveyed between that country and the United Kingdom direct:

Now we, the undersigned, being three of the Commissioners of Her Majesty's Treasury, do, in exercise of the power reserved to us in and by the said Act, and of all other powers enabling us in this behalf, by this warrant, under our hands, order and direct, that such printed newspapers; printed publications, printed prices current, printed commercial lists, and printed courses of exchange as are hereinafter mentioned, may be sent by the post according to the regulations and rates hereinafter set forth, that is to say:

British newspapers, and such British publications as are allowed to pass by the post as newspapers in 'the United Kingdom, may, if posted in the United Kingdom, addressed to Hamburgh, be sent from the United Kingdom to Hamburgh direct by packet boat or private ship free of postage.

Newspapers, and other publications allowed to pass by the post as newspapers in Hamburgh, published and posted in Hamburgh, and addressed to the United Kingdom, may be sent from Hamburgh direct to the United Kingdom by packet boat free of postage, and by private ship at a rate of one halfpenny each.

Newspapers, and other publications allowed to pass by the post as newspapers in Hamburgh, published and posted in Hamburgh, may be sent from thence to the British colonies and foreign. countries through the United Kingdom, and foreign and colonial newspapers, addressed to Hamburgh, may be sent from foreign countries and the British colonies to Hamburgh through the United Kingdom (the conveyance in every case between the United Kingdom and Hamburgh being direct by packet boat or private ship), at a rate of one halfpenny each.

Periodical publications (not allowed to pass as newspapers) printed, published, and posted within the United Kingdom, addressed to Hamburgh, and periodical publications (not allowed to pass as newspapers) printed, published, and posted in Hamburgh, addressed to the United Kingdom, may be transmitted direct between the two countries by packet boat or private ship at the following retres remains following rates, namely:

> For every publication, not exceeding two ounces in weight, one penny.

> Above two ounces in weight, and not exceeding three ounces, six pence.

> Above three ounces in weight and not exceeding four ounces, eight pence.

> And for every additional ounce in weight above four ounces, up to sixteen ounces (the limit of weight beyond which such publications are not to be sent by the post, except at the letter rates of postage), two pence more; and every lesser weight than an ounce is to be charged as a full

Printed courses of exchange, printed prices current, printed commercial lists, and such other printed papers as are allowed, either in the United Kingdom or Hamburgh, to pass by the post at a reduced rate of postage, may, if posted in the United Kingdom addressed to Hamburgh, or posted in Hamburgh addressed to the United Kingdom, be transmitted between the United Kingdom and Hamburgh direct by packet boat or private ship at a rate of one penny each.

Printed courses of exchange, printed prices current, and printed commercial lists, published and posted in or addressed to Hamburgh, may be sent between Hamburgh and the British colonies, or foreign countries, through the United Kingdom (the conveyance between Hamburgh and the United Kingdom being direct by packet boat or private ship), at a rate of one penny each.

The said newspapers, periodical publications, printed courses of exchange, printed prices current, printed commercial lists, and such other printed papers as aforesaid, to be forwarded under and subject to the following conditions (that is to

Each must be printed in the language of the country in which it is published.

Each must be sent without a cover, or in a band or cover open at the sides, and there must be no word or communication printed on the

cover thereof, nor any writing, figures, or manual marks upon it, or upon the band or cover of it, except the name and address of the person to whom sent.

There must be no paper or thing enclosed in or with any such newspaper, periodical publication, printed course of exchange, printed price current, printed commercial list, or other printed paper.

The courses of exchange, prices current, and commercial lists must contain merely the names and prices of the goods, without mentioning the name or residence of the vendor or sender.

Any newspaper, periodical publication, course of exchange, price current, commercial list, or other printed paper, not forwarded in conformity with such conditions, is to be chargable with the full letter rates of postage.

And we do hereby further order and direct, that the terms and expressions used in this warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said Act passed in the fourth year of the reign of Her present Majesty.

And we do further direct, that this warrant shall come into operation on the first day of September one thousand eight hundred and forty-

Provided lastly, and we do hereby declare and direct, that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or any three of them, by warrant under their hands, at any time hereafter to alter or repeal any of the rates hereby fixed or altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.
