TREASURY WARRANT.

Whereas by an Act, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," certain scales of weight and rates of postage were fixed and made chargeable and payable upon, for, or in respect of letters, newspapers, parliamentary proceedings, and printed papers, transmitted and forwarded by the post, and various regulations were made for facilitating the transmission of such letters and papers by the post:

And whereas by an Act, passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office," the proviso concerning the maximum weight of letters to be sent by the post, as fixed in and by the said first-mentioned Act, is repealed; and, in order to prevent packets of an unwieldy bulk or an inconvenient size being transmitted by the post, power is given to the Commissioners of Her Majesty's Treasury, at any time or times thereafter, by warrant under their hands, to fix a maximum weight of letters to be sent by the post, and, from time to time, to repeal or revoke such maximum weight wholly or in part, and declare any other maximum of weight in lieu thereof, and all letters are to be forwarded, conveyed, and delivered by the post in conformity with any such warrant, and also in conformity with and
