first day of May and the first day of November in each year; and that the first payment in each case shall be made on the first day of May next, and shall be calculated from the day on which the said fees became by law receivable by the perpetual curates of such new parishes respectively. "And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.
