WHEREAS by an Act, passed in the session of Parliament holden in the fifth and sixth years of Her present Majesty, intituled "An Act " to amend the law of copyright," it is, among

copyright, or some person authorized by him, to import into any part of the United Kingdom, or into any other part of the British dominions, for sale or hire any printed book first composed or written, or printed and published in any part of the United Kingdom wherein there shall be copyright, and reprinted in any country or place whatsoever out of the British dominions:

And whereas by an Act, passed in the session of Parliament holden in the eighth and ninth years of the reign of Her present Majesty, intituled "An Act to regulate the trade of the " British possessions abroad," books, wherein the copyright is subsisting, first composed or written or printed in the United Kingdom, and printed or reprinted in any other country, are absolutely prohibited to be imported into the British possessions abroad:

And whereas by an Act, passed in the session of Parliament holden in the tenth and eleventh years of the reign of Her present Majesty, inother things, enacted, that it shall not be lawful | tituled "An Act to amend the law relating to

" the protection in the colonies of works entitled " to copyright in the United Kingdom," it is enacted, that in case the legislature or proper legislative authorities in any British possession shall be disposed to make due provision for securing or protecting the rights of British authors in such possession, and shall pass an Act or make an Ordinance for that purpose, and shall transmit the same in the proper manner to the Secretary of State, in order that it may be submitted to Her Majesty; and in case Her Majesty shall be of opinion that such Act or Ordinance is sufficient for the purpose of securing to British authors reasonable protection within such possession, it shall be lawful for Her Majesty, if she think fit so to do, to express Her royal approval of such Act or Ordinance, and thereupon to issue an Order in Council, declaring, that so long as the provisions of such Act or Ordinance continue in force within such colony, the prohibitions contained in the aforesaid Acts, and hereinbefore recited, and any prohibitions contained in the said Acts, or in any other Acts against the importing, selling, letting out to hire, exposing for sale or hire, or possessing foreign reprints of books first composed, written, printed, or published in the United Kingdom, and entitled to copyright therein, shall be suspended, so far as regards such colony:

And whereas an Act has been passed by the Lieutenant Governor, Council, and Assembly of Prince Edward's Island, intituled "An Act to "regulate the importation of books, and to "protect the British author," whereby provision is made for securing to British authors a certain remuneration in respect of unauthorized copies of works under copyright imported into the said island:

. And whereas Her Majesty bath expressed Her royal approval of the same:

Now, therefore, Her Majesty, by and with the advice and consent of Her Privy Council, and by the authority of the same, doth order, and it is hereby ordered, that so long as the said Act of the Legislature of the said island shall remain and continue in force within the said island, all prohibitions in either of the said hereinbefore recited Acts of the Imperial Parliament, or in any other Acts thereof contained against the importing into the said island, or against the selling, letting

out to hire, or possessing therein foreign reprints of books first composed, written, printed, or published in the United Kingdom, and entitled to copyright therein, shall be suspended, so far as regards foreign reprints imported into the said island:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Earl Grey, one of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein, as to them may respectively appertain.

HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to " amend and render more effectual an Act, passed " in the last session of Parliament, for build-" ing, and promoting the building, of additional " churches in populous parishes," or under or by virtue of any other power or authority vested in the said Commissioners by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the sixteenth day of September one thousand eight hundred and forty-eight, in the words following, viz.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent fo your Majesty, that having taken into consideration all the circumstances of the parish of Clodock, in the county of Hereford, and within the diocese of St. David's, it appears to them to be expedient, that a particular district should be assigned to the consecrated church of St. John, situate at Newton, in the said parish of Clodock, under and by virtue of the power or authority for such purpose contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the

Third, intituled "An Act to amend and "render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," or under or by virtue of any other power or authority in this behalf vested in your Majesty's said Commissioners by the Church Building Acts, and that such proposed district should be named, "The Chapelry District of Newton," with boundaries as hereinafter mentioned:

" The chapeley district of Newton is bounded on the north and east by the parish of Saint Margaret, on the south and south east by the remaining part of the parish of Clodock, from which the proposed chapelry district is separated by proceeding from the boundary line which separates the said parish of Saint Margaret from the parish of Clodock, at the south eastern extremity of a meadow belonging to Mary Jones, and proceeding in a westerly direction along the southern boundary of such meadow and by a field of pasture belonging to Mrs. Sarah Lewis; and thence by the same line of fences till it crosses the road leading to Cwm dulas, and continuing westerly along the southern hedge of the said road and common land, until it reaches the road leading from the middle Maescoed to the Brynn toll-bar; and thence, in a northerly direction, up the middle of that road until it joins the road leading from Longtown, along which latter road it then proceeds westerly as far as the river Escley, up which river the boundary then proceeds, north westerly, as far as the parish of Michael Church, Escley; which said parish then forms the north western boundary of the said district, which said chapelry district is more particularly delineated on the map hereunto annexed, and thereon coloured pink:

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that it also appears to them to be expedient, that baptisms, churchings, and burials should be solemnized or performed in the said church of St. John, at Newton; and that the fees arising therefrom should be paid and belong to the present incumbent of the parish church of the said parish of Clodock during his incumbency thereof, but that upon his avoidance of the said parish church such fees

should belong to the incumbent or minister for the time being of the said church of St. John, at Newton aforesaid:

"That the consent of the Right Reverend Connop Lord Bishop of St. David's (as Bishop of the diocese) has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof, the said Connop Lord Bishop of St. David's has signed and sealed this representation:

"Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the solemnization of baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty is further pleased, by and with the like advice, to direct, that this Order be forthwith registered by the Registrar of the diocese of St. David's.

Transfer of Sheffleld Canal to River Dun Navigation Company.

OTICE is hereby given, that application will be made to Parliament in the next session thereof, for leave to bring in a Bill for the purpose of transferring from the Manchester, Sheffield, and Lincolnshire Railway Company, to the Company of Proprietors of the Navigation of the River Dun, the Sheffield Canal, and all the works, lands, houses, and hereditaments, property, estate, and effects, rights, powers, and privileges, which, immediately before the passing of "The Sheffield Canal Purchase Act, 1848," were held, used, or enjoyed by the Company of Proprietors of the Sheffield Canal (excepting certain land, tenements, and hereditaments, rights, and privileges, in the town of Sheffield, which it is intended to reserve to the said Railway Company), so that the Company of Proprietors of the Navigation of the River Dun, their successors or assigns, may levy tolls for the use of the said canal and works, and exercise all the rights and powers over the same canal, property, and works, or connected therewith (except as aforesaid), which are now vested in the said Railway Company by virtue of the said Sheffield Canal Purchase Act, 1848, subject, however, to such liabilities and engagements as are imposed by the said Act upon the said Railway Company, with respect to the former company of proprietors thereof.

And it is further intended by such Bill to confer upon the said Railway Company the necessary powers and authority for making such transfer; and to vary or extinguish all existing rights or privileges which would in any manner impede or interfere with the objects aforesaid, and to confer such rights, powers, and privileges as may be necessary or convenient for the attainment of those objects.

And notice is hereby also given, that it is intended in such Bill to alter, amend, and enlarge the powers and provisions of an Act, passed in the 55th year of the reign of King George the Third, intituled "An Act for making and maintaining a navigable canal from Sheffield to Tinsley, in the west riding of the county of York," and also to alter, amend, and enlarge the provisions of "The Sheffield Canal Purchase Act, 1848," or to repeal the same Act; and also to alter, amend, and enlarge the powers and provisions of an Act, passed in the twelfth year of the reign of King George the First, intituled "An Act for making the River Dun, in the west riding of the county of York, navigable from Holmstile, in Doncaster, up to the utmost extent of Tinsley, westward, a township within two miles of Sheffield;" and also of several Acts relating to the navigation of the river Dun, or to the company of proprietors thereof, passed respectively in the thirteenth year of the same reign (cap. 20), the sixth year of the reign of King George the Second (cap. 9), in the thirteenth year of the same reign (cap. 11), in the session of Parliament held in the first and second years of the reign of King George the Fourth (cap. 46),
