Buckingham-Palace, February 1, 1819.

Royal Highness Prince Albert, proceeded in state from Buckingham-Palace to the House of Peers, where she arrived soon after two o'clock; and was received, on alighting from her state coach, by the Lord Chancellor, the Lord President of the Council, the Lord Privy Seal, Sir Angustus Clifford, Bart. C.B. Deputy Great Chamberlain, (in the absence of the Lord Willoughby d'Eresby), the Lord Steward of the Househeld, the Duke of Wellington, Garter King of Arms, and the Yeoman Usher of the Black Rod, and proceeded to the robing-room in the customary manner.

Her Majesty was there robed, and the procession moved into the House in the usual order;—the sword of state was borne by the Duke of Wellington, the cap of maintenance by the Marquess of Winchester, and the crown by the Marquess of Lansdowne.

Her Majesty being seated on the Throne, and His Royal Highness Prince Albert on a Chair on the left side of the Cloth of Estate, the Great Officers of State and others standing on the right and left, James Pulman, Esquire, Yeoman Usher of the Black Rod, was sent with a message from Her Majesty to the House of Commons, commanding their attendance in the House of Peers. The Commons being come thither accordingly, Her Majesty was pleased to deliver the following most gracious Speech to both Houses of Parliament:

My Lords, and Gentlemen,

THE period being arrived at which the business of Parliament is usually resumed, I have called you together for the discharge of your important duties.

It is satisfactory to me to be enabled to state, that both in the North and in the South of Europe the contending parties have consented to a suspension of arms for the purpose of negotiating terms of peace.

The hostilities carried on in the Island of Sicily were attended with circumstances so revolting, that the British and French Admirals were impelled by motives of humanity to interpose, and to stop the further effusion of blood.

I have availed myself of the interval thus obtained, to propose, in conjunction with France, to the King of Naples, an arrangement calculated

to produce a permanent settlement of affairs in Sicily. The negotiation on these matters is still pending.

It has been my anxious endeavour, in offering my good offices to the various contending powers, to prevent the extension of the calamities of war, and to lay the foundations for lasting and honourable peace. It is my constant desire to maintain with all foreign states the most friendly relations.

As soon as the interests of the public service will permit, I shall direct the papers connected with these transactions to be laid before you.

A rebellion of a formidable character has broken out in the Punjaub, and the Governor-General of India has been compelled, for the preservation of the peace of the country, to assemble a considerable force, which is now engaged in military operations against the insurgents; but the tranquillity of British India has not been affected by these unprovoked disturbances.

I again commend to your attention the restrictions imposed on commerce by the navigation

If you shall find that these laws are in whole or in part unnecessary for the maintenance of our maritime power, while they fetter trade and industry, you will no doubt deem it right to repeal or m diffy their provisions.

Gentlemen of the House of Commons,

I have directed the estimates for the service of the year to be laid before you; they will be framed with the most anxious attention to a wise economy.

The present aspect of affairs has enabled me to make large reductions on the estimates of last year.

My Lords, and Gentlemen,

I cbs rve with satisfaction that this portion of the United Kingdom has remained tranquil amidst the convulsions which have disturbed so many parts of Europe.

The insurrection in Ireland has not been renewed, but a spirit of disaffection still exists; and I am compelled, to my great regret, to ask for a continuance, for a limited time, of those powers which in the last session you deemed necessary for the preservation of the public tranquility.

I have great satisfaction in stating that commerce is reviving from those shocks which at the commencement of last session I had to deplore.

The condition of the manufacturing districts is likewise more encouraging than it has been for a considerable period.

It is also gratifying to me to observe that the state of the revenue is one of progressive improvement.

I have to lament, however, that another failure in the potato crop has caused very severe distress

in some parts of Ireland.

The operation of the laws for the relief of the poor in Ireland will properly be a subject of your inquiry; and any measures by which those laws may be beneficially amended, and the condition of the people may be improved, will receive my cordial assent.

It is with pride and thankfulness that I advert to the loyal spirit of my people, and that attachment to our institutions which has animated them during a period of Commercial difficulty, deficient production of food, and political revolution.

I look to the protection of Almighty God for favour in our continued progress; and I trust that you will assist me in upholding the fabric of the constitution, founded as it is upon the principles of freedom and of justice.

THEREAS Her Majesty's Commissioners for building new churches have, in pur-Euance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to " amend and render more effectual an Act, passed in the last session of Parliament, for build-"ing, and promoting the building, of additional churches in populous parishes," or under or by virtue of any other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the fifth day of January one thousand eight hundred and forty-nine, in

the words following, viz:
"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, having taken into consideration all the circumstances of the united parishes of Kirkby Malzeard and Masham, the former of which parishes is situate within the west riding and the latter within the north riding of the county of York, and both being within the diocese of Ripon, it appears to them to be expedient, that a particular district should be assigned to the consecrated church of Saint Paul, situate at Healey, in the said parish of Masham, under and by virtue of the power or authority for such purpose contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in 'the last session of Parliament, for building, 'and promoting the building, of additional 'churches in populous parishes,' or under or by virtue of any other power or authority in this behalf vested in your Majesty's said Commissioners under the Church Building Acts, and that such proposed district should comprize all that portion of the said parish of Masham which lies to the west of the eastern boundary-line hereinafter described, which comprizes also the entire township of Ellingstring, the township of Healey-cum-Sutton (excepting all that portion thereof called or known by the name of Sutton), the entire township of Ilton-cum-Pott, the greater part of the township of Fearby, with detached portions of the townships of Masham, Burton, Ellington, and Swinton, as well as the unenclosed moorland belonging to the parish of Masham, and not divided between the several townships in such parish, and that such proposed district should be called 'The Chapelry District of Healey,' with boundaries as hereinafter mentioned:

" The chapelry district of Healey is bounded on the south and south west by the said parish of Kirkby Malzeard, on the north west by the parish of Coverham, on the north by the parish of East Witton, and on the east by the remaining part of the said parish of Masham, from which the proposed chapelry district is separated by the western and south western boundary line of the township of Ellington, as far as to the point where the road from Ellingstring to Swinton crosses Swinny Beck; then by the said road, leading from Ellingstring to Swinton, till it meets the Burn river; thence by the river Burn, running in a westerly direction up to the mouth of Quarry Gill Beck; thence by the Quarry Gill Beck till it arrives at the boundary of the township of Ilton; then by the boundary line of the township of Swinton as far as to the road leading from Masham to Ilton; and then by the boundary line of the township of Burton till it meets the boundary of the parish of Kirkby Malzeard on the south, as such proposed chapelry district, is more particularly delineated on the map or plan hereunto annexed, and is thereon coloured pink:

"Your Majesty's said Commissioners beg leave further to represent, that it also appears to them to be expedient, that banns of marriage should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed in the said church of Saint Paul, and that the fees to arise therefrom should be paid and belong to the incumbent of such church for

the time being:

" That the consent of the Right Reverend Charles Thomas Lord Bishop of Ripon (as Bishop of the diocese) has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof, the said Charles Thomas Lord Bishop of Ripon has signed and sealed this representation:

"Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom

shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered,

that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Lichfield.
