THE Commissioners for executing the office of Lord High Admiral of the United Kingdom of Great Britain and Ireland do hereby give notice, that, on Thursday the 29th instant, at one o'clock, they will be ready to treat with such persons as may be willing to contract for supplying and delivering into Her Majesty's Victualling Stores, at Deptford, the undermentioned articles, viz.

Rum (the produce of the British Possessions, and not less than half to be the produce of the British Possessions in the West Indies), 100,000 gallons; half to be delivered in three weeks, and the remainder in three weeks afterwards.

Sugar (the produce of the British Possessions), 100 tons; half to be delivered in three weeks, and the remainder in three weeks afterwards.
Cocoa, 50 tons; half to be delivered in three weeks, and the remainder in three weeks afterwards.

Wheat (Red) 2000 quarters; half to be delivered in three weeks, and the remainder in three weeks afterwards.

Wheat (White) 1000 quarters; half to be delivered in three weeks, and the remainder in three weeks afterwards.

Soap (Mottled), 50 tons; half to be delivered in three weeks, and the remainder in three weeks afterwards.

The Rum, Sugar, and Cocoa, to be exempted from the Customs' duties.

Samples of Cocoa (not less than two pounds) of the Wheat (not less than two quarts), and of the Soap (not less than a bar), must be produced by the parties tendering, and a sample of the Sugar, together with the conditions of the contracts may be seen at the said Office.
