The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the passed in the session of Farnament head in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with "certain modifications, the Fourth Report of the "Commissioners of Ecclesiastical Duties and "Revenues;" and of another Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An Act to explain and amend two several Acts relating " to the Ecclesiastical Commissioners for England; and of another Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make "better provision for the spiritual care of popu-"lous parishes;" and also of another Act, passed in the session of Parliament held in the eleventh and twelfth years of Her Majesty's reign, intituled " An Act to carry into effect the arrangements " of the Ecclesiastical Commissioners for England, " for making better provision for the cure of " souls in the parish of Wolverhampton, in the " county of Stafford, and diocese of Lichfield;" duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of February, in the year one thousand eight hundred and forty-nine, in the words and figures following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled 'An 'Act to carry into effect, with certain Modifications, the Fourth Report of the Commis-sioners of Ecclesiastical Duties and Revenues, and of another Act, passed in the session of Parliament held in the fourth and fifth years of your

T the Court at Buckingham-Palace, the | ' and amend two several Acts relating to the Ecclesiastical Commissioners for England,' and of another Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituted 'An Act to make better 'provision for the Spiritual Care of populous 'Parishes,' and also of another Act, passed in the session of Parliament held in the eleventh and twelfth years of your Majesty's reign, intituled 'An Act to carry into effect the Arrangements of the Ecclesiastical Commissioners for England for making better provision for the cure of souls in the parish of Wolverhampton, in the county of Stafford, and diocese of Lichfield,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for making better provision for the cure of souls in the said parish of Wolverhampton.

> "Whereas by the first and secondly recited Acts, the deanery of Wolverhampton is suppressed, and the endowments thereof and also the endowments of all the non-residentiary prebends and offices in the collegiate church of Wolverhampton are, upon the vacancies thereof repectively, absolutely vested in us; and it is enacted, that out of the said endowments of whatsoever kind, and by the authority of a scheme or schemes prepared by us and ratified by an order or orders of your Majesty in Council, better provision shall be made for the cure of souls in the districts or places with which the said collegiate church is connected; and it is by the same Act further enacted, with an especial view to the better care of populous parishes, that arrangements might from time to time be made by the like authority for improving the value or making a better provision for the spiritual duties of ill-endowed parishes or districts, by means of such alterations in the exercise of patronage as may be agreed upon by patrons, with the consent of the Bishop in every such case, and where a Bishop himself is one of the patrons, then with the consent of the Archbishop:

" And whereas the fourthly recited Act, after transferring to and vesting in us certain sums of money, stock, and dividends therein mentioned, Majesty's reign, intituled 'An Act to explain and a piece of land therein described as part of the

endowment of the perpetual curacy of Wolverhampton aforesaid, and declaring that the office of sacrist in the said collegiate church of Wolverhampton was abolished, and the estates and emoluments appertaining or belonging to the said office were absolutely vested in us, contains enactments, whereby the district of the parish of Wolverhampton assigned to the collegiate church of Saint Peter, as therein mentioned, is constituted a Rectory, and the Reverend John Osmond Dakeyne and his successors, incumbents of the same church, are constituted rectors of Saint Peter's, Wolverhampton, with all the rights, privileges, and emoluments which would have belonged to the perpetual curate of Saint Peter's Wolverhampton, except so far as the same are otherwise appropriated or disposed of by the Acts herein recited; and it is by the same fourthly recited Act enacted, that the minister for the time being of each of the several districts of the said parish of Wolverhampton specified in the schedule to the said Act, and of the district of Ettingshall, so far as the same is in the said parish of Wolverhampton, shall immediately after the present minister thereof respectively shall have given his consent to the same Act (to be testified by writing under his hand, and to be deposited in the registry of the diocese), be entitled to all surplice fees arising or accruing within the same district, and as to the respective ministers of the districts of Saint John and Saint George, in the said parish, in addition to a certain yearly stipend of twenty pounds apiece in the same Act mentioned as payable to them by the Wolverhampton General Cemetery Company, freed and discharged from all claim in respect thereof by the incumbent of Saint Peter's, Wolverhampton; and it is further enacted, that, in consideration of the premises we shall, out of the endowments late belonging to the said collegiate church or the common fund vested and to be vested in us by the herein first and secondly recited Acts, as we shall see fit, and under the authority aforesaid, provide a sum not exceeding seven huudred and fifty pounds for or towards the purchase of a site, and a sum of one thousand five hundred pounds for or towards the erection, under our sanction and control, of a suitable rectory house, to be conveyed to and vested in the rector of Saint Peter's and his successors; and it is by the same Act also enacted, that nothing therein contained shall deprive the present clerk of the church of Saint Peter's, Wolverhampton, of any fees or perquisites to which he is by law or custom entitled in or out of any of the said districts, but that from and after his death, resignation, or removal, all fees to the clerk of the rectory of Saint Peter's, payable from or out or in respect of any other district shall be abolished; and that by the like authority, and at such time or times, and from time to time, as by such authority shall be deemed expedient, it shall be lawful to constitute and declare the several districts and parishes mentioned in the schedule thereunto annexed (being the districts comprised in the schedule hereto annexed, except the districts of Ettingshall and Moxley), or any of them, or any other districts or parishes to be thereafter constituted in the said parish of Wolverhampton, to be separate parishes and vicarages, and the incumbents thereof vicars, but on such conditions, and with such respective grants of money or augmentations of income, or without the same, as to us shall appear expedient and reasonable, and as shall be directed by the like authority; and that on every such district being constituted a vicarage, the then existing incumbent shall be the first vicar thereof, and that every such vicar shall be a corporation sole, and may receive and take and hold such lands, tithes, or other hereditaments as were vested in him as incumbent of the district so constituted a vicarage at the time of the now reciting Act, or any future augmentation thereof, in as full, ample, and beneficial a manner as any other corporation sole can receive, hold, and enjoy the same:

"And whereas it is by the same Act further enacted, that all the powers and authorities vested in your Majesty in Council, and in us by the therein thirdly and fourthly recited Acts, being the Acts herein firstly and secondly recited with reference to the matters therein respectively contained, and all other the provisions of the same Acts relating to schemes and Orders prepared, made, and issued for the purposes thereof, and also all other the provisions of the same Acts, so far as they are applicable, and not inconsistent with or repugnant to anything in the same Act contained, shall be extended and shall apply to all matters contained in and all the purposes of such Act as fully and effectually as if the said powers, authorities, and other provisions were repeated therein:

"And whereas the consents of all the incumbents of the several districts mentioned in the said fourthly recited Act, and of the district of Moxley so far as the same comprehends a part of Wolverhampton, have been duly given in writing under their hands respectively, and have been deposited in the registry of the diocese of Lichfield, according to the provisions of the same Act:

"And whereas the church of Saint John, Wolvorhampton, is in the patronage of the Right Honourable Harry Earl of Stamford and Warrington, and in consideration of the augmentation hereinafter proposed to be made by us the said Earl has agreed to transfer the right of patronage of the said church, subject to his life interest therein, to trustees, in the manner hereinafter mentioned:

"And whereas the church of Saint Paul, Wolverhampton, is in the joint patronage of the Reverend William Dalton, of the Lloyd, in the same parish, Clerk, and Sarah his wife, who have expended more than ten thousand pounds in the purchase of sites for and in building the said church, and a parsonage and schools attached thereto; and in consideration of the augmentation hereinafter proposed by us, the said William Dalton and Sarah his wife have agreed to transfer the right of patronage of the said church, subject to their life interest therein, to the Bishop of the diocese:

"And whereas the church of Saint Mary, Wolverhampton, is in the patronage of Theodosia Hinckes, of Tettenhall, near Wolverhampton aforesaid, Spinster, who has also expended more than ten thousand pounds in the purchase of sites for and in building the said church, and a parsonage and schools attached thereto; and in consideration of the augmentation proposed by us, the said Theodosia Hinckes has also agreed to transfer the right of patronage, of the said church, subject to her life interest therein, to the said Bishop:

"And whereas the church of Wednesfield is in the patronage of John Moore Paget, of East Cranmore, in the county of Somerset, Esquire, and the said John Moore Paget hath agreed forthwith to transfer the right of patronage of the said church to the said Bishop, and also to give and duly to convey a house, garden and grounds thereto belonging, containing together between two and three acres, as a residence for the incumbent of the said church, and also, in consideration of the augmentation proposed by us, to give the sum of one thousand pounds towards the further augmentation thereof:

"And whereas the patronage of the church of the chapelry district of Saint Leonard Bilston is vested in the inhabitant householders of the said district, and the patronage of the church of Saint Mary, Willenhall, is vested in the landowners resident in the said parish, and we do not consider it expedient that the sail two last-mentioned churches should be constituted vicarages under the powers of the said fourthly-recited Act so long as the patronage shall continue to be so vested:

"And whereas John Biddulph, the present Clerk of the said church of Saint Peter's, Wolverhampton, claims to be entitled to perform the usual duties and services of a parish clerk, and to receive the accustomed perquisites and fees payable to such parish clerk on the performance of such services or otherwise, throughout the whole of the said parish of Wolverhampton, and the districts comprised therein, as constituted and existing previously to the passing of the said fourthlyrecited Act; and by an Act commonly called or known by the name of 'The Wolverhampton General Cemetery Act,' and passed in the year one thousand eight hundred and forty-seven, certain fees were made payable to the said clerk by the Wolverhampton General Cemetery Company, formed and incorporated under the same Act, in respect of persons dying within the limits of such districts as therein mentioned:

"And whereas the said John Biddulph, in consideration of the annuity to be paid to him, as hereinafter mentioned, so long as he shall continue such clerk, hath consented and agreed to execute a deed und r his hand and seal, releasing and resigning all his right or title to perform any services or duties, or to receive any perquisites or fees accustomably payable or otherwise arising or to arise within the said parish of Wolverhampton, or any of the districts into which the same is now divided; except within the district assigned to the church of Saint Peter's, Wolverhampton, and the limits thereof as now constituted; and except also such fees as are made payable under the said last-mentioned Act:

"And whereas arrangements had been agreed upon and were previously to the passing of the said fourthly-recited Act about to be recommended by us to your Majesty in Council, under the provisions of the said first-recited Act, for the purchase by us of a site for a church and residence house for the district of Saint Mark, Wolverhampton, for the sum of one thousand seven hundred and twenty-five pounds, which, upon due inquiry, we had satisfied ourselves was a just and reasonable price for the same:

"And whereas a convenient site has been found for the erection of a rectory house for the said rectory of Saint Peter, and the present owner thereof hath consented and agreed to sell the same for that purpose for the sum of seven hundred and fifty pounds, and we have upon due inquiry satisfied ourselves that the said sum is a just and reasonable price for the same:

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend John Bishop of Lichfield, in testimony whereof he has signed and sealed this scheme, that the payment of the said sum of one thousand seven hundred and twenty-five pounds towards the purchase of the said site for a church and parsonage house for the said district of Saint Mark, shall be hereby authorized and confirmed, and that we

shall further be authorized and empowered to pay the sum of seven hundred and fifty pounds as the purchase money for the said site for a rectory house for the said rectory of Saint Peter; and that the said sums may be paid by us upon the due conveyance of the said sites respectively to the rector of Saint Peter's and the minister of the district of Saint Mark, Wolverhampton; and that there may also be paid by us, to such persons, and at such times as we shall deem expedient and proper, a sum not exceeding one thousand five hundred pounds for or towards the erection of a suitable rectory house for the said rectory of Saint Peter, upon condition that such house shall be built under the direction and supervision of an architect to be nominated by us and the Bishop of Lichfield for the time being.

"And we further recommend and propose, that upon and from the day upon which notice shall be published in the London Gazette, that the said John Biddulph hath duly executed a deed to the purport and effect aforesaid, all and every his claim, right and title, to perform any services or duties, or to receive any perquisites or fees (except the fees so made payable by the said Cemetary Act as aforesaid) accustomably payable on the performance of such services, or duties, or otherwise, within the several districts mentioned in the said schedule hereunto annexed (except the rectory and parish of Saint Peter as now constituted), shall be abolished; and that the said John Biddulph shall receive in lieu thereof, as from the first day of November in the year one thousand eight hundred and forty-eight, such yearly sums as are in the seventh column of the same schedule set against the names of certain of the churches mentioned in such schedule, such sums amounting in the whole to the annuity or yearly sum of twenty-two pounds, and such sums respectively shall be payable and paid by the incumbents of the said churches respectively, by half-yearly payments on the first day of May and the first day of November in each and every year, and shall be receivable by the said John Biddulph so long as he shall continue such clerk as aforesaid, but no longer; the first such half-yearly payment in each case to be made on the first day of May next; and that the due payment of the said several sums by such incumbents respectively, shall be one of the conditions whereupon the several augmentations of income and grants of money hereinafter provided for shall respectively depend.

"And we further recommend and propose, with the consent of the said Harry Earl of Stamford and Warrington, William Dalton and Sarah his wife, Theodosia Hinckes, and John Moore Paget, the respective patrons of the churches of Saint John, Saint Paul, Saint Mary and Wednesfield, in testimony whereof they have respectively signed and sealed this scheme, that the patronage of and right of nomination to the said church of Saint John shall, upon and from the death of the said earl, become and be transferred to, and absolutely vested in, and may be exercised by three trustees appointed and to be appointed as hereinafter mentioned; that is to say, the Bishop of Lichfield for the time being, the Earl of Stamford for the time being, and such third person, as such bishop and the said Harry Earl of Stamford and Warrington shall, at any time during the life of the said earl, appoint, by an instrument in writing under their hands and seals, to be registered and kept in the registry of the diocese of Lichfield, or as upon any subsequent vacancy of such third person, by death, resignation or otherwise, such bishop and the Earl of Stamford for the time ... being shall in like manner appoint; and that the patronage of and right of nomination to the several churches of Saint Paul and Saint Mary Wolverhampton shall, upon and from the death of the present patrons of such two last-mentioned churches respectively, become and be transferred to, and absolutely vested in, and may be exercised by the bishop of the diocese for the time being; and that the patronage of and right of nomination to the church of Wednesfield shall forthwith be, and the same is hereby transferred to and absolutely vested in the bishop of the diocese for the time being; and with respect to the church of Saint James, Wolverhampton, the patronage whereof is now vested in five trustees, the present Bishop of Lichfield and the present Archdeacon of Stafford, being two of such trustees, but not by virtue of their respective offices, and the said Reverend William Dalton and the Reverend Humphry Pountney, being two other of such trustees, and the office of the fifth trustee being now vacant, we recommend and propose, with the consent of the Right Honorable Most Reverend John Bird, Archbishop of Canterbury, and of the said four trustees, testified by their having respectively signed this scheme, that the bishop of the diocese and the archdeacon for the time being of the archdeaconry wherein the said church is or shall be situated, shall at all times hereafter be, and be held to be, by virtue of such their respective offices, duly nominated and appointed as two of the five trustees in whom the patronage and right of nomination of and to the said church of Saint James, Wolverhampton, shall be absolutely vested.

"And whereas the five districts of Saint Mark and Saint Matthew, Wolverhampton, Holy Trinity and Saint Stephen, Willenhall, and Saint Luke, Bilston, mentioned in the said schedule hereunto annexed, were duly constituted and endowed under the provisions of the thirdly-recited Act, and will respectively become new parishes upon the consecration and approval of churches for such districts respectively under the provisions of the same Act; we further recommend and propose, with the consent of the same bishop so testified as aforesaid, that the said five several districts, so soon as they shall have respectively so become new parishes, and all the several other parishes mentioned in the same schedule (except the said rectory of Saint Peter), upon and from the twenty-first day next following the day upon which any Order of your Majesty in Council ratifying this scheme shall be duly published in the London Gazette, shall respectively be constituted and become and be vicarages, and the several ministers or incumbents thereof vicars, and as such vicarages and vicars shall be respectively invested with and entitled to all the same and the like rights and privileges as any new parish or per-petual curate would be invested with and entitled to under the said thirdly-recited Act; and that there shall, out of the endowments late belonging to the said collegiate church of Wolverhampton or out of any monies from time to time in our hands under the said recited Acts, or any of them, be paid by us to the respective vicars for the time being of the said vicarages, and to the respective ministers for the time being of the said five districts, so long as they respectively remain districts, and also of the districts of Ettingshall and Moxley, mentioned in the same schedule, the several augmentations of income or yearly sums of money which in the second column of the same schedule are set against the names of the respective districts and churches, by equal half-yearly payments on the first day of May and the first day liament.

of November, in each and every year, the first of such payments respectively to be made on the first day of May now next ensuing, and that in the case of any and every future vacancy in any of the said vicarages or districts happening on any other day than one of the days so named, the amount payable shall be duly apportioned between and paid to the vicar or minister making the vacancy, or his personal representatives, and the vicar or minister succeeding to the same vicarage or district; and that there shall be paid by us, out of the like endowments or monies, when and so soon as occasion shall require, and to such persons and at such times as we shall deem expedient, the several grants or sums of money mentioned in the fourth column of the same schedule in respect of the several districts or vicarages opposite to the names of which, or of the churches thereof, such sums are placed, and for the objects and purposes mentioned in the fifth column of such schedule; but upon condition that the several sites for churches and residence houses shall be duly conveyed to and vested in the vicars of such vicarages or ministers of such districts respectively, and their respective successors for ever, and shall, previously to any treaty being entered into for the purchase of such sites respectively, be approved by us and by the bishop of the said diocese for the time being, and that the several churches and residence houses shall be erected and built under the direction and supervision of an architect so as aforesaid, to be nominated by us and the said Bishop of Lichfield. •

"And we further recommend and propose, that such vicarages and vicars shall be so respectively constituted and-such augmentations of income and grants of money made subject to and upon the several conditions hereinbefore mentioned, and also the several further conditions set against the names of the corresponding districts and churches in the sixth and seventh columns of the said schedule; and that in default of such conditions being duly accepted with every such grant, or if and whenever at any future time, and from time to time, any of such conditions shall in any case be unfulfilled, the grant, or so much thereof as shall in such case remain unpaid, shall be withheld by us until every such condition shall be fulfilled to our satisfaction according to the terms and tenor of this scheme.

"And whereas the said several districts of Saint Mark, Saint Matthew, Holy Trinity, Saint Stephen, Saint Luke, and Moxley were constituted by Orders of your Majesty in Council duly made and gazetted under the provisions of the said thirdly-recited Act, and the endowments thereof were secured to the said several districts in the form of certain graduated incomes made payable by us under the same Orders in Council; we recommend and propose, that the several yearly sums of money, so as aforesaid set against the names of the said several districts in the said second column of the same schedule, shall be and be held to be in lieu and full satisfaction of and for such graduated incomes, and that all sums of money so payable under and by virtue of the said Orders in Council to the ministers of the same districts shall cease and determine as from the first day of November now last past.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measure relating to the matters aforesaid or any of them, in accordance with the provisions of the said Acts or any of them, or of any other Act of Parliament.
