Camp, Ferozepore, February 13, 1849.

In the General Order of the Governor-General, dated the 1st instant, relating to the surrender of Mooltan, his Lordship, while thanking Major Edwardes and Lieutenant Lake for the services rendered by the forces under their commands, purposely omitted the name of General Cortlandt, wishing to address him as an officer of the Maharaja of Lahore, through the Resident.

His Lordship now desires that his thanks may be conveyed to General Cortlandt for his conduct in connection with the force under Major Edwardes, and for the gallantry and firmness which he has evinced throughout all the operations in the Mooltan district and Derajat.

You are requested to transmit the thanks of the Governor-General to General Cortlandt, direct to

himself.
