and in the diocese of Ripon, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint Matthew, situate at West Town, in the said parish of Dewsbury, under and by virtue of the power or authority for such purpose contained in the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His late Majesty King George the Third, intituled 'An Act to ' amend and render more effectual an Act, passed ' in the last session of Parliament, for building, ' and promoting the building, of additional churches 'in populous parishes,' or under or by virtue of any other power or authority in this behalf vested in your Majesty's said Commissioners by the Church Building Acts, and that such district should be named 'The Chapelry District of West Town, Dewsbury,' with boundaries as hereinafter mentioned:

"The chapelry district of West Town commences at the north-east corner of the Daw Green Charity School, and extends therefrom, down the centre of Boothroyd-lane, to the house now occupied by Mrs. Howroyd; and from thence, down the public footpath, to the north side of the bridge under the Leeds and Dewsbury Railway; crosses Webster-hill, and then proceeds in a westerly direction, along the north side of the said railway, to the river Calder; and then proceeds in a northwestwardly direction to the junction of the parish of Dewsbury with the parish of Mirfield, and then proceeds in a northwardly direction along the boundary of the said parish of Mirfield, to the boundary of that part of the parish of Dewsbury already as-signed as a district chapelry to Saint John's Church, Dewsbury Moor; and then proceeds in an eastwardly direction, on the south side of the boundary of such last-mentioned district chapelry, to the north-east corner of the Daw Green Charity School aforesaid, as such proposed chapelry district of West Town is more particularly delineated on the map or plan hereunto annexed, and thereon coloured green :

" Your Majesty's said Commissioners beg leave further to represent, that it also appears to them to be expedient, that banns of marriage should be published, and that marriages, baptisms, church-ings and burials should be solemnized or performed in the said church of Saint Matthew at West Town aforesaid; and that the fees to arise therefrom should be equally divided between the minister thereof and the vicar or incumbent of the parish church of the said parish of Dewsbury

for the time being respectively: "That the consent of the Right Reverend Charles Thomas Lord Bishop of Ripon (as Bishop of the diocese) has been obtained thereto, as required by the Act and section hereinbefore mentioned; in testimony whereof the said Charles Thomas Lord Bishop of Ripon has signed and sealed this representation :

" Your Majesty's said Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the publication of banns, and the solemnization of marriages, baptisms, church-

ings and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Ripon.
