NOTICE is hereby given, that Her Majesty will hold a Drawing-Room at St. James's-Palace, on Thursday, 31st May next, at two o'clock.

REGULATIONS TO BE OBSERVED AT THE QUEEN'S DRAWING-ROOM.

The Ladies, who purpose to attend Her Majesty's Drawing-Room, are requested to bring with them two large cards, with their names legibly written thereon, one to be left with the Queen's Page in Attendance in the Presence-chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

And those Ladies, who are to be presented, are hereby informed, it is absolutely necessary that their names, together with the names of the Ladies who are to present them, should be sent in to the Lord Chamberlain's Office, on the Tuesday previous to the Drawing-Room on the 31st of May, before twelve o'clock, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command, that no presentation shall take place unless the name of the Lady presenting, together with that of the Lady to be presented, shall appear on the card to be delivered to the Lord Chamberlain, which names shall correspond with those previously sent in to the Lord Chamberlain's Office.

It is particularly requested, that in every case written cards only be delivered.

NOTICE is hereby given, that the carriages proceeding to her Majesty's Drawing-Room, on Thursday the 31st of May, are to fall into line and come down the left-hand side of St. James's-street, enter at the iron gate nearest the Palace, set down at the Arcade, turn round, and go out by the iron gate nearest Marlborough-house, to wait in St. James's-square. When called, they are to pass from the square through Charles-street, into Regent-street and Jernyn-street, come down St. James's-street as before, take up, and go away through Pall-mall.

No hackney carriages will be admitted within the gates.

For all persons having the privilege of the *entrée*, tickets will be delivered at the Board of Green Cloth, on Tuesday next, from eleven till three o'clock: their carriages are to pass through Constitution-hill-gate, into St. James's-park: those belonging to the Ambassadors and Foreign Ministers are to set down at the Ambassadors'-entrance in Marlborough-court, at the east end of St. James's-palace, and wait there till called: those belonging to the Cabinet Ministers and Great Officers of State are to set down in the Middle-court, and wait there: the carriages of all other persons having the *entrée* are likewise to set down in the Middle-court, and wait in Stable-yard, or St. James's-park, till called: they are then to take up in the same order as they had set down, and pass away up St. James's-street.

No carriage will be admitted with company a second time with the same ticket; to prevent which, it must be produced at Constitution-hill-gate, and Stable-yard-gate also, where a corner of it will be torn off by the Marshalmen in attendance; and no person can be allowed the privilege of the *entrée* by any other approach to the Palace than as above directed.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixth section of an Act, passed in the session of Parliament holden in the third and fourth years of Her Majesty's reign, intituled "An Act to further amend the Church Building Acts," duly prepared and laid before Her Majesty in Council a representation, bearing date the eighth day of May one thousand eight hundred and forty-nine, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that, in the year one thousand eight hundred and thirty, your Majesty's said Commissioners (with the consent of the Right Honourable and Right Reverend Charles James Lord Bishop of London, signified under his hand and seal) made a representation to His Majesty King George the Fourth, in Council, stating (among

other things) that it appeared to them to be expedient that the parish of Saint Mary, Islington, in the county of Middlesex, and in the diocese of London, should, and they therefore humbly prayed that such parish might be divided into ecclesiastical districts under the twenty-first section of an Act, passed in the fifty-eighth year of His then late Majesty King George the Third, intituled 'An Act for building and promoting the building of additional churches in populous parishes,' and that such districts should be named respectively, 'The Trinity District,' 'The Saint Paul's District,' and 'The Saint John's District,' and that the residue of the said parish of Saint Mary, Islington, wherein the parish church would be situated should be called 'Saint Mary's District,' and that the boundaries of Saint Paul's District and Saint Mary's District, respectively, should be as follow; that is to say:

"Saint Paul's District. This district is bounded on the north by the parishes of Saint Mary, Newington, and of Saint Mary, Hornsey; on the west by Saint Mary's District; on the south by the parishes of Saint John, Hackney, and of Saint Leonard, Shoreditch; and on the east by the parishes of Saint Mary, Newington, of Saint Mary, Hornsey, and of Saint John, Hackney, as the boundary thereof is hereinafter more particularly described; namely:—commencing at the fence on the north-east side of the New North-road, about seventy-six feet north-west of the bridge over the Regent's Canal, the boundary line runs to the north-north-east above five hundred and four feet by a watercourse to an angle in the same; thence east-south-east about five hundred and two feet by an imaginary line to the end of Sheperton-street, to within about seventy-six south of the south-east corner of the Rosemary Branch Public-house, and about seventy feet north-north-west of the bridge over the Regent's Canal; thence north-north-east, about one thousand three hundred and fourteen feet by the irregular line of a watercourse, to an angle in the same; thence about one hundred and eighty-three feet north-north-west to another angle in the same, where the watercourse turns to the west, about twenty-five feet from the east corner of the front of Pleasant-row; thence by an imaginary line north-north-east about three hundred and fifty-six feet; thence by another imaginary line west-north-west, about one hundred and seventy-one feet; thence north-north-east, partly by an imaginary line and partly by an old ditch, to within about one hundred and fifty-three feet south-west of the road from Ball's Pond to Kingsland; thence to the east by a watercourse on the side of a lane, at the rear of the premises belonging to the houses of Brunswick-place, to an angle in the same, at the end of the said lane; thence north-east about one hundred and seventy feet by the line of an old ditch to a watercourse in the rear of the premises belonging to the houses in Elizabeth-place; thence to the east by the line of the said watercourse, at the rear of premises of Elizabeth-place, and of other buildings on the south side of Ball's Pond-road, and partly by an imaginary line in the rear of the said premises, and by the boundary of other premises on the southern side of the road, in front of Union-road, to within about thirty-one feet of the front wall of the said premises; thence north by an imaginary line through No. 4, in the said row, four feet west of the east party-wall thereof, and through a yard at the back of the same, and also through other premises, and a garden belonging to a house in Kingsland-road, to the north-east angle thereof; thence east about forty-one feet by an imaginary line to the south wall of Saint Bartho-

lomew's Chapel; thence north, by an imaginary line through the said chapel to the north wall thereof, about eighteen feet from the eastern end of the said chapel; thence in the same direction, by an imaginary line across Ball's Pond-road, in front of the premises in the Kingsland-road, at the end of the said Ball's Pond-road, and across Kingsland-green to the north side thereof; thence nearly in the same direction by the outer edge of the footpath, on the east side of a lane leading from Kingsland-green to Newington-green, to the south end of Baynes'-buildings; thence by an imaginary line through the four courts of the said buildings, across William-street to a passage near the end of the said street; thence through the said passage, and by the west side of the footpath in front of Tingle's-buildings, crossing Cock-lane, and by an imaginary line in the middle of the aforesaid lane, leading from Kingsland to Newington-green, passing the end of Barrett-grove, to the fence on the north side of Newington-green; thence to the west, crossing the road at the west side of the said green, by a ditch in front of the north wall of the premises at the north-west corner of the said green, which ditch passes under a small triangular garden to a hedge-row at the rear of premises on the south-west side of the road to Southgate; thence about four hundred and ninety feet by the irregular line of the said ditch and hedge-row to an angle in the same, about two hundred feet south-west of the road; thence north-north-east, about two hundred and thirty-five feet by the line of the said ditch to another angle in the same, about thirty-six feet south-west of the road; thence by the irregularly curved line of the said ditch, behind the houses in Millfield-place and an old mill, and within a few feet of the New River, to the end of the said ditch, about twenty-eight feet south of the bridge, over the said river; thence by an imaginary line on the west side of the said bridge, across the New River, to another ditch; thence north-north-west, about one hundred and eight feet by the line of the last-mentioned ditch, to an angle in the same; thence four hundred and fifty feet in nearly the same direction, by the line of an old ditch, on the west side of the said road to Southgate, to its junction with the road; thence by the ditch on the west side of the road, and by an imaginary line across the New River, at a bridge over the same, to the north corner of lane, leading thence to Mount Pleasant; thence to the west, through the middle of the said lane, and across the New River, to the end of the footpath in Highbury-vale; thence to the south, by the west side of the said footpath, passing in front of the houses in Highbury-park, and of the houses on the east side of Highbury-grove to Hopping-lane; thence across the lane to the east side of the footpath, six feet from the east wall of the premises belonging to Canonbury Tavern; thence south-south-east, by the east side of the said footpath to the outer edge of the footpath adjoining the south side of Canonbury Tavern; thence west-south-west, by the outer edge of the said footpath, passing a pond to within about six feet of the boundary wall of premises belonging to No. 4, Canonbury-lane; thence south-south-east, crossing the east end of the said lane to the outer edge of the footpath in the rear of houses and premises on the east side of Canonbury-square, and in front of the houses of Canonbury-terrace; thence in the same direction by the outer edge of the said footpath to the bridge in the New North-road, over the New River; thence south-east, across the New River, and by the outer edge of the footpath, and partly by the line of fence on the north-east side of the said New North-road, cross-

ing the Lower-street, passing the ends of New Norfolk-street, George-street, Wilham-street, and crossing Sheperton-street, to within seventy-six feet of the aforesaid bridge, over the Regent's Canal, as such district was more particularly delineated and described in the plan annexed to the said representation :

“ Saint Mary's District. This district is bounded on the north by Saint John's district ; on the west by Trinity district and by the parish of Saint James, Clerkenwell ; and on the south by the parishes of Saint Luke and of Saint Leonard, Shoreditch ; and on the east, by Saint Paul's district ; as the boundary thereof is hereinafter more particularly described ; namely :—commencing in the middle of the road, opposite the Angel-inn, at the junction of High-street with the City-road, the boundary line runs to the east along the middle of the said City-road, and obliquely across the same to the boundary of certain houses, premises, and fore-courts, abutting on the north-east side of Goswell-street-road ; thence by the said boundary of the south party-wall of No. 18, Frederick's-place, on the said road ; thence to the north-east along the line of the said party-wall to the rear wall of the said house ; thence to the south-east by the line of the rear walls of Nos. 100 and 101, Goswell-road, to the north-west boundary wall of 102 ; thence north-east, by the line of the said wall, to the north-east boundary wall of the premises belonging to the said house ; thence south-east, by the said wall and the southern party-wall of No. 29, Sydney-street, to the front of the last-mentioned house ; thence across the said street to the southern party-wall of No. 2, in the said street ; thence in the same direction, along the said party-wall, to the rear thereof ; thence by an imaginary line to within about eleven feet east of the south-west corner of No. 16, Sydney-place ; thence nearly north, by an imaginary line to the east flank-wall of No. 6, Saint Vincent-place, City-road ; thence to the north, across the said road, and through the middle of a street leading to Nelson-terrace to an angle in the common sewer at the end of the said terrace ; thence nearly east, by the line of the said sewer, passing under a shed belonging to No. 15, Nelson-place, by the corner of City-garden-row, across Macclesfield-street, and through part of the premises of a wharf numbered 17, on the west side of the City-road-basin of the Regent's Canal to the said basin ; thence across the said basin, nearly in the same direction, by the line of the aforesaid sewer, which passes beneath the same to the east side thereof ; thence by the line of the same sewer, and in the same direction, to an angle in the said sewer, on the east side of a new street ; thence north-north-west, by an imaginary line, to an angle within a few feet of the south bank of the said canal at the end of the said new street ; thence east-north-east, in the direction of the said canal, on the southern bank thereof, crossing Wenlock-basin and the Shepherd and Shepherdess-path to the south side of Sturt's-lock in the said canal, near the New North-road ; thence by an imaginary line, crossing obliquely the said canal, to the northern bank thereof, about two hundred feet south-west of the said road ; thence to the north-east side of the said road, about seventy-six feet from the said canal ; thence north-north-west, partly by the line of fence, and partly by the outer edge of the footpath on the north-east side of the said New North-road, crossing Sheperton-street, passing the ends of Wilham-street and George-street, and New Norfolk-street, and crossing the Lower-street, Islington, and the New River to the corner of the footpath on the west side of the

New-road, in front of Canonbury-terrace, at the outer edge thereof ; thence north-north-west, by the outer edge of the said footpath, in a direct line, to the outer edge of the footpath on the north side of the road, opposite Canonbury-house ; thence east-north-east, by the said edge of the footpath, to the outer edge of the footpath on the east side of the premises belonging to Canonbury Tavern ; thence north-north-west, by the line of the last-mentioned footpath, to Hopping-lane ; thence across the said lane, by an imaginary line, and to the north by the outer edge of the footpath in front of the houses on the east side of Highbury-grove and Highbury-park to Highbury-vale ; thence in the same direction, by the west side of the footpath, through the said vale, to its junction with a watercourse near the New River ; thence to the south-west, by the line of the said watercourse, to an angle in the same, about two hundred and sixty feet from the New River ; thence to the south, about sixty feet, to another angle in the watercourse ; thence to the west-south-west, by the irregular line of the said watercourse, to a diverging watercourse ; thence to the south, about nine hundred and thirty feet, and to the west-south-west, about three hundred feet, by the line of the said watercourse, to its junction with the Hornsey-road ; thence south-west, by the outer edge of the footpath, on the south-east side of the said road, and by an imaginary line across the Great North-road to the outer edge of the footpath on the south-west side of the same ; thence to the south-east, by the said edge of the footpath, to the outer edge of the footpath, on the north-west side of Cornwall-place ; thence to the south-east, by the said edge of the footpath, on the north-west side of Cornwall-place and Eden-place, to the outer edge of the footpath on the south-west side of Grove-street ; thence south-east, by the edge of the last-mentioned footpath, to the outer edge of the footpath on the north-west side of George-street ; thence to the south-west, by the outer edge of the said footpath and of the footpath in front of the houses, on the north-west side of the grove, and by the south edge of the footpath leading thence to Copenhagen-house, crossing the New-road, from Battle-bridge to Holloway, to a hedge-row about four hundred and fifteen feet from the said road ; thence to the south, by the irregular line of the said hedge-row, crossing a footpath from Barnsbury-park to Copenhagen-house, and passing between two ponds at an angle in the same, about sixty-eight feet west of the said road, opposite a hedge-row running thence to the Albany-road ; thence to the east, by the line of the last-mentioned hedge-row, again crossing the said New-road, and the footpath from Barnsbury-park to Copenhagen-house, and by the line of an old hedge-row on the south side of the Albany-road, to the west corner of a wall forming the northern boundary of gardens belonging to certain houses on the north side of Barnsbury-park ; thence in the same direction by the line of the said wall, and of a wall forming the northern boundary of the house at the south corner of Park-lane, in the Liverpool-road, to the outer edge of the footpath on the west side of the said road ; thence to the south by the outer edge of the said footpath, passing the ends of Felix-street, and the street leading to Cloudesley-square, to the south side of the east end of Sermon-lane ; thence into the carriage-road, six feet from the outer edge of the footpath, on the west side of the said road ; thence by an imaginary line in the said road to the middle of High-street, nearly opposite the turn-pike ; and thence south, through the middle of the said High-street, to its junction with the City-road,

as the same district called Saint Mary's district was more particularly delineated and described in the plan annexed to the said representation :

"Your Majesty's said Commissioners beg leave further to represent that by an Order of His late Majesty King George the Fourth in Council, bearing date the seventh day of April, one thousand eight hundred and thirty, His Majesty having taken the premises into His royal consideration, was graciously pleased, by and with the advice of His Privy Council, to approve of the proposed division of the said parish of Saint Mary, Islington, into ecclesiastical districts as aforesaid, and to order, as it was thereby ordered, that the same should be accordingly made and effected agreeably to the provisions of the said Act :

"Your Majesty's said Commissioners beg leave further to represent that a description of the boundaries of each of the said districts, called Saint Paul's District and Saint Mary's District, was duly enrolled in your Majesty's High Court of Chancery, on the first day of July one thousand eight hundred and thirty :

"Your Majesty's said Commissioners beg leave further to represent that the aforesaid Order in Council for forming the said district called Saint Paul's District has, by an avoidance of the vicarage or parish church of the said parish of Saint Mary, Islington, which took place in the year one thousand eight hundred and thirty-two, taken complete effect, and the same, since such avoidance, became a district parish within the meaning of the said recited Act, and that such district parish is now called and known by the name of 'The District Parish of Saint Paul, Ball's Pond,' and that the said district called Saint Mary's District has, since the said division was made, been, and still is, for ecclesiastical purposes, called or distinguished by the name of the Parish of Saint Mary, Islington :

"Your Majesty's said Commissioners beg leave further to represent, that having taken into consideration the present circumstances of the said district called Saint Paul's District Parish, and also of the said district called Saint Mary's District, otherwise the Parish of Saint Mary, Islington, it appears to them to be expedient that the boundaries of the said district Parish of Saint Paul, Ball's Pond, and of the said district called Saint Mary's, otherwise the Parish of Saint Mary, Islington, as aforesaid, should be respectively altered under the provisions of the sixth section of an Act passed in the session of Parliament holden in the third and fourth years of your Majesty's reign, intituled 'An Act to further amend the Church Building Acts,' and that the boundaries hereinafter set forth should be substituted for those comprised in the said Order in Council, bearing date the seventh day of April one thousand eight hundred and thirty, and so enrolled in your Majesty's High Court of Chancery as aforesaid, and that the said district parish should continue to be called or distinguished by the name of 'The District Parish of Saint Paul, Ball's Pond,' and that such district, called Saint Mary's District, otherwise the Parish of Saint Mary, Islington, should continue to be called or distinguished by the name of the Parish of Saint Mary, Islington, with boundaries as hereinafter mentioned ; that is to say :

"The district parish of Saint Paul, Ball's Pond, is bounded on the north and east by the parish of Saint Mary, Newington ; on the south-east, by the parishes of Saint John, Hackney, and Saint Leonard, Shoreditch ; on the west, by the chapelry district of Saint Stephen, Islington ; and on the west and north, by the parish of Saint Mary,

Islington, and is hereinafter more particularly described ; thus :—commencing in the New North-road, about fifty-six feet north-west of the bridge from the New North-road, over the Regent's Canal ; thence in a north-west direction, in a line of the New North-road and King-street, in the middle thereof, to the Lower-road at the corner of Scott's-place ; thence to the north-east, in the Lower-road, to the south-east end of Northampton-street ; thence taking a northerly direction through the middle of Northampton-street, to the north end thereof ; thence taking the same direction across the New River ; and from thence, nearly in the same direction, in an imaginary line to the rear of the houses on the eastern side of Canonbury-place ; thence westerly, through the house in the south-east angle of Canonbury-place, and through the middle of the said place to Canonbury-terrace ; thence northward, at the back of the houses on the western side of Saint Mary's-road, to Hopping-lane, to a point of about one hundred and fifty feet westward from the north-west corner of Saint Mary's-road ; thence easterly, along Hopping-lane, in the middle thereof, to the curve leading to Highbury-grove-road ; and thence, northerly, in Highbury-grove-road, in the middle thereof, to the corner of the garden ground belonging to the houses shewn on the map hereinafter mentioned or referred to ; from thence easterly, for a length of about eighteen hundred and ten feet, in an imaginary line to a point next the New River, given by a measurement of about thirteen hundred and ten feet from the south-western pier of the aqueduct of the New River, passing over the London and Blackwall Railway ; thence northerly, by the irregular course of the New River, to the bridge under the road leading from London to Enfield, about seven hundred and eighty feet south of the third mile-stone, in the road from London to Enfield ; from thence in a south and south-easterly direction by the irregular line of the original boundaries of the parishes of Islington and Saint Mary, Stoke Newington ; thence westerly and southerly, by the irregular lines of boundaries of the parishes of Saint John, Hackney, Saint Leonard, Shoreditch, and the parish of Islington, to the point first given in the New North-road, next the bridge, over the Regent's Canal, and which said district parish of Saint Paul, Ball's Pond, is more particularly delineated on the map hereto annexed, and thereon coloured red.

"The parish of Saint Mary, Islington, is bounded on the west by the district parish of the Holy Trinity, Islington, and the chapelry district of Saint James, Lower Holloway ; on the north, by the district parish of Saint John, Upper Holloway, and the parish of Saint Mary, Hornsey ; on the east, by the parish of Stoke Newington, the district parish of Saint Paul, Ball's Pond, and the chapelry district of Saint Stephen, Islington ; on the south-east, by the parish of Saint Leonard, Shoreditch ; and on the south, by Saint Peter's district, and is hereinafter more particularly described ; thus :—commencing at the junction of the High-street with the Liverpool-road at the extreme south end thereof, and thence in a northerly direction, by the edge of the footpath on the western side of the Liverpool-road, to a curve at the northern end of Chapel-place, Holloway ; thence in an easterly direction through Palmer-place, in the middle thereof, to the north side of the high-road leading to Upper Holloway ; thence in the line of the latter road by the edge of the footpath towards the north, and crossing the said road to Francis-place ; thence north-east, passing through the rear of No. 1, in the said place, to an

old irregular line of hedge-row at the back of the said place; thence northerly, keeping the irregular line to Hornsey-lane, about fifty feet east of Appleby-place and Brand-street; thence towards the east, to the south-east corner of Hornsey-lane on the north-east side thereof; thence nearly in a north-east direction, by the irregular line of water-course, till it meets another watercourse in a north-westerly direction, forming an angle in the boundary; thence inclining a few points to the eastward, by the same line of watercourse to Highbury-vale, and on by the same course through the archway under the New River, to a culvert passing under the Occupation-road; and thence by the line of road and brick-wall in a north-easterly direction, to the main-road leading from London to Enfield, about fifty-six feet northward of a bridge crossing the New River under the said road; thence in a southerly direction by the line of the latter road to another bridge across the New River, about seven hundred and eighty feet south of the third mile-stone from London; and thence nearly in the same direction by the irregular line of the New River to a point given by a measurement of thirteen hundred and ten feet from the south-western pier of the aqueduct of the New River, passing over the Birmingham and Blackwall Railway, in the district parish of Saint Paul, Ball's Pond; thence from the latter point in a westerly direction by an imaginary line, about eighteen hundred and ten feet in length, to Highbury-grove-road, at the south corner of the garden ground shewn in the said map; from thence southerly by the line of Highbury-grove, in the middle thereof, to the curve at the junction of the same with Hopping-lane; thence westerly by the line of the latter road to about one hundred and fifty feet from the western side of Saint Mary's-road; and thence southerly in an imaginary line to the north-west corner of Canonbury-terrace, then westward to the north-east corner of Canonbury-square; thence to the south-east, on the eastern side of the square, to the south-eastern corner thereof; thence westerly, on the southern side of Canonbury-square, by the edge of the footpath to the south-west corner thereof; thence southward in an imaginary line through the gardens between the houses No. 1, Canonbury-square, and No. 1, Canonbury-lane, continuing in the same direction to the north end of Sable-street, continuing southward in the line of Sable-street and Sebbon-street, and crossing Spencer-street in an oblique direction to Allan-street; thence eastward through Allan-street into Halton-street; thence southward through Halton-street, in the middle thereof, to the Lower-road, crossing the Lower-road to Elder-walk; and thence to the east, by an imaginary line, in the rear of the houses in Elder-walk, to Popham-terrace; thence northerly to the west end of South-street; thence easterly by the water-course, on the south side of South-street, to its junction with the New North-road; thence to the south-east, in the New North-road, to the northern side of the bridge across the canal in the New North-road; thence in a southerly direction to the south-eastern side of the Regent's Canal; thence, in a south-westerly direction, by the boundaries of the parishes of Islington and Saint Leonard, Shoreditch, to the bridge crossing the Regent's Canal from Saint Peter's-street; thence in a north-westerly direction by the rear garden walls of the houses on the north east side of Saint Peter's-street, about one hundred and ten feet from the middle of the street crossing Rheidol-terrace, at the south end of River-lane; from thence, nearly in the same direction, at the back

of the houses in River-lane, and the distance of one hundred and ten feet from the middle of the road on the north side thereof to the Lower-road; thence southerly in the Lower-road, and on the eastern side of Islington-green, to the High-street; thence, nearly in the same direction, to the junction of the High-street and the Liverpool-road; and which said parish of Saint Mary, Islington, is more particularly delineated on the said map hereunto annexed, and thereon coloured blue:

STEAMERS' LIGHTS.—TO PREVENT COLLISION.

By the Commissioners for executing the Office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, &c. &c.

Whereas under and by virtue of the Act of Parliament, passed in the tenth year of the reign of Her present Majesty, intituled "An Act for the regulation of steam navigation, and for requiring sea-going vessels to carry boats," we hereby require, in pursuance of the said Act, that lights shall be exhibited by all steam vessels, except in the river Thames, above Yantlett Creek,

between sunset and sunrise, of such description and in such manner as hereinafter mentioned; that is to say:

When under Weigh.

1. Bright white light, at the foremast-head.
2. Green light, on the starboard side.
3. Red light, on the port side.

When at Anchor.

A common bright light.*

The following conditions to be observed: viz.

1. The mast-head light to be visible at a distance of *at least five miles* in a clear dark night, and the lantern to be so constructed as to show a uniform and unbroken light over an arc of the horizon of twenty points of the compass; viz. from right ahead to two points abaft the beam on each side of the ship.

2. The coloured side-lights to be visible at a distance of *at least two miles* in a clear dark night, and the lanterns to be so constructed as to show a uniform and unbroken light over an arc of the horizon of ten points of the compass; viz. from right ahead to two points abaft the beam on their respective sides.

3. The side-lights to be moreover fitted with inboard screens, of at least three feet long, to prevent them from being seen across the bow. The screens to be placed in a fore and aft line with the inner edge of the side-lights.

*4. The lantern used when at anchor to be so constructed as to show a good light all round the horizon.

** Diagrams, illustrative of the above plan, and instructions, as to the proper mode of fitting the lights on board steam vessels, will be furnished to parties applying for them.

Nosshead Lighthouse.

THE Commissioners of the Northern Lighthouses hereby give notice, that a lighthouse has been built upon the Point of Nosshead, in the county of Caithness, the light of which will be exhibited on the night of Monday the 18th June 1849, and every night thereafter, from sunset till sunrise.

The following is a specification of the lighthouse, and the appearance of the light, by Mr. Alan Stevenson, Engineer to the Commissioners:

The lighthouse is in N. lat. $58^{\circ} 28' 38''$, and in W. long. $3^{\circ} 3' 5''$. By compass the lighthouse bears from Ackergill Tower in Sinclair's Bay, E. by S. $\frac{3}{4}$ S, distant 2 miles; from Duncansby Head, S.S.W. $\frac{3}{4}$ W., distant 10 miles; from Pentland Skerries' Lighthouse, S.W. by S. $\frac{1}{4}$ W., distant 13 miles; from Elzierness, N.N.E. $\frac{1}{2}$ E., distant $1\frac{1}{2}$ mile; and from Sarclethead, N.E. $\frac{1}{4}$ N., distant $6\frac{3}{4}$ miles.

The Nosshead Light will be known to mariners as a revolving light, which gradually attains its brightest state once every half minute, and then as gradually declines, until to a distant observer it totally disappears. The light will be visible towards the north and east, between W.N.W. and S.W. $\frac{1}{4}$ W. From S.W. $\frac{1}{4}$ W. to N.E. $\frac{3}{4}$ N. in a south-easterly direction, the light will be of the natural appearance; but from N.E. $\frac{3}{4}$ N. to W.N.W. in a northerly direction (or within Sinclair's Bay) it will be coloured Red. The lantern is elevated 175 feet above the level of the sea; and the light will be seen at the distance of about 15 miles, and at lesser distances according to the state of the atmosphere; and, to a near observer, in favourable weather, the light will not wholly disappear between the intervals of greatest brightness.
