The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the session of Parliament holden in the fifth and sixth years of the reign of Her present Majesty, intituled "An Act to amend the law of copyright," it is, among other things, enacted, that it shall not be lawful for any person, not being the proprietor of the copyright, or some person authorized by him, to import into any part of the United Kingdom, or into any other part of the British dominions, for sale or hire any printed book first composed or written, or printed and published in any part of the United Kingdom wherein there shall be copyright, and reprinted in any country or place whatsoever out of the British dominions:

And whereas by an Act, passed in the session of Parliament holden in the eighth and ninth years of the reign of Her present Majesty, intituled "An Act to regulate the trade of the British possessions abroad," books, wherein the copyright is subsisting, first composed or written or printed in the United Kingdom, and printed or reprinted in any other country, are absolutely prohibited to be imported into the British posses-

And whereas by an Act, passed in the session of Parliament holden in the tenth and eleventh years of the reign of Her present Majesty, in-tituled "An Act to amend the law relating to "the protection in the colonies of works entitled " to copyright in the United Kingdom," it is enacted, that in case the legislature or proper legislative authorities in any British possession shall be disposed to make due provision for securing or protecting the rights of British authors in such possession, and shall pass an Act or make an Ordinance for that purpose, and shall transmit the same in the proper manner to the Secretary of State, in order that it may be submitted to Her Majesty; and in case Her Majesty shall be of opinion that such Act or Ordinance is sufficient for the purpose of securing to British

authors reasonable protection within such possession, it shall be lawful for Her Majesty, if she think fit so to do, to express Her royal approval of such Act or Ordinance, and thereupon to issue an Order in Council, declaring, that so long as the provisions of such Act or Ordinance continue in force within such colony, the prohibitions contained in the aforesaid Acts, and hereinbefore recited, and any prohibitions contained in the said Acts, or in any other Acts against the importing, selling, letting out to hire, exposing for sale or hire, or possessing foreign reprints of books first composed, written, printed, or published in the United Kingdom, and entitled to copyright therein, shall be suspended, so far as regards such colony:

And whereas an Act has been passed by the Governor, Council, and Assembly of the Bahamas, No. 1208, intituled "An Act for protecting in the Bahamas the Rights of British Authors," whereby provision is made for securing to British authors a certain remuneration in respect of unauthorized copies of works, under copyright, im-

ported into the Bahamas:

And whereas Her Majesty hath expressed Her

royal approval of the same:

Now, therefore, Her Majesty, by and with the advice and consent of Her Privy Council, and by the authority of the same, doth order, and it is hereby ordered, that so long as the said Act of the Legislature of the Bahamas shall remain and continue in force within the said Bahamas, all prohibitions in either of the said hereinbefore recited Acts of the Imperial Parliament, or in any other Acts thereof contained, against the importing into the said Bahamas, or against the selling, letting out to hire, or possessing therein foreign reprints of books first composed, written, printed, or published in the United Kingdom, and entitled to copyright therein, shall be suspended, so far as regards foreign reprints imported into the said Bahamas:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Earl Grey, one of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein, as to them may respectively appertain.

all its rights and privileges.

We earnestly trust that, under the blessing of Almighty God, the proceedings on which we are about to enter shall be so conducted as in no respect to forfeit the confidence which your Majesty has been pleased to repose in our loyalty and attachment, and it is our fervent prayer that in all our consultations we may be so directed by the wisdom which cometh from above, as to be instrumental in the advancement of true religion, the welfare and efficiency of the Church of Scotland, and the best interests of its members.

The renewed appointment of Lord Belhaven, as your Majesty's High Commissioner and Representative in this Assembly, is regarded by us as an additional proof of your Majesty's favour, as in former years we have had the most gratifying experience of his courtesy, prudence, and fidelity, his affection for the church of which he is a member, and his other peculiar qualifications for the efficient and acceptable discharge of the important

duties entrusted to him.

Your Majesty's royal warrant for two thousand pounds to be applied to the reformation of the Highlands of Scotland has been most gratefully received, and it shall be our study to devote this liberal gift to the important object for which it

has been conferred.

STEAMERS' LIGHTS.-TO PREVENT COLLISION.

By the Commissioners for executing the Office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, &c. &c.

Whereas under and by virtue of the Act of Parliament, passed in the tenth year of the reign of Her present Majesty, intituled "An Act for the regulation of steam navigation, and for requiring sea-going vessels to carry boats," we hereby require, in pursuance of the said Act, that lights shall be exhibited by all steam vessels, except in the river Thames, above Yantlett Creek, between sunset and sunrise, of such description and in such manner as hereinafter mentioned; that is to say:

When under Weigh.

1. Bright white light, at the foremast-head.

2. Green light, on the starboard side.

3. Red light, on the port side.

When at Anchor. A common bright light.*

The following conditions to be observed: viz.

1. The mast-head light to be visible at a distance of at least five miles in a clear dark night, and the lantern to be so constructed as to show a uniform and unbroken light over an arc of the horizon of twenty points of the compass; viz. from right ahead to two points abaft the beam on each side of the ship.

2. The coloured side-lights to be visible at a distance of at least two miles in a clear dark night, and the lanterns to be so constructed as to show a uniform and unbroken light over an arc of the horizon of ten points of the compass; viz. from right ahead to two points abaft the beam on their respective sides.

3. The side-lights to be moreover fitted with inboard screens, of at least three feet long, to prevent them from being seen across the bow. The screens to be placed in a fore and aft line with the inner edge of the side-lights.

*4. The lantern used when at anchor to be so constructed as to show a good light all round the horizon.

** Diagrams, illustrative of the above plan, and instructions, as to the proper mode of fitting the lights on board steam vessels, will be furnished to parties applying for them.
