And notice is hereby also given, that it is intended to obtain powers by the said Act to alter, amend, extend, and enlarge the powers and provisions of all or some of the following Acts relating to the navigation of the River Dun:—the 12th George I., c. 38; 13th George I., c. 20; 6th George II., c. 9; 13th George II., c. 11; 1st & 2nd George IV., c. 46; 7th George IV., c. 97; 33rd George III., c. 117; 38th George III., c. 47; 49th George III., c. 71; 55th George III., c. 65; 11th and 12th Victoria, c. 94; 12th and 13th Victoria, c. 29; and 12 and 13th Victoria, c. 75. Also of the Acts relating to the Dearne and Dove Canal, viz., the 33rd George III., c. 115; and the 39th and 40th George III., c. 37; and to enable the said South Yorkshire, Doncaster, and Goole Railway Company to raise money by way of mortgage or otherwise, upon the security of the tolls, rates, or duties authorized to be taken and levied by such Acts, or some of them, for the purpose of redeeming or purchasing the shares of the proprietors of the navigation of the River Dun and of the Dearne and Dove Canal.

And it is also intended by the said Act to enable the South Yorkshire, Doncaster, and Goole Railway Company, to alter and vary the tolls, rates, and duties authorized to be charged or levied under and by virtue of the provisions of the said first-mentioned Acts, and to levy tolls, rates, and duties in respect of the said new lines of railway, and to grant exemptions from such tolls, rates, and duties, and also to obtain powers for the compulsory purchase of lands, houses, and hereditaments, to be described upon the plans hereinafter mentioned. And also power to vary and extinguish all rights and privileges touching such lands, houses, and hereditaments, which may in any manner interfere with the objects aforesaid, and to confer other rights and privileges. And also to enable the said South Yorkshire, Doncaster, and Goole Railway Company to raise a further sum of money by the creation of new or additional shares, and by loan, or otherwise, for the purposes aforesaid, and for the general purposes of their undertakings.

London (Watford) Spring Water Company.

For supplying the Cities of London and Westminster and Suburbs, and other places with Pure Spring Water.

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing session for leave to bring in a Bill to incorporate and empower a Company under the name and title of "The London (Watford) Spring Water Company," for providing an ample supply of pure water for the use of the inhabitants of the metropolis, comprising the cities and liberties of London and Westminster, and the boroughs of Marylebone, Finsbury, the Tower Hamlets, and the towns, villages, or hamlets following; that is to say: Watford, Bushey, Stanmore, Harrow, Pinner, Edgware, Elstree, Chipping Barnet, Monken Hadley, Totteridge, High Wood Hill, Mill Hill, Whetstone, Finchley, Kingsbury, Hendon, Hampstead, Highgate, and other places in the neighbourhood of the proposed works, such supply of water to be taken from wells to be sunk in and adits to be driven under certain fields called Bushey Hall Meadows, in the parish of Bushey, in the county of Hertford, the property of Stewart Marjoribanks, Esq., on the west side of a lane leading from the turnpike-road from London to Watford, at or near the turnpike-gate at Chalk Hill, to Bushey Hall, in the said parish of Bushey, in the said county of Hertford, and adits to be driven under certain other meadows lying between the River Colne and a certain lane called Roach Lane, leading from Watford Church to Bushey Mill, and certain fields lying to the west of the said lane called Roach Lane, which meadows and fields are situate in the parish of Watford, in the liberty of Saint Albans, in the county of Hertford, and the said meadows are severally marked A, and the said fields are severally marked B, on the plans to be deposited as hereinafter mentioned; with power to such Company to make and maintain a reservoir or reservoirs on Stanmore Heath, in the parish of Great Stanmore, in the county of Middlesex aforesaid; and also a reservoir or reservoirs in or near a certain field belonging to and in the occupation of Henry Norris, on the east side of the turnpike-road from London to Watford, in the parish of Harrow, in the county of Middlesex, with all proper embankments and works connected with such reservoirs respectively; and also to make and maintain the several other reservoirs, cuts, aqueducts, and conduits hereinafter described, together with all proper and necessary embankments, cuttings, weirs, sluices, and drains connected therewith; that is to say: An aqueduct, cut, or conduit, connecting the said wells one with the other respectively, and passing from and out of the said wells, or one of them, from, through, or into the several parishes, townships, extra-parochial and other places of Bushey, in the county of Hertford, and Watford and Aldenham, in the liberty of Saint Albans, in the county of Hertford, and the parishes of Great Stanmore and Harrow, in the county of Middlesex, or some of them, and terminating at and in the said reservoir or reservoirs above mentioned; also an aqueduct or conduit commencing at the said reservoir or reservoirs, and connecting each the one with the other, and passing from and out of the said reservoirs, or one of them, from, in, through, or into the several parishes, townships, extra-parochial, and other places of Harrow, Great Stanmore, Little Stanmore, Edgware, Hendon, Kingsbury, Wilsdon, otherwise Willesden, Saint John, Hampstead, Paddington, and Saint Marylebone, in the county of Middlesex, and terminating
