The Lords Commissioners of Her Majesty's Treasury having certified to the Commissioners for the Reduction of the National Debt, in pursuance of the Act, 10th Geo. 4th, c. 27, sec. 1, that the actual surplus revenue of the United Kingdom of Great Britain and Ireland, beyond the actual expenditure thereof, for the year ended the 5th day of January 1850, amounted to the sum of two millions and ninety-eight thousand one hundred and twenty-six pounds two shillings and one penny;

The Commissioners for the Reduction of the National Debt hereby give notice, that the sum of five hundred and twenty-four thousand five hundred and thirty-one pounds ten shillings and six pence, being one-fourth part of the said surplus of two million and ninety-eight thousand one hundred and twenty-six pounds two shillings and one penny, will be applied, under the provisions of the said Act, between the 7th day of April 1850 and the 5th day of July 1850; viz.:
