It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The state apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes;" and of another Act, passed in the session of Parliament held in the seventh and eighth years of Her Majesty's reign, intituled "An Act to explain "and amend an Act for making better provision "for the spiritual care of populous parishes;" and of another Act, passed in the last session of Parliament, intituled "An Act to amend the Acts "relating to the Ecclesiastical Commissioners for "Eagland," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twentieth day of February, in the year one thousand eight hundred and fifty-one, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An 'Act to make better provision for the spiritual 'care of populous parishes,' and of another Act, passed in the session of Parliament held in the seventh and eighth years of your Majesty's reign, intituled 'An Act to explain and amend an Act 'for making better provision for the spiritual care of 'populous parishes,' and of another Act, passed in the session of Parliament held in the thirteenth and fourteenth years of your Majesty's reign, intituled 'An Act to amend the Acts relating to 'the Ecclesiastical Commissioners for England,' have prepared, and now humbly lay before your Majesty in Council, the following scheme, for altering the bounds of the district of Saint James, Hatcham, in the county of Surrey, and diocese of London.

"Whereas it is by the secondly-recited Act enacted, that it shall be lawful, by the authority provided in the first-recited Act, at any time or times within twelve months after the date of the licence of the minister first licensed to any separate district, constituted under the provisions of the same Act, to alter the bounds of such district, although any alteration be not required with a view to the constituting of another separate district; provided always, that the scheme for making any such alteration shall be subject to all the provisions relating to schemes for constituting separate districts under the said first-recited Act; and that any portion of any such separate district which, by any such alteration as aforesaid, shall become detached or excluded therefrom, shall to all intents and purposes again belong to and form part of the parish, chapelry, or district out of

which such portion was taken, upon such separate district being originally constituted, or to and of any new district, as shall be determined by the like authority:

"And whereas it is by the thirdly-recited Act enacted, that the powers and authority relating to the alteration of the boundaries of districts contained in the secondly-recited Act may, as to any such district now existing, notwithstanding the limitation in the same Act contained, be exercised at any time within five years from the passing of the thirdly-recited Act, and as to every such district to be constituted thereafter within five years from the date of the licence of the minister first licensed thereto, and that notwithstanding that any such district may have become a new parish by virtue of the provisions of the said first-recited Act.

"And whereas, under the provisions of the said first-recited Act, so much of the parish of Saint Paul, Deptford, in the counties of Kent and Surrey, as was comprised within the hamlet of Hatcham, was duly constituted a separate district for spiritual purposes, and named 'The District of 'Saint James, Hatcham,' by a scheme prepared by us, and ratified by an Order of your Majesty in Council, bearing date the thirtieth day of June in the year one thousand eight hundred and forty-five, and since duly gazetted:

"And whereas it has since been represented to us, and appears to us to be expedient, that the bounds of such district should be altered in the manner hereinafter mentioned:

"Now, therefore, we humbly recommend and propose, with the consent of the Right Honourable and Right Reverend Charles James, Bishop of London, in testimony whereof he has signed and sealed this scheme, that the bounds of the said district of Saint James, Hatcham, shall be altered so as to include, in addition to its present limits, all that part of the said parish of Saint Paul, Deptford, which is situate on the southeastern side of an imaginary line commencing at a point (marked a on the map or plan hereunto annexed) on the north-eastern boundary of the said hamlet of Hatcham, and in the middle of the North Kent and London and Greenwich Railway, and thence extending eastward along the middle of the North Kent Railway as far as the middle of the bridge by which the road called Tanner's-hill crosses the same, and thence extending first southward along the middle of such last-mentioned road across the Lewisham-road, and along the middle of Common-lane, as far as the boundary of the said

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measure relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament."

And whereas the draft of the said scheme has been transmitted to the incumbents and patrons affected thereby as required by the said Acts, and certain objections to the said scheme have been made and have been laid before Her Majesty in Council with the said scheme.

And whereas the said scheme has, notwithstanding such objections, been approved by Her Majesty in Council; now, therefore, Her Majesty by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of London.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act passed in the session of Parliament holden in the eighth and ninth years of Her Majesty's reign, intituled "An Act "for the further amendment of the Church Build-"ing Acts," or under and by virtue of any and every other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the third day of February one thousand eight hundred and fifty-one, in the words following, that is to say:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that having taken into consideration all the circumstances of the parishes of Halifax and Bradford, in the West Riding of the county of York, and within the diocese of Ripon, it appears to them to be expedient to unite and consolidate certain contiguous portions of the said parishes of Halifax and Bradford, and to form the same into one consolidated chapelry for all ecclesiastical purposes, for the consecrated church of Saint Michael and All Angels, situate at Shelf, in the said parish of Halifax, under and by virtue of the power or authority for this purpose contained in the ninth section of an Act passed in the session of Parliament holden in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amend-'ment of the Church Building Acts,' or under and by virtue of any and every other power or authority in this behalf vested in your Majesty's said Commissioners, by the Church Building Acts, and that the same should be called 'The consolidated chapelry of Shelf,' with boundaries as hereinafter mentioned.

"The boundary line of the consolidated chapelry of Shelf commences at the point marked A on the map or plan hereinafter referred to, at which point a stream crosses the Halifax and Bradford turnpike-road, and proceeds down that stream, south-easterly, to its junction with another stream in Sun Wood, up the middle of which last-mentioned stream it proceeds, north-westerly, to the road leading from Dean-house to Ox Heys; it then proceeds easterly, along the middle of that road, and on the south side of Ox Heys until it meets the road on the eastern side of Ox Heys, and, crossing that road, proceeds by an imaginary

straight line, north-easterly, to a point in the stream which forms the boundary line between the parishes of Halifax and Bradford; thence down the middle of such stream to Horse Close Bridge; it then proceeds from the said bridge, northerly, along the footpath from Norwood-green to Lowmoor, until it enters Buttershaw-lane, up the middle of which lane it continues, northerly, as far as the road to Low-moor; it then proceeds north-westerly, along the middle of that road, until it enters the Halifax and Bradford turnpike-road, along the middle of which road it proceeds, westerly, to four cottages, on the south side of the turnpike, called Kellett's Houses; it then proceeds north-westerly, by an imaginary line, to the foot-path at Schoolfold, and along that footpath to Gracy Fold, and from Gracy Fold, by a line drawn in the middle of a bye road, into the road lying between Queen's Head and Wibsey, at Beacon-hill, along the middle of which latter road it proceeds, westerly, to the boundary of the townships of Clayton and North Bierley, along which boundary it will proceed, south-westerly, to Soaper-lane, and then along the middle of that lane to Old Soaper-lane, along the middle of which last-mentioned lane it proceeds as far as the stream forming the boundary of the parishes of Bradford and Halifax, it then proceeds up that stream or boundary to the lane leading to High Cross-green, along the middle of which lane it continues, westerly, to the middle of the said green; it then proceeds southerly, by the middle of the road which passes over Pepper-hill to Stone Chair, until it arrives at a stream crossing the last-mentioned road near Stone Chair, and down the same stream until it arrives at the point where the boundary line of the said consolidated chapelry of Shelf commenced, which said consolidated chapelry is more particularly delineated on the map or plan hereunto annexed, and thereon coloured blue and yellow.
