The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the thirty-first day of October, in the year one thousand eight hundred and fifty-one, in the words following; that is to

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Your Majesty's reign, intituled An Act to make better provision for the spiritual care of populcus parishes, have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of certain property formed belonging the tain property formerly belonging to the prebend of Saint Nicholas Penyffos, in the cathedral church of Saint David's, and now vested in us.

"Whereas it is by the said Act (amongst other things) enacted, that notwithstanding the charge by that Act created (being a charge created in favour of the Governors of the Bounty of Queen Anne), all the same and the like powers and rights of ownership as are possessed and enjoyed respecting and over any lands, tenements, or other hereditaments whatsoever, by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent-charges, tenements, or other hereditaments vested in us under certain Acts therein mentioned (being the Acts under which the property hereinafter described is vested in us), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us, by proper instruments in writing, duly executed according to law, with a certain proviso respecting the application of every sum of money received as the consideration or purchase money for the sale, transfer, and conveyance by us of any of such lands, tithes, tenements, or other hereditaments, or of any estate or interest therein, and with a further proviso that none of such lands, tithes, tenements, or other hereditaments be sold, transferred, or con-

T the Court at Windsor, the 14th day of | veyed, except by the authority of a scheme, and an Order issued by Your Majesty in Council, ratifying the same:

" And whereas all the lands, tenements, hereditaments, and endowments (excepting any right of patronage) formerly belonging to the said prebend of Saint Nicholas Penyffos became vested in us on the vacancy of the said prebend, subject to any legally subsisting lease or leases thereof:

"And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and after due consideration it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as shall appear to us to be advisable:

"We therefore humbly recommend and propose that we may be authorized and empowered, by deed or deeds duly executed under our common seal, from time to time to sell, and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, and hereditaments (except as aforesaid) heretofore belonging to the said prebenc, with their appurtenances, and to the said prebenc, with their appurtenances, and interest therein, or all our estate, right, title, and to the use in any part of parts thereof, unto and of any person or persons desirous of willing purchase the same, and his or their heirs, 2 assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall, upon due calculation and inquiry appear to us to be just and reasonable.

" And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.'

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Saint David's.

HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act, passed in the session of Parliament holden in the eighth and ninth years of Her Majesty's reign, intituled "An "Act for the further amendment of the Church "Building Acts," or under and by virtue of any and every other power or authority vested in them said Commissioners by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the twentyfirst day of October one thousand eight hundred and fifty-one, in the words following; that is to

"Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that having taken into consideration all the circumstances of the parishes of Duloe, Lanreath, and Saint Pinnock, in the county of Cornwall, and within the diocese of Exeter, it appears to them to be expedient to unite and consolidate certain contiguous portions of the said three parishes, and to form the same into one consolidated chapelry for all ecclesiastical purposes, for the consecrated church of All Saints, situate at Herod's Foot, in the said parish of Duloe, under and by virtue of the power or authority for this purpose contained in the ninth section of an Act, passed in the session of Parliament holden in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amend-'ment of the Church Building Acts,' or under or by virtue of any and every other power or authority in this behalf vested in your Majesty's said Commissioners by the Church Euilding Acts, and that such proposed consolidated chapelry should be called or named 'The consolidated chapelry of Herod's Foot,' with boundaries as hereinafter mentioned: The boundary of the consolidated: chapelry of Herod's Foot; commences at the northeastern corner of field No. 292 northemutation plan of the mutation plan of the mutation plan of the marsh of Duloe, and proceeds gide active director along the eastern the enclosures of Nos. 292 and 291 to the southern corner of the latter field; then northwesterly along the south-western side of the same field, and enters the road leading from Dubwalls, along the western side of which road the boundary then proceeds in a south-westerly direction as far as the south-eastern corner of field No. 268 on the said tythe commutation plan; then turns westerly along the southern side of that field and of field No. 521 to the north-eastern corner of field No. 526; then proceeds southerly, down the eastern sides of fields Nos. 526 and 527 to the road on the south side of such latter field, along which road it proceeds westerly, as far as field No. 531 on the said plan; and then passing along the eastern and southern sides of that field, again enters the road, and proceeds westerly along the same until it reaches the stream passing the western sides of fields Nos. 1319 and 1336 on the before-mentioned tythe commutation plan, up which stream the boundary will then proceed northerly, to the south-eastern corner of field No. 1389 on the said plan, and westerly along the southern side of that field to the north-eastern corner of field No. 1390; then southerly, down the eastern side of that field, and north-westerly, along the southern side thereof and of field No.

No. 1060 on the tythe commutation plan of the parish of Lanreath, and will proceed in a northerly direction up the western sides of fields Nos. 1060, 1061, 994, and 992, and along the south-western. sides of No. 966; then along the north-western side of Nos. 966 and 967 and 968, and the westernsides of Nos. 969, 875, 874, and 862, to the northwestern corner of the latter field; then easterly, along the northern sides of fields Nos. 862, 863, 864, 869, 972, 974, and 1081, when it meets witha stream of water passing southerly down the eastern side of field No. 1081, along which said stream the boundary will then proceed in a south-easterly direction as as the north-eastern corner of field No. 932 on the tythe commutation plan of ne parish of Saint Pinnock, and will then proceed in a northerly direction up the north-western sides of Nos. 952, 931, 930, 925, and 919; then easterly, along the northern sides of fields No. 919, 918, 917, and 927, and again reaches the parish of Duloe, at the north-western side of field No. 381 on the tythe commutation plans of the said parish of Duloe, and will then proceed north-easterly, along the western sides of fields Nos. 381, 380, and 348; and then easterly; along the northern sides of fields Nos. 348, 347, 346, 345, 300, 299, 298, 297, 293, and 292, to the north-eastern corner of the latter field, where the boundary of the said consolidated chapelry of Herod's Foot commenced, and as the same is more particularly shewn on the map or plan hereunto annexed, and thereon coloured green, pink, and yellow:
"That the consents of the Right Reverend

Henry, Bishop of the said diocese of Exeter, of the Master and Fellows of Baliol College, within the University of Oxford, patrons of the parish church of the said parish of Duloe, of John Francis Buller, of Morval, in the said county of Cornwall, Esquire, patron of the parish church of the said parish of Lanreath, and of the Reverend James Rawlings, of Saint Pinnock aforesaid, Clerk, of the Reverend Edward John Treffry, of Place Fowey, in the said county of Cornwall, Clerk, and of Augustus Coryton, of Pentillie Castle, in the said county of Cornwall, Esquire, patrons in turn of the parish church of the said parish of Saint Pinnock, have been respectively obtained to the formation of the said consolidated chapelry of Herod's Foot, as required by the Act and section hereinbefore mentioned, in testimony whereof the said Henry, Bishop of Exeter, John Francis Buller, James Rawlings, Edward John Treffry, and Augustus Coryton have signed and sealed this representation, and the said Master and Fellows have hereto affixed their common or college seal:

"Your Majesty's said Commissioners beg leave further to represent that it has been mutually agreed between the said Master and Fellows, John Francis Buller, James Rawlings, Edward John Treffry, and Augustus Coryton, as such respective patrons as aforesaid, testified as aforesaid (with the approbation of your Majesty's said Commissioners, testified as hereinafter mentioned, and of the said Henry, Bishop of Exeter, testified as aforesaid), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church of All Saints, at Herod's Foot aforesaid, should be rested in, belong to, and, whenever occasion may require be exercised by, the rector for the time being of the parish church of the said parish of Duloe.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your consideration, and to make such Order in respect thereto as to your Majesty, in your royal wisdom, shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed formation into one consolidated chapelry be accordingly-made, and the agreement in respect of the right of presentation and appointment of an inclimbent or perpetual curate to serve the said church of All Saints, at Herod's Foot aforesaid, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith enrolled, pursuant to the said Acts, and registered by the Registrar of the diocese of Exeter.

station for colliers on the said river Thames, between Gravesend and Blackwall, as shall be assigned to or appointed for such ship or vessel by the said order; and such ship or vessel shall be described or designated in the said order by a number to be inserted in the said order by the said Harbour-master; and such master or other person as first aforesaid shall, upon receiving such order, forthwith with his said ship or vessel proceed to and anchor, moor, or place his said ship or vessel in the section, berth, or station so appointed for or assigned to his said ship or vessel in the said order as aforesaid; and such master or other person as aforesaid shall also, upon receiving such order, forthwith write or cause to be written in a legible and conspicuous manner upon each bow of such ship or vessel, and in figures of not less than one foot in length and of a proportionate width, the number by which such ship or vessel is so designated or described in the said order as aforesaid, and such master or other person as aforesaid shall keep and continue the said figures so legibly written upon each bow of such ship or vessel as aforesaid until the ship or vessel shall be unloaded or discharged; and that no such ship or vessel shall be removed from the section, berth, or station which shall be so assigned to or appointed for such ship or vessel as aforesaid, without permission for that purpose first had and obtained from the Harbour-masters of the said port of London, or some or one of them, such permission to be printed or written or partly printed and partly written. And in case any master, or other person having the command, management, or charge of any ship or vessel, laden or partly laden with coals, shall proceed with such ship or vessel above or to the westward of Gravesend, without having obtained from the Harbour-master on duty at Gravesend such order as aforesaid; or in case any master or other person as aforesaid shall not, upon receiving such order, forthwith proceed with his said ship or vessel unto, and anchor, moor, or place his said ship or vessel, in the section, berth, or station so appointed for or assigned to such ship or vessel in the said order as aforesaid; or in case any master or other person as aforesaid shall not, upon receiving such order, forthwith write or cause to be written in a legible and conspicuous manner upon each bow of the said ship or vessel, and in figures of the dimensions aforesaid, the number by which the said ship or vessel is designated or described in the said order as aforesaid, or does not keep and continue the same so legibly and conspicuously written on each bow of the said ship or vessel until the said ship or vessel shall have been unloaded or discharged;. or in case any master or other person as aforesaid shall remove such ship or vessel from the section, berth, or station which shall have been so assigned: to or appointed for such ship or vessel as aforesaid, without such permission for that purpose first had and obtained from the said Harbour-masters, or some or one of them as aforesaid, such master or other person as aforesaid shall for every such offence forfeit and pay a sum not exceeding ten pounds.

other person having the command, management, or charge of any such ship or vessel, shall, upon receiving any such order to remove, forthwith with his said ship or vessel proceed to and anchor, moor, or place his said ship or vessel in the section, berth, or station appointed for or assigned to his said ship or vessel in such lastmentioned order for removal as aforesaid; and that every such ship or vessel shall remain at such altered section, berth, or station until the said ship or vessel shall be unloaded or discharged, or duly permitted to remove to some other section, berth, or station as aforesaid. And in case any master or other person so having the command, management, or charge of any such ship or vessel as aforesaid shall not, upon receiving any such order to remove, forthwith proceed to, and anchor, moor, or place his said ship or vessel in the section, berth, or station so appointed for or assigned to his said ship or vessel, in such order for removal as last aforesaid; or in case any such ship or vessel shall not remain at such altered section, berth, or station until his said ship or vessel shall be unloaded or discharged, or be again permitted to remove to some other section, berth, or station in manner and form aforesaid, such master or other person as aforesaid shall for every such offence forfeit and pay a sum not exceeding ten pounds.

4. And be it further ordained and established by the authority aforesaid, that at such times and so often as it shall seem expedient to the Harbourmaster on duty at Gravesend that no more ships or vessels, laden or partly laden with coals, should for the time being proceed above or to the west-ward of Gravesend, then and in such case the said Harbour-master shall cause a flag or lamp to be conspicuously exhibited and displayed at some convenient place and distance below the said section, berth, or station, No. 7, situate from below the entrance of the Thames and Medway Canal, to Shorn Mead Battery, on the south side of the said river, such place and distance being such as that every master, or other person having the command, management, or charge of any such ship or vessel, may be afforded a reasonable time to moor and anchor his said ship or vessel at such lastmentioned section, berth, or station as aforesaid; and the said Harbour-master shall keep and continue the said flag or lamp so exhibited and displayed during all such time as such Harbour-master shall deem it expedient to prevent any more such ships or vessels from proceeding above or to the westward of Gravesend. And if any master or other person having the command, management, or charge of any such ship or vessel as aforesaid shall, at any time while such flag or lamp is exhibited as aforesaid, proceed higher up the said river than the said section, berth, or station No. 7, at Higham Bight, without permission for that purpose first had and obtained from the said Harbour-master, such permission to be printed or written or partly printed and partly written, such master or other person as aforesaid shall for every such offence forfeit and pay a sum not exceeding ten pounds.

5. And be it further ordained and established by the authority aforesaid, that no ship or vessel, laden or partly laden with coals, shall under any circumstances, without a written or printed or partly written and partly printed order or consent for that purpose, first had and obtained from one of the said Harbour-masters, remain or continue in any of the tiers between London-bridge and Limehouse Hole, or in any other tier in any other part of the said river and within the said port, for a longer period than fifteen days next after such ship or vessel shall have entered

any such tier, exclusive of the day of entering the same. And if any master, or other person having the command, management, or charge of any such ship or vessel as aforesaid, shall cause or permit such ship or vessel to remain or continue in or at any such tier as aforesaid for a longer period than the said period of fifteen days next after such ship or vessel shall have entered such tier, exclusive of the day of entering the same, without having first obtained such order or consent as aforesaid for that purpose, such master or other person as aforesaid shall, for every such offence, forfeit and pay a sum not exceeding ten pounds.

6. And be it further ordained and established by the authority aforesaid, that every ship or vessel, laden or partly laden with coals as aforesaid, admitted into any tier in any part of the said river within the said port, shall go out of and remove from such tier at the next succeeding flood-tide after the cargo of coals in such ship or vessel shall have been discharged, and shall forthwith proceed to such berth or station as shall be for that purpose appointed by the said Harbour-masters, or either of them. And if any master, or other person having the command, management, or charge of any such ship or vessel shall cause or permit the same to remain or continue in any such tier as aforesaid after the flood-tide next succeeding the period at which the cargo of coals in such ship or vessel shall have been discharged, or shall not, after removing out of such tier, forthwith proceed to such section, berth, or station as shall be for that purpose appointed as aforesaid, such master or other person as aforesaid shall, for every such offence, forfeit and pay a sum not exceeding ten pounds. And the said Harbour-masters are, and each of them is, hereby authorized and required, in case of any such ship or vessel not being so removed as aforesaid, within the time aforesaid, to remove the same from such tier as aforesaid, and to take and place the same in such section, berth, or station, as shall be for that purpose appointed; and the expenses of so removing and placing such ship or vessel shall be charged to and be recovered and be recoverable from the owner or owners of the said ship or vessel, or from the master, or other person having, at the time of such removal or placing, the command, management, or charge of the said ship or vessel, to the use of the said Mayor and Com-monalty and Citizens of the city of London, in and by the same manner and means as penalties by this bye-law are recoverable.

Provided always, that nothing herein contained shall extend or be deemed or construed to prevent any ship or vessel, laden or partly laden with coals, from proceeding directly and without delay, into any dock, canal, or creek, or to any wharf within the said port, for the purpose of discharging the cargo of such ship or vessel in such dock, canal, or creek, or at such wharf.

7. And be it further ordained and established by the authority aforesaid, that in case the master, or other person having the command, management, or charge of any ship or vessel, laden or partly laden with coals, shall proceed up the said river within the said port for the alleged purpose of discharging the cargo of coals of such ship or vessel in any dock, canal, or creek, or at any wharf, and shall not proceed directly and without delay into such dock, canal, or creek, or to such wharf, such master or other person as aforesaid, shall for every such offence forfeit and pay a sum not exceeding ten pounds.
