cathedral church, that the said ground and premises should be permanently vested in the said dean and chapter, and towards effecting this object they have, by means of payments or investments out of their divisible corporate revenues, purchased or acquired the said leasehold interest

"And whereas the Most Reverend John Bird, Archbishop of Canterbury, is willing, for the purpose aforesaid, to sell and dispose of his reversionary interest in the said ground and premises, under and subject to the powers and provisions of the said secondly recited Act:

"And whereas an application has been made to us in writing, under the corporate seal of the said dean and chapter, for our sanction to the arrangements hereinafter mentioned, which appear to us to be just, reasonable and expedient, and we have satisfied ourselves that the value of the said ground and premises in fee simple in possession, amounts to one thousand two hundred and sixtyseven pounds, and that the value of the reversionary interest of the said archbishop therein, amounts to six hundred and twenty-four pounds, seven shillings, and ten pence, and that the payments so made as aforesaid by the said dean and chapter out of their divisible corporate revenues, for the purchase and acquisition of the said leasehold interest in the said ground and premises, exceed the sum of six hundred and forty-two pounds, twelve shillings, and two pence, in addition to the costs, charges, and expenses incident to this arrangement, amounting to fifty-six pounds, nineteen shillings, and six pence:

"And whereas a sum of one thousand five hundred and seventy-two pounds, being the purchase money of certain lands in the parishes of Fairfield, Ebony, and Appledore, in the county of Kent, sold by the said dean and chapter to the South Eastern Railway Company, under the powers and provisions of the several Acts of Parliament relating to the said Company, has been paid into the Bank of England, with the privity and consent of the accountant-general of the Court of Chancery, and placed to the credit of his account there, ex-parte the said dean and

chapter:

"Now therefore, with the consent of the Most Reverend John Bird, Archbishop of Canterbury, as such archbishop, and also as visitor of the said dean and chapter, testified by his having hereunto affixed his corporate seal, and also with the consent of the said dean and chapter, testified in like manner, we humbly recommend and propose, that the said archbishop be authorized to sell and convey to the said dean and chapter, and that they be authorized to purchase and take to hold all the reversionary estate and interest of the said Archbishop and See of Canterbury, in the said piece or parcel of ground and premises described in the Schedule hereunto annexed, as aforesaid, with all rights of way, easements, and appurtenances thereto belonging, at and for the price or sum of six hundred and twenty-four pounds, seven shillings, and ten pence aforesaid, and that such price or sum shall in the manner in that behalf prescribed by the said secondly recited Act, be paid or transferred to the credit of the said archbishop by the said accountant-general, out of the said sum of one thousand five hundred and seventy-two pounds, so standing to his account, ex-parte the said dean and chapter as aforesaid, and that thereupon the said accountant-general shall also out of the same last-mentioned moneys, pay to the said dean and chapter, the said two several amounts of six hundred and forty-two pounds, twelve shillings, and two pence, and fifty- l

six pounds, nineteen shillings, and six pence, as a reimbursement of the amount so paid and advanced by them as aforesaid out of their divisible corporate revenues, in respect of the purchase or acquisition of the said leasehold interest in the said ground and premises, and of the costs, charges, and expenses incident to this arrangement.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said recited Acts, or of any other Act of Parliament.

"SCHEDULE.

"All that piece or parcel of ground lying at the northern corner of the west end of the cathedral church at Canterbury, on part of which stand sheds and other buildings, used for workshops and clerks office, the same premises being now demised to the dean and chapter of Canterbury by two several leases, dated respectively the twenty-first day of December one thousand eight hundred and forty-seven, and the tenth day of January one thousand eight hundred and forty-eight, and being bounded on the south partly by the cathedral yard, and partly by other freehold property of the said dean and chapter; on the west, partly by the street called Palace-street, and partly by freehold property of the Lord Archbishop of Canterbury, demised to the Reverend John White, and others; on the north, partly by the freehold property of the said archbishop, held on a lease granted to the late George Austin, Esquire, and partly by ground forming part of the garden of one of the prebendal houses in the cathedral precincts, and partly by vacant ground lying between the property of the said archbishop, demised as last aforesaid, and property of the said dean and chapter, on the east, partly by the before mentioned garden, and partly by the cloisters of the said cathedral church. All which premises are more particularly delineated on a plan hereto annexed, and intended to be deposited according to the directions of the said Ecclesiastical Commissioners."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Wm. L. Bathurst. Canterbury.
