

city and liberties, and for enforcing order at the places in the said city and liberties, at which metropolitan stage carriages call or ply for passengers.

(Hackney Carriages.)

Now, therefore, with respect and in relation to hackney carriages standing or plying for hire in the said city and the liberties thereof, this Court, in pursuance and by virtue of the powers and authorities granted by the said Act of Parliament, passed in the reign of His late Majesty King George the Fourth (so far as such powers and authorities extend), and also in pursuance and by virtue of the powers and authorities granted by the said Act of Parliament, passed in the reign of His late Majesty King William the Fourth, and of all other the powers and authorities enabling this Court in that behalf, doth hereby repeal the said several rules, orders, and regulations respectively, made on the seventeenth day of July, in the year of our Lord one thousand eight hundred and twenty-seven, the third day of January, in the year of our Lord one thousand eight hundred and thirty-two, the twenty-ninth day of May, in the year of our Lord one thousand eight hundred and thirty-two, the third day of December, in the year of our Lord one thousand eight hundred and thirty-three, the twenty-ninth day of September, in the year of our Lord one thousand eight hundred and thirty-four, the fourth day of May, in the year of our Lord one thousand eight hundred and forty-one, and the twenty-eighth day of March, in the year of our Lord one thousand eight hundred and forty-three, and each and every of them; and all other rules, orders, and regulations, whatsoever, at any time heretofore made by the said Court of Mayor and Aldermen, in pursuance or by virtue of the powers and authorities granted by the said first and secondly hereinbefore mentioned Acts of Parliament, or either of them, or any other Act or Acts of Parliament whatsoever, or under or in pursuance of any other power or authority whatsoever (that is to say): so far as the said several rules, orders, and regulations hereinbefore mentioned, or any or either of them, appoint any place or places in the said city and liberties, or either of them, for the standing or plying for hire of any hackney coaches, chariots, or cabriolets, or any hackney carriages whatsoever, or regulate or relate to the number of any such hackney carriages

to stand in any such place or places respectively, within the said city and liberties, or the distances at which they or any of them shall stand from each other or the times at or during which they, or any or either of them, may stand or ply for hire; or in any other manner order or regulate or relate to, hackney coaches, chariots, or cabriolets, or other hackney carriages, within the said city and liberties, or the drivers or other the person or persons having the management thereof respectively, save and except only from and out of the matters and things hereby repealed, such parts or part of the said several rules, orders, and regulations, or any of them, as repeal or repeals any former or other rule, order, or regulation in that behalf; and, in the stead and room of the rules, orders, regulations, and matters hereby repealed as aforesaid, this Court doth, by virtue and in pursuance of the said Act of Parliament, passed in the reign of His late Majesty King William the Fourth, hereby appoint the proper places in the said city of London, and liberties thereof, where hackney carriages may stand and ply for hire, and doth, by virtue and in pursuance of the said last-mentioned Act of Parliament, make orders for regulating the number of such hackney carriages to stand in such places respectively, in manner following (that is to say):

This Court doth hereby order and appoint the thirty-nine several places in the said city of London and liberties thereof hereinafter mentioned and described, in the first or left hand, and the second or middle column of the list or table hereinafter contained, and respectively numbered in such list, with consecutive numbers from one to thirty-nine, as, and for, and to be places where hackney coaches, chariots, or cabriolets, or other hackney carriages, may stand and ply for hire (the same respectively appearing to this Court to be proper in that behalf).

And this Court doth hereby order and direct, that the number of such hackney coaches, chariots, cabriolets, or other hackney carriages to stand in each of such thirty-nine places respectively, shall or may be the number hereinafter mentioned in the third or right hand column of the said list or table, opposite to and next after and in connexion with the name and description of each such place so appointed as last aforesaid, or any less number; that is to say:—
