THE Right Honourable Sir John S. Pakington has this day received a Dispatch and its Enclosures, of which the following are Copies, addressed to the Right Honourable Earl Grey by Lieutenant-General Sir Henry G. W. Smith, Bart., K.G.C.B.

No. 47.—Military.

MY LORD,

Camp, Blinkwater, 17th March 1852.

I HAD the honour to receive on the 1st instant at King William's Town your Lordship's Dispatch, No. 732, of the 14th January last, intimating to me that Her Majesty's Government had deemed it an unavoidable duty to relieve me from my present position, that my Sovereign had approved of the measure, and that my successor was immediately to leave England. At that period, however, such were the prospects of this war, and so rapid the progression towards that state of things which can alone perpetuate peace (best shown by the Proclamation issued by me on the 6th of February, and again enclosed), that a sense of the duty which has guided me in the service of my Sovereign and country for so many years, induced me to persevere in the preparatory steps I had taken for the expulsion from certain strongholds within the colony, of the rebel Gaikas and Hottentots under the wily Chief Macomo, a renegade from the authority of his paramount Chief Sandili; as also for expelling the Gaika tribes from British Kaffraria, and driving them

over the Great Kei. My intention was communicated to your Lordship in my despatch of the 16th ultimo.

2. I have the honour, therefore, to report that on the 5th instant I moved the 12th Lancers and a large detachment of the Cape Mounted Rifles under Lieutenant-Colonel Pole; two guns Royal Artillery, the 6th, 60th, and four companies of the 45th Regiment, with detachments of Hottentot and Fingoe levies, under Lieutenant-Colonel Michel; two guns Royal Artillery, the 43rd Light Infantry and 73rd Regiment, and detachments of Hottentot and Fingoe levies, under Lieutenant-Colonel Eyre, all well supplied with provisions, to the general rendezvous at Fort Beaufort, where I established my head-quarters.

3. On the 4th instant Major-General Somerset had a smart affair with the enemy in the Water Kloof, in which the 91st Regiment greatly distinguished itself; Lieutenant-Colonel Yarborough, of that regiment, and Captain Bramly, of the Cape Mounted Rifles, having, however, been severely, and Ensign Hibbert, of the 91st, slightly wounded. The Chief Macomo fought with great determina-tion; but one hundred head of cattle and forty horses were captured—the best criterion of suc-Subsequently to this affair, such part of Major-General Somerset's division as was available for the field, consisting of the 91st Regiment, four companies of the 74th Highlanders, the Cape Mounted Rifles, and strong detachments of Hottentot and Fingoe levies, was assembled at Haddon's Old Post, on the western end of the low mountain range forming the Water Kloof, Blinkwater, and Fuller's Hoek; the best position it could occupy with reference to my intended operations.

4. Meanwhile, Lieutenant-Colonel Perceval, with a detachment Royal Artillery and a gun, with rockets, the 12th Regiment, detachments of the 91st Regiment, Cape Mounted Rifles, and Armstrong's Horse, and Hottentot and Fingoe levies, and burghers, had been ordered to act on the enemy's position in the Fish River Bush. The various posts of defence in the neighbourhood of my proposed scene of action, viz. Whittlesea, Eland's Post, Blinkwater, and Post Retief, were at the same time strengthened for the purpose of patrolling.

5. On the 9th instant the troops marched to establish themselves on their respective bases of operation, as set forth in the instructions annexed; and I established my head-quarters at the Blinkwater Post-a commanding and central position.

6. On the 10th instant, the several officers in command, Lieutenant-Colonels viz. Michel. Eyre, and Napier, having well reconnoitered the strong positions held by the rebels, moved forward to the attack. The enemy was everywhere well prepared, and received them, especially Lieutenant-Colonel Eyre, whose column I had reinforced with two additional guns and two companies of the 74th from the Blinkwater Post, with his usual war cry, and even more than common demonstrations of defiance.

7. The enemy opposed to Lieutenant-Colonel Eyre was well and judiciously posted in that part of the range called Fuller's Hoek, very extensive and densely wooded, and where Macomo's "Den," as they termed it, was so strongly situated in a deep kloof as to be regarded almost inaccessible. By the activity of Captain Faddy, of the Royal Artillery, the four guns were with incredible exertion dragged up a precipitous ascent, judiciously posted and well served, aided by rockets. The Lieutenant-Colonel moved upon these savages in eight small columns of attack, and the troops carried every thing before them. Every obstacle was speedily overcome; and a well-known and most difficult pass, held stoutly by the enemy, was gallantly carried by Captain Campbell, of the 73rd Regiment, with a company of his own corps and two companies of the 43rd Light Infantry. troops crowned the heights, where they burned many villages, destroyed some cultivation, drove the enemy before them in every direction, and bivouncked for the night.

8. On the following day, the 11th instant, Ligutenant-Colonel Eyre made the most able disposition of his troops, so as to descend the mountain and effectually dislodge the enemy from those positions which the columns had been able only to pass through on the previous day. His special object also was, to assail the Den and stronghold of Macomo, the destruction of which I regarded as a great step towards the humbling of the rebels; for although Sandili and the Gaikas affected humility and a desire for peace, I well knew that all eyes were intent on the result of these operations. Colonel Eyre, aware of the importance I attached to this service, headed the column for the assault of the Den, the descent to which was found by the assistance of a captured woman, a flight of natural steps affording great means of defence. This column was most successful, though stoutly resisted; the Den was carried, the four guns firing into it with sanguinary effect, and 130 women, now prisoners, were found stowed away in the clefts of rock. Among them is Macomo's young and favourite wife, as also his great wife, a Tambookie, much regarded among the tribe, and mother of his great son Namba. Large quantities of European wearing apparel, provisions of different kinds, some little gun-powder, a bullet mould and supply of lead in bars, were found in the Den, which was completely destroyed, and the huts consumed. The number slain by our guns was very great, eleven having been found in one spot, and seven in another, and many fell in the assault. Meanwhile, Captain Campbell made his way down the difficult pass by which he had ascended the day before, and was again stoutly resisted by the enemy in front and flank. Here three gallant soldiers of the 73rd regiment fell, another being at the same time wounded, and farther on, Lieutenant the Honourable Henry Wrottesley of the 43rd, received a mortal wound.

9. The carrying by our troops of this "Den," heretofore regarded as inaccessible, has had throughout the effect of magic; and no positive

resistance has since been offered. Colonel Eyre continued his operations through the whole of the extensive fastnesses of the Fuller's Hoek and adjoining kloofs, but the enemy appeared no more. On the 15th instant, he again ascended the passes, and re-visited Macomo's Den, to shew the enemy our determination to expel him. Not a single Kafir was to be seen; and Colonel Eyre and the rest of the officers, who had then leisure for observation, describe the loss suffered by the enemy as evidently very considerable, and much greater than they had believed. It indeed could not well be otherwise, exposed as he was to the fire of four well directed guns and rockets, and so hemmed in that he necessarily suffered severely from mus-

ketry, and even from the bayonet.

10. On the same day, the 10th instant, Lieutenant-Colonel Michel's column moved from Blakeway's Farm, ascended the heights, the guns being with great exertion brought up an almost impracticable acclivity, and occupied the dense bush connecting Fuller's Hock with the Water Kloof, formerly the scene of considerable conflict. Every part of this bush was well traversed, and many kraals destroyed. Few of the rebel Hottentots or Kafirs shewed themselves, until Lieutenant-Colonel Napier's column, ascending the valley of the Water Kloof, entered the narrow and bushy defile which forms its head. Here he was fiercely attacked, the onset of the enemy being, according to his usual custom, especially directed to the rear of the advancing column. This was, however, judiciously anticipated by Colonel Napier, who advantageously posted the 91st Regiment, under Major Forbes, so as to resist the attack. The rebels were daring on this occasion, and well sustained the fight until they saw Colonel Michel advancing, when they gave way in every direction and fled into the dense bush to escape pursuit.

11. On the following day, these two columns acted simultaneously, driving the enemy before them, and destroying his villages in the Water Kloof. On the third day it was necessary for both to procure provisions at their respective bases of operation. Colonel Michel very judiciously took the opportunity to report himself to me; and I at the same time ascertained that 200 Boers of the district of Somerset and the Konap had arrived at Haddon's Old Post. Upon this, I immediately dispatched Major-General Somerset, whom I had retained with me at head-quarters, to take the command of these burghers and of Colonel Napier's column. On doing so, the Major-General at once ascended the heights overhanging the Water Kloof, bringing up his two guns by a very difficult ascent; and then proceeded to penetrate the bush with his infantry, while his mounted force watched the open - thus acting simultaneously with Colonel Michel. In these operations the enemy showed little resistance. On the afternoon of the 15th instant, observing a number of the enemy in possession of cattle in a deep valley, General Somerset dispatched his mounted force of Cape Corps and burghers, under Lieutenant-Colonel Napier, in pursuit. One hundred and thirty head, and many horses were captured, several of the rebels slain,

and some fifty women and children made prisoners.

12. On the 15th instant, Lieutenaut-Colonel Michel, having replenished his provisions, moved from the base of his operations to the neighbour-hood of the Eisler Krantz, or "Iron Mountain," in the Water Kloof, where he halted and cooked. His intention was to assail this mountain with small parties, according to the mode in which he had previously conducted his operations; but observing that the Kafirs numerously occupied the

rocky heights, and were evidently prepared for a determined resistance, he collected his troops, advanced in regular order, and endeavoured to turn the position. A rocky ravine, however, well maintained by the enemy, posted behind bushy rocks, prohibited any successful attempt upon his A direct advance to the front became therefore necessary, and was immediately ordered by Colonel Michel; so well, however, was it met by the enemy, that the troops received a momentary check; when Captain Hope's company of the 60th Rifles, fixed swords, charged, and carried the mountain, supported by the column. enemy were driven over krantzes and rocks with great slaughter; many cattle and horses were captured, in the defence of which so stout a resistance had been made; and Major Bedford, with two companies of the 60th Rifles, pursued the fugitives over declivities nearly impassable, many more cattle falling into his hands. The whole capture amounted to 560 head and 75 horses; The whole some of the latter being very valuable. In this gallant and rapid affair, Colonel Michel reports that he remarked the especial gallantry displayed by Captain Hope and Lieutenant Du Cane of the 60th Rifles, by his Brigade-Major, Lieutenant Whitmore, of the Cape corps, and by Mr. De Robeck, of Armstrong's Horse. Colonel Michel subsequently continued his operations with every activity, and all the country placed before him was well cleared of the enemy. On the morning of the 15th instant, Captain Taylor, with his company of Hottentot levies, had a sharp affair with a party was the last occasion on which the enemy appeared. Colonel Michel describes Captain Taylor's company of levies as deserving the name of soldiers.

13. On the 10th instant, Lieutenant-Colonel Perceval, with his column strengthened by the force assembled from Graham's Town and its neighbourhood, and aided by a few burghers of that town, attacked the strong position of the Chief Stock in the Fish River Bush, in two divisions, under himself and Major Armstrong. These simultaneous and well-conducted movements, in a very difficult country, were completely successful; and after a sharp conflict, in which Colonel Perceval much praises the conduct of Major Armstrong, the enemy were driven from every point. One hundred and ninety head of cattle were captured, as well as large flocks of goats, some horses, and several stand of arms; among the latter the double-barrelled fowling-piece of the Chief Dodo, who is believed to have fallen in the fight. enemy was so hotly pushed as to drive a small herd of cattle into the Fish River, which was full. Nineteen of these, and a Kafir, were shot in the act of swimming. Colonel Perceval was preparing, when I last heard from him, to attack the Chief Tola, who occupied a position somewhat higher up the river; of whom he will, no doubt, give a good account.

14. Your Lordship will perceive, by the instructions which I enclose, that Lieutenant-Colonel Pole, with the 12th Lancers, has been placed intermediately between Eland's Post and Post Retief, so as to intercept fugitives from the Water Kloof range of mountains during the progress of the operations which I have described. The different posts on the line of the enemy's retreat into the Amatolas have also detached parties to occupy the numerous drifts of the rivers; and the Fingoes of Fort Beaufort and Fort Hare have been most successful in capturing horses and cattle, and in adding to the consternation of the rebels. They were fleeing yesterday in all directions, in the distance, past this post—men, women, and chil-

dren—without cattle; and I pronounce these difficult, and heretofore well-maintained, positions of the enemy, viz. the Water Kloof, Blinkwater, and Fuller's Hoek, to be now completely cleared.

15. This day, the 17th instant, the columns of Lieutenant-Colonels Michel and Eyre, under my immediate command, move, with five days' provisions, on the Chumie range of the Amatolas, for the purpose of dislodging the tribe of Tyalie and the rebel Hottentots, and then penetrating into the heart of the mountains, while I leave Major-General Somerset with his division to pursue the retreating enemy, 200 Cradock burghers under the Civil Commissioner, Mr. Gilfillan, operating at the same time from Whittlesea against the Tambookies. Every part of the rebel enemy's country will thus be assailed.

16. I deeply regret, for the credit of the frontier inhabitants, to report that only 200 burghers from the district of Somerset, 200 from Cradock, and 33 from Graham's Town, have responded to my command. They first objected to the volunteer system which I offered to their loyalty. They then requested to be commanded to turn out. Their shuffling conduct is melancholy. There are many loyal and energetic men who do not fall under this censure, especially the burghers of Albert, under Mr. Cole, who, although they have not turned out on this last occasion, having been only just dismissed after a long and harassing though successful inroad over the Upper Kei, have done right good service during the war.

17. I am fully aware that I have been accused, during the progress of this campaign, of using the language of hyperbole in describing the numerous rencontres which have occurred, and in giving praise to the gallant officers and troops as well as burghers. Possessing, however, some experience in war, I must maintain that such is not the case. Troops acting in the open field expect not the stimulus of praise; the soldier sees his foe and his British courage rises at each step; but he who, after perhaps a night march of great length, has to ascend mountains or penetrate dense bush and ravines, filled probably with a daring and intrepid enemy, as resolute as athletic, ready to murder any one who may fall into his hands, and whose warfare is of the most stealthy and enterprising kind, appreciates the praise of his commander, because when his acts are conspicuously daring, he is conscious he deserves it. He does his duty; but human nature renders even the soldier's intrepid heart sensible of the approbation of his superior, which he is proud to know may reach the eye of his parents and friends.

18. Upon the eve, therefore, of relinquishing this command, I will not shrink from the performance of my duty: and I here record the value I attach to the indefatigable services of Major-General Somerset, whose experience of thirty years in Kafir warfare, its difficulties and its labours, renders him a most valuable, as he is a highly deserving officer. Lieutenant-Coloncl Michel, of the 6th Royal Regiment, has frequently distinguished himself in command, and on no occasion more so than in the recent affair of the 15th instant on the "Iron Mountain:" his energy in the field is equal to his zeal and attention to regimental duty. Lieutenant-Colonel Nesbitt, of the 6 th Rifles, merits much praise; and I regret that I have been only able on one occasion to give him a separate command. Lieutenant-Colonel Eyre, perpetually in the field since the commencement of hostilities, has been so frequently praised by me for his invariable success in every operation entrusted to his conduct, that what I now add enhances, and does not merely

establish, his reputation. I must here record my opinion of the soldierlike and judicious manner in which he carried and cleared the stronghold of the enemy in Fuller's Hoek, a position occupied with defiance by Macomo; and express my conviction that the war would remain unextinguished until that determined chief should be, as he has been, thoroughly dislodged and expelled. This has been effected in a masterly manner by the gallantry, judgment, and perseverance of Lieutenant-Colonel Eyre. The 73rd Regiment first set the example, under my orders, of taking the bush; they have been ever most successful, and the other regiments have emulated their exertions with equal results. Lieutenant-Colonel Pole has commanded his efficient regiment, the 12th Lancers, with zeal and activity. Lieutenant-Colonel Napier, of the Cape Mounted Rifles, has frequently been entrusted with the direction of patroles, which he has ever well conducted. Lieutenant-Colonel Yarborough, of the 91st, is a steady officer, and greatly distinguished himself on the day he was wounded. The 2nd Queen's Regiment have, upon this occasion, occupied the different forts; their services during the campaign under Lieutenant-Colonel Burns, have been valuable. Lieutenant-Colonel Skip-with, of the 43rd Light Infantry, is an officer of much promise. Lieutenant-Colonel Perceval, of the 12th Regiment, has greatly attracted my attention by his exertions, ability, and natural talent for command. Major Kyle, commanding the four companies of the 45th Regiment, is a very valuable officer, and there is indeed no field officer, from the gallant Major Pinckney, of the 73rd, downwards—the senior of his rank in this army—who has not well performed his many

I fear, my Lord, that I render this a lengthy At the wind-up of a fifteen months' campaign, desultory it is true, but on that account and opposed as we have been to from 20 to 25,000 intrepid warriors, probably of even a more than usually arduous character, much labour will naturally have devolved upon the officers of the staff, general as well as personal. I desire to draw your Lordship's attention to the services of Colonel Cloete, the Chief of the Staff, whose unremitting zeal in the performance of the many duties devolving upon him, has been as remark-able as the intelligence and perfect knowledge of his profession, which he has invariably evinced. I am deeply indebted to him, and the service equally so. Every officer of the General Staff has ably and zealously done his duty. To Lieutenant-Colonel Garvock, my Private Secretary, and Captain Maydwell, my Military Secretary, who have had the largest share of correspondence of every varied character, of any officers in this army, I am truly grateful. Their devotion to the public service merits every encomium. The perseverance of these officers has greatly contributed to ensure that economy in the public expenditure which I have endeavoured to enforce, and I hope with much success. My Aide-de-Camps, Major Holdich, Captain Smith, and Lieutenant Greville, have filled their situations with great utility to me and labour to themselves.

PROCLAMATION

HENRY GEORGE WARELYN SMITH, Baronet, Knight Grand Cross of the Most Honourable Order of the Bath, Colonel of the Second Battalion Rifle Brigade, Governor and Commander-in-Chief of the colony of the Cape of Good Hope, in South Africa, and of the territories and dependencies thereof, and Ordinary and Vice-Admiral of the same; and Her Majesty's High Commissioner for the settling and adjustment of the affairs of the territories in Southern Africa, adjacent and contiguous to the eastern and north-eastern frontier of the said colony, &c. &c. &c.

WHEREAS the time has arrived when it is both just and expedient to expel the rebel Gaika tribes and the rebel Hottentots, from the Water-kloof, Blinkwater, Fuller's Hoek, Kat River, and the whole of the Amatola Mountains; all the burghers of the divisions of Albany, Somerset, Fort Beaufort, Victoria, Albert, Cradock, and Graaff-Reinet, between the ages of twenty and fifty, are commanded to assemble; that is to say: The burghers of Albany, at Fort Brown

Somerset, at Post Retief

, Fort Beaufort, at Old Koonap
Post

,, Victoria, at Fort Hare

,, Albert and Cradock, at Whittlesea

,, Graaff-Reinet, to assemble at Cradock, as a second line.

In the name and in behalf of Her Majesty, I do hereby proclaim and make known that the burghers aforesaid are commanded to take the field upon the old commando system, with this exception, the rations will be provided for themselves by Commissariat arrangements, but no expense will be incurred by the Government for arms, horses, or appointments. They are to nominate their own officers, but they will be moved by the Commanderin-Chief himself, after their assembly, upon those points where their services may be most required to co-operate with Her Majesty's Army, which will be so disposed in converging columns, under the Commander-in-Chief personally, as to sweep the whole country, extending from Fort Beaufort to the left bank of the Mancazana, and the Winterberg eastward to the Kie.

I do hereby proclaim to the colonists, that they are now called on and commanded by Her Majesty's representative to aid in the expulsion of those irreclaimable Gaikas and Hottentot rebels, in driving them over the Kei, and in establishing in perpetuity that security for this frontier which can alone protect the families, the homes, and the property of its inhabitants.

And I do hereby make known, and do warn all concerned, that if this commando be not promptly and fully obeyed, the colonists must bear the responsibility which will be entailed upon them by their own apathy.

The burghers will be at the points herein designated, by the 8th day of March proximo, prepared to move.

The head-quarters of the Commander-in-Chief will be, on the 8th day of March, either at Forf

Beaufort or Fort Hare, as may be hereafter announced.

Head-Quarters, Fort Beaufort, 8th March 1852.

THE troops assembled at and near Fort Beaufort, to dislodge the rebel Hottentots and Kafirs under the Chief Macomo, occupying the strongholds of the Blinkwater, Fuller's Hoek, Water Kloof, &c. will be thus posted at the base of the respective operations of the different columns.

2. The right column under Lieutenant-Colonel Eyre, consisting of two guns Royal Artillery, 43rd Light Infantry, 73rd Regiment, and detachment of Levies, Hottentots, and Fingoes, at the Blinkwater Post. This column will be joined by two guns Royal Artillery, and two companies 74th Highlanders now occupying that post, Captain Harwell's Mounted Detachment now there,

will march to Post Retief.

3. The centre column under Lieutenant-Colonel Michel, consisting of two guns Royal Artillery, 6th Royal Regiment, four companies 45th Regiment, 60th Rifies, and detachment of Hottentot and Fingoe levies at Blakeway's Farm.

4. These two columns will post themselves on these points to-morrow, Tuesday the 9th instant.
5. The left column under Lieutenant-Colonel

Napier, consisting of two guns Royal Artillery, the 91st Regiment, four companies 74th Highlanders, 150 Cape Mounted Rifles, 200 Fingoes, and the burghers ordered to assemble at Haddon's Old Post, will make that post the base of its operations.

6. On Tuesday the 9th instant, this column will move and occupy the small farm, called Nel's

Farm, on the road below the Bush Neck.

7. The 12th Lancers, and detachment Cape Mounted Rifles, are posted at Hertzog, near Eland's Post, for the purpose of interrupting the retreat of the rebels into the Amatola Mountains.

8. On Wednesday the 10th instant, the three

columns will move to the attack.

The right column will direct its main exertions to dislodge the rebels from Fuller's Hock, the ridge of which the enemy principally occupies, and where Macomo's kraal is.

9. The centre column will ascend the high ridge by the route pursued by Lieutenant-Colonel Fordyce, in the former attack, and will assail the Bushy Kloof, connecting Fuller's Hock with the

Water Kloof.

10. The left column will move by the waggonroad up the Water Kloof valley to its head, and will direct its Infantry and Cape Mounted Rifles to ascend thence, to meet the attack of the centre column, while its mounted force of burghers patroles, so as to cut off any dislodged fugitives, who may endeavour to cross from one kloof to the other, communicating with the mounted burghers expected to move from Post Retief.

11. The troops to carry with them three days' bread and field rations. It is possible they may supply themselves with slaughter cattle, but, whether or not, they must not be withdrawn from | ceased. Dated 10th March 1852.

any stronghold of which they may possess them-selves, for where the troops are, the rebels cannot be, but move forward invariably into the bush, never coming into the open. The mounted force must cut off fugitives.

12. These are the outlines of the operations.13. The officers commanding columns, and Major-General Somerset, will meet the Com-mander-in-Chief at 10 o'clock this day, to enter into the minutice of their combined operations, upon which success depends.

14. The Head-Quarters and Major-General

Somerset will be established at Blinkwater.

ADMIRALTY NOTICE RESPECTING LIGHTS TO BE CARRIED BY SEA-GOING VESSELS TO PREVENT COLLISION.

By the Commissioners for Executing the Office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, &c. &c.

BY virtue of the power and authority vested in Us by the Act 14 and 15 Victoria, Cap. 79, dated 7th August, 1851, we hereby require and direct that the following Regulations be strictly observed:—

Steam Vessels.

All British Sea-going Steam Vessels (whether propelled by Paddles or Screws), shall within all Seas, Gulfs, Channels, Straits, Bays, Creeks, Roads, Roadsteads, Harbours, Havens, Ports, and Rivers, and under all circumstances, between sunset and sunrise, exhibit Lights of such description, and in such manner, as hereinafter mentioned, viz:—

When under Steam.

{ A Bright White Light at the Foremast Head. A Green Light on the Starboard Side. A Red Light on the Port Side.

- 1. The Mast Head Light is to be visible at a distance of at least five miles in a dark night, with a clear atmosphere, and the Lantern is to be so constructed as to shew a uniform and unbroken light over an arc of the horizon of twenty points of the Compass, being ten points on each side of the Ship, viz. from right ahead to two points abaft the beam on either side.
- 2. The Green Light on the Starboard side is to be visible at a distance of at least two miles in a dark night, with a clear atmosphere; and the Lantern is to be so constructed as to shew a uniform and unbroken light over an arc of the horizon of ten points of the Compass, viz. from right ahead to two points abaft the beam on the Starboard side.
- 3. The Red Light on the Port side is likewise to be fitted so as to throw its light the same distance on that side.
- 4. The side Lights are moreover to be fitted with screens, on the inboard side, of at least three feet long, to prevent the lights from being seen across the bow.

When at Anchor.—A Common Bright Light.

Sailing Vessels.

We hereby require that all Sailing Vessels when under sail, or being towed, approaching or being approached by any other Vessel, shall be bound to shew between sunset and sunrise a bright light in such a position as can be best seen by such vessel or vessels, and in sufficient time to avoid collision.

such a position as can be best seen by such vessel or vessels, and in sufficient time to avoid collision.

All Sailing Vessels at anchor in Roadsteads or Fairways, shall be also bound to exhibit between sunset and sunrise, a constant bright light at the Mast-head, except within Harbours or other places where regulations for other Lights for Ships are legally established.

The Lantern to be used when at anchor, both by Steam Vessels and Sailing Vessels, is to be so constructed, as to shew a clear good light all round the horizon.

We hereby revoke all Regulations heretofore made by us relating to Steam Vessels exhibiting or carrying Lights; and we require that the preceding Regulations be strictly carried into effect, on and after the 1st of August, 1852.




DIAGRAMS INTENDED TO ILLUSTRATE THE WORKING OF THIS MODE OF FITTING LIGHTS.

In this situation the Steamer A will only see the Red Light of the Vessel B, in which soever of the three positions the latter may happen to be, because the Green Light will be hid from view. A.






It is scarcely necessary to remark that the Mast-head Light will always be visible in every situation till abaft the Beam.


3RD SITUATION:

4TH SITUATION.




Here a Green light only will be visible to each; the screens preventing the Red Lights from being seen. They are therefore passing to Starboard.

Here the two coloured Lights, visible to each, will indicate their direct approach towards each other. In this situation both should put their helms to Port.



DIRECTIONS FOR FITTING THE LIGHTS.

The manner of fixing the Coloured Lights is to be particularly attended to. They should be fitted, each, with a screen of wood, on the inboard side, in order to prevent both being seen at the same moment from any direction but that of right-a-head.

This is important, for without the screens (a principle first introduced with this plan) any plan of

bow-lights would be ineffective as a means of indicating the direction of steering.

This will be readily understood by a reference to the preceding illustrations, where it will appear evident, that in any situation in which two vessels may approach each other in the dark, the coloured lights will instantly indicate to both the relative course of each—that is, each will know whether the other is approaching directly or crossing the bows, either to starboard or to port. This intimation is all that is required to enable vessels to pass each other in the darkest night, with almost equal safety as in broad day, and for the want of which so many lamentable accidents have occurred.

Patterns of the Lanterns to be carried, and of the mode in which the Screens are to be fitted,

may be seen at the Custom Houses of the principal Commercial Ports of the United Kingdom.
