

" 12. That the patronage, on every third turn, of the rectory of Hedsor, in the county of Bucks, and in the diocese of Oxford, which said patronage is now vested in the Bishop of Lincoln, be transferred unto and henceforth be and remain vested in the Bishop of Oxford and his successors.

" 13. That the patronage of the rectories of Hagworthingham and Thornton-le-Moor; in the county and diocese of Lincoln, and which said

patronage is now vested in the Bishop of Ely, be transferred unto and be and remain henceforth vested in the Bishop of Lincoln and his successors.

" 14. That the patronage of the several benefices comprised in the Table VI., hereinafter set forth, and which said patronage is now vested in the Bishop of Ely, be transferred unto and henceforth be and remain vested in the Bishop of Norwich and his successors.

" 15. That the patronage of the vicarage of Tannington with the curacy of Brandish, in the county of Suffolk and in the diocese of Norwich, and which patronage is now vested in the Bishop of Rochester, be transferred unto and henceforth be and remain vested in the Bishop of Norwich and his successors.

" 16. That the patronage, alternately with the Crown, of the rectory of St. Mary Feltwell, in the county of Norfolk and in the diocese of Norwich, and which said alternate patronage is

now vested in the Bishop of Ely, be transferred unto and henceforth be and remain vested in the Bishop of Norwich and his successors.

" 17. That, upon the next avoidance of the see of Winchester, the patronage of the benefices comprised in the Table VII., hereinafter set forth, and which patronage now belongs to the Bishop of Winchester, be transferred unto and thenceforth be and remain vested in the Bishop of Lichfield and his successors.
