such parish westward, and afterwards northward, to the point where such district chapelry commenced, as the same is more particularly delineated on the map or plan hereunto annexed, and thereon

coloured yellow.

"The district chapelry of Luton commences at East Villa, at the bottom of Chatham Hill, and proceeds along the boundary line of the parish of Chatham, south-eastwardly up Chatham Hill, to the boundary stone of the parishes of Chatham and Gillingham; thence southwardly along the boundary of those parishes, and afterwards westwardly along the boundary of the parishes of Chatham, Boxley, and Aylesford, to the point where such boundary crosses Robin Hood-lane; thence northwardly along the middle of Robin Hood-lane and Hook and Hatchett-lane as far as the footpath turning to Magpie Hall-lane; thence along the middle of that footpath and of Magpie Hall-lane; to the point where such district chapelry of Luton commenced, and as the same is more particularly delineated on the said map or plan hereunto annexed, and thereon coloured green.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed in Saint John's Church, and also in Christ Church aforesaid, and that the fees to arise therefrom should be paid and belong to the rospective ministers or incumbents of the said two

churches for the time being.
"That the consent of the Right Reverend George, Bishop of the said diocese of Rochester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

" Your Majesty's said Commissioners, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment be accordingly made; and the recommendations of the said Commissioners, in respect of the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials, and the fees arising therefrom, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Rochester.
