WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the session of Parliament holden in the eighth and ninth years of Her Majesty's reign, intituled "An "Act for the further amendment of the Church "Building Acts," or under and by virtue of any and every other power or authority vested in them by the Church Building Acts, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-sixth day of March, one thousand eight hundred and fifty-three, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent, that on the ninth day of June, one thousand eight hundred and fifty-two, they made a representation to your Majesty in Council, with the several consents testified under hand and scal of the Right Reverend George, Bishop of the diocese of Peterborough, of the Right Honourable George Harry, Earl of Stamford and Warrington, patron of the parish church of the parish of Newtown Linford, in the county of Leicester, and in the said diocese of Peterborough, of the Right Honourable Robert Adam Christopher, then Chancellor of your Majesty's duchy of Lancaster, and as such patron in right of the crown of the parish church of the parish of

Whitwick, in the county and diocese aforesaid, of Charles March Philipps, of Garendon Park, in the said county of Leicester, Esquire, patron of the parish church of the parish of Sheepshed, in the county and diocese aforesaid, of the said George Harry, Earl of Stamford and Warrington, the said Charles March Phillipps, of the Right Honourable Richard William Penn Curzon, Earl Howe, on behalf of the most Honourable the Marquis of Hastings, a minor, and of William Herrick, of Beau Manor Park, in the said county of Leicester, Esquire, patrons with Edward Dawson, of Whatton House, in the said county of Leicester, Esquire, of the church of the consolidated chapelry district of Saint Paul, Woodhouse Eaves, in the county and diocese aforesaid, and forming a majority of the patrons of such last-named church and district, as required by the twentieth section of the Act secondly hereinafter mentioned or referred to, that it appeared to your Majesty's said Commissioners to be expedient, and they therefore humbly prayed that certain contiguous portions of the said parishes of Newtown Linford, Whitwick, and Sheepshed, and of the said consolidated chapelry district of Saint Paul, Woodhouse Eaves, might be formed into one consolidated chapelry for all ecclesiastical purposes for the consecrated church called the Oaks Church, situate in that portion of Charnwood Forest, which is within the said parish of Newtown Linford, under and by virtue of the power or authority contained in the ninth section of an Act, passed in the eight and ninth years of your Majesty's reign, intituled 'An Act for the further amendment of the Church Building Acts,' and in the nineteenth and twentieth sections of an Act, passed in the fourteenth and fifteenth years of your Majesty's reign, intituled 'An Act to amend the Church Building 'Acts,' and that such proposed consolidated chapelry should be named or called "The Consolidated Chapelry of the Oaks Church on Charn-wood Forest,' and that the boundaries thereof should be those mentioned in the said representation, and hereinafter described; that is to say:

"The boundary of the consolidated chapelry of the Oaks Church on Charnwood Forest, commences at the crossing of the Sheepshed and Newtown and the Loughborough and Bosworth-roads, near Warren Hill, as shewn on the eastern side of the map or plan hereunto annexed, and proceeds in a south-westerly direction along the centre of the Loughborough and Bosworth-road, to where it joins the Sheepshed and Wherscroft-road, along that road in an eastwardly direction for one

hundred and forty yards to the boundary of the township of Woodhouse, and along the southwestwardly boundary line of that township to where it joins the liberty of Charley, from thence in a north-westwardly direction along the boundary line of Charley and Beau Manor, to where it joins the parish of Sheepshed, thence in the same direction until it joins the parish of Newtown Linford, thence in a south-westwardly direction till it joins the parish of Whitwick, near an ancient well, called Carter's Well, from thence the boundary of the consolidated chapelry of the Oaks Church passes in a south-westwardly direction along the boundary line of the parishes of Whitwick and Markfield to the Whitwick and Leicester turnpike-road, near to Green Hill, and at the southern end of the Charley Mill-lane, from thence the boundary of such consolidated chapelry proceeds along the said turnpike-road, north-westwardly to the Hugglescote and Sheepshed-road, including the Forest Rock Publichouse, on the westerly side of the said road, and proceeding thence along the said Whitwick and Leicester turnpike-road, for a distance of four hundred and forty yards to a bound-stone; from the said turnpike-road the boundary of such consolida ed chapelry passes in a northwardly direction to another bound-stone, on the northern side of the Oaks-road, and along the centre of that road westwardly, for a distance of seven hundred and seventy yards, to the road leading from Belton to Whitwick; thence along the centre of that road north-eastwardly, to where it joins the boundary of the parish of Sheepshed, near 'Burrow's where it leaves the Belton-road and Springs, passes along the Sheepshed parish boundary to the Loughborough and Ashby-de-la-Zouch turnpike-road; from thence the boundary of such consolidated chapelry passes eastwardly along the centre of that road to the junction of the Woodhouse-road, near Snells Nook, and along the centre of the last-mentioned road south-eastwardly, crossing the Forest Canal, to where that road joins the parish of Loughborough; from thence in a south-westwardly direction to an ancient land-mark, called 'Nettle Bed Bush,' where it joins the liberty of Beau Manor, and the said consolidated chapelry district of Saint Paul, Woodhonse Eaves; and from thence the boundary proceeds south-westwardly, along the boundary line of Sheepshed and Beau Manor, to the Sheepshed and Newtown-road; and from thence in a southeastwardly direction along the centre of that road to where it crosses the Loughborough and Bosworth-road, at the point where the description of the boundaries of the said consolidated chapelry of the Oaks Church on Charnwood Forest commences, as the same was more particularly delineated on the map or plan annexed to the said representation, and thereon coloured pink, green, blue, and yellow.

"That in the said representation it was further stated that it had been mutually agreed between the said several patrons (with the approbation of your Majesty's said Commissioners, and also of the said George, Bishop of Peterborough, testified as therein mentioned), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, called The Oaks Church, should be vested in, belong to, and whenever occasion might require, be exercised by, the lords of the several manors, for the time being, of Groby, Whitwick, Beau Manor, Sheepshed, Ulverscroft, and Belton, in the county of Leicester

"That by an Order of your Majesty in Council, bearing date the fifteenth day of June, one

thousand eight hundred and fifty-two, your Majesty was graciously pleased, by and with the advice of your Privy Council, to approve of and to order, as it was thereby ordered, that the proposed formation into one consolidated chapelry should be accordingly made, and the agreement in respect to the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, called the Oaks Church, should be carried into effect, agreeably to the provisions of the said Acts.

"Your Majesty's said Commissioners beg leave further to represent that having taken into consideration the existing circumstances of the said consolidated chapelry of the Oaks Church on Charnwood Forest aforesaid, it appears to them to be expedient that the present boundaries thereof should be altered, as hereinafter mentioned, under and by virtue of the powers or authority contained in the sixteenth section of the said Act, passed in the eight and ninth years of your Majesty's reign, and that such proposed or altered boundaries should be those next hereinafter set forth, in lieu of, and in substitution for, the said boundaries hereinbefore mentioned, and comprised in your Majesty's said Order in Council, of the fifteenth day of June, one

thousand eight hundred and fifty-two.

"The boundary of the consolidated chapelry of the Oaks Church on Charnwood Forest, commences at the crossing of the Sheepshed and Newtown, and the Loughborough and Bosworth-roads, near Warren Hill, as shewn on the eastern side of the map or plan hereunto annexed, proceeds in a south-westerly direction along the centre of the Loughborough and Bosworth-road, to where it joins the Sheepshed and Ulversalong that road in a croft-road, eastwardly direction for one hundred and forty yards to the boundary of the township of Woodhouse, and along the south-westwardly boundary line of that township to where it joins the liberty of Charley, from thence in a north-westwardly direction along the boundary line of Charley and Beau Manor to where it joins the parish of Sheepshed, thence in the same direction until it joins the parish of Newtown Linford, thence in a southwestwardly direction till it joins the parish of Whitwick, near an ancient well, called 'Carter's Well;' from thence the boundary of the said consolidated chapelry of the Oaks Church passes in a southwardly direction along the boundary line of the parishes of Whitwick and Markfield to the Whitwick and Leicester turnpike-road, near to Green Hill, and at the southern end of the Charley Mill Lane; from thence the boundary of such consolidated chapelry proceeds along the said turnpike-road north-westwardly to the Hugglescote and Sheepshed Road, including the Forest Rock Public House, on the westwardly side of the said road, and proceeding thence along the said Whitwick and Leicester turnpike-road, for a distance of four hundred and forty yards to a bound stone; from the said turnpike-road the boundary of such consolidated chapelry passes in a northwardly direction to another bound-stone on the northern side of the Oaks-road, and along the centre of that road westwardly for a distance of seven hundred and seventy yards to the road leading from Belton to Whitwick, thence along the centre of that road north-eastwardly to where it joins the boundary of the parish of Sheepshed, near Burrows Springs, where it leaves the Beltonroad and passes along the Sheepshed parish boundary to the Loughborough and Ashby-de-la-Zouch turnpike-road; from thence the boundary of such consolidated chapelry passes eastwardly along the centre of that road to its junction with

the Sheepshed and Newtown-road, and from thence in a south-eastwardly direction along the centre of that road to where it joins the Loughborough and Bosworth-road, at the point where the description of the boundaries of the said consolidated chapelry of the Oaks Church on Charnwood Forest commences, as the same is more particularly delineated on the said map or plan hereunto annexed and is thereon coloured pink, green,

blue, and yellow.

"That the said George, Bishop of Peterborough, George Harry, Earl of Statuford and Warrington, The Right Honourable Edward Strutt (now Chancellor of your Majesty's said duchy of Lancaster), the said Charles March Phillipps, the said George Harry, Earl of Stamford and Warrington, the said Charles March Phillipps, the said Richard William Penn Curzon Earl Howe, and William Herrick, as such respective patrons as aforesaid, and which said George Harry, Earl of Stamford and Warrington, as Lord of the said Manors of Ulverscroft and Groby, the said Charles March Phillipps, as Lord of the said Manor of Sheepshed, the said Richard William Penn Curzon, Earl Howe, on behalf of the Most Honourable the Marquis of Hastings, a minor, as Lord of the said Manor of Whitwick, the said William Herrick, as Lord of the said Manor of Beau Manor, and Edward Dawson, of Whatton House, in the said county of Leicester, Esquire, as Lord of the said Manor of Belton, are the patrons of the said church called the Oaks Church, have severally consented to the said proposed alteration of boundaries of the said consolidated chapelry of the Oaks Church on Charnwood Forest, as required by the sixteenth section of the said Act passed in the eighth and ninth years of your Majesty's reign, in testimony whereof they have signed and sealed this representation.

"Your Majesty's said Commissioners beg leave further to represent and submit to your Majesty, that such proposed alteration of boundaries should not in any manner prejudice, alter, or affect the right of patronage of the said church, called the Oaks Church, as settled by your Majesty's said

Order in Council.

"Your Majesty's said Commissioners, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the recommendations of the said Commissioners in respect of the boundaries of the said district be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Peterborough.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that, having taken into consideration all the circumstances of the district parish of Christ Church, Saint Marylebone, in the county of Middlesex, and in the diocese of London, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint Matthew, situate in Carlislestreet, in the said district parish of Christ Church, Saint Marylebone, under and by virtue of the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to 'amend and render more effectual an Act, passed in 'the last session of Parliament, for building and 'promoting the building of additional churches in 'populous parishes,' as enlarged by the twelfth section of an Act of Parliament, passed in the first and second years of your Majesty's reign, intituled An Act to amend and render more effectual the 'Church Building Acts,' and extended by the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assignment of ecclesiastical districts to churches 'or chapels augmented by the Governors of the 'Bounty of Queen Anne, and for other purposes,' and that such proposed district should be named or called 'The District Chapelry of Saint Matthew, Saint Marylebone,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

" The district chapelry of Saint Matthew, Saint Marylebone, is bounded on the north by a line drawn in the centre of Princess-street; on the east by a line drawn in the centre of Grove-road and Grove-place; on the south by a line drawn in the centre of Earl-street East and Earl-street West; and on the west by a line drawn in the centre of the Edgware-road, as such district chapelry of Saint Matthew, Saint Marylebone, is more particularly delineated on the map or plan hereunto annexed, and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of matrimony should be published, and that marriages, baptisms, and churchings, should be solemnized or perchurchings, formed in the said church of Saint Matthew, in Carlisle-street aforesaid, and that the fees to arise therefrom should be received on account of and paid over to the Reverend Robert Walpole, Bachelor of Divinity, the present rector or incumlent of such district parish of Christ Church, Saint Marylebone, during his incumbency thereof, and that upon his avoidance of the said district parish, such fees should belong to the incumbent for the time being of the said church of Saint Matthew, in Carlisle-street aforesaid.

"That the consent of the Right Honourable and Right Reverend Charles James, Bishop of the said diocese of London, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, and also the consent of the said Robert Walpole (as the incumbent of the said district parish of Christ Church, Saint Marylebone), as required by the Act and section secondly hereinbefore mentioned, in order that the sub-division of such district parish, by forming thereout a district chapelry as aforesaid, shall take effect from the assignment of such district chapelry, in testimony whereof the said Charles James, Bishop of London, and Robert Walpole, have signed and scaled this representation.

"Your Majesty's said Commissioners, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom

NOTICE TO THE PUBLIC.

The Earl of Clarendon, Her Majesty's Secretary of State for Foreign Affairs, has received from Lord Bloomfield, Her Majesty's Envoy Extraordinary and Minister Plenipotentiary at the Court of Berlin, a capy of an instruction addressed by the Prassian Government to their authorities in the provinces, stating that Passports granted by

Foreign Consuls in Foreign States are contrary to the Police Regulations, and are not to be regarded as valid; and directing them to cause the necessary steps to be taken for insuring the strict observance of those regulations in future.

REGULATIONS RESPECTING PASSPORTS ISSUED AT THE FOREIGN OFFICE TO BRITISH SUBJECTS.

- 1. Applications for Foreign Office Passports must be made in writing; and addressed to Her Majesty's Secretary of State for Foreign Affairs, with the word "Passport" written upon the cover.
 - 2. The fee on the issue of a Passport is 7s. 6d.
- 3. Foreign Office Passports are granted only to British subjects; including in that description foreigners who have been naturalized by Act of Parliament, or by Certificates of Naturalization granted before the 24th day of August, 1850: in this latter case, the party is described in the Passport as a "Naturalized British subject."

4. Passports are granted between the hours of twelve and four on the day following that on which the application for the Passport has been

received at the Foreign Office.

5. Passports are granted to persons who are either known to the Secretary of State or recommended to him by some person who is known to him; or upon the written application of any Banking Firm established in London or in any other part of the United Kingdom.

6. Passports cannot be sent by the Foreign Office to persons already abroad. Such persons should apply to the nearest British Mission or

Consulate.

7. Foreign Office Passports must be countersigned at the Mission, or at some Consulate in England, of the Government of the country which the bearer of the Passport intends to visit.

8. A Foreign Office Passport granted for one journey may be used for any subsequent journey, if countersigned afresh by the Ministers or Consuls of the countries which the bearer intends to visit.

For the preservation of Her Majesty's moorings, and for the mooring, anchoring, and placing of all private ships of war, transports, and all other private and merchant ships and vessels, lighters, barges, boats, and other craft whatsoever, in the harbour or haven of Milford, in the county of Pembroke, for the purpose of insuring free and safe ingress, egress, and regress unto, into, and from Her Majesty's docks, dock-yard, arsenals, wharfs, and moorings therein, pursuant to an Act of Parliament made and passed in the 54th year of His Majesty King George the Third, and intituled "An Act for the better regulation of the several ports, harbours, roadsteads, sounds, channels, bays, and navigable rivers in the United Kingdom, and of His Majesty's docks, dock-yards, arsenals, wharfs, moorings, and stores therein, and for repealing several Acts passed for that purpose;" it is hereby ordered,

1. That no private ship of war, transport, or other private or merchant ship or vessel, lighter, barge, boat, or other craft whatsoever, shall be moored, anchored, or placed within the following spaces or limits; viz.: a line extending from the shore at the north-west angle of Ford Pater to the White Buoy, at the Carr Spit; and thence by a straight line running eastward from the said buoy to the Red Buoy, at the Dock-yard Bank; and thence by another straight line from the said Red Buoy to the Black Buoy, on the Dock-yard Bank; and thence, southerly, from the said Black Buoy by another straight line to the south shore, at the Camber, in the dock-yard, near its eastern extremity, except in case of necessity, to prevent damage to herself or that of the Queen's ships which may be at any contiguous mooring, and then to remove as soon as possible thereafter; except also in cases where any of the said ships, vessels, or craft may be consigned to the dock-yard, and must therefore necessarily anchor contiguous thereto till they can come to the cranes and wharfs for delivery of their cargoes, and then to be placed in such situations as Her Majesty's officers or Queen's pilots, by whom they are conducted, shall direct.

Nor shall any private ship of war, transport, or

other private or merchant ship or vessel, lighter, barge, boat, or other craft whatsoever be made fast to or moored or secured by any of the mooring anchors or chains to which access can be had when the tide is out, or be made fast to any of the buoys or piles of Her Majesty within the said harbour, in the fronts of the said dock-yard or other premises belonging to it, nor anchor or moor, so as to swing within any of the said buoys

or piles.
2. All private ships of war, transports, and other private and merchant ships and vessels, lighters, barges, boats, and other craft whatsoever, are hereby prohibited from being breamed in any part of the said harbour or haven of Milford, except on the shores at Pembroke, or to the westward of the Pennarmouth, and eastward of Pembroke Ferry; and all private ships of war, transports, and other private and merchant ships or vessels, lighters, barges, boats and other craft (except any having gunpowder on board not exceeding two tons in weight, and keeping to the northward of the beacon on the Carr Rocks, or having any gunpowder on board not exceeding one ton in weight, for the use of the Stone Quarries and town of Pembroke, and passing up Pennar Pill) are hereby prohibited from coming or entering into the said harbour above Milford, being laden with or having on board any quantity of gun-powder exceeding five pounds' weight in the whole; and all such gunpowder, except as aforesaid, is hereby appointed to be left and deposited at the depôt established for that purpose, on board Her Majesty's ship Mulgrave, moored to the eastward of the quarantine ground in the said harbour, nearly opposite the town of Milford, where the same will be taken and received according to the provisions of the said Act. The said vessels may be distinguished during the day by wearing a red burgee.

And it is hereby ordered, that no gunpowder exceeding five pounds' weight in the whole be landed between the town of Milford and Lawrenny Ferry, or below Bentlass, in Pennar Pill, or any part of the south side of the haven of Mil-

ford above Bullwell.

3. And for the protection of the said harbour or haven, it is hereby ordered, that no person or persons shall take any ballast or shingle from the shores or banks, or any portion of the shores or banks, between Pennarmouth to a distance of one mile to the eastward of Pembroke Ferry, on any account or pretence whatsoever, without being duly authorized by us, or other sufficient authority of Her Majesty's Government; but this regulation is not to restrict the raising of the sea sand for agricultural or other purposes, in the shoal water to the eastward of Pembroke Ferry, by the barges and craft which have hitherto been or may be employed thereon.
