for themselves or their property, and they might depend upon the same protection which they had hitherto enjoyed, such protection and freedom from danger, as far as their persons and property are concerned, will continue to be extended to all British and French subjects, without exception (to whatever trade or profession they may belong), who, quietly attending to their own business, observe the established laws of the country, and refrain from all acts for-

bidden by them.
