WHEREAS the Ecclesiastical Commission ers for England have in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for the "spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-seventh day of April, in the year one thousand eight hundred and fifty-four, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the

session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled 'An Act to make better provision for the spiritual care of populous parishes, have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of cer-tain property belonging to the Prebend of Stoke Newington, in the cathedral church of Saint Paul,

in London, and now vested in us.

"Whereas it is by the said Act (amongst other things) enacted, that notwithstanding the charge by that Act created (being a charge created in favour of the Governors of the Bounty of Queen Anne), all the same and the like powers and rights of ownership as are possessed and enjoyed respecting and over any lands, tithes, rent-charges, tene-ments, or other hereditaments whatsoever, by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent-charges, tenements, or other hereditaments vested, in us under certain Acts therein mentioned (being the Acts under which the property hereinafter described, is vested in us), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us, by proper instruments in writing duly executed according to law; with a certain proviso respecting the application of every sum of money received as the consideration or purchase-money for the sale, transfer, or conveyance by us of any of such lands, tithes, tenements, or other hereditaments, or of any estate or interest therein, and with a further proviso that none of such lands, tithes, tenements, or other hereditaments be sold, transferred, or conveyed, except by the authority of a scheme, and an Order issued by your Majesty in Council ratifying the

"And whereas all the lands, tenements, hereditaments, and endowments, formerly belonging to the said Prebend of Stoke Newington (except any right of ecclesiastical patronage), became vested in us on the vacancy of the said prebend, which occurred on or about the third day of December, one thousand eight hundred and fortythree, by the appointment of the Reverend John Lonsdale, the then prebendary, to the Bishoprick of Lichfield, subject to any legally subsisting lease

or leases thereof:

"And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and, after due consideration, it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as

shall appear to us to be advisable:

"We, therefore, humbly recommend and propose, that we may be authorized and empowered, by instrument or instruments in writing, duly executed according to law, from time to time to sell, and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, hereditaments, or endowments heretofore belonging to the said prebend of Stoke Newington, and so vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall, upon due calculation and inquiry, appear to us to be just and reasonable:

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of London.

THEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act, passed in the eighth and ninth years of Her Majesty's reign, intituled "An Act for the further amendment " of the Church Building Acts," and of the nineteenth and twentieth sections of an Act, passed in the fourteenth and fifteenth years of Her Majesty's reign, intituled "An Act to amend the "Church Building Acts," duly prepared and laid before Her Majesty in Council a representation, bearing date the fourth day of April, one thousand eight hundred and fifty-four, in the words follow-

ing; viz.:
"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the extra parochial place called Ogley Hay, of the district chapelries of Walsall Wood, in the parish of Walsall, and of Stonnall, in the parish of Shenstone, and of the parishes of Norton Canes and Hammerwich, all in the county of Stafford, and in the diocese of Lichfield, it appears to them to be expedient to unite and consolidate the whole of the said extra parochial place of Ogley Hay and certain contiguous portions of the said district chapelries of Walsall Wood and Stonnall, and of the said parishes of Norton Canes and Hammerwich, and to form the same into one consolidated chapelry for all ecclesiastical purposes for the consecrated church of Saint James, situate at Ogley Hay aforesaid, under the powers or authorities contained in the ninth section of an Act of Parliament passed in the eighth and ninth years of your Majesty's reign, intituled 'An Act 'for the further amendment of the Church Building 'Acts,' and in the nineteenth and twentieth sections of an Act of Parliament, passed in the fourteenth and fifteenth years of your Majesty's reign, intituled 'An Act to amend the Church Building 'Acts,' and that such proposed consolidated chapelry should be named or called 'The Con-'solidated Chapelry of Ogley Hay,' and that the boundaries thereof should be those hereinafter mentioned; that is to say :

"The boundary line of the said consolidated chapelry of Ogley Hay commences at the Catshill Toll-gate, in Icknield-street, by the canal, and proceeds north-westerly along the towing-path of the Wyrley and Essington Canal, as far as the weir that empties the spare water of the canal into the watercourse on Clayanger Common; then proceeds along the middle of such watercourse in

a northerly, north-westerly, again northerly, north-easterly, and easterly direction, as far as the Rising Sun Public-house; and from thence in a straight line easterly through fields marked Nos. 285 and 286 on the tithe commutation map of the said parish of Norton Canes, and across Norton Common to that part of the boundary of the said parish of Hammerwich which lies in Norton Pool; and from thence south-easterly by the boundary line of the hamlet of Burntwood as far as the Colliery Railway belonging to the Marquis of Anglesey, and proceeds south-westerly and southerly, along the middle of such railway, as far as the South Staffordshire Railway; and from thence crossing the latter railway in a straight line southerly to Watling-street and the said extra parochial place of Ogley Hay then proceeds southerly, south-westerly, and northerly, along the boundary line of the said extra parochial place of Ogley Hay until it reaches the said Wyrley and Essington Canal at the north-eastern corner of Brawn's Coppice; and from thence proceeds northwesterly along the south-western side of such canal as far as Catshill Toll-gate, where the boundary line of the said consolidated chapelry of Ogley Hay commenced, as the same is more particularly delineated on the map or plan hereunto annexed and thereon coloured green, pink, yellow, red, and buff:

"That the consents of the Right Reverend John, Bishop of the said diocese of Lichfield, and also Patron (in right of his see) of the parish church of the said parish of Norton Canes, of the Reverend John Hodges Sharwood, Master of Arts, Vicar and Incumbent of the parish church of the said parish of Walsall, and (as such Vicar) patron of the church of the said district chapelry of Walsall Wood, of the Reverend Robert William Essington, Master of Arts, Vicar and Incumbent of the parish church of the said parish of Shenstone, and (as such Vicar) patron of the church of the said district chapelry of Stonnall, and of Joseph Ashmall, of Ediall, in the parish of Saint Michael Lichfield, in the county of Stafford, William Stubbs, of Hammerwich aforesaid, William Middleton, also of Hammerwich, and John Forster, of Haunch Hall, in the parish of Longdon, in the said county of Stafford, patrons, in trust, of the parish church of the said parish of Hammerwich, have been severally obtained to the formation of the said consolidated chapelry of Ogley Hay, as required by the Acts and Sections hereinbefore mentioned, in testimony whereof the said John, Bishop of Lichfield and the said other persons, as such respective patrons as aforesaid,

have signed and sealed this representation.

"Your Majesty's said Commissioners beg leave further to represent, that it has been mutually agreed between the said John, Bishop of Lichfield, John Hodges Sharwood, Robert William Essington, Joseph Ashmall, William Stubbs, William Middleton, and John Forster (as such respective patrons as aforesaid), testified as aforesaid (with the approbation of your Majesty's said Commissioners, testified as hereinafter mentioned, and of the said John, Bishop of Lichfield, testified as aforesaid), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church of Saint James, at Ogley Hay aforesaid, should be vested in, belong to, and whenever occasion may require, be exercised by the Bishop of the said diocese of Lichfield for the time being.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect should consist of the westernmost part of the said

thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the consolidated chapelry therein mentioned for the consecrated church of Saint James, at Ogley Hay, be accordingly formed, and that the agreement mentioned in the said representation in respect of the right of presentation and appointment of an Incumbent or perpetual Curate to serve the said church be carried into effect, agreeably to the provisions of the said Acts; and that the right of presentation and nomination to the said church shall belong to, and be exercised by, the Bishop of the diocese of Lichfield for the time being, he being the person mentioned in such representation; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the said diocese of Lichfield.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the parish of Shinfield, in the county of Berks, and in the diocese of Oxford, it appears to them to be expedient that a particular district should be assigned to the consecrated church of the Holy Trinity, situate at Lambwood Hill Common, in the said parish of Shinfield, under and by virtue of the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act passed in the last session of Parliament for ' building and promoting the building of additional 'churches in populous parishes,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assignment of ecclesiastical districts to 'churches or chapels augmented by the Government's chapels augmented by the Government of the control of the

parish of Shinfield, and also a detached portion thereof locally situate in the parish of Strathfield-saye, and should be named or called 'The District Chapelry of Lambwood Hill,' and that the boundaries thereof should be those hereinafter mentioned; that is to say: on the south-east by the parish of Swallowfield, on the south-west by the parish of Strathfieldsaye, on the west by the parish of Sulhamsted, on the north-west by the parish of Burghfield, on the north and north-east by the parish of St. Giles Reading, and on the east by the remaining part of the said parish of Shinfield, from which the said district chapelry of Lambwood Hill is separated by an imaginary line drawn along the middle of the turnpike-road leading from Reading to Basingstoke, from the point where such turnpike-road leaves the boundary line separating the said parishes of Shinfield and Saint Giles Reading, at the south-eastern corner of Great Lea Common to the point where such turnpike-road crosses the boundary line separating the said parishes of Shinfield and Swallowfield on Spencer's Wood Common, as such district chapelry of Lambwood Hill is more particularly delineated on the map hereto annexed, and is thereon coloured

"Your 'Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, churchings and burials, should be solemnized or performed in the said church at Lambwood Hill aforesaid, and that the fees to arise therefrom should be paid and belong to the minister or incumbent of such church for the time being.

"That the consent of the Right Reverend Samuel, Bishop of the said diocese of Oxford, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed assignment of a district chapelry to the church of the Holy Trinity at Lambwood Hill Common, in the parish of Shinfield, in the county of Berks, be accordingly made, and the recommendations of the said Commissioners in respect of the publication of banns and the solemnization of marriages, baptisms, churchings, and burials, and in respect of the fees to arise therefrom, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Oxford.
