A T the Court at Buckingham Palace, the 8th day of June, 1854.

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An Act to amend and render more effectual an "Act, passed in the last session of Parliament, for building and promoting the building of additional churches in populous parishes," and of the third section of an Act of Parliament, passed in the second and third years of Her Majesty's reign, intituled "An Act to make better provision for the assignment of ecclesiastical districts to churches or chapels augmented by the Governors of the Bounty of Queen Anne, and for other purposes," duly prepared and laid before Her Majesty in Council a representation, bearing date the 1st day of June, one thousand eight hundred and fifty-four, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the parish of Saint Cuthbert, in the city and diocese of Carlisle, it appears to them to be expedient that a particular district should be assigned to the consecrated church called Christ Church, situate in the said parish of Saint Cuthbert, under and by virtue of the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of King George the Third, intituled 'An Act to amend and render more effectual an 'Act, passed in the last session of Parliament, for building and promoting the building of additional 'churches in populous parishes,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assignment of ecclesiastical districts to churches or chapels augmented by the Governors of the Bounty of Queen Anne, and for other purposes, and that such proposed district should be called or named, 'The District Chapelry of 'Christ Church, Carlisle;' and that the boundaries thereof should be those hereinafter mentioned; that is to say: commencing at Holmhead, on the River Caldew, and then proceeding northwardly,

down the River Caldew, to the Nelson Bridge; then eastwardly up the middle of Bridge-road to James-street; then southwardly along the middle of James-street to Wood-street; thence easterly along the middle of Wood-street to the southwestern side of the central railway station where it meets the ancient boundary of the city of Carlisle; thence by the line of the said ancient boundary, south-eastwardly and eastwardly, to Botchergate, and across Botchergate to Mary-street, and along the middle of Mary-street to the boundary-line between the parishes of Saint Cuthbert and Saint Mary; thence along the said boundary-line, eastwardly, to the boundary-line between the parishes of Saint Cuthbert and Stanwix; thence along the last-mentioned boundaryline to to the boundary-line between the parishes of Saint Cuthbert and Wetheral; thence along the said last-mentioned boundary-line, southerly and south-westwardly, to the boundary-line of Upperby District, and along such boundary-line of Upperby District, westwardly, southwardly, and north-westwardly, to the River Caldew, where the boundary of the said District Chapelry of Christ Church, Carlisle, commenced, and as the same is more particularly delineated on the map or plan hereunto annexed, and thereon coloured green.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published and that marriages, baptisms, and churchings should be solemnized and performed in the said church called Christ Church; and that the fees to arise therefrom should belong and be paid to the incumbent of such church for the time being.

"That the consent of the Honourable and Right Reverend Hugh, Bishop of the diocese of Carlisle, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty, in your royal wisdom, shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of her Privy Council, to approve thereof, and to order, and it is hereby ordered, that
