HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," and of another Act, passed in the session of Parliament held in the seventh and eighth years of Her Majesty's reign, intituled "An Act to explain and "amend an Act for making better provision for "the spiritual care of populous parishes;" and of another Act, passed in the session of Parliament held in the thirteenth and fourteenth years of Her Majesty's reign, intituled "An Act to amend the "Acts relating to the Ecclesiastical Commissioners "for England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-seventh day of April, in the year one thousand eight hundred and fifty-four, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament, held in the sixth and seventh years of your Majesty's reign, intituled "An Act to make better provision for the "spiritual care of populous parishes," and of another Act, passed in the session of Parliament, held in the seventh and eighth years of your Majesty's reign, intituled "An Act to explain "and amend an Act for making better provision "for the spiritual care of populous parishes," and of another Act, passed in the session of Parliament held in the thirteenth and fourteenth years of your Majesty's reign, intituled "An Act "to amend the Acts relating to the Ecclesiastical "Commissioners for England," have prepared and now humbly lay before your Majesty in Council, the following scheme for altering the bounds of the new parish of Saint Paul, High Elswick, in the county of Northumberland, and in the diocese of Durham.

"Whereas it was by the herein secondly-recited Act enacted, that it should be lawful, by the authority provided in the herein first-recited Act, at any time or times within twelve months after the date of the license of the minister first licensed to any separate district, constituted under the provisions of the same Act, to alter the

bounds of such district, although any alteration should not be required with a view to the constituting of another separate district; provided always, that the scheme for making any such alteration should be subject to all the provisions relating to schemes for constituting separate districts under the said first-recited Act; and that any portion of any such separate district, which by any such alteration as aforesaid should become detached or excluded therefrom, should to all intents and purposes again belong to and form part of the parish, chapelry, or district, out of which such portion was taken, upon such separate district being originally constituted, or to and of any new district.

"And whereas it was by the herein thirdlyrecited Act enacted, that the powers and authority relating to the alteration of the boundaries of
districts contained in the said secondly-recited
Act might, as to any such district then existing,
notwithstanding the limitation in the same Act
contained, be exercised at any time within five
years from the passing the said thirdly-recited
Act.

"And whereas the said new parish of Saint Paul, High Elswick, was duly constituted out of the parish of Newcastle-upon-Tyne, in the said county and diocese, under the provisions of the said first-recited Act, by a scheme prepared by us, and ratified by an Order of your Majesty in Council, bearing date the sixth day of April, in the year one thousand eight hundred and forty-six, and duly gazetted.

six, and duly gazetted.

"And whereas it has been represented to us, and appears to us to be expedient, that the bounds of such district should be altered in the manner hereinafter mentioned.

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend Edward Bishop of Durham, in testimony whereof he has signed and sealed this scheme, that the boundaries of the said new parish of Saint Paul, High Elswick, be altered and extended, so as to include all that part of the township of Elswick in the parochial chapelry of Saint John, Newcastle-upon-Tyne, in the said county and diocese, which is now situate on the southern side of the said new parish of Saint Paul, High Elswick, all which part is delineated and set forth in the map or plan hereunto annexed, and that the same be added to and included in, and form part of the said new parish of Saint Paul, High Elswick.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measure relating to the said district, in accordance with the provisions of the said Acts or of any other Act of Parliament."

And whereas the draft of the said scheme has been transmitted in accordance with the provisions of the said Acts, to the patron and incumbent of the parochial chapelry or parish of St. John, Newcastle-upon-Tyne, and no objections have been made thereto.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Durham.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament, held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An "Act for carrying into effect the reports of the "Commissioners appointed to consider the state " of the established church in England and Wales, " with reference to ecclesiastical duties and reve-"nues so far as they relate to episcopal dioceses, "revenues, and patronage," and of another Act, passed in the session of Parliament, held in the tenth and eleventh years of Her Majesty's reign, intituled "An Act for establishing the Bishop-"rick of Manchester, and amending certain Acts " relating to the Ecclesiastical Commissioners for "England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-ninth day of June, in the year one thousand eight hundred and fifty-four, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled 'An Act for carrying into effect ' the reports of the Commissioners appointed to consider the state of the established church in ' England and Wales, with reference to ecclesias-'tical duties and revenues so far as they relate to 'episcopal dioceses, revenues, and patronage,' and of another Act, passed in the session of Parliament, held in the tenth and eleventh years of your Majesty's reign, intituled 'An Act for establish-' ing the Bishoprick of Manchester, and amending 'certain Acts relating to the Ecclesiastical Com-' missioners for England,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for providing a permanent residence for the Bishop of Manchester.

"Whereas under the provisions of the above mentioned Acts, the Bishoprick of Manchester was by an Order of your Majesty in Council, bearing date the tenth day of August, in the year one thousand eight hundred and forty-seven, founded, and the endowment thereof fixed at the annual sum of four thousand two hundred pounds; and whereas by another Order of your Majesty in Council, bearing date the eleventh day of February in the year one thousand eight hundred and forty-eight, it is provided that such endowment shall be paid yearly out of the fund under our control applicable to the purposes of the said Acts; and whereas it is directed by the firstly-recited Act, that a fit house of residence shall be provided for the Bishop of Manchester.

"And whereas we are seized in fee simple in possession of the house and premises, called or known as Mauldeth Hall, situate at Heaton Norris, in the parish of Manchester, in the county of Lancaster, and of certain lands adjoining thereto, the same being particularly set forth and described in the first part of the schedule hereunto annexed, and we are, under and by virtue of an assignment of a lease thereof, also possessed of the lands adjoining to a portion of the first-mentioned premises, and particularly set forth and described in the second part of the same schedule; and whereas the said house and premises will afford a fit and convenient residence for the Bishops of Manchester.

"Now, therefore, we humbly recommend and propose, that the said house, lands, and premises, described in the first part of the said schedule hereunto annexed, shall upon and from the day on which any Order of your Majesty in Council, ratifying this scheme shall be published in the London Gazette, and without any conveyance or assurance in the law, other than such order, be permanently annexed to the see of Manchester, and shall become, and be the house of residence of the bishop of such sec, and his successors for ever, and that all our estate and interest in the lands and premises described in the second part of the said schedule, shall be also transferred to and vested in the said bishop and his successors.

And whereas by an Order of your Majesty in Council, bearing date the twenty-fifth day of August, in the year one thousand eight hundred and fifty-one, issued under the provisions of an Act, passed in the session of Parliament, held in the thirteenth and fourteenth years of your Majesty's reign, chapter ninety-four, and duly published in the London Gazette, regulating the incomes of the several archbishops and bishops of England and Wales, it is provided that until the Bishoprick of Manchester shall have been endowed with lands or other hereditaments, nothing in such Order contained, shall in any manner affect or relate to the Bishop and see of Manchester.

"We, therefore, further recommend and propose that upon the first avoidance of the said see which may happen after the passing of an Order of your Majesty in Council, ratifying this scheme as aforesaid, all the provisions of the said Order of the twentieth day of August, in the year one thousand eight hundred and fifty-one, shall apply to, and affect the Bishop and see of Manchester in the same manner, as they apply to and affect the other bishops therein referred to.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament."

"SCHEDULE.—FIRST PART.

"All those several pieces or parcels of land, comprising in extent thirty-four acres and nineteen perches (statute measure) little more or less, part of which is used as a garden and pleasureground, situate at Heaton Norris, in the parish of Manchester, in the county of Lancaster, with the mansion or dwelling-house and offices erected thereon, and called or known as Mauldeth Hall, and all the appurtenances thereunto belonging, which said lands, mansion-house, and premises were formerly in the ownership and occupation of Edmund Wright, Esquire, now deceased, and have been conveyed by his representatives to the Ecclesiastical Commissioners for England, by a deed, bearing date the seventh day of February, one thousand eight hundred and fifty-four, in the margin whereof they are, with their several boundaries, delineated by a plan, and coloured green and pink.

"SCHEDULE.—SECOND PART.

"All those pieces or parcels of land, comprising in extent five acres, one rood, and thirty perches, little more or less, situate at Heaton Norris aforesaid, adjoining and occupied with the hereditaments mentioned in the first part of this schedule, which said pieces or parcels of land were also formerly in the occupation of the said Edmund Wright, and were conveyed by his said representatives to the said Ecclesiastical Commissioners for England, by the above-mentioned deed, in the margin whereof they are, with their several boundaries, delineated by a plan, and coloured brown."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Manchester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to effect exchange of "patronage by archbishops, bishops, and other "ecclesiastical corporations," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-seventh day of July, in the year one thousand eight hundred and fiftyfour, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixteenth and seventeenth years of your Majesty's reign, intituled 'An Act to effect exchange of patronage 'by archbishops, bishops, and other ecclesiastical 'corporations,' have prepared and now humbly lay before your Majesty in Council, the following scheme for effecting an exchange of the patronage of certain livings belonging to the Crown for certain other livings belonging to the see of Oxford.

"Whereas it was by the said Act enacted, that it should be lawful for any bishop by the authority

of a scheme prepared by us, ratified by your Majesty in Council, and duly gazetted, to assign and transfer by way of exchange only, and not otherwise, any benefice or benefices of which he should be seised in right of his see, to any person for the patronage of any other benefice or benefices, and that from and after the publication of the Scheme and Order in Council effecting such transfer, the benefice or benefices and patronage thereby purporting to be transferred and exchanged, should be and remain thereby duly vested in the respective bishop, or other person party to such exchange without any transfer, conveyance, or assurance in the law, other than the said Scheme and Order so published in the Gazette as aforesaid: provided that in every such case we should, before submitting such Scheme for the consideration and approval of your Majesty in Council, make due inquiry into the circumstances of the proposed exchange, and into the equal or relative value of the benefices and patronage proposed to be thereby transferred, and should certify the same to your Majesty with such particulars thereof, as might be necessary to shew that such exchange was made in conformity with the intentions of an Act, passed in the session of Parliament, held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, chapter seventy-seven; and it was also enacted that the word person should extend to and include your Majesty, as well in respect of patronage vested, or to be vested in or exercised by your Majesty in right of the Crown or otherwise; and that in every case of exchange in right of the Crown, when the benefice is above the value of twenty pounds in the Queen's books, the assent of your Majesty should be testified by the signature of the Lord High Treasurer or First Commissioner of the Treasury for the time being; and that where the patronage of any benefice or benefices is given in exchange by the Crown, the benefice or benefices respectively taken in exchange for the same, should follow and be subject to the course of patronage of the benefice or benefices so given by the Crown:

"And whereas the Right Honourable George, Earl of Aberdeen, First Lord Commissioner of your Majesty's Treasury, and, as such, Patron in right of the Crown of the several benefices mentioned and described in the first schedule hereunder written, and the Right Reverend Samuel, Bishop of Oxford, who is seised in right of his see of the benefices mentioned and described in the second schedule hereunder written, have signified to us their desire that the patronage of the said benefices may be exchanged as hereinafter recommended and proposed.

"And whereas we have made due enquiry and calculation as to the circumstances of the proposed exchange and the relative value of the said benefices, and we do hereby certify to your Majesty, that having regard to the more onerous nature of the duties to be performed in the parishes of Abingdon and Newbury, as compared with the parish of Saint Albans, the value of the two benefices mentioned and set forth in the first of the said schedules is equivalent as nearly as may be to the value of the three benefices mentioned and set forth in the second of the said schedules, and that the particulars of such benefices respectively are as set forth in the said schedules.

"We, therefore, with the consent of the Right Honourable George, Earl of Aberdeen, as the First Lord Commissioner of your Majesty's Treasury, and the Right Reverend Samuel, Bishop of Oxford, in testimony whereof the said Earl bath signed,

and the said Bishop hath signed and sealed this exchange for the same the patronage of or right scheme, humbly recommend and propose that immediately from and after the publication in the London Gazette of an Order of your Majesty in Council ratifying this scheme, and without any further or other assurance or conveyance in the law, the patronage of or right of nomination to the said benefices mentioned and described in the said first schedule hereto annexed shall be assigned and transferred from your Majesty and your successors, and shall become and be vested in and be exercised by the said Samuel, Bishop of Oxford, in accordance with the provisions of the said Act and his successors in the said see, and that in or of any other Act of Parliament.

by your Majesty and your successors.

THEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-seventh day of July, in the year one thousand eight hundred and fifty-four, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for

session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled 'An Act to make better provision for the spiritual care of populous parishes, have prepared, and now humbly lay before your Majesty in Council, the following scheme for constituting a separate district for spiritual purposes out of the extraparochial place called Savernake, and out of the parish of Preshute, in the county of Wilts, and in the diocese of Salisbury.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent, and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any England, in pursuance of an Act, passed in the scheme for constituting any such district shall be

delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the mean time, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shall be increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

"And whereas it is by the said Act further enacted, that it shall be lawful, by the authority aforesaid, at any time to assign the right of patronage of any such district or new parish as aforesaid, and the nomination of the minister or perpetual curate thereof respectively, either in perpetuity, or for one or more nomination or nominations, to any ecclesiastical corporation, aggregate or sole, or to either of the Universities of Oxford, Cambridge, or Durham, or to any college therein respectively, or to any person or persons, or the nominee or nominees of such person or persons or body respectively, upon condition of such corporation, university, college, person or persons contributing to the permanent endowment of such minister or perpetual curate, or towards providing a church or chapel for the use of the inhabitants of such district or new parish, in such proportion and in such manner as shall be approved by the like authority:

"And whereas it has been made to appear to us that it would promote the interests of religion that the portion of the extra-parochial place called Savernake, in the said county of Wilts and diocese of Salisbury, hereinafter mentioned, together with a part of the adjoining parish of Preshute, hereinafter also mentioned and described, which parts of the said extra-parochial place and parish do not at present contain within their limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in the manner hereinafter set forth:

"And whereas a sum of two thousand five hundred pounds, Three Pounds per Centum Consolidated Bank Annuities, has been contributed and transferred to our account and into our names in the books of the Governor and Company of the Bank of England by the Right Honourable Charles Brudenell Bruce, Marquis of Ailesbury, and the Right Honourable George William Frederick Brudenell, Baron Bruce, commonly called Earl Bruce, towards the permanent endowment of the minister of the said district herein recommended to be constituted, and after such district shall have become a new parish as by the said Act is provided, of the perpetual curate thereof:

"And whereas by a deed, bearing date the eighth day of July, one thousand eight hundred

and fifty-four, made or expressed to be made between Peter Richard Hoare, Esquire, and Frederick Iltid Nichol, Esquire, of the first part, the said Marquis of Ailesbury and the said Earl Bruce of the second part, the Dean and Chapter of the cathedral church of Salisbury of the third part, and us the said Ecclesiastical Commissioners for England of the fourth part, all those the apportioned tithe-commutation rent-charge, or portions of tithe-commutation rent-charge, respectively specified in a summary form in the schedule to such deed, and issuing, arising, or payable out or in respect of the lands, tenements, and hereditaments referred to in the said schedule, have been granted and conveyed to us in fee simple in possession, in accordance with the provisions of the said Act, and of another Act, passed in the session of Parliament held in the fourteenth and fifteenth years of your Majesty's reign, intituled "An Act to amend the Church Building Acts," upon trust, to be applied towards the further permanent endowment of the minister or perpetual curate for the time being of the said district or new parish:

"And whereas a church has been provided by the said Marquis of Ailesbury and by the said Earl Bruce, which is intended to be offered for approval by us and for consecration as the church of the said district, for the use and service of the minister and inhabitants thereof:

"And whereas it has been proposed to us, and it appears to us to be expedient, that, in consideration of the benefactions aforesaid, the whole right of patronage of and nomination of the minister or perpetual curate to the said district or new parish should be assigned to the said Marquis of Ailesbury and his assigns during his life, and after his decease to the said Earl Bruce, his heirs and assigns.

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend Walter Kerr, Bishop of Salisbury, testified by his having signed and sealed this scheme, that all that part of the said extra-parochial place, called Savernake, and also all that part of the said parish of Preshute, described in the schedule hereunto annexed, all which parts, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto also annexed, shall be together constituted a separate district for spiritual purposes accordingly, and that the same shall be named 'The District of Savernake:'

" And we further recommend and propose that the minister of the district herein recommended to be constituted as aforesaid, and as soon as such district shall have become, according to the provisions of the herein first-recited Act, a new parish for ecclesiastical purposes, the perpetual curate thereof shall be permanently endowed in the manner following; that is to say: there shall be paid by us, in each and every year, by equal half-yearly pay-ments, on the first day of May and the first day of November, to such minister, or perpetual curate, as the case may be, when duly licensed according to the same Act, the annual sum of seventy-five pounds; and that the first such half-yearly payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister, or of such perpetual curate, as aforesaid; and we also recommend and propose that such minister or perpetual curate shall be further permanently endowed with the said tithes, or portions of tithes, or tithe rent-charge respectively granted and conveyed by the hereinbeforerecited deed, and that such tithes, or portions of tithes, or tithe rent-charge, shall accordingly, without any conveyance or assurance in the law, other

than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, be transferred and secured to such minister or perpetual curate so soon as he shall be appointed, and shall be permanently vested in such minister or

perpetual curate for the time being.
