of Leek, or within the limits before-mentioned; and to require the sale of all such tolls, stallages, and rates, to the Commissioners, and to enable the parties for the time being beneficially entitled to such tolls, stallages, and rates to lease and sell and transfer the same, and all their rights and interests therein, to the Commissioners, and any property, buildings, and works connected or used therewith; and to alter any of such tolls, and to fix and determine in the Bill the future amount of such tolls, stallages, and rates, and to enable the Commissioners to receive the same or the tolls so altered; and also to purchase by compulsion or agreement certain lands, situate on the south western side of the present cattle market, in the township of Leek and Lowe, and adjoining or near to the street called Derbystreet, and to the turnpike road leading to Ashbourne, and to provide and erect thereon a market for cattle, sheep, and other animals, or to apply the same for other public purposes; and to make and maintain in the said township an approach to such market from Canal-street, and for such purpose to widen Workhouse-street, and to form a road or communication to the site of the intended cattle market, and to enable the Commissioners to levy rates, tolls, or rents, for the use of such market, and to alter existing tolls and rates; and to enable the Commissioners to erect and provide a town hall and a market house, with suitable buildings, stalls, standings, sheds, courts, yards, works, and conveniences connected therewith, or attached thereto; and to remove to such market house the present market, now held in the said town, and to authorize the holding of the markets and fairs in such market house, on such days, and at such times as the Commissioners shall from time to time determine; and for the purpose of erecting and providing such town hall and market house, and the buildings and conveniences to be connected therewith, to purchase by agreement or compulsion the lands, houses, and buildings, in the township of Leek and Lowe aforesaid, situate in, or near the present Market-place and Stockwell-street, at or near the junction of Stockwell-street, with the said Market place; also to purchase by agreement any additional lands for the purposes of a cattle market, and a town hall, and a market house, or any of them; and to make provision for the better regulation and maintenance of the said markets and fairs, and of any other market and fair held in the town; and for the sale in the market house to be provided of butcher's meat, poultry, game, butter, cheese, fruit, vegetables, and other provisions, and articles, matters and things; and for preventing after the crection of the market house, sales, or exposures for sale, in the public streets, in respect of articles for which such market house is provided, and the hawking of such articles within the town; and to enable the Commisssiners to levy rates, stallages, and tolls for the use of such market house, and the stalls, weighing muchines, and conveniences connected therewith; and for preventing the sale of cattle and animals in the public streets after the new cattle market is provided. To enable the Commissioners to provide slaughter-houses, and to remove or prohibit the use of any of the existing slaughter houses within the extended limits and to havy tolls for the use of slaughter-houses so provided, and to make other provisions with reference

To enable the Commissioners to form and maintain a cemetery or cemeteries, with chapels and buildings attached thereto, both for the consecrated and unconsecrated part or parts thereof; and to prevent interments, either wholly or partially, in the existing churchyards, places for interment, and burial grounds, within the extended limits; and to given to Burial Boards, under or by virtue of the

vary and extinguish existing rights and privileges in connection with all such churchyards and burial grounds, or any of them; and to confer other rights and privileges, and to purchase compulsorily, take, or appropriate, for the formation of such cemetery or cemeteries, certain land at or near Cornhill Cross, in the said township of Leek and Lowe, as hereinafter described, namely,-first, a close of land belonging to the churchwardens of the township of Leek and Lowe, and of the parish of Cheddleton, or one of such places, in the occupation of Thomas Smith, and bounded on or towards the north and north-west by land belonging to the Rev. Henry Sneyd, and to the trustees of William Finney Johnson, Esquire, deceased, and to John Davenport, Esquire; on or towards the west and south by land belonging to the said John Davenport; and on or towards the east by land and buildings belonging to the Earl of Macclesfield, and to Mrs. Frances Ann Ward, and by the turnpike-road leading from Leek to Sandon. condly, a close of land belonging to the said John Davenport, in the occupation of George Williamson, and bounded on or towards the north and north-east, by the close of land lastly before described; on or towards the west and south by land belonging to the said John Davenport; and on or towards the east by the said turnpike road, and by other land belonging to the said John Davenport. -Thirdly, part of a close of land belonging to the said John Davenport, in the occupation of George Caley, so far as the same is bounded on the cast and north-east sides thereof by the closes of land first and secondly before described, and which part of the close of land is bounded on or towards the east side thereof by the close of land lastly before described; on or towards the north-east by the said close of land belonging to the said churchwardens first before described; on or towards the north and west by land belonging to the said John Davenport; and on or towards the south by the remaining part of the said close of land belonging to the said John Davenport, and in the occupation of the said George Caley.—Fourthly, part of another close of land belonging to the said John Davenport, in the occupation of John Gould, so far as the same is bounded on or towards the north and west sides thereof by the said close of land secondly before described, in the occupation of George Williamson, and which last-mentioned part of the close of land is bounded on or towards the east side thereof by the said turnpike-road, and on or towards the south side thereof by the remaining part of the said close of land belonging to the said John Davenport, and in the occupation of the said John Gould, with approaches to such lands so to be taken, commencing in the said turnpike road in the said township. Also to purchase compulsorily, take, or appropriate the lands belonging to the trustee of the Leek Town Lands, in the occupation of . John Clarke, called or known as Woodcroft Heath, in the township of Leek and Lowe, and situate to the north of the Leek gas works, with an approach or communication to such proposed cemetery, commencing in the turnpike-road leading from Leek to Newcastle-under-Lyme, near the said gas works, and terminating in the field or land proposed to be taken for such cemetery, all in the said township; also to purchase compulsorily, take, or appropriate any other of the lands belonging to the said trustee of the Leek Town Lands, in the last mentioned township; also, to purchase by agreement any additional lands for the purposes of cemeteries; and to authorise the Commissioners to receive or regulate the fees, rates, and charges in respect of burial in such cemetery or cemeteries.
