Those Ladies who are to be presented are hereby informed, it is absolutely necessary that their names, with the names of the Ladies who are to present them, should be delivered at the Lord Chamberlain's Office before twelve o'clock, on the Tuesday previous to the Drawing-Room, or upon any earlier day, between the hours of eleven and four, in order that they may be submitted for The Queen's approbation; it being Her Majesty's command, that no presentation shall take place, unless the name of the Lady presenting, together with that of the Lady to be presented, shall appear on the card to be delivered to the Lord Chamberlain, which names shall correspond with those previously sent in to the Lord Chamberlain's Office.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with certain "modifications, the fourth report of the Commis-"sioners of Ecclesiastical Duties and Revenues," and of another Act, passed in the session of Parliament held in the thirteenth and fourteenth years of Her Majesty's reign, intituled "An Act "to amend the Acts relating to the Ecclesiastical "Commissioners for England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of February, in the year one thousand eight hundred and fifty-five, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled 'An Act 'to carry into effect, with certain modifications, 'the fourth report of the Commissioners of Eccle-'siastical Duties and Revenues,' and of another Act, passed in the session of Parliament held in the thirteenth and fourteenth years of your Majesty's reign, intituled 'An Act to amend the 'Acts relating to the Ecclesiastical Commissioners 'for England,' have prepared and now humbly lay before your Majesty in Council the following scheme for augmenting the income of the Archdeaconry of the East Riding of York, in the diocese of York.

"Whereas it is by the first-recited Act enacted that, by the authority therein provided, that is to say, by a scheme prepared by us, and a duly gazetted Order of your Majesty in Council ratifying the same, any archdeaconry may, subject to the consent of the bishop, be endowed, amongst other modes, by augmentation out of the common fund in the said Act mentioned, but not so as in that case to raise the average annual income thereof to an amount exceeding two hundred pounds, with a proviso that no archdeacon shall be entitled to hold any endowment or augmentation or other emolument, as such archdeacon, under the provisions of the said Act, unless he shall be resident for the space of eight months in every year within the diocese in which his archdeaconry is situate, subject however to the same provisions as to licenses for non-residence which are enacted with respect to incumbents of benefices by the Act relating to pluralities and the residence of the clergy, in the same Act mentioned.

"And whereas it is by the said first-recited Act further enacted, that upon the endowment of an archdeaconry being made under the provisions thereof, all lands, tithes, and other hereditaments

(except any right of patronage) belonging to such archdeaconry at the time of such endowment, may, with the consent of the bishop of the diocese, and of any archdeacon in possession at the time of the passing of the same Act, and by the authority therein provided, be vested in us for the purposes of the said Act.

poses of the said Act.

"And whereas by the secondly-recited Act it is declared and enacted, that in the case of any archdeaconry which shall no longer be held by the archdeacon who was, at the time of the passing of the said first-recited Act, in possession thereof, the provisions of the same Act which relate to the transfer to us of the estates of any archdeaconry upon its endowment in either of the modes therein provided, shall be construed and held to authorize such transfer with the consent of the bishop of the diocese and of the archdeacon in possession of the archdeaconry at the time.

"And whereas the said archdeaconry of the East Riding of York is endowed by the annexation thereto of the rectory and parsonage of Mappleton, in Holderness, in the county of York, with the lands, tithes, and hereditaments thereunto belonging, now demised upon a lease for lives; and it has been made to appear to us that the average annual income of the said archdeaconry, arising from other sources, does not exceed the sum of twenty pounds.

"Now, therefore, we humbly recommend and propose, with the consent of the Right Honourable and Most Reverend Thomas, Archbishop of York, in testimony whereof he has signed and sealed this scheme, that there shall be paid by us out of the common fund, in the said first recited Act mentioned, to the said Charles Maitland Long and his successors in the said archdeaconry, so long as he or they shall respectively hold the same, and shall duly reside in accordance with the provisions of the said first recited Act, or shall have obtained license of non-residence, the annual sum of one hundred and eighty pounds, on the first day of January in every year, and that the first such whole yearly payment, or a proportionate part thereof, shall be made on the first day of January next; and that every such payment shall be made only on production to us of a certificate, under the hand of the Archbishop of York for the time being, that the said Charles Maitland Long, or his successor for the time being in the said archdeaconry, has duly resided as aforesaid during the preceding year, or on the production to us of a licence of non-residence; and that whenever a vacancy in the said archdeaconry shall happen on any other day than the first day of January, the then next yearly payment shall be duly apportioned, and paid between and to the archdeacon making the vacancy, or his representatives, and the archdeacon succeeding to such archdeaconry.

And we further recommend and propose (with the like consent of the said Thomas, Archbishop of York; and also with the consent of the Venerable Charles Maitland Long, the present archdeacon of the said archdeaconry, in testimony whereof the said archdeacon has signed and sealed this scheme), that without any conveyance or assurance in the law other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and after the day of such gazetting, the said rectory and parsonage of Mappleton, in Holderness, and all lands, tithes, tenements and hereditaments whatsoever at any time heretofore annexed to, and now forming part of, the endowment of the said archdeaconry of the East Riding of York (except any right of patronage), shall forthwith be disannexed therefrom, and be-

come and be absolutely transferred to and vested in us for the purposes of the said Acts.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immedidiately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of York.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the first day of March, in the year one thousand eight hundred and fifty-five, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament, held in the sixth and seventh years of your Majesty's reign, intituled 'An Act 'to make better provision for the spiritual care of 'populous parishes.' have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of certain property formerly belonging to the prebend of Oxton Secunda, in the collegiate church of

Southwell, and now vested in us.

"Whereas it is by the said Act (amongst other things) enacted, that notwithstanding the charge by that Act created (being a charge created in favour of the Governors of the Bounty of Queen Anne), all the same and the like powers and rights of ownership as are possessed and enjoyed respecting and over any lands, tithes, rent-charges, tenements, or other hereditaments whatsoever, by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent-charges, tenements, or other hereditaments vested in us under certain Acts therein mentioned (being the Acts under which the property hereinafter described is vested in us), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us, by proper instruments in writing, duly executed according to law, with a certain proviso respecting the application of every sum of money received as the consideration or purchase money for the sale, transfer, or conveyance by us of any of such lands, tithes, tenements, or other hereditaments, or of any estate or interest therein, and with a further proviso that none of such lands, tithes, tenements, or other hereditaments be sold, transferred, or conveyed,

except by the authority of a scheme, and an | Order issued by your Majesty in Council ratify-

ing the same:
"And whereas all the lands, tenements, hereditaments, and endowments formerly belonging to the said prebend of Oxten Secunda (except any right of ecclesiastical patronage), became vested in us on the vacancy of the said prebend, which occurred in or about the month of July, in the year one thousand eight hundred and thirty-nine, by the elevation of the Reverend Frederick Anson, the then prebendary, to the deanery of Chester, subject to any legally subsisting lease or leases

" And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and, after due consideration, it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as

shall appear to us to be advisable:

"We, therefore, humbly recommend and propose, that we may be authorized and empowered, by instrument or instruments in writing duly executed according to law, from time to time to sell and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, hereditaments, or endowments heretofore belonging to the said prebend of Oxton Secunda, and so vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise, as he or they shall direct or appoint, and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable.

" And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Lincoln.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled "An "Act to amend and render more effectual an Act " passed in the last session of Parliament for build-"ing and promoting the building of addi-tional churches in populous parishes," and

of the third section of an Act passed in the session of Parliament held in the and third years of Her Majesty's reign, intituled "An Act to make better provision "for the assignment of ecclesiastical districts "to churches augmented by the Governors of "the Bounty of Queen Anne, and for other pur-"poses," duly prepared and laid before Her Majesty in Council, a representation, bearing date the third day of March, one thousand eight hundred and fifty-five, in the words following: viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent, that having taken into consideration all the circumstances of the united parishes of Saint Maurice and Saint Mary Kalendar, in the city and diocese of Winchester, it appears to them to be expedient that a particular district should be assigned to the consecrated church called Trinity Church, situate in the said united parishes of Saint Maurice and Saint Mary Kalendar, under the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of Ilis Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed ' in the last session of Parliament, for building and 'promoting the building of additional churches 'in populous parishes,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty reign, intituled 'An Act to make better provision for the assignment of ecclesiastical districts to churches or chapels augmented by the Governors of the Bounty of Queen Anne, and for other 'purposes,' and that such proposed district should be named 'The District Chapelry of the Holy Trinity, Winchester,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"The boundary line of the said District Chapelry of the Holy Trinity, Winchester, com-mences at the northern end of Saint Peter's-street, at the point where the boundary-line of the parishes of Saint Mary Kalendar, Saint Bartholo-mew Hyde, and Saint Thomas Winchester meet; and proceeds from thence in a southerly, easterly, and again in a southerly direction, along the boundary line of the said parishes of Saint Mary Kalendar and Saint Thomas, until such boundary line reaches the backs of the houses on the northern side of Saint George's-street, the boundary line of the said district chapelry; then leaves the said parish boundaries, and proceeds in an easterly direction along the backs of the houses in that street, crossing over Parchment-street, Upper Brooks, and Middle Brooks, to the backs of the houses on the northern side of Silver-street, continuing easterly, along the backs of such houses, until it reaches the backs of the houses on the western side of Lower Brooks; then turning northerly, proceeds along the backs of the houses of Lower Brooks until it reaches a point opposite to the western end of Forder's Buildings; then crossing over Lower Brooks to the backs of the houses in Forder's Buildings, proceeds easterly, along the same, in a straight line to the southern end of the island in the watercourse; and from thence to the garden wall of Saint John's Hospital, along which said wall it proceeds in an easterly and southerly direction to the gate in High-street; and from thence to the boundary line of the parishes of Saint Peter Colebrook and Saint Maurice, in the middle of the High-street, and follows the boundary line of the said parish of Saint Maurice in an easterly, northerly, and westerly direction, until it meets the boundary line of the parish of Saint Mary Kalendar, along which

it proceeds, still westerly, to the point at the northern end of Saint Peter's-street, where the boundary line of the said District Chapelry of the Holy Trinity, Winchester, commenced, as the same is more particularly delineated by the map hereunto annexed, and is thereon coloured green.

"Your Majesty's said Commissioners beg leave further to represent, that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, and churchings, should be solemnized or performed in Trinity Church aforesaid, and that the fees to arise therefrom should be paid and belong to the incumbent of that church for the time

being.
"That the consent of the Right Reverend
"That the said diocese of Charles Richard, Bishop of the said diocese of Winchester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this

representation.
"Your Majesty's said Commissioners therefore humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto, as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to Trinity Church, in the united parishes of Saint Maurice and Saint Mary Kalendar, in the city of Winchester, be accordingly made, and that the recommendations of the said Commissioners in respect of the publication of banns, and the solemnization of marriages, baptisms, and churchings, in the said church, and the fees to arise therefrom, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Winchester.
