PRESENT,

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for the "spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the seventh day of June, in the year one thousand eight hundred and fifty-five, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled 'An Act 'to make better provision for the spiritual care 'of populous parishes,' have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of certain property situate in the parishes of Newborough and Saint John the Baptist Peterborough, and now vested in us.

"Whereas it is by the said Act (amongst other things) enacted, that notwithstanding the charge by that Act created (being a charge created in favour of the Governors of the Bounty of Queen Anne), all the same and the like powers and rights of ownership as are possessed and enjoyed respecting and over any lands, tithes, rent-charges, tenements, or other hereditaments whatsoever, by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent-charges, tenements, or other hereditaments vested in us under certain Acts therein mentioned (being the Acts under which the property hereinafter described is vested in us), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us, by proper instruments in writing duly executed according to law ; with a certain proviso respecting the application of every sum of money received as the consideration or purchase money for the sale, transfer, or conveyance by us of any of such lands, tithes, tenements, or other hereditaments, or of any estate or interest therein ; and with a further proviso that none of such lands, tithes, tenements, or other hereditaments be sold, transferred, or conveyed, except by the authority of a scheme, and an Order issued by your Majesty in Council ratifying the same:

"Whereas under and by virtue of an indenture of assignment, bearing date the thirteenth day of July, one thousand eight hundred and fifty-four, made between Henry Parsons, therein described, of the one part, and us, the said Ecclesiastical Commissioners for England, of the other part ; of another indenture of assignment, bearing date the fifth day of October, one thousand eight hundred and fifty-four, made between John Gates. therein described, of the one part, and us, the said Ecclesiastical Commissioners for England, of the other part; and of another indenture of grant, bearing date the ninth day of January, one thousand eight hundred and fifty-five, made between George, Lord Bishop of Peterborough, of the first part, Henry Thomas, Earl of Chichester, John George Shaw Lefevre, and the Right Honourable Henry Goulburn, therein respectively described as Church Estates Commissioners, of the second part, and us, the said Ecclesiastical Commissioners for England, of the third part; all that the site of the manor or mansion-house of Boroughbury, comprising six hundred and ninety-five acres, three roods, and two perches of land, more or less, with certain messuages thereon, situate in the parishes of Saint John the Baptist Peterborough and Newborough, in the county of Northampton, with the appurtenances thereunto belonging, became vested in us, subject to the provisions of the said Act.

"And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and, after due consideration, it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as shall appear to us to be advisable:

"We, therefore, humbly recommend and propose, that we may be authorized and empowered, by instrument or instruments in writing, duly executed according to law, from time to time to sell, and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, or hereditaments, so vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall, upon due calculation and inquiry, appear to us to be just and reasonable :

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Peterborough.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received a Despatch from Her Majesty's Consul at Rotterdam, enclosing the translation of an extract from the Staats Courant, being a Notice to Mariners, issued by the Netherland Minister of Marine relative to a New Lighthouse, which has been erected on the West Harbour Head of Helvoetsluÿs.

NOTICE TO MARINERS.

THE Minister of Marine hereby gives notice, that on the lighthouse, situated on the West Harbour-head of Helvoetsluÿs, a catadioptric lighting apparatus of the 4th size has been erected, to replace the Argand Lamp light formerly exhibited there: the new light will be visible at a distance of fully two geographical miles, and will illuminate the horizon from the N.W. $\frac{1}{2}$ N., through the west and south to east, by unadjusted compass.

Vessels coming in, which by the indication of the red part of the Coast Light of Goedereede, cross the North Pampus, will by the obscuration of the Light of Helvoetsluys, in the direction of N.W. $\frac{1}{2}$ N., know that they have passed that bank (the North Pampus), about a cable's length; in most cases, however, this obscuration will have to be taken observation of eight or ten ells above the ship's deck, on account of the height of the sand hills near the Kwak.

The Right Honourable Sir John Jervis, Knt., Lord Chief Justice of Her Majesty's Court of Common Pleas, at Westminster, has appointed John Wardle King, of Walsham-le-Willows, in the county of Suffolk, to be one of the Perpetual Commissioners for taking the acknowledgments of deeds to be executed by married women, under the Act passed for the abolition of fines and recoveries, and for the substitution of more simple modes of assurance, in and for the county of Suffolk.

TREASURY WARRANT.

WHEREAS by an Act, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Postmaster-General to remit any of the rates of British postage for the time being, payable by law on the transmission of post letters, newspapers, or other printed papers, to such extent as the Lords of the Treasury shall from time to time direct; and power is also given to the Commissioners of Her Majesty's Treasury

from time to time, by Warrant under their hands, to alter and fix any of the rates of British or Inland postage, payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas it is expedient that regulations should be made for the transmission by the post of the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the power or authority in us for such purpose vested in and by the said Act, and of all other powers enabling us in this behalf, do by this Warrant (under the hands of two of us the said Commissioners, by the authority of the statute in that case made and provided) order and direct, that on every letter not exceeding one quarter of an ounce in weight, posted in or addressed to any part of the United Kingdom, and sent from or to any commissioned Officer employed in Her Majesty's Foreign Legion, in Heligoland, transmitted by the post between any place in the United Kingdom and Heligoland, direct or via Hamburgh, direct or via Belgium, Prussia, and Hamburgh (the sea conveyance being either by packet-boat or private ship), there shall be charged and taken, in lieu of any rates of postage now payable by law on such letters, a uniform rate of three pence (which shall include any foreign postage that may be payable thereon).

And we further order and direct, that on every letter not exceeding one quarter of an ounce in weight, posted in or addressed to any part of the United Kingdom, and sent from or to any noncommissioned officer, serjeant, corporal, drummer, trumpeter, fifer, or private soldier, employed in Her Majesty's Foreign Legion, in Heligoland, transmitted by the post between any place in the United Kingdom and Heligoland, direct or viâ Hamburgh, direct or viâ Belgium, Prussia, and Hamburgh (the sea conveyance being either by packet-boat or private ship), there shall be charged and taken, in lieu of any rates of postage now payable by law on such letters, a uniform rate of three pence (which shall include any foreign postage that may be payable thereon).

And we direct, that on every letter, transmitted as is mentioned in this Warrant, exceeding a quarter of an ounce in weight, there shall be charged, taken, and paid, in lieu of any rates of postage now payable by law on such respective letters, progressive and additional rates of postage as follows; that is to say:

- On every letter, exceeding a quarter of an ounce in weight, and not exceeding half an ounce in weight, two rates of postage.
- On every letter exceeding half an ounce in weight, and not exceeding three quarters of an ounce in weight, three rates of postage.
- On every letter exceeding three quarters of an ounce in weight, and not exceeding one ounce in weight, four rates of postage. And for every quarter of an ounce in weight
- And for every quarter of an ounce in weight above the weight of one ounce, there shall be charged and taken one additional rate of postage; and every fraction of a quarter of an ounce above the weight of one ounce shall be charged as an additional quarter of an ounce; and each progressive and additional rate, chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under the provisions hereinbefore contained, if not exceeding one quarter of an ounce in weight.

And we further direct, that in respect of letters sent by any non-commissioned officers, serjeants, corporals, drummers, fifers, or private soldiers, under the regulations of this Warrant, the following conditions shall be observed; that is to say: upon each such letter shall be superscribed the name of the writer, and his class or description in the regiment or detachment to which he shall belong; and upon every such letter there shall be written in the handwriting of, and signed by, the officer having at the time the command of the regiment or detachment to which the privileged person belongs, the name of such officer and the name of such regiment or detachment.

And we further direct, that in respect to letters received by the post under this Warrant by any commissioned officers or any non-commissioned officers or private soldiers, the following conditions shall be observed; that is to say: the postage of each such letter posted in the United Kingdom shall be prepaid, either in money or by the proper stamp or stamps being affixed thereto, at the time of the same being posted; and as to letters received by any non-commissioned officers or private soldiers, each letter shall be directed to the privileged person, specifying on the superscription thereof, the regiment or detachment to which he shall belong.

And we further direct, that if the postage of any such letter posted in the United Kingdom shall not be prepaid either in money or by stamps, when posted, the same shall not be forwarded by the post; and that if in any case any other of the conditions hereinbefore prescribed be not complied with, the letter shall be charged with the same rates of postage as if this Warrant had not been signed.

And we further direct, that nothing herein contained shall be construed in anywise to annul, prejudice, or affect any of the exemptions and privileges granted by or under the said recited Act; and that all such exemptions and privileges shall remain in full force.

And we further direct, that the several terms and expressions used in this Warrant shall be construed to have the like meaning in all respects as they would have had if inserted in the said recited Act.

Provided lastly, and we hereby declare and direct, that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or any two of them, by Warrant under their hands, at any time hereafter, to alter or repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.

TREASURY WARRANT.

WHEREAS by an Act, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," it was enacted (amongst other things) that printed newspapers might be sent free of

postage, or liable to postage according to certain regulations and rates in the said Act set forth. And it was by the said Act provided that the Postmaster-General might remit any of the rates of British postage or inland postage for the time being payable by law on the transmission of post letters, newspapers, or other printed papers, to such extent as the Lords of the Treasury should from time to time direct. And by the said Act powers were given to the Commissioners of Her Majesty's Treasury from time to time, and at any time thereafter, by Warrant under their hands, to alter and fix any of the rates of British postage or inland postage payable by law on the transmission by the post of foreign or colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be con-tained in such Warrant; and from time to time, by Warrant as aforesaid, to alter or repeal any of such altered rates, and make and establish any new or other rates in lieu thereof; and from time to time, by Warrant as aforesaid, to appoint at what time the rates which might be payable were to be paid, and the power thereby given to alter and fix rates of postage was extended to any increase, or reduction, or remission of postage :

And whereas by an Act passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office," it was, amongst other things, enacted that it should be lawful for the Postmaster-General, if he should think fit (with the consent of the Commissioners of Her Majesty's Treasury), to allow any printed words, writing, or marks, in addition to the direction to be put on any printed newspapers or other printed papers sent by the post, or on the covers thereof, and any such newspapers or other printed papers should from thenceforth be forwarded either free of postage or subject to such rates of postage as the Postmaster-General, with the consent of the Commissioners of Her Majesty's Treasury should from time to time direct.

And whereas by an Act passed in the present session of Parliament, intituled "An Act to amend the laws relating to the stamp duties on newspapers, and to provide for the transmission by post of printed periodical publications," it is amongst other things enacted, that every periodical publication therein mentioned which should be printed within the United Kingdom, on paper stamped for denoting the rate of duty then imposed by law on newspapers should be entitled to the like privileges of transmission and retransmission by the post between places in the United Kingdom, either postage free or otherwise, on the same terms and conditions and under and subject to the like rules and regulations as newspapers duly stamped were then entitled and subject to, under any Act or Acts in force, but under and subject nevertheless to the terms and conditions in that Act contained; and further that it should be law-ful for the Commissioners of Her Majesty's Treasury, by Warrant under their hands, to allow any printed newspaper (British, colonial, or foreign) to be transmitted by the post between places in the United Kingdom and Her Majesty's colonies or foreign countries, or between any ports or places beyond the sea, whether through the United Kingdom or not, either free of postage or subject to such rates of postage not exceeding two pence for each newspaper, irrespective of any foreign or colonial postage as the Commissioners of the Treasury or the Postmaster-General, with their consent, should from time to time think fit; and as a condition to any British newspaper being transmitted by the post to any place out of the United Kingdom, the same should be printed on paper duly stamped with an appropriate die under the provisions of that Act; and the said lastmentioned Commissioners or the Postmaster-General might require such newspaper to be registered at the General Post Office in London, in such form, and with such particulars, and subject to the payment of such fees as therein mentioned, and also that it should be lawful for Her Majesty's Postmaster-General, with the consent of the Commissioners of Her Majesty's Treasury, at any time or times thereafter, to make and issue such orders, regulations, conditions, and restrictions as he should deem to be necessary or expedient for the purpose of regulating the receipt, transmission, and delivery by post of periodical publications under the provisions of that Act, or for preventing or detecting frauds or abuses in relation thereto, and for giving effect to the purposes of that Act; and that it should also be lawful for the said Postmaster-General, with the like consent, from time to time to rescind or revoke all or any such orders, regulations, conditions, and restrictions, and to make and issue any new ones in lieu thereof. And also that all periodical publications sent by post, otherwise than in conformity with the terms, conditions, and regulations established by or under the authority of that Act, might be detained by the Postmaster-General and any officer of the Post Office, and after being opened the same should be either returned to the senders thereof, or forwarded to the places of their destination charged with the like rates of postage as if the same were letters transmitted by the post; provided always, that it should be lawful for the Commissioners of Her Majesty's Treasury, by Warrant under their hands, to authorize Her Majesty's Postmaster-General to charge in any such case any such less rate of postage as to him should seem fit.

And whereas it is expedient to make provision for regulating the transmission by the post of certain newspapers, periodical publications, and printed prices current in manner hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the several before-mentioned Acts, or either of them, and of all other powers, enabling us in this behalf, do, by this Warrant under the hands of two of us the said Commissioners, by the authority of the statute in that case made and provided, order, direct, and consent, that the several printed newspapers, periodical publications, and printed prices current, mentioned in the schedule to this Warrant annexed, shall and may be transmitted by the post between any part of the several places mentioned and set forth in the said schedule to this Warrant annexed, in conformity with and under and subject to the several orders, regulations, conditions, and restrictions hereinafter mentioned and contained (and as respects certain of the said places in the said schedules mentioned, such transmission may also be by the routes and by the means respectively mentioned against such places in such schedule), either free or that the rates of postage for the transmission thereof shall and may be those which are mentioned and set forth against the said places respectively in the said schedule, according as the word, free, or the said rate of postage shall be

mentioned or set forth against the said places respectively in the said schedule.

- 1. Every such newspaper, periodical publication, and printed price current shall be sent without a cover, or in a cover open at the sides.
- 2. There shall be no word or communication printed on any such newspaper, periodical publication, or price current, after the publication thereof, or upon any cover thereof nor any writing or marks upon any such newspaper, periodical publication, or price current, or upon any cover thereof, other than and except the name and address of the person to whom the same is sent, and as to any such newspaper or periodical publication, or the cover thereof, except the name or title of such newspaper or periodical publication, and the name and address of the publisher, newsvender, or agent by whom the same is sent.
- 3. There shall be no paper or thing enclosed in or with any such newspaper, periodical, publication, or price current.
- 4. Every such newspaper, or periodical publication shall be put into the Post-office at such hours in the day and under all such regulations as the Postmaster-General may appoint, including therein the payment of postage on such as are liable to postage when put into the Post-office, if the Postmaster-General shall so require.

And we do further order, direct, and consent that every British newspaper which shall be hereafter sent by the post to places out of the United Kingom shall be posted in the United Kingdom within fifteen days next after the day on which the same shall be published, the day of publication to be determined by the date of such publication.

And we do further order, direct, and consent that Her Majesty's Postmaster-General shall and may charge all or any newspapers, periodical publications, and prices current sent by post otherwise than in conformity with the terms, conditions, and regulations established by or under the authority of the said Act last hereinbefore mentioned or of this present Warrant with such rates or rate of postage not exceeding in amount such rates or rate as would be chargeable upon the same as letters or a letter as to him shall seem fit.

And we do further order and direct that the term "by the post," used in this Warrant, or in the schedule hereunto annexed, shall include the conveyance by any British, foreign, or colonial packet-boat and also by private ship; and that the term "East Indies," used in this Warrant or in the schedule hereto annexed, shall be construed to mean any port or place in Asia within the limits of the Charter of the East India Company; and that the several other terms and expressions used in this Warrant or in the schedule hereto annexed shall be construed to have the like meaning in all respects as they would have had if inserted in either of the said Acts hereinbefore in this present Warrant mentioned and recited.

And we do further order and direct that the Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands duly made, at any time hereafter alter, repeal, or revoke any of the rates of postage hereby fixed or any of the orders, regulations, conditions, and restrictions hereby made, and may make and establish any new or other rates, orders, regulations, conditions, and restrictions in lieu thereof, and from time to time appoint at what time the rates which may be payable are to be paid.
