T is hereby notified that the Right Honourable the Earl of Clarendon, K.G., Her Majesty's Principal Secretary of State for Foreign Affairs, has received from the Lords Commissioners of the Admiralty a copy of a communication from Rear-Admiral the Honourable R. S. Dundas, Commander-in-Chief of Her Majesty's Naval Forces in the Baltic, enclosing a copy of a joint Notification, issued by him and by Rear-Admiral Penaud, Commander-in-Chief of the Naval Forces of His Imperial Majesty the Emperor of the French in the Baltic, which notification is as follows:

"It is hereby notified, in the name of Her "Britannic Majesty Queen Victoria, and His "Imperial Majesty Napoleon III., Emperor of " the French, that on the 12th day of July instant, "the French, that on the 12th day of July instant, "all Russian ports, roads, havens, and creeks in "the Gulf of Bothnia, from Torneå, in Lat. "65° 46' N., Long. 24° 7' E. of Greenwich, to "Nystad, in Lat. 60° 46' N., Long. 21° 20' E. of "Greenwich, including especially the ports of "Uleaborg, Brahestad, Gamla Carleby, Nyå "Carleby, Wasa, Christinestad, Biörneborg, and "Raumo, were placed in a state of strict Blockade "by a competent force of the Allied Fleets. And " by a competent force of the Allied Fleets. And " it is hereby further notified, with reference to " the Blockade of the coast of Finland between " Nystad and Hangö Head, and of the islands and " islets fronting the said coast, established on the "15th ultimo, that on the 14th day of July "instant, all other Russian islands fronting the "coast of Finland, and all Russian islands in the "Gulf of Bothnia, including especially the Aland " Islands, were placed in a state of strict Blockade " by a competent force of the Allied Fleets. And "it is hereby further notified, that all measures " authorized by the laws of nations and the re-"spective treaties between their Majesties and " the different neutral powers will be adopted and " executed with respect to all vessels which may " attempt to violate the said Blockades.

HEREAS the Ecclesiastical Commissioners VV for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty, King William the Fourth, intituled "An Act for carrying into effect "the reports of the Commissioners appointed "to consider the state of the Established "Church in England and Wales, with refer-"ence to Ecclesiastical Duties and Revenues, "so far as they relate to Episcopal Dioceses, "Revenues, and Patronage," and of another Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with certain "modifications, the fourth report of the Commis-" sioners of Ecclesiastical Duties and Revenues," and of another Act, passed in the session of Par-liament held in the fourth and fifth years of Her Majesty's reign, intituled "An Act to explain " and amend two several Acts relating to the "Ecclesiastical Commissioners for England," duly prepared and laid before Her Majesty in Council a scheme, bearing date the fourteenth day of June, in the year one thousand eight hundred and fifty-five, in the words and figures following; that

is to say: "We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled 'An Act for carrying into effect 'the reports of the Commissioners appointed to 'consider the state of the Established Church in 'England and Wales, with reference to Eccle-'sinstical Duties and Revenues, so far as they 'relate to Episcopal Dioceses, Revenues, and 'Patronage,' and of another Act, passed in the session of Parliament, held in the third and fourth years of your Majesty's reign, intituled 'An Act 'to carry into effect, with certain modifications, 'the fourth report of the Commissioners of Eccle-'siastical Duties and Revenues,' and of another Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled 'An Act to explain and amend two 'several Acts relating to the Ecclesiastical Com-'missioners for England,' have prepared and now humbly lay before your Majesty in Council the following scheme for substituting a money payment to the Bishop of Lichfield for certain estates belonging to his see.

"Whereas it was by the secondly and thirdly recited Acts enacted, that, by the authority therein provided (that is to say, by a scheme prepared by us, and an Order of your Majesty in Council ratifying the same), and for the purpose of fully carrying into effect any of the provisions of the same Acts, or of the said first recited Act, any arrangement might from time to time be made, with the consent in writing under the corporate seal of any bishop, for the sale, transfer, or exchange of any lands, tithes, or other hereditaments belonging to the see of such bishop, or for the purchase of other lands, tithes, or other hereditaments in lieu thereof, or for substituting in any case any lands, tithes, or other hereditaments for any money payment, or any money payment for any lands, tithes, or other hereditaments.

"And whereas the Right Reverend John, Bishop of Lichfield, is seised, in right of his see, of the manors, lands, and hereditaments, described in the schedule hereunto annexed, subject to the several leases in such schedule mentioned.

"And whereas one of the purposes of the said Acts is to provide a fund for making better provision for the cure of souls, and we are of opinion that it would ultimately conduce to the improvement of the said fund, that the said manors, lands, and hereditaments, should be transferred from the said See of Lichfield to us, and that an annual money payment to the said John, Bishop of Lichfield, and his successors, should forthwith be substituted for the same.

"Now, therefore, we humbly recommend and propose, with the consent of the said John, Bishop of Lichfield, testified by his having signed this scheme and sealed the same with his corporate seal, that from and after the day of the due publication in the London Gazette, of an Order of your Majesty in Council ratifying this scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the manors, lands, and hereditaments, so described or referred to in the said schedule hereunto annexed (excepting any right of ecclesiastical patronage), and all the estate, right, title, and interest therein and thereto of the said John, Bishop of Lichfield, and of his successors, Bishops of Lichfield, shall be and become conveyed and transferred from the said bishop and his successors, Bishops of Lichfield, and shall be absolutely vested in us (subject to any legally subsisting leases or grants thereof).

grants thereof). "And we further recommend and propose, that in consideration of and for such conveyance and transfer, and in substitution for the said manors, lands, and hereditaments, there shall be paid by us to the said John, Bishop of Lichfield, and his successors, Bishops of Lichfield, the annual sum of eight hundred and eighty-four pounds, by equal half-yearly payments, on the twenty-fifth day of March and the twenty-ninth day of September in every year, and that two of such payments in respect of the year ended the twenty-fifth day of March now last past, shall be made forthwith.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, in conformity with the provisions of the said recited Acts, or of any other Act of Parliament."

## " The SCHEDULE to which the above Scheme refers.

"All that the Rectory of Belgrave, in the county of Leicester, with the appurtenances thereunto belonging, now (with certain exceptions) in the tenure or occupation of Sir Cornwallis Ricketts, Baronet, his executors, administrators, assigns, or undertenants, by virtue of a lease dated the twenty-eighth day of April, one thousand cight hundred and fifty-four, granted to him by the said Bishop of Lichfield, for the term of twenty-one years from the twenty-fifth day of March then last past, subject to annual reservations, amounting in the aggregate to the sum of one hundred and forty-seven pounds, three shillings, and ten pence.

"Also all that the Rectory of Towyn Merion, otherwise Towyn Merioneth, and the chapels of Lenwyhangel, Tallyllynn, and Pennall, in the county of Merioneth, with the appurtenances thereunto belonging, all which are now (with certain exceptions) in the tenure or occupation of the Honourable Adolphus Frederick Charles William Vane Tempest, commonly called Lord Adolphus Vane Tempest, and James Edwards, their exceutors, administrators, assigns, or undertenants, by virtue of a lease, dated the twentyeighth day of April, one thousand eight hundred and fifty-four, granted to them by the said Bishop of Lichfield, for the term of twenty-one years from the twenty-fifth day (f March then last past, subject to annual reservations, amounting in the aggregate to the sum of one hundred and twentythree pounds, three shillings, and sixpence.

"And also all and singular those four late several prebends, commonly called by the names of Mordall, otherwise Moorhall Prebend, Beveley Hall, otherwise Beverley Hall Prebend, Chilton, otherwise Chilterton Hall Prebend, and Sucker Hall, otherwise Suckers Hall Prebend, heretofore founded and erected, and being within the Parish Church or Church Collegiate of Gnosall, in the county of Stafford, with the appurtenances thereunto belonging, all which are now (with certain exceptions) in the tenure or occupation of Richard Hinckley, his executors, administrators, assigns, or undertenants, by virtue of a lease, dated the first day of August, one thousand eight hundred and fifty-four, granted to him by the said Bishop of Lichfield, for the term of twenty-one years from the twenty-fifth day of March then last past, subject to annual reservations, amounting in the aggregate to the sum of ninety-three pounds, thirteen shillings, and cleven pence."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Liebfield. *Wm. WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act, passed in the session of Parliament held in the eighth and ninth years of Her Majesty's reign, initialed "An Act for the "further amendment of the Church Building "Acts," duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-seventh day of Junc, one thousand eight hundred and fifty-five, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the parishes of Great Warley, Shenfield, and South Weald, in the county of Essex, and in the dioces f Rochester, it appears to them to be expedient to unite and consolidate certain contiguous portions of those parishes, and to form the same into one consolidated chapelry for all ecclesiastical purposes, for the consecrated church called Christ Church, situate in the said parish of Great Warley, under the power for such purpose contained in the ninth section of an Act of Parliament, passed in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amendment of the Church Building 'Acts,' and that such proposed consolidated chapelry should be named or called 'The Consolidated Chapelry of Christ Church, Great Warley,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"The consolidated chapelry of Christ Church, Great Warley, is bounded by a line, commencing on the north at the Brentwood Station of the Eastern Counties Railway, and proceeding from thence in an easterly direction along the middle of such railway to the point where the boundary line of the parishes of Shenfield and Great Warley cross the railway westward of the road from Childerditch to Brentwood, and from such point following the boundary line separating the said parishes in an easterly and south-easterly direction until such boundary line meets the parish of Ingrave, and then proceeding southerly and westerly along the boundary line separating the parish of Great Warley from the said parish of Ingrave, the parish of Childerditch, and the parish of Little Warley, as far as the road leading to Warley Barracks at a point where a bound-stone is placed, C. C. of C. C. Gt. W., from which stone the boundary line of the said consolidated chapelry will proceed in a straight line westerly to the southern corner of the plantation on the eastern side of Little Warley-lane, and from such corner will proceed westerly along the middle of the lane leading to Green-lane, and then proceeding in a northerly direction along the middle of the said Green-lane and Warley-lane as far as the said Eastern Counties Railway, and then leaving the said Warley-lane and proceeding in an easterly direction along the middle of the said railway as far as the Brentwood Station, where the boundary commenced as such con-solidated chapelry of Christ Church, Great Warley, is more particularly delineated on the map or plan hereunto annexed, and thereon coloured blue, pink, and green.

"That the consents of the Right Reverend George, Bishop of the said diocese of Rochester,

and also patron, in right of his see, of the parish church of the said parish of South Weald, of the Right Honourable Thomas Philip, Earl de Grey, patron of the parish church of the said parish of Shenfield, and of the Master, Fellows, and Scholars of the College of Saint John the Evangelist, in the University of Cambridge, patrons of the parish church of the said parish of Great Warley, have been obtained to the formation of the said consolidated chapelry of Christ Church, Great Warley, as required by the Act and section hereinbefore mentioned, in testimony whereof the said George, Bishop of Rochester, and Thomas Philip, Earl de Grey, have signed and sealed this representation, and the said Master, Fellows, and Scholars have hereto affixed their common seal.

"Your Majesty's said Commissioners beg leave further to represent, that it has been mutually agreed between the said George, Bishop of Rochester, Thomas Philip, Earl De Grey, and the said Master, Fellows, and Scholars, as such respective patrons as aforesaid, testified as afore-said, and Sarah Clay, of Great Warley aforesaid, Spinster, the Reverend Hastings Robinson, Doctor in Divinity, of Great Warley aforesaid, the Reverend John Clay, Master of Arts, of Stapenhill, in the county of Derby, Clerk, and the Reverend Joseph Webster Harden, Master of Arts, of Condover, in the county of Salop, Clerk (in whom, as trustees, the right of presentation and appointment of a minister to serve the said church called Christ Church, at Great Warley aforesaid, is now vested, under the powers contained in the twenty-third section of the hereinbefore recited Act of Parliament, as amended by the fourth section of an Act of Parliament, passed in the eleventh and twelfth years of your Majesty's reign, intituled 'An Act to your Majesty's reign, initial An Act to 'amend the law relative to the assignment of Ecclesiastical Districts'), testified by their signing and scaling this representation (with the approbation of your Majesty's said Commis-sioners, testified as hereinafter mentioned, and of the said George, Bishop of Rochester, testified as aforesaid), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church called Christ Church, at Great Warley aforesaid should be vested in, belong to, and whenever occasion may require, be exercised by, the said Sarah Clay, Hastings Robinson, John Clay, and Joseph Webster Harden, as trustees thereof.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the consolidated chapelry therein mentioned for the consecrated church of Christ Church, situate in the parish of Great Warley, be accordingly formed, and that the agreement mentioned in the said representation, in respect of the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, be carried into effect, agreeably to the provisions of the said Act; and that the right of presentation and nomination to the said church shall belong to, and be exercised by, Sarah Clay, Hastings Robinson, John Clay, and Joseph Webster Harden, as trustees thereof, they being the persons mentioned in such representation; and Her Majesty is further plensed to direct that this Order be forthwith registered by the Registrar of the diocese of Rochester.

#### NOTICE TO MARINERS.

#### Board of Trade, Whitehall, July 24, 1855.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received a Despatch from Her Majesty's Pro-Consul at Marseilles, enclosing a Notice to Mariners issued by the Ministry of Agriculture, Commerce, and Public Works, France, respecting a New Lighthouse which has been erected at Marseilles, a translation of which is subjoined.

#### (Copy.)

THE Ministry of Agriculture, Commerce, and Public Works gives notice to mariners that, from the 15th August next, a fixed red light will be exhibited every night on the top of the tower recently erected on the southern point of the mole of the "Port de la Joliette."

The following indications show the geographical position, and the distance at which this new light will be visible.

Latitude, 43° 17' 56" (forty-three°, seventeen', fifty-six"); longitude, 3° 1' 17" E. (three°, one', seventeen" E.)

Elevation above the sea, 25 (twenty-five) metres, about 81 (eighty-one) feet; distance 8 (eight) miles.
